Confirmation of Minutes.

On motion by Councillor Prue, the Minutes of the Board of Health meeting held on June 18, 2001, were confirmed.

7.1 Appointment of Associate Medical Officer of Health.

The Board of Health had before it a report (June 25, 2001) from the Medical Officer of Health, advising the Board of Health on recent appointments of Associate Medical

Officers of Health (AMOH's); advising that there are no financial implications resulting from the adoption of this report; and recommending that:

- (1) the recommended designations of Associate Medical Officers of Health as outlined in this report be transmitted to City Council and to the provincial Minister of Health for approval; and
- (2) the authority be granted to introduce the necessary bill in Council to give effect to the above recommendation.

On motion by Councillor Prue, the Board of Health recommended to City Council, for its meeting on July 24, 2001:

(1) that the following new Public Health Physicians be appointed as Associate Medical Officers of Health for the City of Toronto Health Unit, and that this recommendation be transmitted to the Provincial Minister of Health and Long Term Care for approval:

Dr. Michael Finkelstein Dr. Bonnie Henry; and Dr. Karl Kabasele;

(2) that the appointments of the following former Public Health Physicians as Associate Medical Officers of Health for the City of Toronto Health Unit be rescinded:

Dr. Shelley Deeks; and Dr. Monir Taha; and

(2) that authority be granted to introduce the necessary bill in Council to give effect to the above recommendations.

7.2 Response to the Jordan Heikamp Jury Inquest Recommendations.

The Board of Health had before it a report (July 4, 2001) from the Medical Officer of Health, responding to those recommendations from the Jordan Heikamp Coroner's

Inquest that pertain to Toronto Public Health; advising that there are no financial implications resulting from the adoption of this report; and recommending that:

- (1) Toronto Public Health advocate for additional provincial funding for additional staff to visit high-risk families and to provide staff training, outreach and targeted promotion of the Healthy Babies Healthy Children (HBHC) Program;
- (2) Toronto Public Health, in collaboration with the City's Shelter, Housing and Support Division and other key stakeholders, develop referral and service co-ordination protocols for shelters who serve homeless youth who are pregnant or parents with children under six:
- (3) the Board of Health forward this report to the Children and Youth Action Committee and to the Community Services Committee for information; and
- (4) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

The Board of Health also had before it a communication (July 16, 2001) from Councillor Pam McConnell, requesting the Medical Officer of Health to report to the Board this fall on the desirable level of pre-natal and post-natal services.

Councillor Olivia Chow appeared before the Board of Health in connection with the foregoing matter.

Nancy Peters declared an interest in this matter in that her employer provided evidence to the Inquest.

On motion by Dr. Pellizzari, the Board of Health recommended to the Community Services Committee:

- (1) adoption of the foregoing report (July 4, 2001) from the Medical Officer of Health; and that
- (2) Toronto Public Health facilitate a process with other Toronto health care service providers, such as hospitals and Community Care Access Centres (CCACs) to explore the possibility of organizing and resourcing a 24-hour phone line and breastfeeding support service;
- (3) the Medical Officer of Health report to the Board of Health in the fall on specific resources needed by the City and Province in

order to fully implement the Jury's recommendations; and (moved on behalf of Councillor Chow)

(4) the Chairs of the Board of Health and Community Services Committee be requested to meet with their provincial counterparts to discuss the foregoing recommendations. (moved on behalf of Councillor Chow)

7.3 Leaf Blowers and Other Lawn Garden Equipment.

The Board of Health had before it a report (July 3, 2001) from the Medical Officer of Health, reporting from a public health perspective on noise and air pollutant emissions from leaf blowers; an acceptable noise level for leaf blowers and other lawn/garden equipment; whether a leaf blower by-law or ban is justified based on health concerns; and by-laws and bans in major cities in North America that restrict leaf blower use; advising that there are no financial implications resulting from the adoption of this report; and recommending that:

- (1) the Board of Health request the City Solicitor to report on the extent to which the City has the authority to regulate and prohibit the operation of gas-powered leaf blowers within the City of Toronto;
- (2) the Board of Health request the General Manager of the Parks and Recreation Division, the Commissioner of Works and Emergency Services, and the Canadian Union of Public Employees (Local 416) to report back on:
 - (a) the implications on City operations and budget of a by-law to prohibit the operation of gas-powered leaf blowers; and
 - (b) suggested parameters for such a by-law (e.g., exemptions for use during specified times of the year), if deemed necessary to mitigate adverse impacts on operations;
- (3) the Board of Health request the Ontario Ministry of the Environment to convene a multi-stakeholder task group to develop health-protective standards for noise,

exhaust and evaporative emissions to be met by manufacturers of lawn/garden equipment;

- (4) the Board of Health forward this report to the Planning and Transportation Committee and the Works Committee for their consideration:
- (5) the Planning and Transportation Committee seek public input on this report at Community Councils (at the same time that Community Councils give consideration to the Urban Development Services report on a harmonized Noise By-law for Toronto);
- (6) the Medical Officer of Health forward a copy of this report for information to: the Occupational Health and Safety Coordinating Committee of the City of Toronto; Toronto Cancer Prevention Coalition; City Agencies, Boards and Commissions; Environment Canada; Ontario Public Health Association; Ontario Ministry of Health; Health Canada; Ontario Ministry of Labour; Ontario Federation of Labour; Workplace Safety and Insurance Board; The Occupational Health Clinics for Ontario Workers Inc.; Landscape Ontario; Ontario Parks Association; Canadian Hearing Society; Canadian Centre for Occupational Health and Safety; NoiseWatch; the League for the Hard of Hearing; Industry Canada; the Canadian Standards Association; and the Noise Pollution Clearinghouse; and

 - (b) between 6:00 pm and 8:00 am on weekdays, and at all times on Saturday

and Sunday, on non-residential properties; and

(2) the Medical Officer of Health be requested to prepare a position paper for public discussion after the harmonized Noise By-law has been considered by the Planning and Transportation Committee at which time a method for public hearings will be established; (Carried)

7.4 Health Effects of Noise.

The Board of Health had before it a report (June 27, 2001) from the Medical Officer of Health, reporting on the process of seeking epidemiological data on the health effects of noise, as requested by the Board of Health; advising that there are no financial implications resulting from the adoption of this report; and recommending that:

- (1) the Board of Health request the Commissioner of Works and Emergency Services, in consultation with the Commissioner of Urban Development Services and the Medical Officer of Health to:
 - (a) develop a uniform noise monitoring program that specifies the targets for monitoring (such as population subgroups or geographic locations), sampling methods, protocol for data collection, data analysis, and reporting;

- (b) consider appropriate remedial measures when the levels of noise exceed the thresholds for adverse health effects; and
- (2) the appropriate city officials be authorized and directed to take the necessary action to give effect thereto.

(5) the Medical Officer of Health be requested to report to the Board of Health on the staffing needs to implement a seven-day, 24 hours a week noise control program.

7.5 Response to the Proposed Provincial Regulation regarding Lakeview Generating Station.

The Board of Health had before it a report (July 10, 2001) from the Medical Officer of Health, responding to the proposed provincial Regulation regarding electricity production at the Lakeview Generating Station; advising no direct financial implications for the City of Toronto; and recommending that:

- (1) the Board of Health and City Council convey their opposition to a proposed provincial Regulation which would allow the Lakeview Generating Station to continue using inefficient technology instead of high efficiency, combined cycle natural gas turbines in order to reduce the adverse health impacts arising from environmental pollution; and
- (2) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

On motion by Mr. MacKay, the Board of Health recommended to City Council, for its meeting on July 24, 2001, adoption of the foregoing report.

7.6 Strategy to Achieve a Phase Out of Non-essential Outdoor Uses of Pesticides.

The Board of Health had before it a (July 10, 2001) from the Medical Officer of Health, responding to a request from the Chair of the Board of Health to develop a strategy to phase out non-essential outdoor uses of pesticides on public and private property; advising no financial implications stemming from this report, further that any budget implications arising from an approved action plan will be considered in a future budget cycle; and recommending that the Board of Health:

- (1) request City Council to authorize the Pesticides Subcommittee of the Toronto Interdepartmental Environment Committee (TIE) to:
 - (a) determine public attitudes towards greater restriction on the non-essential outdoor use of chemical pesticides on private property;
 - (b) continue to identify alternatives to the outdoor use of chemical pesticides;
 - (c) continue to consult with organic and traditional lawn care companies regarding chemical pesticide phase out options;
 - (d) develop a strategy to phase out non-essential outdoor uses of pesticides on private property, including an expanded education and outreach campaign targeted at pest control companies and the general public;
 - (e) submit the recommended strategy to the Board of Health and other appropriate standing committees for consideration;
- (2) request City Council to direct the City Solicitor, in consultation with the Pesticides Subcommittee of the Toronto Interdepartmental Environment (TIE) Committee, to report to City Council on the most appropriate legal mechanisms by which the City can phase out non-essential outdoor use of pesticides; and
- (3) authorize and direct the appropriate City Officials to take the necessary action and give effect thereto.

On motion by Councillor Mihevc, the Board of Health advised City Council, for its meeting on July

- 24, 2001, of having endorsed, in principle, the regulation of cosmetic pesticides in the City of Toronto and recommended that:
- (1) the Medical Officer of Health, pending affirmation by the City Solicitor on the legality of introducing a by-law to restrict cosmetic pesticide use in the City of Toronto, be requested to prepare a public discussion document and seek broad input on the nature and scope of a potential pesticides by-law;
- (2) the Board of Health and Toronto City Council establish a Reference Group of interested Board members, Councillors, representatives from Economic Development, Culture and Tourism and Works and Emergency Services Departments, to engage in public consultation and to provide input to the Pesticides Sub-committee of the Toronto Interdepartmental Environment Committee (TIE); (amended by Councillor Prue for Councillor Denzil Minnan-Wong)
- (3) the Commissioner of Urban Development Services be requested to report on the possible inclusion of cosmetic pesticide use within the Official Plan:
- (4) the Medical Officer of Health be requested to submit an interim report to the Board no later than the November 26, 2001 Board of Health meeting;
- (5) City Council authorize the Pesticides Subcommittee of the Toronto Interdepartmental Environment Committee (TIE) to:
 - (a) determine public attitudes towards greater restriction on the non-essential outdoor use of chemical pesticides on private property;
 - (b) continue to identify alternatives to the outdoor use of chemical pesticides;

- (c) continue to consult with organic and traditional lawn care companies regarding chemical pesticide phase out options;
- (d) develop a strategy, in consultation with the City Solicitor, to phase out non-essential outdoor uses of pesticides on private property, including the proposed enactment of a by-law, and an expanded education and outreach campaign targeted at pest control companies and the general public;
- (e) submit the recommended strategy to the Board of Health and other appropriate standing committees for consideration;
- (6) Economic Development and Parks Committee be requested to explore opportunities to work with Organic Landscape Alliance to educate small businesses on pesticides-free lawn care techniques; and (moved by Councillor Bussin)
- (7) appropriate City Officials be authorized and directed to take the necessary action and give effect thereto.

Councillor Miheve resumed the Chair.

On motion by Councillor Pitfield, the Board of Health further advised Council of having requested:

- A. the Medical Officer of Health to report back to the Board of Health on:
- (i) in consultation with the City Solicitor, how the City could ban the sale of pesticide products in retail stores and on any other legal authority to effect the same;
- (ii) what the Toronto Catholic District School Board, French Public and French Separate

School Boards are doing with respect to pesticide uses on their properties;

- (iii) how the City could pursue some form of organic treatment as used by private organic companies;
- (iv) the number of smog alert days in 2001 during the grass-cutting season and its impact on work schedules;
- (v) the use of wildflowers and sea-grasses on boulevards as alternatives to pesticide uses; and
- B. the Medical Officer of Health to write to the Provincial Minister of the Environment for more information in light of the recent Supreme Court of Canada's ruling with respect to the Town of Hudson, Quebec.

On motion by Councillor Mihevc, the Board conveyed its congratulations to the Town of Hudson, Quebec and to the intervenors on the success of the Supreme Court of Canada case that upheld the municipality's authority to legislate restrictions on the use of cosmetic pesticides within its boundaries.
