The East York Community Council met on Wednesday, January 21, 1998, in the True Davidson Council Chamber, East York Civic Centre, East York, commencing at 9:35 a.m.

2. East York Community Council Political Structure.

The East York Community Council had before it a communication from Ms. Margaret Simpson, East York, (January 18, 1998) requesting an evening information session to allow East York residents to debate and discuss the meaning and details of the process to increase the political representation for Ward One, East York.

- (iii) the aforementioned meeting be scheduled at a time which is acceptable to the Special Committee to Review the Final Report of the Toronto Transition Team; and

8. Parking Restrictions on Coxwell Avenue: Proposal to Implement a No Parking Restriction adjacent to 806 Coxwell Avenue.

- (1) East York By-law No. 92-93, entitled "To Regulate traffic on roads in the Borough of East York", be amended to introduce a "No Parking Anytime" restriction on the west side of Coxwell Avenue from Queensdale Avenue to a point 19 metres south thereof; and
- (2) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

- (2) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

10. Implementation of a Disabled Parking Space on Bryant Avenue.

- this disabled parking space be removed when Mr. Alex Goydas ceases to reside at 18 Bryant Avenue; and

(3) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.
