## 72. 1998 CAPITAL BUDGET - FACILITIES MANAGEMENT

#### 73. 1998 CAPITAL BUDGET - PARKS AND RECREATION

The North York Community Council had before it the following:

- (a) the 1998 Parks and Recreation Capital Budget;
- (b) communication from the City Clerk (March 2, 1998) regarding the Joint Project with Metropolitan Separate School Board at St. Basil The Great College School Ward 6 North York Humber which was previously discussed by the North York Community Council on February 18, 1998, wherein it was recommended to the Budget Committee and Council, the adoption of the report (February 5, 1998) from the Commissioner of Parks and Recreation.
- (c) communication from the City Clerk (March 2, 1998) regarding Parkland Acquisition North York Community which was previously discussed by the North York Community Council on February 18, 1998, wherein it was recommended to the Budget Committee and Council, that Recommendation (b) embodied in the report (February 5, 1998) from the Commissioner of Parks and Recreation be referred to the Budget Committee for consideration during the Capital Budget process.

- Ms. Cheryl MacDonald, North York, who addressed the Community Council with respect to the funding for childcare.

Councillor Mammoliti, North York Humber, moved that:

- (1) Council be requested to consider:
  - (a) establishing a User Fee Task Force no later than the end of the next meeting of Council scheduled for April 16, 1998, and that it be mandated to deliver to Council for consideration at its meeting of October 1, 1998, recommendations on the user fee structure for the City of Toronto; and
  - (b) appointing Councillor Mammoliti as Chair of the Task Force;
- (2) a representative from every Department meet with every Member of Council to determine a 5-year working plan for each Ward and that all recommendations made by the Ward Councillors be forwarded to the Budget Committee before the end of August 1998; and
- (3) the Interim Lead for Parks and Recreation conduct a feasibility study on the need for recreational space and aquatic recreation facilities in the west end of the former City of North York and that the funds for this study be allocated from the Parks and Recreation Department Budget.

Upon the question of the adoption of Part (1) of the motion by Councillor Mammoliti, it was carried.

#### 74. 1998 CAPITAL BUDGET - TRANSPORTATION

#### 75. 1998 CAPITAL BUDGET - SOLID WASTE

During the course of its deliberations on the 1998 Capital Budgets, the North York Community Council discussed the matter of the Dufferin Transfer Station pilot project.

Councillor Moscoe, North York Spadina, moved that:

- (1) the mixed waste processing facility pilot project proposed for the Dufferin Transfer Station be deferred and that only sufficient funds be included in the Solid Waste Budget to conduct the necessary studies (including a transportation review, a planning and site plan analysis and an extensive consultation process with the community through the offices of the Local Councillors) for this facility;
- (2) an amount of \$3 Million be deleted from the 1998 Capital Budget for the mixed waste processing pilot project;
- (3) the proposal calls for this project not be opened until such time as the studies have been completed; and
- (4) an amount of \$3 Million be deleted from the Dufferin Material Recovery Facility (MRF) project.

Councillor King, Seneca Heights, moved that Recommendation (4) contained in the motion by Councillor Moscoe be referred to the Works and Utilities Committee for further consideration.

Upon the question of the adoption of the amendment moved by Councillor King, to refer Recommendation (4) to the Works and Utilities Committee, it was lost.
