4.1 Ventilation Option for the Environmental Tobacco Smoke (ETS) By-law.

The Board of Health had before it a report (April 28, 1999) from Councillor John Filion, Chair, Board of Health, recommending that:

- (1) the Ontario Restaurant Association provide to the Medical Officer of Health, by May 31, 1999, specific details on the ventilation technology which they believe to be an effective alternative to 100 percent smoke-free status for hospitality establishments, along with independent scientific evidence supporting the effectiveness of this technology; and
- (2) the Medical Officer of Health report to the Board of Health by June 28, 1999, regarding the appropriateness of including a ventilation option in the proposed ETS by-law.

Councillor Mihevc moved:

- (1) the adoption of the forementioned report; and
- (2) that the Medical Officer of Health be requested to report back to the next meeting of the Board on whether the Ontario Restaurant Association has responded. (**Carried**)

Mr. MacKay moved that the Medical Officer of Health be requested to circulate the final consolidated report on the ETS By-law in sufficient time to provide members of the Board the opportunity for review prior to the Board meeting on June 28 and 29, 1999. (Carried)

4.2 Renewal of the Ontario Tobacco Strategy.

The Board of Health had before it a report (April 29, 1999) from the Medical Officer of Health advising the Board of recent steps taken by the Province to strengthen tobacco control and prevention in Ontario; and recommending that:

(1) the Board write to the Ontario Minister of Health to acknowledge her efforts to renew the Ontario Tobacco Strategy and to urge her to ensure early implementation of the remaining recommendations from the Expert Panel; and

(2) the Board's position be communicated to City Council, to local MPP's in the Toronto area, and to the Association of Local Public Health Agencies (ALPHA) in the form of a draft resolution on this matter.

On motion by Councillor Prue, the Board of Health deferred consideration of the aforementioned report until its next meeting, scheduled to be held on June 3, 1999.

4.3 Changes in Ontario's Electrical Sector and Air Quality - Follow-up.

The Board of Health had before it a report (April 28, 1999) from the Medical Officer of Health responding to the requests of the Board at its meeting on April 6, 1999, during consideration of her report dated March 25, 1999, entitled "Changes in Ontario's Electrical Sector and Air Quality"; and recommending that the Board:

- (1) revise the first and second recommendations embodied in the communication dated April 6, 1999, from Councillor Jack Layton, to indicate that air conditioners in City buildings, and in buildings belonging to others in the City, be set at an average temperature of 23 degrees Celsius during summer months; and
- (2) encourage the Ministry of Environment to take all steps necessary to shorten the time frame between the collection of air samples and the reporting of air sampling results to the public.

The Board also had before it a report (May 6, 1999) from the Medical Officer of Health recommending that:

- (1) Recommendation No. (1) of the report dated April 28, 1999, be deleted; and
- (2) the first and second recommendations contained in the communication from Councillor Jack Layton (April 6, 1999) be revised as follows:
 - (a) that the Commissioner of Corporate Services and the Commissioner of Works and Emergency Services consider setting thermostats in City buildings at a minimum of 23 degrees Celsius (73.4 degrees Fahrenheit) during summer months to conserve energy and minimize air pollution from coal-generated electricity, while ensuring that air temperatures within City buildings are maintained within the comfort range of 23 to 26 degrees Celsius (73 to 79 degrees Fahrenheit); and

(b) that the City of Toronto promote this practice to other building owners and tenants through the Building Owners and Managers Association (BOMA).

On motion by Councillor King, the Board of Health:

- (a) adopted the aforementioned report dated May 6, 1999, and in so doing recommended to City Council that:
 - (1) the Commissioner of Corporate Services and the Commissioner of Works and Emergency Services consider setting thermostats in City buildings at a minimum of 23 degrees Celsius (73.4 degrees Fahrenheit) during summer months to conserve energy and minimize air pollution from coal-generated electricity, while ensuring that air temperatures within City buildings are maintained within the comfort range of 23 to 26 degrees Celsius (73 to 79 degrees Fahrenheit); and
 - (2) the City of Toronto promote this practice to other building owners and tenants through the Building Owners and Managers Association (BOMA); and
- (b) adopted Recommendation No. (2) of the aforementioned report dated April 28, 1999, subject to amending the recommendation to provide that the Board of Health:
 - "(2) encourage the Ministry of the Environment to take all steps necessary to shorten the time frame between the collection of air samples and the reporting of air sampling results to the public, and further request the Ministry of the Environment to prepare an annual report on the air quality within the City of Toronto".

4.4 Community Consultations on Public Health.

The Board of Health had before it a report (April 26, 1999) from the Medical Officer of Health outlining a proposed process for community consultations on public health issues, in the context of Real Time Strategic Change, including special meetings to be held in each Community Council area; and recommending that the Board approve the community consultation process as set out in this report.

On motion by Ms. Lindsay, the Board of Health approved the community consultation process as set out in the aforementioned report, and requested the Medical Officer of Health to incorporate the suggestions made by the Members of the Board.

4.5 1999 Operating Budget - Update.

The Board of Health had before it a report (April 29, 1999) from the Medical Officer of Health respecting the 1999 Operating Budget approved by City Council and the provisional estimates of provincial funding for public health programs and services; and recommending that:

- (1) the Board receive for information the 1999 operating budget approved by City Council.
- (2) the Board request the Chief Administrative Officer to report the results of his upcoming review of Public Health to City Council through the Board of Health, in addition to any applicable standing committees; and
- (3) the Board express its appreciation to the Minister of Health for her efforts to strengthen public health through a return to cost shared funding for general programs and for increased support for provincial priorities.

On motion by Councillor Prue, the Board of Health adopted Recommendations Nos. (1) and (2) of the aforementioned report, and deferred consideration of Recommendation No. (3) until its next meeting, scheduled to be held on June 3, 1999.

4.6 Expansion of Hostel Services.

The Board of Health had before it a communication (April 29, 1999) from the Medical Officer of Health forwarding, for information, a report (March 26, 1999) addressed to the Community and Neighbourhood Services Committee, respecting expansion of hostel services and Public Health initiatives to reduce the spread of communicable diseases, in particular TB, wherein it is recommended that:

- (1) the Community and Neighbourhood Services Committee continue to support the optimal service level for Toronto Public Health's TB program;
- (2) current Public Health initiatives pertaining to communicable diseases other than TB should be harmonized across the City and workloads associated with both the current and new hostels should be monitored with a view to considering provincial cost-sharing of hostel-specific public health services;
- (3) prior to the construction of any new hostels, Toronto Public Health should be consulted regarding ways to minimize the risk of communicable diseases within the new environments;
- (4) the Community and Neighbourhood Services Committee continue to advocate with the Province for provincial funding for appropriate accommodation for people without housing who have active TB in order to reduce disease transmission and promote stability and health, as requested by the Board of Health on January 25, 1999; and
- (5) the Community and Neighbourhood Services Committee continue to support the recommendations in the Report of the Mayor's Homelessness Action Task Force, which states that no-one should be discharged from an institution to the street and that the Ministry of Health should fund infirmary beds in appropriate locations for homeless people recovering from illness or surgery.

On motion by Councillor King, the Board of Health received the aforementioned communication.

"RESOLVED that the Scarborough Community Council request the Board of Health to conduct a Public Meeting in Scarborough to hear public deputations on a Harmonized Environmental Tobacco Smoke (ETS) By-law for the City of Toronto."

The Board also had before it copies of correspondence between the Chair of the Board of Health and the Chair of the Scarborough Community Council regarding the options available regarding the holding of a public meeting on the Environmental Tobacco Smoke By-law.

On motion by Councillor King, the Board of Health received the aforementioned communication and correspondence; and directed that the Scarborough Community Council be advised that interested parties will be invited to attend meetings of other Community Councils or the meeting of the Board of Health on June 28, 1999.
