Confirmation of Minutes.

On motion by Councillor Sinclair, the Minutes of the meeting of the Works Committee held on October 6, 1999, were confirmed.

7.1 General Cleanliness in the Downtown Core.

The Works Committee had before it a communication (October 18, 1999) from Councillor Olivia Chow, Downtown, recommending that the Commissioner of Works and Emergency Services develop a comprehensive plan that will improve the general cleanliness of the downtown core, including increasing the number of times the streets are swept and the number of garbage receptacles in the downtown core and involving a public education campaign.

The Committee also had before it a communication (November 2, 1999) from Councillor Pam McConnell, Don River, suggesting that the Commissioner of Works and Emergency Services meet as soon as possible with the downtown area Councillors concerned about this issue, and review options for running a "Clean Toronto" pilot project that addresses the deteriorating level of cleanliness in the City core; and further suggesting that the Commissioner conclude the discussions and complete the development of a strategy by early January.

The Committee also had before it a communication (November 2, 1999) from Mr. Gordon Dreger, Urban Design Committee Chair, Bloor-Yorkville Business Improvement Area, concurring with Councillor Chow that the level of street cleaning and the number of garbage receptacles presently provided needs to be increased; noting that by-law enforcement also requires improvement; and requesting that the Bloor-Yorkville BIA be included in recommendations for improvement.

7.2 Garbage Packers.

The Works Committee again had before it a communication (April 19, 1999) from the City Clerk advising that City Council on April 13, 14 and 15, 1999, directed that Clause No. 6 contained in Report No. 4 of The Works and Utilities Committee, headed "Garbage Packers", be struck out and referred back to the Works and Utilities Committee for further consideration; and that Council also adopted the following recommendation:

"It is recommended that the Chair of the Works and Utilities Committee, Councillor Shiner and the Commissioner of Works and Emergency Services meet to discuss this matter prior to it being again considered by the Works and Utilities Committee."

- (1) the southbound left turns from Bathurst Street to Old Orchard Grove be prohibited from 4:00 p.m. to 6:00 p.m., Monday to Friday; and
- (2) the appropriate by-laws be amended accordingly.

7.4 Toronto Integrated Solid Waste Resource Management Process – Request for Proposals for Proven Diversion Services; CUPE/TEA Wet/Dry Proposal.

Works and Emergency Services recommending that the Toronto Integrated Solid Waste Resource Management Process Request for Proposals for Proven Diversion Services be approved for issuance on or about December 1, 1999, substantially in accordance with the Request for Proposals document attached to this report as Appendix "A".

7.5 Prince Edward Viaduct – Don Section Structure Modification, Contract No. T-71-99. (Midtown – Don River)

The Works Committee had before it a report (October 20, 1999) from the Commissioner of Works and Emergency Services recommending that:

- (1) Contract No. T-71-99, Tender Call No. 222-1999, for the installation of a safety fence on the Prince Edward Viaduct be cancelled;
- (2) the Commissioner of Works and Emergency Services be authorized to issue a new Request for Proposals with a maximum budget of \$2.5 million, to solicit new design concepts and full engineering services for this project, based on a design/build concept, with the submission being evaluated by a similar Project Steering Committee comprised of representatives from:
 - (a) the Schizophrenia Society of Ontario;
 - (b) the Council on Suicide Preventions;
 - (c) the Toronto Historical Board/Heritage Toronto;
 - (d) Architecture and Civic Improvements, City Planning;
 - (e) the Public Art Policy Advisory Committee; and
 - (f) the Technical Services Division, Works and Emergency Services Department; and
- (3) the appropriate City of Toronto officials be directed to take the necessary action to give effect thereto.

The Committee also had before it a communication (October 29, 1999) from the City Clerk, advising that City Council, at its meeting held on October 26 and 27, 1999, had before it Clause No. 9 contained in Report No. 4 of The Works Committee, headed "Prince Edward Viaduct – Measures to Deter Suicide Attempts"; and directed that the aforementioned Clause be struck out and referred back to the Works Committee for further consideration at its next meeting to be held on November 3, 1999.

The Committee also had before it a communication (November 3, 1999) from Councillor Pam McConnell, Don River, suggesting that the Committee continue to pursue the existing design, and defer the matter until the Commissioner can report on what can be done to reduce the overall

cost of the existing proposal (including changes to the contract tendering process) and what can be done to raise money to offset the increased costs.

The Committee also had before it the following communications:

- (i) (June 11, 1999) from Dr. Richard H. Seiden, Oakland, California, advising that taking positive steps to reduce suicides through environmental modification is not a comparable "displacement" to other places; and that the effectiveness of telephone measures is not so clear, suggesting instead the provision of a general "crisis" line;
- (ii) (October 13, 1999) from Dr. Morton M. Silverman, M.D., Associate Professor of Psychiatry, Editor-in-Chief, Suicide and Life-Threatening Behaviour, stating that limiting access to available means for suicide is a major preventive intervention within an overall community suicide prevention plan; and urging the City to make every effort to proceed quickly with implementing the Bloor Viaduct suicide prevention project;
- (iii) (October 15, 1999) from Dr. David Lester, Professor of Psychology, Richard Stockton College of New Jersey, in support of the fencing in of the Prince Edward Viaduct; and advising that there is good research evidence that restricting access to lethal methods for suicide reduces their use for suicide; that there are no published research reports that evaluate the effectiveness of the use of other measures such as placement of telephones on bridges; and that all privately owned structures are fenced in;
- (iv) (October 20, 1999) from Staff Inspector W. Fordham, No. 54 Division, Toronto Police Service, respecting the proposal to install a signed telephone system on the bridge where high risk or emotionally disturbed persons would have immediate access to on-line counselling;
- (v) (October 21, 1999) from Dr. D.J. Gunnell, Senior Lecturer in Epidemiology and Public Health Medicine, University of Bristol, outlining experience with efforts to reduce suicides from the Clifton Suspension Bridge in Bristol; and reiterating his support for the erection of safety barriers on the Prince Edward Viaduct;
- (vi) (October 21, 1999) from Dr. Robin R. Richards, Head Division of Orthopaedics, St. Michael's Hospital, informing the Committee of the medical costs and public health consequences when a person survives a jump from the Bloor Viaduct, and urging City Councillors to complete the suicide barrier without further delay;
- (vii) (October 25, 1999) from Dr. Claude Prevost, Regie Regionale de la Sante et des Services

Sociaux, stating that the installation of a safety fence is the most appropriate prevention measure for the suicide problem at the Bloor Street Viaduct; and encouraging City Councillors to examine alternative designs that would meet both suicide prevention and fiscal requirements;

Therefore, it is recommended that the Commissioner of Works and Emergency Services, in consultation with the Commissioner of Urban Planning and Development Services and the Chief General Manager of the Toronto Transit Commission, report on a process for the development of a transportation infrastructure implementation plan that not only places a priority on the maintenance and rehabilitation of the City's existing assets, but also identifies strategic investments in technological, operational and facility improvements which support the mobility needs of the City and the City's role in the Greater Toronto Area."

and connect to the detention tank is \$3.28 million; that the department will request \$60,000.00 from the 2000 Capital Budget to undertake a Class Environmental Assessment (EA) for Schedule "B" projects to evaluate the costs and benefits of undertaking such a project; and that if the Class EA concludes that the storage conduit is recommended, \$0.2 million in savings would be realized and the impact of construction would be minimized if this work is done together with the proposed forcemain for the residue from the R.C. Harris Filtration Plant; and recommending that this report be received for information.

On motion by Councillor Layton, the Committee deferred consideration of the aforementioned report until its next meeting, scheduled to be held on December 1, 1999.

7.21 Wet Waste Collection from Businesses in City of Toronto.

The Works Committee again had before it a report (August 24, 1999) from the Commissioner of Works and Emergency Services responding to a request from City Council to research options for a pilot project and full implementation of a wet waste collection program for businesses in the City of Toronto; concluding that due to the logistical difficulties and high costs associated with developing a wet waste collection for businesses, it is not recommended to proceed with a pilot or full implementation at this time; and recommending that this report be received for information.

On motion by Councillor Layton, the Committee received the aforementioned report, on the understanding that Works and Emergency Services staff will be participating in meetings with businesses in the Don River area, and will report back to the Committee on whether a pilot emerges from such meetings.

7.22 Relocation of Litter Bins.

The Works Committee again had before it a report (September 21, 1999) from the Commissioner of Works and Emergency Services respecting the relocation of existing litter bins which will become available as a result of the placement of new bins with advertising, as requested by Council at its meeting of June 9, 10 and 11, 1999; advising that staff are planning to replace existing litter bins in the Community Council area of Scarborough and in the Midtown and High Park wards that are in poor condition, with better quality bins that will become available as the new OMG Media bins are placed in other areas of Toronto, but that staff do not recommend relocating surplus litter bins due to the increased costs that would be incurred to empty and maintain these additional bins; and recommending that this report be received for information.

The Committee received the aforementioned report for information.

7.23 Feasibility of Direct Purchasing as a Method of Purchasing Commodities.

The Works Committee had before it a report (September 22, 1999) from the Chief Financial Officer and Treasurer providing information requested by Council at its meeting on July 6, 7 and 8, 1999, respecting the feasibility of direct purchasing as a method of purchasing commodities; concluding that the current process of purchasing commodities which provides all interested suppliers, whether manufacturers or distributors, an opportunity to compete and provide bids for City requirements should be maintained; and recommending that this report be received for information.

On motion by Councillor David, the Committee received the aforementioned report for information.

7.24 Vehicle Emission Testing.

The Works Committee again had before it a communication (August 6, 1999) from the City Clerk advising that City Council at its meeting held on July 27, 28, 29 and 30, 1999, struck out and referred back to the Works Committee for further consideration Item (w), entitled "Vehicle

Emission Testing (All Wards)" embodied in Clause No. 33 contained in Report No. 2 of The Works Committee, headed "Other Items Considered by the Committee", wherein the Works Committee reported having received a report dated June 15, 1999, from the Commissioner of Works and Emergency Services which provided additional information on the provincial Vehicle Emission Testing program, as requested by City Council at its meeting of April 13, 14 and 15, 1999.

On motion by Councillor Davis, the Committee received the aforementioned communication.

(Clause No. 16(n), Report No. 5)

7.25 Environmental Remediation.

The Works Committee had before it a communication (October 27, 1999) from Mr. Cosmo Mannella, Labourers' International Union of North America (LIUNA) Canadian Tri Fund, requesting the opportunity to give a presentation to the Works Committee on LIUNA's efforts to have the federal government establish a fund for environmental remediation, similar to the U.S. Superfund.

Councillor Disero moved that the Committee endorse, in principle, the initiative outlined in the aforementioned communication with a request that Mr. Mannella be invited to appear before the Committee at its next meeting, scheduled to be held on December 1, 1999. (**Carried**)

Councillor Layton moved that the Committee suggest that Mr. Mannella also contact the Federation of Canadian Municipalities with respect thereto. (**Carried**)

7.26 Environment Days.

The Works Committee had before it a report (October 27, 1999) from the Commissioner of Works and Emergency Services recommending that:

- (1) the following booking procedures, which are similar to those adopted by Council for the 1999 Environment Days, be approved for the year 2000 Environment Days:
 - (a) the number of Environment Days to be held in 2000 be limited to 28, one per ward;
 - (b) the Commissioner of Works and Emergency Services be authorized to choose the date and location and host the Environment Days in any ward where the two Councillors cannot agree by March 1, 2000, to jointly host an event on an available date and at a suitable location; and
 - (c) no changes be made to dates and locations for the Environment Days after they have been publicized, unless deemed absolutely necessary by the Commissioner of Works and Emergency Services; and
- (2) blue and grey boxes continue to be provided free of charge at Environment Days with a limit of one per resident.

Councillor Saundercook appointed Councillor Disero Acting Chair, and vacated the Chair.

On motion by Councillor Saundercook, the Committee:

- (1) recommended to Council the adoption of the aforementioned report; and
- (2) requested the Commissioner of Works and Emergency Services to report back to the next meeting of the Committee, scheduled to be held on December 1, 1999, on:
 - the implications of the announcement on November 3, 1999, by the Minister of the Environment with respect to the Waste Diversion Office (WDO); and
 - (ii) any potential industrial/municipal product stewardship partnership arrangements being considered for household hazardous waste, and how these may be dealt with by the WDO.

(Commissioner of Works and Emergency Services; c: General Manager, Solid Waste Management Services – November 3, 1999)

Councillor Saundercook resumed the Chair.

7.27 Change in Ownership of the Browning-Ferris Group of Companies.

The Works Committee had before it a report (October 26, 1999) from the Commissioner of Works and Emergency Services presenting the City of Toronto's position on whether consenting to the change in ownership of the Browning Ferris Companies is the best strategy for the City, at this time, given concerns about future competition levels and ongoing developments in the industry; and recommending that this report be received for information and any action deemed necessary by Council.

The Committee recommended to Council that the required consent under the Waste Transport and Disposal Agreement with the Browning-Ferris Group of Companies be given on the basis set out in the aforementioned report.

7.28 Proposed Installation of Traffic Control Signals -Dundas Street West and Easterly Access Driveway to Kingsway Mills Plaza. (Kingsway – Humber)

The Works Committee had before it a report (October 26, 1999) from the Commissioner of Works and Emergency Services recommending that:

- traffic control signals be approved at the intersection of Dundas Street West and the easterly access driveway to the Kingsway Mills plaza located at No. 4242 Dundas Street West;
- (2) installation of the traffic control signals be subject to the receipt of 50 percent funding from the owner of Kingsway Mills Plaza, for the capital cost and lump sum payment of \$15,000.00 for their contribution to the future operation and maintenance of the signals, with the remaining installation portion to be funded by the Transportation Services Division from its 1999 Capital Budget; and

(3) the appropriate City officials be requested to take whatever action is necessary to give effect to the foregoing, including the introduction in Council of any bills that may be required.

On motion by Councillor Sinclair, the Committee recommended to Council the adoption of the aforementioned report.

(Clause No. 12, Report No. 5)

7.29 Biosolids Advisory Group Pellet Marketing and Distribution Criteria.

The Works Committee had before it a communication (October 6, 1999) from the City Clerk advising that the Committee at its meeting on October 6, 1999, had before it a report (October 6, 1999) from the Commissioner of Works and Emergency Services, respecting criteria developed by the Biosolids Advisory Group for consideration by the City to assist in its negotiations with USF Canada on the biosolids pellet marketing contract, as requested by Council; and further advising that the Committee endorsed List A embodied in the aforementioned report for discussion with the contractor, and deferred consideration of List B until its next meeting, scheduled to be held on November 3, 1999, on the understanding that the contract not be signed pending such further consideration of List B.

The Committee also had before it a communication (November 3, 1999) from Councillor Jack Layton, Don River, submitting recommendations with respect to criteria to be adhered to by City staff during the negotiations with USF Canada on the biosolids pellet marketing contract.

The following persons appeared before the Committee in connection with the foregoing matter:

- Ms. Karen Buck, Toronto, Ontario, and submitted a communication with respect thereto;
- Ms. Shelley Petrie, Toronto Environmental Alliance;
- Ms. Karey Shinn, Chair, Safe Sewage Committee; and
- Ms. Maureen Reilly, Sludge Watch.

Councillor Layton moved that:

- (1) the following criteria be adhered to by City staff during the negotiations with USF Canada:
 - (i) delay giving authorization for USF Canada to market Toronto pellets for home use until the earlier of Year 3 of the contract or

until an expert panel made up of scientists, environmentalists, City staff, the Medical Officer of Health, Councillors and other interested people have determined that home use of Toronto pellets is environmentally safe; (Lost)

- a requirement that the land application of all Toronto pellets meet the Ontario guidelines for sewage sludge of 8 tonnes per hectare over a five-year period; and (Lost)
- (iii) a requirement that Toronto pellets are not mixed with other municipal sludge, paper mill sludge or other wastes; and (Lost)
- (2) that the Biosolids Advisory Group be continued, that other stakeholders including rural participants be invited to join the Advisory Group, and that the Advisory Group participate in:
 - (i) monitoring Toronto sludge quality through a half-yearly review which examines, but is not limited to, the presence of dioxins, mercury and endocrine disruptors; and
 - (ii) an annual review of pellet use.

(Carried)

Councillor Shiner moved that the Commissioner of Works and Emergency Services be requested to report directly to Council for its meeting commencing on November 23, 1999, responding to the concerns expressed by Ms. Maureen Reilly, Sludge Watch, and Ms. Shelley Petrie, Toronto Environmental Alliance, during their deputations. (**Carried**)

The following is the action therefore taken by the Committee:

The Committee:

(1) recommended to Council that the Biosolids Advisory Group, authorized by Council at its meeting on July 27, 28, 29 and 30, 1999, by its adoption of Clause No. 19 of Report No. 2 of The Works Committee, as amended, be continued, that other stakeholders including rural participants be invited to join the Advisory Group, and that the Advisory Group participate in:

- (i) monitoring Toronto sludge quality through a half-yearly review which examines, but is not limited to, the presence of dioxins, mercury and endocrine disruptors; and
- (ii) an annual review of pellet use; and
- (2) requested the Commissioner of Works and Emergency Services to report directly to Council for its meeting commencing on November 23, 1999, responding to the concerns expressed by Ms. Maureen Reilly, Sludge Watch, and Ms. Shelley Petrie, Toronto Environmental Alliance, during their deputations.

7.30 City Properties – 80 and 100 Turnberry Avenue. (Ward 21)

The Works Committee had before it a report (October 31, 1999) from the Commissioner of Works and Emergency Services providing an update on the status of the City properties located at 80 and 100 Turnberry Avenue, as requested by the Committee at its meeting on July 14, 1999; advising that the property located at 100 Turnberry Avenue is the site of an operating Transportation Division yard, and that the department is currently preparing a Terms of Reference and Project Plan for a major yards consolidation in this part of the City; further advising that the sale of the property located at 80 Turnberry Avenue was authorized by City Council; and recommending that this report be received for information.

On motion by Councillor Disero, the Committee received the aforementioned report for information.

7.31 Deputization of City of Toronto By-law Enforcement Staff and Toronto Transit Commission Route Inspectors as Municipal Law Enforcement Officers (MLEOs).

The Works Committee had before it a report (November 2, 1999) from the Commissioner of Works and Emergency Services recommending that:

- (1) City staff listed in Appendix 'A' as may be amended from time to time, attached to this report, be deputized as Municipal Law Enforcement Officers (MLEOs);
- (2) Route Supervisors of Toronto Transit Commission be deputized as MLEOs; and
- (3) the appropriate City officials be requested to take the necessary action to give effect thereto, including the introduction of all necessary bills.

On motion by Councillor Sinclair, the Committee recommended to Council the adoption of the aforementioned report.

(Clause No. 8, Report No. 5)

7.32 Works and Emergency Services – By-law Harmonization Priorities.

The Works Committee had before it a report (October 31, 1999) from the Commissioner of Works and Emergency Services forwarding a list of by-law harmonization priorities for 1999-2000 as identified by senior management of the Works and Emergency Services Department; and recommending that this report be received for information.

The Committee received the aforementioned report for information.

(Clause No. 16(q), Report No. 5)
