#### 12.1 2000 Operating Budget

The Budget Advisory Committee had before it the 2000 Operating Budget, Summary of Budget Review Programs – Wrap up, for the various departments, Agencies, Boards and Commissions of the City of Toronto.

#### **Toronto Transit Commission**

The Budget Advisory Committee had before it the following reports:

- (a) (February 28, 2000) from the Chief Administrative Officer recommending that:
  - (1) the 2000 Request of \$806.521 million gross and \$189.355 million net, comprised of the following services, be received:

- (2) the TTC as one of the City's Agencies, Boards and Commissions be requested to provide the Budget Advisory Committee with options and strategies to flatline and/or further reduce the 2000 Operating Budget below 1999 levels by providing the following information (prior to "wrap-up" meetings scheduled for the week of April 3<sup>rd</sup>):
  - (i) 5 percent priority reduction proposals;
  - (ii) a priority listing of all activities, with gross expenditures and FTEs identified; and
  - (iii) analysis of the administrative component of the budget to identify priority reduction proposal;
- (b) (December 17, 1999) from the General Secretary, Toronto Transit Commission, advising that the Toronto Transit Commission at its special meeting held on December 17, 1999, adopted, as amended, the recommendations embodied in the report, entitled "Toronto Transit Commission 2000 Operating Budget", wherein it is recommended that the Toronto Transit Commission:

- (1) approve the TTC 2000 Operating Budget (summarized in Appendix "A") as described in this report and as detailed in the following documents:
  - (i) TTC 2000 Operating Budget;
  - (ii) TTC 2000 Organization Charts;
  - (iii) TTC 2000 Goals and Objectives; and
  - (iv) TTC 2000 Detailed Budget Blue Book;
- (2) note the following budget assumptions and highlights:
  - (i) fares to remain unchanged (Operating Surplus to TTC Stabilization Reserve Fund to help offset need for 2001 fare increase);
  - (ii) improved economy expected for 2000;
  - (iii) ridership growth of 2 percent to \$405 million in 2000;
  - (iv) added service to provide for growth into 2001;
  - (v) revenue/cost ratio at 80 percent;
  - (vi) subsidy/Passenger of 37 cents;

the TTC remains the most productive and least subsidized mass transit authority in North America;

- (3) forward this report to the City of Toronto for Council approval of the required 2000 operating subsidy of \$152.7 million, noting that this is the level required to maintain the Council approved policy of the City funding 20 percent of the cost and TTC revenue 80 percent;
- (4) consider this report in concert with the following reports:
  - (i) Wheel-Trans 2000 Operating Budget; and
  - (ii) 2000-2004 TTC Capital Program;
- (5) request the Budget Advisory Committee to nominate members to meet with the TTC Chair, the TTC Vice-Chair, available TTC Commissioners and TTC staff to prepare a three-year funding plan for the TTC; and that the December 17, 1999 Commission report, entitled "TTC 2000 Operating Budget", and supporting documentation form the basis of the discussion at the those meetings; and

- (6) request that City Council contribute \$3.8 million to the TTC Stabilization Reserve Fund, such amount representing the difference between 20 percent of TTC expenses (\$153 million) and the 1999 approved City funding for the TTC (\$149 million); and that such funds as may be in the fund be utilized to help offset the 2001 requirement for a fare increase;
- (c) (December 17, 1999) from the General Secretary, Toronto Transit Commission, advising that the Toronto Transit Commission, at its special meeting held on December 17, 1999, adopted the recommendations embodied in the report, entitled "2000 Wheel-Trans Operating Budget", wherein it is recommended that the Toronto Transit Commission:
  - (1) approve the 2000 Wheel-Trans Operating Budget of \$40.9 million provided for in this report and companion documents noting the following highlights:
    - (i) \$40.4 million in operating subsidy (\$38.4 million for service; \$2.5 million for ELF buses; less \$0.5 million contribution from Stabilization Reserve);
    - (ii) 1,531,500 trip demand;
    - (iii) 1,492,500 passengers carried;
    - (iv) 2.6 percent unaccommodated rate;
    - (v) new low-floor ELF buses in service increase to 74;
    - (vi) partial replacement of Orion fleet resulting in maintenance savings of \$0.8 million;
    - (vii) zone bus service increases from five to six;
    - (viii) accessible taxi service increases to 44 vehicles;
    - (ix) cancellation rate reduced from 14 percent to 11 percent;
    - (x) implementation of integrated trip planning;
    - (xi) implementation of cross-boundary service to the Airport; and
    - (xii) workforce decreases by 10;

- approve the contribution of the projected 1999 Operating Budget underexpenditure of \$0.5 million to the Stabilization Reserve and withdrawal of the same amount in 2000 to reduce the 2000 funding request to \$40.4 million;
- (3) consider this report in concert with the following:
  - (i) the 2000-2004 TTC Capital Program which includes \$6.6 million in 2000 to purchase 30 low-floor (ELF) buses; and
  - (ii) the 2000 TTC Operating Budget;
- (4) forward this report to City Council for approval; and
- (5) forward this report to the TTC Advisory Committee on Accessible Transportation for information;
- (d) (February 10, 2000) from the General Secretary, Toronto Transit Commission, addressed to the Committee Administrator, Policy and Finance Committee, advising that the Toronto Transit Commission, at its meeting of February 9, 2000:
  - (1) received the report (February 9, 2000) from the Toronto Transit Commission, entitled "Workplace Safety and Insurance Board Administration Rate Increase;
  - (2) directed that a copy of the report be forwarded to the Policy and Finance Committee with a request that they consider the possibility of requesting the Provincial Auditor to review the administrative costs of the Workplace Safety and Insurance Board given the extraordinary cost increases outlined in the report; and
  - (3) directed a copy of the report also be forwarded to the Budget Advisory Committee for information given this unanticipated budget pressure;
- (e) (March 22, 2000) from the Chief General Manager, Toronto Transit Commission, advising that the Toronto Transit Commission on March 8, 2000, approved the following:
  - (1) the Commission reiterate its position that the continuation of the 80/20 split on the Operating Budget is important to the future of public transit on Toronto:
  - (2) the Commission reiterate its budget request for a flatlined \$149 million

- subsidy; and
- (3) the Chief General Manager be instructed to provide his presentation to the Budget Advisory Committee noting the impacts that will result from a reduction in subsidy and/or the elimination of the Toronto Transit Commission Stabilization Reserve Fund;
- (f) (March 31, 2000) from the Chief Financial Officer and Treasurer providing a reconciliation of the TTC Stabilization Reserve Fund as at December 31, 1999; analysing the TTC 80/20 Operating Budget subsidy ratio to include capital financing charges for the TTC capital program; and recommending that, if necessary, the Chief Administrative Officer and the Chief Financial Officer and Treasurer report back to the Policy and Finance Committee on a policy framework which would provide a rationale for budgeting contributions to the TTC Operating Stabilization Reserve Fund; and
- (g) (March 29, 2000) from the Chief Financial Officer and Treasurer, entitled "Toronto Transit Commission (TTC) December 31, 1999 Operating Budget Variance and 2000 Operating Budget and Service Improvements", recommending that:
  - (1) the report (March 9, 2000) from the General Secretary, Toronto Transit Commission, addressed to the Director of Budget Services, City of Toronto, for information regarding the December 31, 1999 TTC Operating Budget Variance be received;
  - the TTC 2000 Operating Budget Adjusted Gross and Net Request be reduced by \$5.8 million to \$800.7 million (\$806.5 \$5.8) and \$183.5 million (\$189.3 \$5.8) respectively to reflect the actual arbitrated wage settlements for 1999 and 2000; and
  - (3) the TTC report back to the Budget Advisory Committee on the 2001 ridership projection and their most recent Operating Budget Projection before implementing phase II (\$1.3 million in 2000/\$3.4 million annualized) of the service improvements plan.

Councillor Jakobek appointed Councillor Chong Acting Chair and vacated the Chair.

#### A. Councillor Jakobek moved that:

(1) the Budget Advisory Committee recommend to the Policy and Finance Committee, and Council, the adoption of the 2000 Budget for the Toronto Transit Commission, as follows:

- (a) the 2000 Wheel-Trans Operating Budget subsidy be set at \$40.5 million representing a total net expenditures increase of \$1.3 million of which \$0.8 million will be made available from the Operating Stabilization Reserve Fund; this draw represents a one time funding only which is equal to the 1999 Wheel-Trans Operating Surplus transferred into the reserve;
- (b) the additional funding of \$1.3 million noted above be used to maintain the unaccommodated rate between two and three percent in 2000;
- (c) the Chief General Manager, Toronto Transit Commission be requested to report back prior to the 2001 Operating Budget Cycle with options to offset the possible \$0.8 million pressure in 2001 with respect to Wheel-Trans services;
- (d) the Toronto Transit Commission adjusted Net Operating Budget Request of \$148.4 million be reduced by \$8.3 million to \$140.1 million based on the following;
  - (i) provision for 2000 wage settlement overstated by \$5.5 million;
  - (ii) provision of \$1.0 million for Y2K no longer required; and
  - (iii) provision for fuel increase overstated by \$1.8 million; a new contract was signed in March 2000 and the agreed price came in lower than projected;
- (e) given the significant budget pressure the City is faced with, it is further recommended that \$1.7 million of the Toronto Transit Commission Operating Stabilization Reserve Fund be used to fund a portion of the Toronto Transit Commission Subsidy of \$140.1 million recommended above; this will reduce the amount to be levied to \$138.4 million in 2000 with respect to this program; and

- (f) in order to avoid possible service cuts and/or fare increase in 2001, it is recommended that the Chief General Manager, Toronto Transit Commission, be requested to report back to the Budget Advisory Committee prior to the consideration of the 2001 Operating Budget on strategies to offset and/or mitigate the future Operating Budget pressures; and if necessary:
  - (i) increasing the Toronto Transit Commission Operating Budget subsidy from \$140.1 million as recommended for 2000 to the 1999 subsidy of \$148.9 million; and
  - (ii) restoring the \$1.7 million draw on the Toronto Transit Commission Operating Stabilization Reserve Fund;
- the Chief General Manager, Toronto Transit Commission be requested to report back to the Budget Advisory Committee on 2001 ridership projection and their most recent Operating Budget Projection before implementing phase II (\$1.3 million in 2000/\$3.4 million annualized) of the service improvements plan;
- (3) the Chief General Manager, Toronto Transit Commission be requested to report back prior to the start of the 2001 Operating Budget providing:
  - (a) a review of the base service level; and
  - (b) a three year Operating Budget projection (2001-2003) which would include the City of Toronto capital financing cost related to the Toronto Transit Commission capital program; and
- (4) the following reports be received:
  - (a) (December 17, 1999) from the General Secretary, Toronto Transit Commission, entitled "Toronto Transit Commission 2000 Operating Budget";

- (b) (December 17, 2000) from the General Secretary, Toronto Transit Commission, entitled "2000 Wheel-Trans Operating Budget";
- (c) (February 10, 2000) from the General Secretary, Toronto Transit Commission, entitled "Workplace Safety and Insurance Board – Administration Rate Increase";
- (d) (March 22, 2000) from the General Secretary, Toronto Transit Commission, entitled "Toronto Transit Commission 2000 Operating Budget";
- (e) (March 29, 2000) from the Chief Financial Officer and Treasurer, entitled "Toronto Transit Commission (TTC) December 31, 1999 Operating Budget Variance and 2000 Operating Budget and Service Improvements"; and
- (f) (March 31, 2000) from the Chief Financial Officer and Treasurer, entitled "Toronto Transit Commission (Toronto Transit Commission) Operating Stabilization Reserve Fund and Subsidy".

- (2) the Toronto Police Service, as one of the City's Agencies, Boards and Commissions, be requested to provide the Budget Advisory Committee with options and strategies to flat line and/or reduce the 2000 Operating Budget below 1999 levels by providing an analysis of the administrative component of the budget, as well as other non front line policing areas to identify priority reduction proposals (prior to the "wrap-up" meetings scheduled for the week of April 3<sup>rd</sup>);
- (3) the Toronto Police Service be requested to report back to the Budget Advisory Committee prior to the "wrap-up" meetings regarding the financial and operational impacts of moving to front line policing levels present at December 31, 1998 should City funding not be available to fund at the 1994 policing level including the impact on performance measures;

- (1) recommended to the Policy and Finance Committee, and Council, the adoption of the 2000 Operating Budget of the Toronto Police Services, as outlined in the report (February 22, 2000) from the Chief Administrative Officer, subject to:
  - (a) the Police/Fire Radio Communication System Technical adjustment of \$270,000.00;
  - (b) reducing the budget by \$3.9 million;
  - (c) the Toronto Police Service Audit function being transferred to the City five positions savings of \$275,000.00;
- (2) recommended to the Policy and Finance Committee, and Council, adoption of the report (March 22, 2000) from Mayor Mel Lastman, entitled "Review of Toronto Police Services Helicopter Pilot Project", (attached to the report dated March 28, 2000, from the City Clerk), conditional upon the following:
  - (a) no pilot or permanent project commence without the following conditions being met and being to the satisfaction of the Chief Administrative Officer and the Chief Financial Officer and Treasurer;
