# **Confirmation of Minutes**

  - (2) that the Commissioner of Economic Development, Culture and Tourism be requested to report to the Budget Advisory Committee for its meeting of April 3, 2000, on:
    - (a) the implications of flatlining the Parks and Recreation 2000 Operating Budget at \$120 million net;
    - (b) the implications of \$900,000.00 being set aside within the Parks and Recreation 2000 Operating Budget to accommodate the growing waiting lists

and meet the need for program spaces in the system; and

- (3) that the Commissioner of Economic Development, Culture and Tourism be requested to report back to the Economic Development and Parks Committee on:
  - (a) designating all 47 centres in low-income communities, as per the list of "High Needs" communities produced by the Parks and Recreation Division in the summer of 1999, as "Priority Centres" which are exempt from charging user fees, as of September 2000; and
  - (b) how to address the extensive waiting list for recreation programs and rising fees, and residents signing up for one or two programs.

- C. Councillor Pitfield moved:
  - (1) that a reasonable amount of funding be added to the Parks and Recreation Division 2000 Operating Budget in order to reduce the tree maintenance backlog;
  - (2) that the fund raising and development funding for Heritage Toronto be restored to \$126,200.00 to allow for fundraising initiatives; and
  - (3) that the Commissioner of Economic Development, Culture and Tourism be requested to report back to the Economic Development and Parks Committee on:
    - (a) the YWCA/YMCA method of waving fees for recreation activities;
    - (b) "fee" programs having a minimum registration or cut-off to allow cost-effectiveness and if minimum registration cannot be met, consideration be given to doubling up at other centres;
    - (c) surveying registrants during summer registration asking how Parks and Recreation services should be funded, i.e., mainly through taxes and user fees or equal combination of taxes and user fees;

- (d) communicating an expectation to registrants that regular attendance is expected due to the extensive waiting list; and
- (e) the shortening of the Seniors Fitness, Health and Wellness Program from 12 weeks to 9 weeks at the Toronto East District.

- (1) that the Commissioner of Economic Development, Culture and Tourism be requested to report to the Budget Advisory Committee as part of the 2000 Operating Budget process on the impact of Parks and Recreation Division's net expenditures budget, excluding capital financing, being set at the same net level as the 1999 actual expenditure; and
- (2) that any reports pertaining to user fees also include estimates of revenues and expenditures based on the level of revenues and based on user fees being:
  - (i) removed, either immediately or over a number of years;
  - (ii) at the levels proposed by the Commissioner of Economic Development, Culture and Tourism to the Economic Development and Parks Committee;
  - (iii) adjusted at various levels; and
  - (iv) included with the Welcome Policy at all City facilities.

  - (1) that the Commissioner of Economic Development, Culture and Tourism be requested to report to the Budget Advisory Committee for its meeting of April 3, 2000, on the financial impact of reducing or increasing the Parks and Recreation budget; and

## 4.7 Recreation User Fees and Welcome Policy -Preliminary Evaluation (All Wards)

The Economic Development and Parks Committee had before it a report:

- (3) City Council authorize receipt of the sponsorship funding and increase the Parks and Recreation Division's 2000 Capital Budget expenditures and revenues to reflect the allocation of the \$650,000.00 to the Woodbine Park capital project and expend such funds to complete construction of the Festival Green Bandshell and related infrastructure by May 1, 2001, under the park construction agreement between EMM Financial Corp and the City of Toronto;
- (4) Council authorize that the annual contribution of \$35,000.00 for 2001 to 2010 be allocated for the purchase of capital improvements for Woodbine Park; and
- (5) subject to satisfactory completion of Recommendation No. (2) by May 1, 2000, City Council concur with the relocation of up to six major events from the Kew Gardens and Ashbridge's Bay Park locations to the new Woodbine Park, commencing in September 2000, and request the appropriate City officials to provide notice by May 15, 2000, of the City's intent to issue permits for up to six major events at the new Woodbine Park venue, commencing September 2000, and its intent not to issue major event permits for the Kew Gardens and Ashbridges Bay venue for the Year 2001.
