The Chairman advised that a communication was received from Councillor Kelly explaining his absence for the morning portion of the meeting, due to a commitment with the Mayor's office.

Mr. Bryan Byng, Manager of Municipal Licensing and Standards, East District, introduced new members of his staff: Deborah Barnard and Gus Michaels, Supervisors of Municipal Licensing and Standards. The Chairman welcomed them to the East District.

### **Confirmation of Minutes**

On a motion by Councillor Duguid, the Minutes of the meeting of the Scarborough Community Council held on January 18, 2000, were confirmed.

### 2.1 Encroachment Agreement – Warden Woods Mall (Ward 13 – Scarborough Bluffs)

The Community Council had before it a report (January 26, 2000) from the Director of Transportation Services, District 4, recommending that the City of Toronto enter into an encroachment agreement with 132181 Canada Limited to allow a city-owned transit shelter to remain on private property; said agreement being for a nominal sum and containing such terms and conditions as are deemed necessary by the City Solicitor and Commissioner of Works and Emergency Services.

On a motion by Councillor Altobello, the Scarborough Community Council recommended to City Council the adoption of the aforementioned report.

### 2.2 Traffic Studies in the Community South of St. Clair Avenue and East of Pharmacy Avenue (Ward 13 – Scarborough Bluffs)

The Community Council had before it a report (January 28, 2000) from the Director of Transportation Services, District 4, recommending that:

- (1) the 40 kilometre per hour speed limit identified in Appendix 1 of this report be adopted;
- (2) the turn prohibitions identified in Appendix 2 of this report be rescinded; and
- (3) the appropriate by-laws be amended accordingly.

On a motion by Councillor Altobello, the Scarborough Community Council recommended to City Council the adoption of the aforementioned report.

  - (c) prepare a final recommendation report for the Public Meeting; and
- (2) that Notice of the Public Meeting be given in a manner prescribed in the regulations under the Planning Act.

### 2.15 Stopping Up and Closing part of Original Road Allowance Between Lots 6 and 7, Concession 2 (Dean Park Road) (Ward 16 – Scarborough Malvern)

The Community Council had before it a report (January 13, 2000) from the Acting Commissioner of Corporate Services requesting authority to stop up and close part of an original road allowance in conformity with a former City of Scarborough subdivision agreement, and recommending that:

- (1) the portion of the original Dean Park Road Allowance, as shown on the attached Schedule "A", be stopped up and closed;
- (2) notice be given of the City's intent to dispose of the lands by conveying them to the adjoining property owner for \$1.00, subject to the purchaser paying the costs associated with advertising the closing; and
- (3) the appropriate City Officials be authorized and directed to take the necessary action to give effect thereto.

On a motion by Councillor Cho, the Scarborough Community Council recommend to City Council the adoption of the aforementioned report.

# 2.16 Potential Designation of the Scarborough Civic Centre and Albert Campbell Square as a Heritage Site within the Meaning of the Ontario Heritage Act (Ward 15 – Scarborough City Centre)

The Community Council had before it a report (February 2, 2000) from the Acting Commissioner of Corporate Services, responding to a request by the Scarborough LACAC for review and recommendation respecting the designation of the Scarborough Civic Centre and the Albert Campbell Square as a heritage site within the meaning of the Ontario Heritage Act, and recommending that this request be referred to the working group of the Office Consolidation Sub-committee dealing with the Scarborough Civic Centre.

### Councillor Soknacki moved that:

- (1) this matter be referred to the Working Group of the Office Consolidation Sub-committee;
- (2) the Scarborough LACAC be requested to report to the Working Group of the Office Consolidation Sub-Committee on which elements of the Scarborough Civic Centre and the Albert Campbell Square, if any, should be designated for historical preservation; and
- (3) the Working Group of the Office Consolidation Sub-Committee be requested to report back to the Scarborough Community Council on this issue.

## 2.17 Burma Star Association Monument on the Albert Campbell Square (Ward 15 – Scarborough City Centre)

The Community Council had before it a report (February 2, 2000) from the Acting Commissioner of Corporate Services, responding to a request by the Burma Star Association to place a memorial on the Albert Campbell Square, and recommending that Community Council consider the request to place the memorial in the location shown on the plan attached as Appendix A.

### Councillor Duguid moved that:

(1) the request by Burma Star Association be approved as illustrated in the aforementioned report; and

(2) the appropriate City Officials be authorized and directed to take the necessary action to give effect thereto.

### 2.18 Canada Day Celebrations 2000 in the East District (Ward 15 – Scarborough City Centre)

The Community Council had before it a report (January 25, 2000) from the Commissioner of Economic Development, Culture and Tourism, responding to a request by the Chair of the Scarborough Community Council to investigate the inclusion of a fireworks display for the July 1, 2000 Canada Day Celebrations in the East District, and recommending that:

- (1) staff investigate the expansion of the Canada Day Program in the Parks and Recreation Division East District by adding a fireworks display on the evening of July 1, 2000;
- (2) Milliken Park, located at Steeles Avenue and McCowan Road, be the selected location for the fireworks, subject to the approval of the Fire Department;
- (3) staff secure the necessary sponsorship to totally offset the costs for set-up, security and the fireworks display;
- (4) the decision to have the fireworks display be dependent upon the sponsorship funding; and

(5) the appropriate City Officials be authorized and directed to take the necessary action to give effect thereto.

Councillor Shaw moved that the Scarborough Community Council:

- (1) recommend to City Council the adoption of the aforementioned report, subject to inserting the words "or any other suitable venue" after the words "McCowan Road" in Recommendation No. (2); and
- (2) request staff to explore options for a low-level fireworks display to take place at the Albert Campbell Square as part of the Canada Day Celebrations 2000, and submit a report thereon to the Community Council.

### 2.19 Use of Albert Campbell Square for Community Events and Festivals (Ward 15 – Scarborough City Centre)

The Community Council had before it a report (January 26, 2000) from the Commissioner of Economic Development, Culture and Tourism, advising Community Council on the approach being used to increase the awareness and use of the Albert Campbell Square, and recommending that:

- (1) to enhance the usage of Albert Campbell Square, the Parks and Recreation Division East District create a promotion and marketing plan to increase awareness and the benefits of hosting events at this location on a cost recovery basis; and
- (2) the appropriate City Officials be authorized and directed to take the necessary action to give effect thereto.

Councillor Shaw moved that Scarborough Community Council:

- (1) recommend to City Council the adoption of the aforementioned report; and
- (2) request the Commissioner of Economic Development, Culture and Tourism to submit to Community Council a list of all of the activities held in the Albert Campbell Square over the last two years; those planned for this year, and comment thereon respecting attendance levels and success of the events.

# 2.20 Tree Removal on Private Property North Star Developments (Formerly Reznick Construction) North Side of Lawrence Avenue East, West of Megan Avenue (Ward 16 – Scarborough Highland Creek)

The Community Council had before it a report (January 25, 2000) from the Commissioner of Economic Development, Culture and Tourism, advising of an application for tree removal by Mr. Frank Dodaro, and recommending that permission be granted to remove eight trees that meet the criteria of Scarborough's Tree Conservation By-law No. 25150 located within the proposed scope of Subdivision T84021, and that a minimum of thirty new trees, each with an 80 millimetre diameter be planted on the boulevard as replacements.

On a motion by Councillor Moeser, the Scarborough Community Council recommended to City Council the adoption of the foregoing report, subject to referring the correspondence (February 15, 2000) received from Mr. William Dempsey to the Commissioner of Economic Development, Culture and Tourism and Commissioner of Urban Development Services in consultation with the City Solicitor, for a report thereon to its next meeting scheduled to be held on March 23, 2000.

Mr. William A. Dempsey, Centennial Community and Recreation Association, appeared before the Community Council in connection with the foregoing matter, expressed support for the staff recommendations, and tabled the following additional recommendations for consideration:

- (1) that consideration be given to the designation of a width of uncultivated land beside trees protected from removal by the Tree By-law, particularly along the rear boundaries of relevant properties;
- (2) that such uncultivated space be designated "woodland natural preserve"; and
- (3) that the uncultivated space remain in the ownership of the low owner.

A copy of the attachment referred to in the foregoing report was included with the Community Council Agenda for February 15, 2000, and a copy thereof is on file in the Office of the City Clerk, Scarborough Civic Centre.

- (2) Councillor Kelly be appointed to the Scarborough Historical Museum Community Museum Management Board;
- these appointments be for a term of office expiring November 30, 2000, and until their successors are appointed; and
- (4) that the appropriate City Officials be authorized and directed to take the necessary action to give effect thereto.

2.25 City-Initiated Zoning By-Law Amendment SC-W19990004
West Side of Pharmacy Avenue, North of Huntingwood Drive,
East Side of Fairglen Avenue, North of Huntingwood Drive
Various Owners in the L'Amoreaux Community
(Ward 14 – Scarborough Wexford)

The Community Council conducted a statutory public meeting, in accordance with Section 17 and Section 34 of The Planning Act; appropriate notice of this meeting having been given in accordance with The Planning Act and the regulations thereunder. No persons appeared before the Community Council in connection therewith.

The Community Council had before it a report (December 21, 1999) from the Director of Community Planning, East District, recommending that City Council:

- (1) amend the Intensity of Use provisions of L'Amoreaux Community Zoning By-law No. 12466, as amended, as it applies to the subject properties only, by deleting the existing Intensity of Use Standard (a maximum of one single-family dwelling is permitted per lot as shown on the Registered Plan) and replacing it with the following:
  - (a) for all odd-numbered properties from 97 to 111 Fairglen Avenue (inclusive) and 115 to 125 Fairglen Avenue (inclusive); all even numbered properties from 2084 to 2104 Pharmacy Avenue (inclusive); and 2110 & 2112 Pharmacy Avenue:
    - "A maximum of one dwelling unit is permitted per parcel of land having a minimum frontage of 19 metres on a public street and a minimum area of 1050 square metres.";
  - (b) for 40 and 42 Huntingwood Drive and 95 Fairglen Avenue:
    - "A maximum of one dwelling unit is permitted per parcel of land having a minimum frontage of 24 metres on a public street and a minimum area of 900 square metres."; and
- (2) authorize such unsubstantive technical, stylistic or format changes as may be necessary to the Zoning By-law to properly carry out the intent of this resolution.

On a motion by Councillor Tzekas, the Scarborough Community Council recommended to City Council the adoption of the aforementioned report.

### (Clause No. 14, Report No. 2)

2.26 City-Initiated Official Plan Amendment SW1994073 and Zoning By-Law Amendment Application SC-Z19990045 and Draft Plan of Subdivision SC-T19990014 by Anndale Properties Lands in and Abutting East Metro Transportation Corridor Malvern, Rouge and Upper Rouge Communities and Rouge Employment District (Ward 18 – Scarborough Malvern)

The Community Council conducted a statutory public meeting, in accordance with Section 17 and Section 34 of The Planning Act; appropriate notice of this meeting having been given in accordance with The Planning Act and the regulations thereunder; and had before it a report (February 14, 2000) from the Director of Community Planning, East District, recommending that Community Council:

- (1) further defer consideration of the reports dated November 12, November 25 and November 26, 1999; and
- (2) direct staff to report regarding the resolution of issues and matters to be heard by the Ontario Municipal Board prior to the pre-hearing conference scheduled for June 20, 2000.

The Community Council also had before it a report (November 12, 1999) from the Director of Community Planning, East District, recommending that City Council:

### (1) Official Plan:

- (a) amend the Rouge Employment District Secondary Plan by deleting the words "in view of special Provincial transportation proposals" from Policy 4.47.2.4;
- (b) amend the Rouge Community Secondary Plan by deleting all references to the EMTC and replacing Numbered Policy 2 with the following:
  - "2. North Side of Highway 401, East of Conlins Road

If the subject lands are not required for transportation purposes in the future, the land may be used for Low Density Residential purposes without further amendment to this plan.";

- (c) amend the Malvern Community Secondary Plan by:
  - (i) redesignating the Milne House property and the lands designated as EMTC, save and except for the portion referenced in Clause 1.3.(c)(iii) affected by Numbered Policy 6, as Regional Natural Environment and transferring them to the Upper Rouge Community;
  - (ii) deleting Neighbourhood No. 3 Policy 14.1 and renumbering the remainder of Policy 14;
  - (iii) replacing Numbered Policy 6 with the following:
    - "6. South Side of Old Finch Avenue, west of Sewells Road:

Low Density Residential uses are permitted on these lands unless the privately-owned property is acquired for Rouge Park, in which case a Regional Natural Environment designation will apply and the lands will be incorporated into the Upper Rouge Community without further amendment to this plan.";

- (iv) deleting the Special Uses Area designation west of Sewells Road, the Temporary Connection designation for Old Finch Avenue, and the Neighbourhood Park designation within the former EMTC;
- (d) amend the Upper Rouge Community Secondary Plan by incorporating the lands referenced in Clause 1(c) above;
- (2) authorize such unsubstantive technical, stylistic or format changes to the Official Plan as may be necessary to give effect to this resolution; and
- (3) request the Ministry of Municipal Affairs and Housing to now repeal Minister's Zoning Order 20/74 as it applies to lands within the City of Toronto.

The Community Council also had before it a report (November 26, 1999) from the Director of Community Planning, East District, advising of the concerns of the Ministry of Municipal Affairs with respect to the aforementioned proposed City-initiated Official Plan amendments and recommending that this report be received for information.

The Community Council also had before it a report (November 25, 1999) from the Director of Community Planning, East District, recommending:

- (1) that Community Council direct the Director of Community Planning, East District, to:
  - (a) process the applications by Anndale Properties Limited in the normal manner;
  - (b) schedule a community information meeting in consultation with the Ward Councillors, for the first quarter of 2000; and
- (2) that City Council request the Province of Ontario to consider the acquisition of the Anndale lands and their conveyance to the Toronto and Region Conservation Authority as part of the Rouge Park.

On a motion by Councillor Balkissoon, the Scarborough Community Council approved the recommendations contained in the report (February 14, 2000) of the Director of Community Planning, East District, and deferred the Public Meeting under the Planning Act on the aforementioned applications to its meeting scheduled to be held on May 2, 2000 at 2:00 p.m.

Mr. Jim Robb, Friends of the Rouge River Watershed, appeared before the Community Council in connection with the foregoing matter and expressed support for the deferral recommendation.

The Community Council received a communication (February 12, 2000) from Mr. Ronald M. Kanter, on behalf of Anndale Properties Limited, requesting that Community Council direct staff to process the Preliminary Evaluation Report in the usual manner respecting his client's application, a copy of which was provided to all Members of the Community Council and a copy thereof is on file in the Office of the City Clerk, Scarborough Civic Centre.

## 2.27 Approved Capital Development at Grey Abbey Park (Ward 13 – Scarborough Bluffs)

The Community Council had before it a report (January 26, 2000) from the Commissioner of Economic Development, Culture and Tourism, responding to Community Council's request that the construction of a proposed barrier in Grey Abbey Park be delayed as a result of a petition received from local residents; providing information as to community meetings held on this issue in 1999; and recommending that:

(1) staff advise the contractor to proceed with the contract, as awarded, at a cost of \$50,043.00, to erect the post and cable barriers along the edge of the Scarborough

Bluffs and install the roadside bollards at Grey Abbey Park to ensure the safety of park users; and

- (2) the appropriate City Officials be authorized and directed to take the necessary action to give effect thereto.
- A. Councillor Shaw moved that Scarborough Community Council recommend to City Council the adoption of the aforementioned report, subject to requesting the Commissioner of Economic Development, Culture and Tourism to report back to Scarborough Community Council on the issue of maintenance of the area between the proposed new barrier and the edge of the bluffs.

(Carried)

B. Councillor Balkissoon moved that the Warning Signs posted in Grey Abbey Park be retained and that an additional Warning Sign be posted on the area formerly owned by Metropolitan Toronto.

(Carried)

The Community Council also had before it, during its consideration of the foregoing matter, a copy of a memorandum (February 9, 2000) from the Manager, Insurance and Risk Management, to the Parks Supervisor, East District, in support of the recommendation that post and cable barriers be installed at this location to achieve a consistent safety standard along the bluffs.

A copy of the attachments referred to in the foregoing report was included in the Community Council Agenda for February 15, 2000, and a copy thereof is on file in the Office of the City Clerk, Scarborough Civic Centre.
