# 7.2 Interim Spending Approvals for the 2000 Water and Wastewater Capital Works Programs.

The Works Committee had before it a report (April 6, 2000) from the Commissioner of Works and Emergency Services recommending that:

- (1) the Budget Committee be requested to recommend the approval of interim spending authority, in the amount of \$19,156,000.00 for the projects identified in Attachment A, prior to the approval of the Water and Wastewater Services Division's 2000-2004 Capital Works Program; and
- (2) the appropriate City officials be authorized and directed to take the necessary action to given effect thereto.

The Committee recommended to Council:

- (1) the approval of interim spending authority in the amount of \$19,156,000.00 for the projects identified in Attachment A in the report dated April 6, 2000, from the Commissioner of Works and Emergency Services, prior to the approval of the Water and Wastewater Services Division's 2000-20004 Capital Works Program; and
- (2) that the appropriate City officials be authorized and directed to take the necessary action to give effect thereto;

and that the Budget Advisory Committee be advised accordingly.
