Confirmation of Minutes.

On motion by Councillor Bossons, the Minutes of the meetings of the Works Committee held on April 15, April 19 and April 25, 2000, and the joint meeting with the Economic Development and Parks Committee on April 19, 2000, were confirmed.

11.1 Drain Grant Appeal Process.

The Works Committee again had before it a report (March 20, 2000) from the Commissioner of Works and Emergency Services recommending that the Drain Grant Appeal Process be amended so that appeal awards be:

- (1) limited to drain repair and replacement work carried out between the streetline and the front foundation wall;
- (2) only involve blockages that are clearly caused by City tree roots;
- (3) paid out at 50 percent of the costs in excess of the maximum grant with an upset limit for the total grant payout not to exceed \$1,000.00 for a partial repair or \$3,000.00 for a full replacement;
- (4) limited to grant applications received for blockages and repairs that occur after May 12, 1999; and
- (5) based on extenuating circumstances around the nature of the repair work itself.

The Committee also had before it a report (May 3, 2000) from the Commissioner of Works and Emergency Services addressing concerns raised at the Works Committee meeting of March 6, 2000, and the North York Community Council meeting of March 23, 2000, regarding the Drain Grant Program; and recommending that the Drain Grant Appeal Process be amended so that:

- (1) all appeals be considered by the Works Committee;
- (2) appeals only be considered in situations where the claimant wishes to pursue the matter and staff have denied a drain grant and determined that the claim is ineligible under the terms of the policy; and
- (3) the maximum eligible grant shall be \$1,500.00 for a complete replacement and \$500.00 (once per three-year period) for a partial repair.

On motion by Councillor Shiner, the Committee recommended to Council the adoption of the aforementioned report dated May 3, 2000.

**11.2 Drain Grant Appeal –
360 Victoria Park Avenue.
(East Toronto)**

The Works Committee had before it a communication (March 27, 2000) from Councillor Tom Jakobek, East Toronto, forwarding a staff report dated March 8, 2000, from Mr. David Parrish, Director of Districts 1 and 2 Water and Wastewater Operations, with respect to a drain grant appeal by Mr. Andrew Balfour for 360 Victoria Park Avenue, East Toronto, which recommended that:

- (1) the appeal be denied; and
- (2) this report and Toronto Community Council's recommendations be forwarded to City Council through the Works Committee.

The Committee also had before it a communication (March 29, 2000) from the City Clerk advising that the Toronto Community Council on March 23, 2000, recommended that, based on extenuating circumstances and undue hardship, the appeal for a drain claim grant in the amount of \$1,382.03 for 360 Victoria Park Avenue be allowed, funds to be provided from the Water and Wastewater Services Division's 2000 Preliminary Operating Budget.

The following persons appeared before the Works Committee in connection with the foregoing matter:

**11.3 Drain Grant Appeal –
144 Upper Canada Drive.
(North York Centre South)**

The Works Committee had before it a communication (April 7, 2000) from the City Clerk advising that the North York Community Council had before it a report (March 3, 2000) from the Director of Water and Wastewater Operations, Districts 3 and 4, which recommended that the Drain Grant Appeal by Mrs. Heather Robinson with respect to 144 Upper Canada Drive be denied; and further advising that the North York Community Council referred the following recommendation to the Works Committee for consideration and report thereon to Council:

- (1) the report (March 3, 2000) from the Director, Water and Wastewater Operations, District 3 and 4, not be adopted; and
- (2) the applicant be reimbursed the full amount of \$2,400.00, subject to submitting to the Director, Water and Wastewater Operations, District 3 and 4, paid invoices for the completed work.

The Committee also had before it a joint report (May 3, 2000) from the Commissioner of Works and Emergency Services and the Chief Administrative Officer, addressing concerns raised at the North York Community Council meeting of March 23, 2000, regarding the Drain Grant Program; and recommending that the report be received for information.

Councillor Joanne Flint, North York Centre South, appeared before the Committee in connection with the foregoing matter.

On motion by Councillor Shiner, the Committee recommended to Council that the appeal for a drain grant in the amount of \$2,400.00 for 144 Upper Canada Drive be allowed, funds to be provided from the Water and Wastewater Services Division's 2000 Preliminary Operating Budget.

**11.4 Drain Grant Appeal –
100 Rivercrest Road.
(Ward 27, York Humber)**

The Works Committee had before it a communication (April 11, 2000) from the City Clerk advising that the York Community Council on March 23, 2000, had before it a report (March 8, 2000) from the Director, Water and Wastewater Operations, Districts 1 and 2, respecting an appeal to a denied drain grant made by Mr. Bruce Proctor, the property owner of 100 Rivercrest Road; and further advising that the Community Council:

- (1) approved Recommendation No. (1) in the subject report, i.e., that the appeal be denied; and
- (2) forwarded the action taken to the Works Committee.

On motion by Councillor Shiner, the Committee recommended to Council that the appeal for a drain grant in the amount of \$500.00 for 100 Rivercrest Road be allowed, funds to be provided from the Water and Wastewater Services Division's 2000 Preliminary Operating Budget

**11.5 Enactment of By-law to Prohibit the
Burning of Used Motor Oil.**

The Works Committee had before it a report (May 1, 2000) from the Commissioner of Works and Emergency Services respecting the enactment of the draft By-law to Prohibit the Burning of Used Motor Oil, as requested by the Committee at its meeting on March 22, 2000; and recommending that:

- (1) should Council wish to proceed with the enactment of the draft By-law to Prohibit the Burning of Used Motor Oil, prior notice be given to affected parties for the purpose of deputation; and
- (2) the appropriate City officials be authorised and directed to take the necessary action to give effect thereto.

Ms. Karen Buck, Citizens for a Safe Environment, appeared before the Committee in connection

with the foregoing matter.

On motion by Councillor Layton, the Committee recommended to Council the adoption of the aforementioned report.

11.6 Kraft Bag Leaf and Yard Waste Collection.

The Works Committee had before it a report (April 28, 2000) from the Commissioner of Works and Emergency Services recommending that:

- (1) effective September 1, 2001, leaf and yard waste no longer be accepted from residents in plastic bags and that this material only be collected in kraft paper bags specifically designed for leaf and yard waste or in rigid open-top containers;
- (2) effective September 1, 2000, the Works and Emergency Services Department start advising residents in its promotional materials of the change in collection policy which will take place in 2001, and encourage residents to use kraft bags or rigid open-top containers as opposed to plastic bags that are currently used for leaf and yard waste collection; and
- (3) staff meet with representatives of the kraft bag manufacturing industry to develop a jointly funded promotional campaign which will inform Toronto residents about the transition to kraft leaf and yard waste bags.

The Committee also had before it a communication (May 17, 2000) from Mr. Brian Cochrane, President, Toronto Civic Employees' Union, CUPE Local 416, recommending that consideration of the report be deferred until such time as staff representatives and Local 416 representatives can meet to address concerns, and that the outcome of these discussions be presented to the Works Committee at the same time as the report.

Councillor Bossons, on behalf of Councillor King, moved that the kraft bag manufacturing industry be requested to consider advertising on kraft bags as a means of lowering the cost to consumers. **(Carried)**

Councillor Layton moved that the Commissioner of Works and Emergency Services be requested to submit a report to Council for its meeting on June 7, 2000, on consultations with Toronto Civic Employees' Union, CUPE Local 416, with regard to this matter; and invited Local 416 to submit further comments directly to Council on the progress of consultations and whether the Union's concerns have been resolved. **(Carried)**

**11.7 Proposed Street Naming Policy –
Community Council Comments.**

The Works Committee had before it a communication (February 7, 2000) from the City Clerk advising that the Committee at its meeting on February 7, 2000, had before it a report (January 21, 2000) from the Commissioner of Works and Emergency Services respecting the proposed Street Naming Policy, which recommended that:

- (1) the Street Naming Policy, outlined in Attachment No. 1, be circulated to the Community Councils for comment;
- (2) the Community Councils be requested to forward their comments to the Works Committee meeting of April 19, 2000, for processing through to City Council; and
- (3) if the Street Naming Policy contained in this report is adopted, the City Solicitor be authorized to apply for special legislation to extend the provisions of the City of Toronto Act, 1991, which allows for the naming and numbering of private streets, to other areas of the new City of Toronto;

and further advising that the Committee concurred in the recommendations embodied in the aforementioned report.

The Committee also had before it the following communications:

- (i) (March 27, 2000) from the City Clerk advising that the East York Community Council on March 23, 2000, recommended that the Criteria for Name Selection embodied in the proposed Street Naming Policy be amended by:
 - (1) striking out No. (3) and inserting in lieu thereof: "Names of living persons may be used."; and
 - (2) striking out No. (4) and inserting in lieu thereof: "A person's full name should be used as a street name to prevent duplication with an existing street name in Toronto and surrounding municipalities.";
- (ii) (March 29, 2000) from the City Clerk advising that the Scarborough Community Council on March 23, 2000, directed that the Works Committee be advised that it endorses the staff recommendations contained in the report (January 21, 2000) from the Commissioner of Works and Emergency Services and the Street Naming Policy embodied therein;
- (iii) (March 29, 2000) from the City Clerk advising that the Toronto Community Council on March 23, 2000, recommended that the Street Naming Policy outlined in Attachment No. (1) of the report (January 21, 2000) be adopted, subject to a statement being inserted to read: "That, as often as possible, names of streets shall not be changed, due to the profound effect on people's lives.";
- (iv) (March 30, 2000) from the City Clerk advising that the North York Community Council on March 23, 2000, recommended to the Works Committee that:
 - (1) the section entitled "Naming and Renaming of Street and Lanes" be the first section to appear in the City of Toronto Street Naming Policy, after the word, "Guidelines";
 - (2) item (2) of the section entitled "Application", be amended to read as follows:
 - "2. In the case of a name change, the name change should also include a petition stating the reason for the change and include the names, addresses and signatures of the persons who reside on or own property that fronts on or is adjacent to the subject street."

and further reporting, for the information of the Works Committee and Council, having requested:

- (i) the Commissioner, Urban Development Services, to bring forward a report, when the proposed Street Naming Policy is being considered by City Council, on the feasibility of securing the names of private roads on condominium properties through the condominium registration process; and
- (ii) the City Clerk to bring forward a report, when the proposed Street Naming Policy is being considered by City Council, regarding the effects of changing the names of streets with regard to the voters list; and to set forth recommendations as to when street name changes should be implemented;
- (v) (April 1, 2000) from the City Clerk advising that the Etobicoke Community Council on March 23, 2000, had before it a communication (February 7, 2000) from the City Clerk forwarding the Street Naming Policy, outlined in Attachment No. (1) to the report (January 21, 2000) from the Commissioner of Works and Emergency Services; and that the Etobicoke Community Council received the aforementioned communication;
- (vi) (April 13, 2000) from the City Clerk advising that the York Community Council on March 23, 2000, endorsed the proposed Street Naming Policy as outlined in Attachment No. 1 to the report (January 21, 2000) from the Commissioner of Works and Emergency Services; and
- (vii) (April 28, 2000) from Mr. Srdjan Besir, Toronto, suggesting that the proposed City of Toronto Street Naming Policy be amended by adding the criterion that in recognition of the increasing multicultural composition of the City and the contributions of its many ethnocultural groups, consideration should be given to names which recognize the heritage of the respective ethnocultural groups which comprise the City.

The Committee deferred consideration of the aforementioned communications until its next meeting, scheduled to be held on June 14, 2000.

**11.8 Procedure for Eliminating
Duplicate Street Names.
(All Wards)**

The Works Committee had before it a communication (April 3, 2000) from the City Clerk advising that City Council, at its meeting held on February 1, 2 and 3, 2000, had before it Clause No. 3 contained in Report No. 1 of The Works Committee, headed "Procedure for Eliminating Duplicate Street Names (All Wards)"; and that Council directed that the aforementioned Clause be struck out and referred, save and except that portion pertaining to Humber Boulevard in Ward 3 (Kingsway Humber), back to the Works Committee for further consideration, together with the following motions; and that the Commissioner of Works and Emergency Services was requested to submit a report to the Works Committee, for consideration therewith, on the inclusion of a public consultation process through the Community Councils:

Moved by Councillor Johnston:

"It is further recommended that the Commissioner of Works and Emergency Services be requested to submit a report to the Works Committee on:

- (1) the inclusion of a public consultation process which would provide for public hearings on street name changes at the Community Councils; and
- (2) the inclusion of additional criteria related to geographic separation in setting priorities for street naming."

Moved by Councillor Lindsay Luby:

"It is further recommended that the Commissioner of Works and Emergency Services be requested to obtain up-to-date statistics regarding the number of residents on all duplicate streets."

Moved by Councillor Prue:

"It is further recommended that, as part of the process to eliminate duplicate street names, the Commissioner of Works and Emergency Services be requested to determine:

- (1) when the street was named; and
- (2) after what historical event, person or figure the street was named.”

and further advising that Council also adopted the following recommendation:

“It is recommended that Humber Boulevard in Ward 3 (Kingsway Humber) be renamed Old Mill Trail.”

The Committee also had before it a report (May 8, 2000) from the Commissioner of Works and Emergency Services providing additional information about the procedures for eliminating duplicate street names pursuant to the directives issued by City Council at its meeting held on February 1, 2 and 3, 2000; setting out a more detailed consultation process involving the Community Councils; and recommending that the process for eliminating duplicate and triplicate street names as described in this report be adopted.

The Committee also had before it the following communications:

- (i) (March 6, 2000) from Councillor Ila Bossons, Midtown, forwarding a communication (March 2, 2000) from the Fire Chief and the General Manager, Toronto Ambulance Services, respecting safeguards being used by Emergency Services to address potential problems with respect to duplicate street names within the City;
- (ii) (March 7, 2000) from Mr. William J. Phillips, Secretary, South Rosedale Ratepayers' Association, respecting the procedure for eliminating duplicate street names and suggesting consideration of historical significance as part of the criteria; and submitting comments with respect to the renaming of Dale Avenue;
- (iii) (March 15, 2000) from Mr. Greg Gatenby, Toronto, urging Councillors to take the opportunity of changing those street names which have been duplicated due to amalgamation, to rename those streets after people who have been important to Toronto; advising that the historical context of thoroughfares such as Peter Street should be preserved; and requesting that a committee of citizens, Councillors and City staff be created to address all issues regarding the renaming of streets;
- (iv) (April 10, 2000) from Councillor Norman Gardner, North York Centre, and Chairman, Toronto Police Services Board, outlining the system of municipal identifiers being used by Bell Canada 9-1-1, Fire, Ambulance and Police Services and Canada Post to distinguish

duplicate street names; noting that his office has received many calls from residents who have expressed their concerns with respect to the renaming of streets; and suggesting there is no justification to proceed with any changes in light of the fact that the system works, and that there will be a financial cost to the City and its taxpayers, as well as the inconvenience it will cause;

- (v) (May 2, 2000) from Graeme E. Armstrong, North York, Ontario, in opposition to the plan to rename duplicate street names;
- (vi) (May 3, 2000) from Doreen and Robert Irwin, North York, Ontario, regarding the renaming of Centre Avenue in North York, and requesting that the name remain the same;
- (vii) (May 4, 2000) from Harry and Jo-Ann George, North York, Ontario, advising that they fully agree with Councillor Norman Gardner's opposition to renaming Homewood Avenue, as set out in his communication dated April 18, 2000, to residents; and
- (viii) (May 4, 2000) from Ewa Byk-Green, North York, Ontario, expressing strong opposition to the renaming of Duplex Street in North York.

Councillor Norman Gardner, North York Centre, appeared the Committee in connection with foregoing matter.

The Committee referred the aforementioned communications to the Community Councils for consideration.

representative to the Sustainability Roundtable, and that the said appointment be in effect to the end of the current term of Council.

**11.10 Implementation of Sustainability Measures
in City-Owned Facilities as Part of the
Better Buildings Partnership Program.
(All Wards)**

The Works Committee had before it a joint report (May 5, 2000) from the Commissioner of Works and Emergency Services and the Commissioner of Corporate Services recommending that:

- (1) the Commissioners of Works and Emergency Services and Corporate Services jointly develop an implementation plan to achieve the highest economically feasible levels of carbon dioxide emissions reduction in facilities owned by the City, as a part of the Better Buildings Partnership;
- (2) the Commissioners of Works and Emergency Services and Corporate Services be authorized to issue Requests for Qualifications, Requests for Proposals and/or Requests for Quotations as appropriate, in order to facilitate the retrofit of the subject buildings as a participant in the Better Buildings Partnership;
- (3) the Chief Financial Officer and Treasurer in consultation with the Commissioners of Corporate Services and Works and Emergency Services and the Executive Director, Toronto Atmospheric Fund (TAF), develop a financing strategy to carry out the energy efficient retrofit of City-owned facilities that considers but is not limited to the following options:
 - (a) Funding/financing through the TAF;

- (b) Private Sector Financing; and
 - (c) Alternative Financing;
- (4) the appropriate staff be authorised to enter into agreements for the comprehensive energy efficiency retrofits of designated portfolios of City-owned facilities in consultation with the respective department head and subject to the approval of the Commissioners of Works and Emergency Services and Corporate Services, the Chief Financial Officer and Treasurer, and the City Solicitor;
 - (5) the Commissioner of Works and Emergency Services in consultation with the Commissioner of Corporate Services and the Executive Director, TAF, develop a plan to publicise actions taken by the City to demonstrate the City's leadership in putting in place economic energy efficiency measures to minimize CO₂ reductions;
 - (6) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto; and
 - (7) this report be forwarded to the Policy and Finance Committee.

On motion by Councillor Layton, the Committee:

- (1) recommended to the Policy and Finance Committee the adoption of the aforementioned report; and
- (2) requested the Commissioner of Works and Emergency Services and the Commissioner of Corporate Services to meet with Toronto Hydro to explore the possibility of Toronto Hydro undertaking this work for the Better Buildings Partnership, and to submit a report to Council for its meeting on June 7, 2000, on that possibility.

**11.11 Lester B. Pearson International Airport (LBPIA)
Noise Monitoring and Impact Review and Assessment.
(Wards 2, 3, 4 and 5)**

The Works Committee had before it a report (May 2, 2000) from the Commissioner of Works and Emergency Services respecting the findings of the Lester B. Pearson International Airport (LBPIA) noise monitoring system and noise impact assessment study; and recommending that:

- (1) this report, including the study report “LBPIA Noise Impact Assessment and Review” prepared by Aercoustics Engineering Limited, dated March 23, 2000, be forwarded to the Greater Toronto Airport Authority (GTAA), the Etobicoke Community Council, the Etobicoke Federation of Residents and Ratepayers Association (EFRRA) and Transport Canada for review and comment; and
- (2) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

11.12 Health Effects of Noise.

be affected; further noting that staff has been directed previously by Council to review traffic calming policy operations for the City, and that the research and consultation process needed to develop a city-wide policy will be completed later this year; and recommending that this report be received for information.

The Committee also had before it comments from CAA Central Ontario in support of a moratorium on all traffic calming measures until the city-wide traffic calming policy has been approved by Council.

- (1) the Toronto Policy Services Board be requested to increase the enforcement of traffic regulations regarding speed limits within streets in the City of Toronto to the fullest extent possible; and

with the police on ways and means they can increase the enforcement of speed limits.
