On motion by Councillor Sinclair, the Minutes of the meeting of the Works Committee held on June 14, 2000, and the joint meeting with the Policy and Finance Committee on June 22 and 23, 2000, were confirmed.

13.1 Draft By-law to Assume Humber Boulevard Between Bloor Street West and Old Mill Road and to Rename that Assumed Highway "Old Mill Trail".

The Works Committee had before it a Draft By-law from the City Solicitor to assume Humber Boulevard between Bloor Street West and Old Mill Road for public highway purposes and to rename that portion of assumed highway "Old Mill Trail".

The Committee also had before it a copy of Clause No. 3 of Report No. 1 of The Works Committee, entitled "Procedure for Eliminating Duplicate Street Names (All Wards)", as amended by the Council of the City of Toronto at its meeting held on February 1, 2 and 3, 2000.

The Committee also had before it the following communications:

- (i) (July 10, 2000) from Mr. David A. George, Senior Vice-President, Legal and Corporate, Monarch Construction Limited, advising that Monarch Construction Limited, which owns land fronting on Humber Boulevard and is the developer of Phases 1 and 2 of the Kensington at the Old Mill condominiums, is fully supportive of the proposed change of name of Humber Boulevard to Old Mill Trail; and
- (ii) (July 11, 2000) from the Fire Chief advising that Toronto Fire Services concurs with Council's recommendation to rename Humber Boulevard "Old Mill Trail", provided there is no other street in the amalgamated City of Toronto with the name "Old Mill Trail".

Councillor Gloria Lindsay Luby, Kingsway Humber, appeared before the Committee in connection with the foregoing matter.

On motion by Councillor Shiner, the Committee recommended to Council that a by-law in the form of the aforementioned draft by-law be enacted.

13.2 Proposed Street Naming Policy.

The Works Committee again had before it a communication (February 7, 2000) from the City

Clerk advising that the Works Committee, at its meeting on February 7, 2000, had before it a report (January 21, 2000) from the Commissioner of Works and Emergency Services respecting the proposed Street Naming Policy; and recommending that:

- (1) the Street Naming Policy, outlined in Attachment No. 1, be circulated to the Community Councils for comment;
- (2) the Community Councils be requested to forward their comments to the Works Committee meeting of April 19, 2000, for processing through to City Council; and
- (3) if the Street Naming Policy contained in this report is adopted, the City Solicitor be authorized to apply for special legislation to extend the provisions of the City of Toronto Act, 1991, which allows for the naming and numbering of private streets, to other areas of the new City of Toronto;

and further advising that the Works Committee concurred in the recommendations embodied in the aforementioned report.

The Committee also had before it the following communications:

- (i) (March 27, 2000) from the City Clerk (East York Community Council) advising that the East York Community Council on March 23, 2000, recommended that the Criteria for Name Selection embodied in the proposed Street Naming Policy be amended by:
 - (1) striking out No. (3) and inserting in lieu thereof: "Names of living persons may be used."; and
 - (2) striking out No. (4) and inserting in lieu thereof: "A person's full name should be used as a street name to prevent duplication with an existing street name in Toronto and surrounding municipalities.";
- (ii) (March 29, 2000) from the City Clerk (Scarborough Community Council) advising that the Scarborough Community Council on March 23, 2000, directed that the Works Committee be advised that it endorses the staff recommendations contained in the report (January 21, 2000) from the Commissioner of Works and Emergency Services and the Street Naming Policy embodied therein;
- (iii) (March 29, 2000) from the City Clerk (Toronto Community Council) advising that the Toronto Community Council on March 23, 2000, recommended that the Street Naming

Policy outlined in Attachment No. (1) of the report (January 21, 2000) be adopted, subject to a statement being inserted to read: "That, as often as possible, names of streets shall not be changed, due to the profound effect on people's lives.";

- (iv) (March 30, 2000) from the City Clerk (North York Community Council) advising that the North York Community Council on March 23, 2000, recommended to the Works Committee that:
 - the section entitled "Naming and Renaming of Street and Lanes" be the first section to appear in the City of Toronto Street Naming Policy, after the word, "Guidelines";
 - (2) item (2) of the section entitled "Application", be amended to read as follows:
 - "2. In the case of a name change, the name change should also include a petition stating the reason for the change and include the names, addresses and signatures of the persons who reside on or own property that fronts on or is adjacent to the subject street."

and further reporting, for the information of the Works Committee and Council, having requested:

- the Commissioner, Urban Development Services, to bring forward a report, when the proposed Street Naming Policy is being considered by City Council, on the feasibility of securing the names of private roads on condominium properties through the condominium registration process; and
- (ii) the City Clerk to bring forward a report, when the proposed Street Naming Policy is being considered by City Council, regarding the effects of changing the names of streets with regard to the voters list; and to set forth recommendations as to when street name changes should be implemented;
- (v) (April 1, 2000) from the City Clerk (Etobicoke Community Centre) advising that the Etobicoke Community Council on March 23, 2000, had before it a communication (February 7, 2000) from the City Clerk forwarding the Street Naming Policy, outlined in Attachment No. (1) to the report (January 21, 2000) from the Commissioner of Works and Emergency Services; and that the Etobicoke Community Council received the

aforementioned communication;

- (vi) (April 13, 2000) from the City Clerk (York Community Council) advising that the York Community Council on March 23, 2000, endorsed the proposed Street Naming Policy as outlined in Attachment No. 1 to the report (January 21, 2000) from the Commissioner of Works and Emergency Services;

13.3 Wind Turbine Project: Terms of Reference for Environmental Assessment Study; ICMC Review; and Siting of Utility Wind Turbine at the Ashbridges Bay Treatment Plant.

The Works Committee had before it a report (June 26, 2000) from the Commissioner of Works and Emergency Services, entitled "Terms of Reference for Environmental Assessment Study for Wind Turbine (All Wards)", recommending that the document entitled "Wind Turbine Assessment Scoping/Terms of Reference Document (Draft) November 1999" prepared by Toronto Renewable Energy Co-Operative and Toronto Hydro be accepted as the basis for the environmental assessment study for the wind turbine project.

The Committee also had before it the a report (June 28, 2000) from the Commissioner of Works and Emergency Services, entitled "Implementation Compliance and Monitoring Committee (ICMC) Review of the Main (Ashbridges Bay) Treatment Plant (ABTP) Mediator's Report dated April 1999 and Toronto Renewable Energy Co-operative (TREC) and Toronto Hydro's report entitled 'Waterfront Turbines at the Ashbridges Bay Treatment Plant' dated June 2000", respecting the findings of the Implementation Compliance and Monitoring Committee regarding the City's compliance with the Mediation Agreement for the Main (Ashbridges Bay) Treatment Plant in respect to Toronto Renewable Energy Co-Operative and Toronto Hydro potentially locating a wind turbine at the Ashbridges Bay Treatment Plant site; and recommending that:

- (1) the attached Implementation Compliance and Monitoring Committee compliance review be received for information; and
- (2) this report be forwarded to the Ontario Ministry of the Environment and Environment Canada;

recommending that subject to the proponent's satisfactory completion of required environmental assessments, and the satisfactory completion of all other approval processes required to locate windmills on the Toronto waterfront:

- (1) the City of Toronto consent to, approve and facilitate the construction of a utility wind turbine in the abandoned southern ash lagoon at Ashbridges Bay Treatment Plant by TREC and Toronto Hydro;
- (2) the City of Toronto facilitate the preparation between the proponents, the Toronto Port Authority, and other relevant parties, the legal arrangements necessary to permit the installation and operation of such a wind turbine, and give effect to the required City approval of such a legal arrangement, for the purpose of locating a wind turbine, as described in the above, including provisions to ensure that the wind turbine does not interfere with the construction and/or operation of existing and future sewage treatment facilities; and
- (3) the appropriate City officials be authorized and directed to take the necessary action to give effect to the foregoing.

13.4 Biosolids Beneficial Use Program – Acquisition of Terratec Environmental Ltd. by Azurix North America.

The Works Committee had before it a report (May 16, 2000) from the Commissioner of Works and Emergency Services providing information requested by the Committee with regard to the acquisition of Terratec Environmental Ltd., one of the City's biosolids program contractors, by Azurix North America; advising that the acquisition of Terratec by Azurix is an internal business matter between these firms and should not affect any requirements of the City, and that Terratec will continue to provide services to the City under the Terratec name; further advising that the City is obligated to negotiate in "good faith" with Terratec in accordance with Council authority, and that if these negotiations are successfully concluded, the City will enter into an agreement with Terratec for the land application of the City's biosolids; noting that staff will also ensure that senior Terratec staff and Azurix North America management clearly understand the City's requirements and expectations for its biosolids beneficial use program contractors; and recommending that the report be received for information.

The Committee also again had before it a communication (February 22, 2000) from Councillor Sandra Bussin, East Toronto, forwarding a communication (February 11, 2000) from Ms. Karen Buck, Member, Board of Directors, Citizens for a Safe Environment, and Ms. Karey Shinn, Chair, Safe Sewage Committee, expressing concerns regarding the change of ownership of Terratec Environmental Ltd. to Azurix, and the impact on the City's biosolids land application program; and requesting that the Committee consider and respond to the issues raised therein.

- (1) the Commissioner of Works and Emergency Services be requested to review and strengthen, if necessary, the system of on-going monitoring of the biosolids program in light of the new corporate ownership with which the City may not be as familiar; and
- (2) the Independent Review Committee established by Council by the adoption of Clause No. 2 of Report No. 6 of The Works and Utilities Committee on July 8, 9, and 10, 1998, as amended, with respect to the biosolids program at the Ashbridges Bay Treatment Plant (formerly the Main Treatment Plant), be reconstituted to meet at least once to review and report to the Works Committee on the monitoring system which is in place and on the various concerns raised during the meeting, in order that Council can be assured of the effective and safe operation of the biosolids program, such process to involve the Toronto Civic Employees' Union, CUPE Local 416.

13.5 Enactment of By-law to Prohibit the Burning of Used Motor Oil.

The Works Committee had before it a communication (June 16, 2000) from the City Clerk forwarding for information and any attention deemed necessary, Clause No. 9 contained in Report No. 12 of The Works Committee, headed "Enactment of By-law to Prohibit the Burning of Used Motor Oil", which was adopted, as amended, by the Council of the City of Toronto at its meeting held on June 7, 8, and 9, 2000; and advising that in so doing, Council adopted a recommendation to proceed with the enactment of the draft by-law to prohibit the burning of used motor oil, and that prior notice be given to affected parties for the purpose of deputations.

The Committee also had before it the following communications:

- (i) (July 10, 2000) from Mr. Douglas Gluck, President, Yorkwoods Motors Ltd., requesting compensation for the cost of the heating unit because the City approved the use of it; and
- (ii) (July 11, 2000) from Mr. John Cochrane, President, Cochrane Automotive, raising the question of compensation for those who are duly licensed by the Ministry of the Environment to use a waste oil furnace, in the event that the City enacts the proposed by-law to ban such furnaces; listing his expenditures with respect to the purchase of a Renzor Waste Oil Furnace, and indicating that such unit causes little or no air pollution; and forwarding correspondence with respect thereto and a copy of his valid license.

Ms. Karen Buck, Citizens for a Safe Environment, appeared before the Committee in connection with the foregoing matter.

On motion by Councillor Sinclair, the Committee recommended to Council the adoption of the By-law to Prohibit the Burning of Used Motor Oil embodied in the aforementioned communication (June 16, 2000) from the City Clerk.

13.6 Proposed Residential Solid Waste Collection By-law.

The Works Committee had before it a report (June 28, 2000) from the Commissioner of Works and Emergency Services recommending that:

- (1) the Residential Solid Waste Collection By-law, consolidating and harmonizing the residential components of the former Area Municipalities' solid waste collection by-laws, be enacted;
- (2) the following by-laws continue to be in effect, provided that in the event of a conflict between the Residential Solid Waste Collection By-law and a by-law referred to below, the Residential Solid Waste Collection By-law will prevail:
 - Chapter 309, City of Toronto Municipal Code, as amended;
 - Chapter 149, Etobicoke Municipal Code, as amended;
 - By-law 1-86, as amended;
 - By-law 2890-78, as amended;
 - By-law 24478, as amended; and
 - By-law 21732, as amended;
- (3) authority be granted for the introduction of the necessary Bill to give effect thereto;
- (4) staff be authorized to take all steps necessary to enforce the Residential Solid Waste Collection By-law;
- (5) residents of the City of Toronto be advised accordingly;
- (6) the Commissioner of Works and Emergency Services be given full authority to discontinue solid waste collection services at any residential location due to non-compliance with the by-law, and only in the event that the Ward Councillor is of the opinion that the location should remain eligible for solid waste collection services while in contravention of the by-law, will the issue be sent to the Works Committee and Council for resolution; and
- (7) the Commissioner of Works and Emergency Services be directed to initiate site investigation at multiple household residential locations and authorize the adjustment of garbage and/or recycling collection service based on the protocol identified in this report.

The Committee also had before it the following communications:

- (i) (May 29, 2000) from the City Clerk advising that the Toronto Community Council, on May 23, 2000, recommended that:
 - (1) Section 2.5 of the proposed by-law attached to the report (March 9, 2000) from the General Manager, Solid Waste Management Services, be amended to read:
 - "2.5 The Commissioner may determine that Owners of multiple household residences who do not participate fully in the City's collection of Recyclable Materials or who sell or otherwise transfer Recyclable Materials to persons other than the City are not eligible to receive any Services."
 - (2) a Schedule of set fines be submitted to Council prior to the adoption of the by-law;

and further advising that the Toronto Community Council requested the Commissioner of Works and Emergency Services to report to the Works Committee, at its meeting at which this matter will be considered:

- (a) in consultation with the City's recycling firms, on the requirement that newspapers and magazines be bagged, given the concern of the Toronto Community Council that this requirement may reduce participation in recycling and make residents guilty of an offence for undertaking an activity which, in the past, was legal; and
- (b) on adding a new section to the proposed by-law which would ensure the proper setting out of garbage and proper recycling of materials for buildings with two or more dwelling units with an absentee landlord; and
- (ii) (May 30, 2000) from the City Clerk advising that the North York Community Council, on May 23, 2000:
 - (1) received the report (March 9, 2000) from the General Manager, Solid Waste Management Services, Works and Emergency Services; and
 - (2) referred the following recommendations respecting the Proposed Residential Solid Waste Collection By-law to the Works Committee for its consideration:

- (a) that as single family homes, townhouses, semi-detached homes and multi-residential developments, other than apartment buildings, are all taxed at the same rate, they should all receive the same level of service for waste collection and curbside collection, and that central point collection be eliminated at all properties except those that may wish to retain central point collection;
- (b) that Section 15.1(c) be amended to provide that only grey and green recycling boxes be used for the collection of the newspapers, telephone directories, magazines and catalogues, and that all references to the use of bags for the collection of paper be deleted; and
- (c) the wording of the proposed Residential Solid Waste Collection By-law be amended to provide that the authority for the ceasing of solid waste collection be only at the discretion of City Council; and
- (3) requested the Commissioner of Works and Emergency Services to:
 - (i) investigate and report on new vehicles and alternative methods that could be used in order to facilitate curbside collection in all townhouse developments and single family homes, including those on laneways and non-standard roadways; and
 - (ii) bring a clean-up crew from downtown to the former City of North York area to undertake a one-time clean-up of litter, in areas where the flower pot bins are located.

Councillor Sherene Shaw, Scarborough Agincourt, appeared before the Committee in connection with the foregoing matter, and requested that she be recorded as being opposed to the aforementioned Residential Solid Waste Collection By-law.

Councillor Disero moved the adoption of the aforementioned report. (Carried)

Councillor Shiner moved that the following be deleted from the proposed by-law:

(1) the requirement for the use of plastic bags for the collection of paper; and

(2) the reference to bi-weekly recycling collection for Multiple Household Residences.

(Referred)

Councillor Disero further moved that the Commissioner of Works and Emergency Services be requested to submit a report directly to Council for its meeting on August 1, 2000, on the foregoing motion by Councillor Shiner, such report to include consideration of issues related to weight and storage space. (**Carried**)

13.7 Proposed Solid Waste Management Services Requirements for New Developments and Redevelopments.

The Works Committee had before it a report (June 28, 2000) from the Commissioner of Works and Emergency Services recommending that:

- based on comments received during the stakeholder consultation process, the attached document, entitled "City of Toronto Requirements for Garbage and Recycling Collection from New Developments and Redevelopments", be approved;
- (2) staff be authorized to make this document available to all parties involved in new developments and redevelopments and impose the requirements contained within; and
- (3) the Commissioner of Works and Emergency Services be authorized to make amendments to the access contained in "City of Toronto Requirements for Garbage and Recycling Collection from New Developments and Redevelopments" from time to time as a result of changes to collection operations.

The Committee also had before it the following communications:

(i) (May 29, 2000) from the City Clerk advising that the Toronto Community Council, on May

23, 2000:

- (1) recommended that the requirements be amended so that public laneway collection would be permitted and encouraged if these new developments are on main commercial streets; and
- (2) requested the Commissioner of Works and Emergency Services to report to the Works Committee, at its meeting at which this matter will be considered:
 - (a) on the possibility of mandatory refrigerated wet waste storage areas; and
 - (b) on a possible requirement for composting, organics separation and fibres separation for new buildings or redevelopment of old buildings;
- (ii) (May 30, 2000) from the City Clerk advising that the North York Community Council, on May 23, 2000:
 - (1) received the report (March 9, 2000) from the General Manager, Solid Waste Management Services, Works and Emergency Services; and
 - (2) referred the following recommendations respecting the proposed Solid Waste Management Services Requirements for Developments and Redevelopments, to the Works Committee for its consideration:
 - (a) that all new single family homes, townhouses, semi-detached homes and multi-residential developments, other than apartment buildings, that are on public or private roads and laneways be designed to facilitate curbside collection in order to eliminate central point collection; and
 - (b) all references to the use of bags to collect paper as referred to in the document headed "Requirements for City of Toronto Garbage and Recycling Collection at New Developments and Redevelopments", be deleted and that grey green recycling boxes continue to be used for the collection of newspapers, telephone directories, magazines and catalogues;

and further advising that the North York Community Council requested the Commissioner of Works and Emergency Services to investigate and report on new vehicles and alternative methods that could be used in order to facilitate curbside collection in all new developments; and

(iii) (June 28, 2000) from Councillor Norm Kelly, Scarborough Wexford, respecting curbside waste collection at condominium units; and requesting the Works Committee to recommend a pilot project at Stonehill Court, Scarborough, for a six-month period for curbside waste collection.

On motion by Councillor King, the Committee recommended to Council the adoption of the aforementioned report, subject to:

- (1) adding to the end of Recommendation No. (2) the words "including Urban Development Services staff in each of the Community Council areas" so that such Recommendation reads as follows:
 - "(2) staff be authorized to make this document available to all parties involved in new developments and redevelopments and impose the requirements contained within, including Urban Development Services staff in each of the Community Council areas"; and
- (2) adding thereto the following recommendation:
 - "(4) the Commissioner of Works and Emergency Services be requested to provide an information session for Urban Development Services staff involved in the processing of applications for new developments and redevelopments to familiarize them with the new requirements."

(Clause No. 4, Report No. 15)

13.8 Harmonization of Transit Shelter Agreements – Contract with Mediacom Inc.

The Works Committee had before it a report (July 5, 2000) from the Commissioner of Works and Emergency Services recommending that:

(1) approval be given to enter into an agreement with Mediacom Inc. for the provision, repair, cleaning, operation and maintenance of transit shelters with and without advertising caissons, subject to the terms and conditions generally as described in this report and such other terms and conditions as may be satisfactory to the Commissioner of Works and

Emergency Services and the City Solicitor, with such agreement to replace all existing transit shelter agreements;

- (2) in the event that Recommendation No. (1) above is not adopted (i.e., the Mediacom offer is rejected), the Commissioner of Works and Emergency Services be directed to issue a Request for Proposals for the Metro and North York transit shelter agreements which expire in 2000 and 2001 respectively, for a term ending in 2005, as described in this report; and
- (3) the appropriate City officials be authorized to take the necessary steps to implement the foregoing, including the introduction in Council of any Bills that may be required.

Mr. Andrew Koropeski, Director, Transportation Services, gave a presentation to the Committee with respect to the foregoing matter.

The following persons appeared before the Committee in connection with the foregoing matter:

- Mr. David P. Smith, Q.C., Solicitor and Chairman of the Board, Fraser Milner, representing Pattison Outdoor;
- Mr. Ronald G. Barr, Executive Director of Community/Government Relations, Pattison Outdoor, and submitted a communication with respect thereto;
- Mr. John Jory, President, Eller Canada, and submitted a communication with respect thereto;
- Ms. Gayle Christie, Gayle Christie Associates;
- Mr. Blair Murdoch, Vice-President, Real Estate, Mediacom Inc., and Mr. Jeffery Lyons, Morrison Brown Sosnovitch, Barristers and Solicitors; and
- Councillor Frances Nunziata, York Humber.

Councillor Layton declared his interest in the foregoing matter in that his daughter has recently become employed with a company called "Availablemedia.com", which markets advertising services to the outdoor advertising sector.

On motion by Councillor Shiner, the Committee recommended to Council the adoption of Recommendations Nos. (1) and (3) embodied in the aforementioned

report, subject to:

- amending the agreement to add an additional 20 shelters per year for years
 3 to 7, to be installed in new locations, bringing the total number of new shelters to 975; and
- (2) including in the agreement the following conditions:
 - (i) any shelters removed that are in satisfactory condition will be reinstalled at new locations at no cost to the City, as requested by the City, Mediacom to be responsible for the maintenance of these shelters;
 - (ii) all shelters will be cleaned on a weekly basis, and in some areas on a more tailored approach; and
 - (iii) a notice will be posted inside every shelter indicating a number to call in the event that the shelter requires cleaning and/or maintenance.

(Clause No. 2, Report No. 15)

13.9 No-Fault Flood Grant Program – Basement Flooding Damages and Clean-Up Costs.

The Works Committee had before it a joint report (June 28, 2000) from the Commissioner of Works and Emergency Services and the Chief Financial Officer and Treasurer recommending that:

- a City-wide Basement Flood Grant program not be established for flooded basements, as it would not provide any beneficial effects for the City, the cost of the program is unpredictable and potentially excessive, and the program is not required under the Municipal Act;
- (2) Resolution No. 91-21 of the former North York City Council be repealed, being a public No-Fault Grant program which provides financial assistance to former City of North York residents for damages caused by sewer back-ups and watermain breaks;
- (3) as a supplement to the City's Claims Administration Procedures and to assist residents with

the City's claims process, staff be authorized to provide the homeowner with a claims procedure cards as shown in Appendix "A";

- (4) should Committee wish to implement a City-wide Basement Flood Grant program, such program shall be in the amount of \$500.00 or \$1,000.00 or \$1,500.00 per flooding incident;
- (5) should Committee adopt Recommendation No. (4) of this report, then the administrative guidelines as set out in Appendix "B" of this report will apply;
- (6) should Committee adopt Recommendation No. (4) of this report, the Chief Financial Officer and Treasurer report back on the creation of the Basement Flood Grant Reserve Fund By-law and funding plan for the program as part of the rate-setting report for the 2001 water rate;
- (7) should Committee adopt Recommendation No. (4) of this report, two additional clerical positions be created to administer the Basement Flood Grant program;
- (8) should Committee adopt Recommendation No. (4) of this report, the existing North York No-Fault Flood Grant program remain in place until such time as a City-wide Basement Flood Grant program is implemented as part of the 2001 budget process; and
- (9) staff be directed to give effect to the foregoing.
 On motion by Councillor Shiner, the Committee deferred consideration of the aforementioned report for consideration during the 2001 Water and Wastewater budget process, with a request that the Commissioner of Works and Emergency Services and the Chief Financial Officer and Treasurer submit a joint report to the Works Committee and the Budget Advisory Committee at that time on:
 - (1) the various costs and financing options;
 - (2) procedures for approval to avoid duplicate payments to the homeowners by their insurance company and the City; and
 - (3) the policy being applicable for claims not covered by the homeowner's insurance company.

(Commissioner of Works and Emergency Services; Chief Financial Officer and Treasurer; c: General Manager, Water and Wastewater Services – July 12, 2000)

13.10 Water Supply from Durham Region for Properties on Finch Avenue East at Pickering Town Line in Toronto. (Scarborough Malvern)

The Works Committee had before it a report (June 28, 2000) from the Commissioner of Works and Emergency Services recommending that:

- (1) the agreement between the Region of Durham and the City of Toronto for the supply of potable water to properties on Finch Avenue East be executed in order that staff can proceed with the tendering of Contract No. 00D4-318WS for the construction of the water main; and
- (2) the appropriate City officials be authorized to take the necessary action to give effect thereto.

On motion by Councillor Sinclair, the Committee recommended to Council the adoption of the aforementioned report.

13.11 Universal Metering – Public Notification.

The Works Committee had before it a communication (April 19, 2000) from the City Clerk advising that City Council, at its meeting on April 11, 12 and 13, 2000, adopted, as amended, Clause No. 9 contained in Report No. 6 of The Works Committee, headed "Universal Metering – Public Notification"; and further advising that in doing so, Council amended the Clause by:

- (1) striking out and referring Recommendation No. (3) of the Works Committee back to the Works Committee for further consideration, viz.:
 - "(3) each Ward Councillor be notified of the names of any customers with increases in flat rate bills as a result of refusing a meter, prior to such increases;";

and further recommended that:

- (a) the City Clerk and the City Solicitor be requested to submit a joint report to the Works Committee on ways the City of Toronto can ensure that homeowners and residents have been notified fully of the issue and on whether or not they want a meter; and
- (b) the City Solicitor be directed to seek a legal opinion from outside legal counsel, Mr. George Rust-D'Eye, in this regard.

The Committee also had before it a joint report (July 7, 2000) from the City Clerk and City Solicitor respecting the issue of notifying homeowners and residents of a water rate increase as a result of refusing a water meter under the City's Universal Metering Program, as requested by Council, and forwarding an opinion dated June 23, 2000, from Mr. George Rust-D'Eye of Weir and Foulds with respect thereto; advising that disclosure of the name of an individual together with personal information relating to their water bill constitutes the personal information of the individual, disclosure of which can only be made in accordance with the Municipal Freedom of Information and Protection of Privacy Act; setting out alternatives to disclosing personal information to City Councillors in an attempt to assist homeowners and residents and to ensure that they aware of the increase in their water bill as a result of refusing a meter; and recommending that this report be received for information.

On motion by Councillor Davis, the Committee received the aforementioned communication and report.

13.12 Revised 2000 Capital Works Plan – Water and Wastewater Programs.

The Works Committee had before it a joint report (July 6, 2000) from the Commissioner of Works and Emergency Services and the Chief Financial Officer and Treasurer respecting changes to the 2000-2004 Capital Program for Water and Wastewater in accordance with Council's approval of a cash flow commitment of \$240.0 million for the year 2000, as well as the future year cash commitments associated with the revised work plan; and recommending that:

- (1) project listed in Appendix A which have cash flow requirements of \$240,765 million in 2000, be approved; and
- (2) future year commitments of \$153.126 million in 2001; \$124.549 million in 2002; \$74.773 million in 2003; and \$49.639 million in 2004 as listed in Appendix A be approved.

The Committee also had before it a report (June 28, 2000) from the Commissioner of Works and Emergency Services respecting the provision of making appropriate Capital budget provisions to allow for the replacement of lead or galvanized water services within one year of a resident's request, and providing residents an opportunity for water service upgrade prior to road work where streets are being reconstructed or resurfaced, as requested by the Budget Advisory Committee; advising that it appears that additional funding of approximately \$3.8 million would be required to make appropriate provision in 2001 to have "on demand" service replacement requests undertaken within one year; further advising that while there are potential cost savings when water service replacements occur just prior to resurfacing, there are significantly insufficient funds to replace all substandard pipe in this situation, let alone provide appropriate funding for "on demand" service replacements; and recommending that this report be received.

Councillor Joe Mihevc, York Eglinton, appeared before the Committee in connection with the foregoing matter.

Councillor Layton, on behalf of Councillor Mihevc, moved that the Committee:

- (1) recommend to the Policy and Finance Committee:
 - (i) the adoption of the aforementioned joint report; and
 - (ii) that a program be developed to accelerate the replacement of lead and galvanized pipes; and
- (2) request the Chief Financial Officer and Treasurer, in consultation with the Commissioner of Works and Emergency Services, to submit a report to the Policy and Finance Committee for its next meeting on July 20, 2000, on funding options with respect to Recommendation No. (2).

Councillor Davis moved that the foregoing motion by Councillor Layton, on behalf of Councillor Mihevc, be amended to provide that the Chief Financial Officer and Treasurer include in such report to the Policy and Finance Committee whether there should be a deadline for requests for replacement of lead and galvanized pipes. (Carried)

Councillor Shiner moved that the aforementioned joint report dated July 6, 2000, be received. (**Redundant**)

(Policy and Finance Committee; c: Councillor Joe Mihevc; Chief Financial Officer and Treasurer; Commissioner of Works and Emergency Services; General Manager, Water and Wastewater Services – July 12, 2000)

13.13 Additional Expenditures for Work on the Biosolids Pelletizing Facility at the Ashbridges Bay Treatment Plant.

The Works Committee had before it a report (June 23, 2000) from the Commissioner of Works and Emergency Services recommending that:

- (1) additional expenditures in the amount of \$750,000.00 including Goods and Services Tax, be authorized for the performance of necessary additional work on the design/build contract with USF Canada Inc. for the construction of the Biosolids Pelletizing Facility at the Ashbridges Bay Treatment Plant, resulting in an overall increase in the contract price from \$22,235,959.00 to \$22,985,959.00; and
- (2) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

On motion by Councillor Shiner, the Committee recommended to Council:

- (1) the adoption of the aforementioned report; and
- (2) that the Commissioner of Works and Emergency Services be requested to do everything possible to effect additional savings to bring the overall cost back in line with the original contract price.

13.14 Ultraviolet Design Optimization Study at the Ashbridges Bay Treatment Plant.

The Works Committee had before it a report (June 15, 2000) from the Commissioner of Works and Emergency Services respecting the status and details of the Ultraviolet Design Optimization Study at the Ashbridges Bay Treatment Plant, as requested by the Committee at its meeting on March 22, 2000; advising that the majority of the field work has already been completed, and that work will continue over the summer of 2000 with a series of vendor evaluations to allow for selection of a UV equipment supplier; noting that further work on the UV system and outfall, including the retention of a consultant for the design and construction management of the project will proceed once the Environmental Assessment is received from the Ministry of the Environment; and recommending that this report be received for information.

On motion by Councillor Shiner, the Committee received the aforementioned report.

13.15 Transportation and Climate Change: Options for Action.

The Works Committee had before it a report (June 28, 2000) from the Commissioner of Works and Emergency Services recommending that:

- (1) the National Climate Change Secretariat be requested to extend its consultations and ongoing dialogue concerning greenhouse gas emissions and climate change to the three largest urban areas in Canada: Toronto, Vancouver and Montreal;
- (2) this report be forwarded to the Greater Toronto Services Board and Greater Toronto Area Regions for their information; and
- (3) the appropriate City officials be authorised and directed to take the necessary action to give effect thereto.

The Committee recommended to Council the adoption of the aforementioned report.

13.16 Air Quality.

The Works Committee had before it a communication (May 29, 2000) from the Secretary, Board of Health, advising that the Board of Health, at its meeting on May 29, 2000, adopted a report (May 7, 2000) from the Medical Officer of Health advising that the Ministry of the Environment has committed to shorten the time frame between the collection and reporting of the air quality monitoring results across Ontario; that Works and Emergency Services, in consultation with Public Health, has agreed to prepare annual air quality reports specific to the City of Toronto; and recommending that the Board of Health forward this report to the Works Committee and request that the Commissioner of Works and Emergency Services, in consultation with the Medical Officer of Health, be directed to report annually to the Works Committee and the Board of Health on the status of air quality in Toronto.

The Committee also had before it a communication (June 12, 2000) from the City Clerk forwarding for information and any attention deemed necessary Clause No. 1 of Report No. 4 of The Board of Health, headed "Air Pollution Burden of Illness in Toronto – Summary Report", which was adopted, as amended by the Council of the City of Toronto at its meeting on June 7, 8 and 9,

2000.

On motion by Councillor Layton, the Committee requested the Commissioner of Works and Emergency Services, in consultation with the Medical Officer of Health, to report annually to the Works Committee and the Board of Health on the status of air quality in Toronto, as recommended in the aforementioned report from the Medical Officer of Health.

(Commissioner of Works and Emergency Services; Medical Officer of Health; c: Secretary, Board of Health – July 12, 2000)

(Clause No. 23(e), Report No. 15)

13.17 Warrants for the Justification of Traffic Control Signals.

The Works Committee had before it a report (May 26, 2000) from the Commissioner of Works and Emergency Services reviewing the City of Toronto's current practice used to assess the technical justification for the installation of a new traffic control signal, and to present the rationale that is used to select the order in which new traffic control signals are installed; noting that while no changes are recommended at this time, the Transportation Services Division monitors trends and technological advances in transportation engineering, and is committed to improving safety for pedestrians, cyclists and drivers; and recommending that the report be received for information.

The Committee also had before it a communication (June 30, 2000) from the City Clerk advising that the Toronto Pedestrian Committee, on June 28, 2000, recommended the adoption of the report dated June 28, 2000, from the Toronto Pedestrian Committee, which recommended that the report be referred to the Commissioner of Works and Emergency Services with a request for a report, through the Pedestrian Committee, on the merits of implementing the following proposals:

- (1) that, to properly assess requests to improve the pedestrian crossing environment, the following information be collected in the study conducted by Transportation Services for each of the eight hours selected for the study:
 - number and adequacy of interruptions of continuous vehicular traffic (also referred to as "gaps in traffic"), in both directions, that allow safe pedestrian street crossings without interference from vehicular traffic (excessive delays in adequate gaps may cause pedestrians to endanger themselves by attempting to cross the street during an inadequate gap);

- (b) motor vehicle operating speeds in both directions, in both the curb and passing lanes;
- (c) counts of heavy trucks and other large vehicles that obstruct a driver's view of a pedestrian(s) occupying a travel lane;
- (d) counts of motor vehicle turning movements within the study area that affect pedestrian crossings; (e.g., Brimley Road south of Huntingwood Drive);
- (e) street lighting conditions and illumination of pedestrians;
- (f) location of bus stops and service schedule (can affect the level of risk-taking); and
- (g) type of development and land use along the approach to, and at, the proposed installation site;
- (2) that Transportation Services' reports include a comprehensive description of traffic and other physical conditions that constitute a hazard for pedestrians crossing the street within the defined study area;
- (3) that the minimum pedestrian volume requirement to justify the installation of traffic control signals be reduced in those parts of the City (mostly suburban) that were built to accommodate travel by the automobile for both long and short trips; and
- (4) that studies be conducted to determine the extent to which improvements to pedestrian crossing environments encourage people to walk (not drive), or walk further, especially for short trips.

Ms. Rhona Swarbrick, Co-Chair, Toronto Pedestrian Committee, appeared before the Committee in connection with the foregoing matter.

On motion by Councillor Bossons, the Committee:

- (1) received the aforementioned report; and
- (2) referred the aforementioned report from the Toronto Pedestrian Committee to the Commissioner of Works and Emergency Services for a report thereon to the Works Committee, through the Toronto Pedestrian

Committee, as soon as possible, such report to include comment on the criteria currently being used to determine whether a pedestrian crossing or traffic control signal is warranted.

13.18 Review of Level Crossings and the Construction of Grade Separations in the City of Toronto.

The Works Committee had before it a report (May 31, 2000) from the Commissioner of Works and Emergency Services providing an overview of the status of level rail crossings and grade separations in the City of Toronto, in response to a request from the former Urban Environment and Development Committee; and recommending that a program to construct high priority grade separations in the City of Toronto be considered as part of the City of Toronto's response to the recently announced federal infrastructure program.

Councillor King moved:

- (1) the adoption of the aforementioned report; and
- (2) that the level crossing of the CN Bala Subdivision south of Sheppard Avenue East between Provost Drive and Old Leslie Street be identified within the inventory of existing rail level crossings in the City of Toronto.

(Carried)

Councillor Shiner moved that priority be given to the construction of grade separations on rail lines which are serving all-day GO Transit rail service or are scheduled for upgrades to all-day GO service, and that the Commissioner of Works and Emergency Services be requested to investigate the potential to share the costs with GO Transit for these upgrades. (Carried)

Councillor Bossons moved that the Commissioner of Works and Emergency Services be requested to submit a report to the Committee on:

- (1) the possibility of any financial contribution from the various railway companies; and
- (2) the frequency of trains and their impact on traffic.

(Carried)

13.19 Evaluation of the Effectiveness of Community Safety Zones.

The Works Committee had before it a report (June 23, 2000) from the Commissioner of Works and Emergency Services recommending that:

- (1) the existing 12 Community Safety Zones (CSZ's) be maintained;
- (2) additional CSZ's not be installed at this time;
- (3) the Toronto Police Service be informed and be requested to maintain a sustained enforcement program for all existing CSZ's;
- (4) the Province be requested to review the existing regulatory sign design associated with CSZ's, with a view to improving their visibility amongst other regulatory signs;
- (5) the Province be requested to expedite the Ministry of the Solicitor General and Correctional Services Provincial CSZ promotion initiatives; and
- (6) Transportation Services staff maintain a program to monitor traffic operations at the three subject study locations, and to conduct a follow-up study of the effectiveness of the subject CSZ's two months after a public education program has been initiated by the Province at the following study locations:

- Dundas Street West between Montgomery Road and 100 metres east of Old Oak Road;
- (ii) East Avenue between Lawrence Avenue East and Island Road; and
- (iii) Parkside Drive between Bloor Street West and Lake Shore Boulevard West.

Councillor Valenti moved the adoption of the aforementioned report, subject to Weston Road between Sheppard Avenue and Finch Avenue being exempt from the policy and designated as a Community Safety Zone. (Carried, as amended)

Councillor Davis moved that the foregoing motion by Councillor Valenti be amended to read as follows:

13.20 Turn Prohibitions at the Intersection of Lawrence Avenue East and Ellington Drive. (Scarborough Wexford)

The Works Committee had before it a report (June 20, 2000) from the Commissioner of Works and Emergency Services recommending that:

- (1) southbound and eastbound left-turn movements be prohibited at all times at the intersection of Lawrence Avenue East and Ellington Drive; and
- (2) the appropriate by-law be amended accordingly.

The Committee recommended to Council the adoption of the aforementioned report.

13.21 Proposed Installation of Traffic Control Signals on Wilson Avenue at a Point 210 Metres West of Transit Road and on Dufferin Street at Transit Road, and Modifications to Traffic Control Signals at Wilson Avenue and Transit Road. (North York Spadina)

The Works Committee had before it a report (June 21, 2000) from the Commissioner of Works and Emergency Services recommending that:

- (1) traffic control signal installation be approved on Wilson Avenue at a point 210 metres west of Transit Road;
- (2) traffic control signals be installed at the intersection of Dufferin Street and Transit Road;
- (3) coincidental with the activation of the signals referenced in Recommendation No. (1):
 - (i) the northbound curb lane be designated a compulsory right-turn lane;
 - (ii) the most westerly northbound lane be designated a compulsory left-turn lane; and
 - (iii) the road widening and improvements described therein be co-ordinated with the installation of traffic control signals on Wilson Avenue;
- (4) coincidental with the activation of the signals referenced in Recommendation No. (2):
 - (i) the two most southerly westbound lanes be designated as a double westbound left turn and the curb lane be designated for westbound right turns;
 - (ii) east-west pedestrian crossing on the south side of the intersection be prohibited in order to eliminate vehicle/pedestrian conflicts associated with double turning movements;
 - (iii) the northbound curb lane of Dufferin Street be designated a compulsory right-turn lane; and

- (iv) southbound left turns be prohibited at all times at the intersection of Dufferin Street and Transit Road;
- (5) traffic control signals at the intersection of Wilson Avenue and Transit Road be modified to incorporate the extension of Transit Road to the south and subsequently to the west to intersect with Dufferin Street;
- (6) coincidental with the modification of the signals referenced in Recommendation No. (5):
 - (i) the northbound curb lane be designated a compulsory northbound right-turn lane;
 - (ii) rescind the existing compulsory right-turn designation for the southbound curb lane; and
 - (iii) the construction of the Transit Road extension to the south and west, described therein, be co-ordinated with the modification of the intersection of Wilson Avenue and Transit Road;
- (7) the appropriate By-law(s) be amended accordingly; and
- (8) all funding is to be secured by way of the Section 37 agreement for the development. The Committee recommended to Council the adoption of the aforementioned report.

13.22 Proposed Installation of Traffic Control Signals – Lawrence Avenue West at Blossomfield Drive. (North York Spadina)

The Works Committee had before it a report (June 22, 2000) from the Commissioner of Works and Emergency Services recommending that:

- (1) traffic control signals be installed at the intersection of Lawrence Avenue West and Blossomfield Drive;
- (2) coincidental with the activation of the signals referenced in Recommendation No. (1):

- (i) Blossomfield Drive be widened and the easterly southbound lanes be designed for southbound left turns and the curb lane be designated for southbound left or right turns;
- (ii) north-south pedestrian crossing on the east side of Blossomfield Drive be prohibited;
- (iii) westbound no right turn prohibitions for the access from the Fortino's store to Blossomfield Drive be implemented to eliminate site generated traffic from entering the surrounding neighbourhood;
- (iv) SCOOT traffic control system be implemented at the proposed new signal and the signal at Bolingbroke Road/CIBC access;
- (v) the road improvements described therein be co-ordinated with the installation of traffic control signals on Lawrence Avenue West at Blossomfield Drive; and
- (vi) the appropriate By-law(s) be amended accordingly; and
- (3) all roadway improvements required as part of the development will be completed to the satisfaction of the Commissioner of Works and Emergency Services, at no expense to the City of Toronto.

On motion by Councillor Shiner, the Committee deferred consideration of the aforementioned report until its next regular meeting, scheduled to be held on September 13, 2000, with a request that the Commissioner of Works and Emergency Services submit a further report to such meeting on ways to prohibit the infiltration of transient traffic from Blossomfield Drive to Bolingbroke Road.

13.24 Alterations to Traffic Calming Measures on Winona Drive. (Ward 28, York Eglinton)

The Works Committee had before it a communication (May 29, 2000) from the City Clerk advising that York Community Council on May 23, 2000, recommended that the Works Committee request the Commissioner of Works and Emergency Services to report on the estimated cost of the removal of the raised pedestrian crossings at Winona Drive and Ava Road and Winona Drive and Belvidere Avenue and replacement with raised intersections, including various construction design options with textured concrete, height reduction and appropriate alternatives, having regard to the Works Committee's request for staff to report on a moratorium on traffic calming and in consideration of proposed City-wide standards for the implementation of traffic calming measures.

The Committee received the aforementioned communication, having regard that Council at its meeting on July 4, 5 and 6, 2000, gave consideration to this matter.

Councillor Layton moved that the President of Enwave District Energy Limited, in conjunction with the Commissioner of Works and Emergency Services, be requested to report to the Works Committee on the feasibility of introducing central heating and cooling ducts into the road elements of the proposed Railway Lands development, in light of the provisions of the Official Plan. (Carried)

Councillor Shiner moved that the Commissioner of Works and Emergency Services be requested to report to the Works Committee on the status of other under-pavement services planned for the proposed Railway Lands development. (Carried)

Councillor Davis moved that the Budget Advisory Committee be requested to give priority in the 2001 Operating Budget process to improvements to the southeast corner of the intersection at Dufferin Street and Eglinton Avenue with respect to the Pedestrian Refuge Island; and that the General Manager, Transportation Services be requested to discuss with Councillor Davis options with respect thereto. (**Carried**)

13.26 Feasibility of Connecting Woodfield Road or Knox Avenue to Lake Shore Boulevard East, and Other Issues Related to F.G. Gardiner Expressway Dismantling Project. (Don River, East Toronto)

The Works Committee had before it a report (June 26, 2000) from the Commissioner of Works and Emergency Services respecting the results of a feasibility study that examined connecting Woodfield Road or Knox Avenue to Lake Shore Boulevard East, and other issues relating to the F.G. Gardiner Expressway Dismantling Project; advising that the review of alternative methods of relieving the eastbound left-turn congestion at Lake Shore Boulevard and Coxwell Avenue concluded that Woodfield Road and Knox Avenue should not be extended to Lake Shore Boulevard East, and that constructing double left-turn lanes at the intersection would be the most desirable and cost-effective approach to the identified problem; noting that no action should be

The Works Committee had before it a report (June 27, 2000) from the Commissioner of Works and Emergency Services responding to a request from Council at its meeting of February 1, 2 and 3, 2000, for a report on a more aggressive program to collect household hazardous waste (HHW), possibly at gas stations; outlining an HHW return-to-retailer program whereby retailers accept from residents categories of HHW related to selected products sold in their stores, similar to a program recently implemented in the Region of Ottawa-Carleton; noting that setting up such a system in Toronto would have budget implications, but that this may be offset by a reduction in HHW operating costs if quantities received through the existing HHW program declined; advising that staff will monitor the Ottawa-Carleton program and report further recommending a retailer-based HHW

program in the City if it appears that it could be operated cost-effectively; and recommending that this report be received for information.

Councillor Shiner moved that the aforementioned report be received; and that the Commissioner of Works and Emergency Services be requested to submit a report to the 3Rs Sub-Committee in September on best practices of other municipalities with respect to their handling of household hazardous waste. (Carried, as amended)

Councillor Bossons moved that the foregoing motion by Councillor Shiner be amended to provide that the Commissioner of Works and Emergency Services be requested to also report to the 3Rs Sub-Committee on any action being taken to raise with the Province of Ontario the stringent provincial regulations with respect to the establishment of temporary HHW collection sites and any means of facilitating such HHW collection. (**Carried**)

Councillor Davis moved that the Commissioner of Works and Emergency Services be requested to also investigate including manufacturers and distributors in addition to retailers in a household hazardous waste program, specifically with respect to the paint industry, and including the British Columbia model, and report back thereon to the Committee. (**Carried**)

13.35 Commercial Garbage and Recycling Service Harmonization Status Report.

The Works Committee had before it a report (June 28, 2000) from the Commissioner of Works and Emergency Services respecting the status of plans to harmonize commercial garbage and recycling service and fees across the City, and options for service eligibility criteria, service levels and service fee structures; presenting a definition of a core area of the City requiring more frequent commercial garbage collection, preliminary eligibility criteria and collection frequency for small commercial locations both within and outside of the core area, as well as a preliminary graduated fee structure; advising that staff are proposing to report back in early 2001 with the results of further systems analysis and consultation with stakeholders, with the new service structure to be implemented in January 2002; and recommending that this report be received for information.

13.36 Toronto Public Health Authority Under the Health Protection and Promotion Act as it Pertains to Garbage Handling and Storage.

The Works Committee had before it a report (June 2, 2000) from the Medical Officer of Health outlining Toronto Public Health's legislative authority in dealing with issues relating to small business garbage handling and storage, and more specifically the role of this Division in dealing with the problem of garbage accumulations in laneways originating from food service premises, as requested by City Council on April 11, 12 and 13, 2000; advising that Public Health and Works and Emergency Services are currently working together to identify those food premises which back or front onto problematic laneways or municipal rights-of-way, and are also developing an information package for distribution to the small business community outlining the relevant legislative requirements and information pertinent to garbage storage and collection; noting that this joint venture is expected to have an immediate positive impact on the cleanliness of such laneways within the City over the summer; and recommending that the report be received for information.

The Committee received the aforementioned report.

- (1) subject to a favourable report by the Manager, Fair Wage and Labour Trades Office, that Contract No. 00D4-101RD, Tender Call No. 10-2000, for the resurfacing of Toronto roads in District 4, for 2000, be awarded to Furfari Paving Co. Ltd. in the total amount of \$2,696,258.23 including all taxes and charges, being the lowest Tender received; and
- (2) in the event that the lowest bidder, Furfari Paving Co. Ltd., does not receive a favourable report by the Manager, Fair Wage and Labour Trades Office, that Contract No. 00D4-101RD, Tender Call No. 10-2000, for the resurfacing of Toronto roads in District 4, for 2000, be awarded to D. Crupi & Sons Ltd. in the total amount of \$3,077,768.14 including all taxes and charges, being the lowest Tender received meeting specifications.

The Committee also had before it a report (July 12, 2000) from the Manager, Fair Wage and Labour Office, providing the Committee with further information on whether the recommended bidder complies with the City's Fair Wage Policy; and recommending that Contract No. 00D4-101RD, Tender Call No. 10-2000, for the resurfacing of Toronto roads in District 4, be awarded to Furfari Paving Co. Ltd. in the total amount of \$2,696,258.23 including all taxes and charges, being the lowest Tender received.

The following Councillors appeared before the Committee in connection with the foregoing matter:
