WEDNESDAY, JANUARY 19, 2000

City Council met in the Council Chamber, City Hall, Toronto.

CALL TO ORDER

S1.1 Mayor Lastman took the Chair and called the Members to order.

The meeting opened with O Canada.

NOTICE OF SPECIAL MEETING

S1.2 Mayor Lastman read the following Notice of Special Meeting:

"In accordance with the direction of Council, this Special Meeting of Council is called for the following purposes:

- (a) to consider Report No. 1 of The Administration Committee, respecting Ward Boundary Options; and
- (b) to consider and enact a bill to confirm the proceedings of this Special Meeting."

PRESENTATION OF REPORT

S1.3 Councillor Berardinetti presented the following Report for consideration by Council:

Report No. 1 of The Administration Committee,

and moved, seconded by Councillor Miller, that Council now give consideration to such Report, which carried.

S1.4 DECLARATIONS OF INTEREST

There were no declarations of interest.

CONSIDERATION OF REPORTS CLAUSES RELEASED OR HELD FOR FURTHER CONSIDERATION

S1.5 The following Clause was held by Council for further consideration:

Report No. 1 of The Administration Committee, Clause No. 1.

CONSIDERATION OF REPORT CLAUSE WITH MOTIONS, VOTES, ETC.

S1.6 Clause No. 1 of Report No. 1 of The Administration Committee, headed "Recommendations to Divide the 22 Provincial Ridings into 44 City Wards".

Motions:

(a) Councillor Berardinetti, seconded by Councillor Miller, moved that:

"WHEREAS City Council on December 14, 15 and 16, 1999, adopted a process to determine a preferred set of 44 single member ward boundaries for the municipal election to be held in 2000; and

WHEREAS, in adopting the process, Council also approved the recommendation of the Administration Committee that the Chair of the Committee and two of its Members be requested to convene meetings and invite any Member of Council who has an interest in a particular riding to attend and provide input; and

WHEREAS the Chair of the Administration Committee, together with Councillors Holyday and Miller, Members of the Administration Committee, have met, as a Committee, with interested Members of Council or their representatives and City Clerk's staff to review options for dividing each Federal/Provincial riding into two City wards; and

WHEREAS, as part of this review, full consideration has been given to:

- (1) Council-adopted ward boundary principles;
- (2) the preliminary draft ward options released by City Clerk's staff;
- (3) the comments from Members of Council and their offices; and
- (4) the feedback from the public open houses and additional options prepared by staff which resulted from the public's comments; and

WHEREAS the Administration Committee on January 11, 2000, endorsed 19 of the 22 ward boundaries proposed by the Committee of the Chair of the Administration Committee and Councillors Holyday and Miller, with only one technical amendment; and

WHEREAS it is appropriate that the ward boundaries recommended by the aforementioned Committee be endorsed in their entirety, since a full review has been undertaken by the Committee on all options;

NOW THEREFORE BE IT RESOLVED THAT the Clause be amended by adding thereto the following:

'It is further recommended that, as recommended by the Committee of Councillor Lorenzo Berardinetti, Chair, Administration Committee, and Councillors Doug Holyday and David Miller, Members of the Administration Committee, Map Option 8-1 for the Provincial Riding of Eglinton-Lawrence, Map Option 11-3 (revised) for the Provincial Riding of St. Paul's and Map Option 19-2 for the Provincial Riding of Scarborough Centre, be adopted."

- (b) Councillor Davis moved that:
 - (1) the Clause be amended by adding thereto the following:

"It is further recommended that the City Clerk be requested to submit a report to the Administration Committee with respect to City Council establishing an Electoral Boundary Commission to consider the federal changes that are expected to occur following the next census, to be held in 2001/2002."; and

- (2) motion (a) by Councillor Berardinetti, seconded by Councillor Miller, be amended to provide that the ward boundary division for the Provincial Riding of Eglinton Lawrence (Ward 8) be as shown on the attached Map 8-B.
- (c) Councillor Rae moved that the Clause be amended to provide that the ward boundary division for the Provincial Riding of Toronto-Rosedale (Ward 14) be as shown on the attached Map 14-3.
- (d) Councillor Duguid moved that motion (a) by Councillor Berardinetti, seconded by Councillor Miller, be amended to provide that the ward boundary division for the Provincial Riding of Scarborough Centre (Ward 19) be as shown on the attached Map Option 19-1 submitted by staff in the document entitled "Draft Preliminary Options to Divide the 22 Provincial Ridings into 44 Single Member Wards", (December, 1999).
- (e) Councillor Adams moved that motion (a) by Councillor Berardinetti, seconded by Councillor Miller, be amended to provide that the ward boundary division for the Provincial Riding of St. Paul's (Ward 11) be as shown on the attached Map 11-2 (revised).
- (f) Councillor Tzekas moved that Council adopt the following procedural motion:

"It is recommended that the vote on the Clause be conducted as follows:

- (1) Council first vote on all ward boundaries for which no alternative has been proposed at this meeting of Council; and
- (2) Council then vote on the remaining ward boundaries in ward order."
- (g) Councillor Korwin-Kuczynski moved that the Clause be amended to provide that the ward boundary division for the Provincial Riding of Parkdale-High Park (Ward 7) be as shown on the attached Map 7-D.

Deputy Mayor Ootes in the Chair.

(h) Councillor Bussin moved that the Clause be amended by adding thereto the following:

"It is further recommended that the Province of Ontario be requested to repeal the provisions of the <u>Fewer Municipal Politicians Act</u> that take away from the City of Toronto only, the ability to determine the size of its Council and ward boundaries, and restore to Toronto the ability to deal with these matters under Sections 14 and 29 of the <u>Municipal Act</u>."

(i) Councillor Filion moved that the Clause be amended to provide that the ward boundary division for the Provincial Riding of Willowdale (Ward 12) be as shown on the attached Map A-12.

- (j) Councillor O'Brien moved that the Clause be amended by adding thereto the following:
 - "It is further recommended that Council support the premise of two Members of Council at large for each City ward."
- (k) Councillor Shiner moved that Council adopt the following procedural motion:

"It is recommended that the order of the vote be taken as follows:

- (1) Council first vote on the recommendations of the Administration Committee, together with motion (a) by Councillor Berardinetti; or
- (2) if Part (1) fails, Council first vote on the 19 wards recommended by the Administration Committee."

Mayor Lastman ruled that motion (j) by Councillor O'Brien would require a re-opening of Clause No. 3 of Report No. 9 of The Administration Committee, headed "Ward Boundaries", adopted by City Council, as amended, at its meeting held on December 14, 15 and 16, 1999.

- (4) the City Clerk be requested to submit a report to the Administration Committee with respect to City Council establishing an Electoral Boundary Commission to consider the federal changes that are expected to occur following the next census, to be held in 2001/2002; and
- (5) the Province of Ontario be requested to repeal the provisions of the Fewer Municipal Politicians Act that take away from the City of Toronto only, the ability to determine the size of its Council and ward boundaries, and restore to Toronto the ability to deal with these matters under Sections 14 and 29 of the Municipal Act."
