1(a). Mr. Ian Tytler, Vice-President <u>Toronto Bicycle Network</u> (April 18, 2001)

> Advising that the proposed system of bicycle paths and trails in the Toronto Master Cycling Plan has been collectively called the Bikeway Network, or the Toronto Bikeway Network; expressing concern that the acronym "TBN" used to describe the Toronto Bikeway Network will create duplication and confusion with the acronym used to describe the club, the Toronto Bicycling Network; and requesting that:

- (1) the Toronto Cycling Committee advise the Toronto Bicycle Network on how far along in the selection process it is in the choosing of a name for the cycling pathways for the Master Cycling Plan;
- (2) the Toronto Cycling Committee select a name for the cycling pathways for the Cycling Master Plan that does not use the name Toronto Bikeway Network or the acronym "TBN"; and
- (3) the Toronto Cycling Committee and Toronto Bicycle Network work together on the selection of an appropriate name for the cycling paths in the Master Cycling Plan.

11. TRAFFIC CALMING POLICY.

City Clerk, Works Committee (March 28, 2001)
