**Advising** that City Council, at its meeting on March 6, 7 and 8, 2001, by its adoption of Clause No. 2 of Report No. 2 of the Nominating Committee, appointed the following people to the Board of Health for a term of office to expire November 30, 2003, and until their successors are appointed: Ms. Helen Chan, Mr. Brian Hyndman, Dr. Rosanna Pellizzari, Ms. Nancy E. Medical Officer of Health (March 28, 2001)

**Presenting** the Toronto Food Charter and the "Growing Season," Phase 2 Report of the Food and Hunger Action Committee, outlining the role of Toronto Public Health in the implementation of the Food and Hunger Action Plan, advising that there are no financial implications arising from this report and **recommending** that this report be received for information.

## 4. GENETICALLY ENGINEERED FOODS.

Medical Officer of Health (March 26, 2001)

**Reporting** on the issue of genetic engineering of food using public health principles and presenting a summary of a larger Technical Report prepared by Toronto Public Health staff (see Attachment 1); synthesizing relevant information based on the findings of reviews of scientific evidence published in peer-reviewed journals, government reports, and advocacy group reports, in relation to public health principles, recommending that other Public Health stakeholders be consulted in order to develop recommendations, and further **recommending** that:

(1) the Board of Health direct public health staff to lead a consultation with other Public Health stakeholders (e.g., the Ontario Public Health Association, the Canadian Public Health Association, Boards of Health in Ontario) to develop recommendations that will address the public health implications of genetically engineered food; and (2) the appropriate City Officials be authorized and directed to continue to take the necessary action to give effect thereto.

## 5. WEST NILE VIRUS.

Medical Officer of Health (March 28, 2001)

**Informing** the Board of Health on the current situation in Ontario on prevention and control measures for the West Nile Virus (WNV), recommending action to be taken by the City; advising that there are no financial implications resulting from the adoption of this report, that resource requirements for the West Nile Response Plan will be subject to a future report to be prepared by the Inter-departmental West Nile Co-ordinating Committee; and **recommending** that:

- (1) the Board of Health request City Council to:
  - (a) endorse the preparation of a co-ordinated City of Toronto West Nile Response Plan for the prevention and control of the West Nile Virus that minimizes the use of pesticides;
  - (b) ensure that the Inter-departmental West Nile Co-ordinating Committee develop and implement a West Nile Response Plan for the City including estimates of the costs of implementation;
  - (c) request the Province of Ontario to provide 100 percent funding to support the measures required to prevent and control the spread of West Nile virus, including the implementation of the City of Toronto West Nile Response Plan;
- (2) the Medical Officer of Health be requested to report back on staff activities to prevent and control the West Nile virus in Toronto; and
- (3) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

## 6. HARMONIZED MUNICIPAL ALCOHOL POLICY ALL WARDS.

<u>Commissioner of Economic Development, Culture and Tourism and</u> <u>Medical Officer of Health</u> (March 7, 2001)

**Introducing**, for Council's consideration, a draft harmonized Municipal Alcohol Policy (MAP), advising the MAP will apply to all Special Occasion Permit events held on City-owned locations, and to any event for which the City is the Special Occasion Permit

holder, advising that there are no financial implications resulting from the adoption of this report; and **recommending** that:

- (1) Council adopt the harmonized Municipal Alcohol Policy as outlined in Attachment No. 1;
- (2) the harmonized Municipal Alcohol Policy not come into effect until six months after the date of Council's approval in order that implementation measures identified in Attachment No. 3 may be carried out;
- (3) the existing Municipal Alcohol Policies of the former municipalities remain in effect during the six-month period noted in Recommendation No. 2 above;
- (4) the harmonized Municipal Alcohol Policy be forwarded to all City agencies, boards and commissions for their information, and that Council recommend to all agencies, boards and commissions that they give consideration to adopting policies respecting alcohol risk management; and
- (5) the appropriate City Officials be authorized and directed to take the necessary action to give effect thereto.

## 7. AIR QUALITY AND ENVIRONMENTAL ASSESSMENT FOR THE NANTICOKE COAL-FIRED POWER PLANT.

Medical Officer of Health (March 21, 2001)

**Informing** the Board of Health of the health and environmental implications of Ontario Power Generation's proposal to install selective catalytic reduction (SCR) units at the Nanticoke coal-fired power plant, seeking authorization to request that an environmental assessment be conducted; advising that there are no direct financial implications for Toronto Public Health or the City of Toronto, and **recommending** that City Council:

- (a) request that Canada's Minister of the Environment refer Ontario Power Generation's proposal to install selective catalytic reduction (SCR) units on its Nanticoke coal-fired power plant to an Environmental Assessment Panel with directions to consider the alternative of conversion to natural gas;
- (b) request that the Ontario Minister of the Environment require Ontario Power Generation (OPG) to prepare an environmental assessment under section 6.1(2) of the Environmental Assessment Act for its proposal to install selective catalytic reduction units on its Nanticoke coal-fired power plant with directions to give full consideration to the alternative of conversion to natural gas, and refer this assessment to the Ontario Environmental Review Tribunal for a full public hearing;

- (c) request that both Ministers of the Environment establish a joint review panel to address OPG's environmental assessment; and
- (d) the appropriate City Officials be authorized and directed to take the necessary action to give effect thereto.
- 7(a). <u>Mr. Jack Gibbons, Chair, Ontario Clean Air Alliance</u> (February 7, 2001)

**Requesting** Council to pass a resolution requesting the Provincial and Federal Ministries of the Environment to subject Ontario Power Generation's proposal to install selective catalytic reduction units at its Lambton and Nanticoke coal-fired plants to a full public environmental assessment, and providing background information.

## 8. PREVENTION OF FEEDING OF WILD ANIMALS.

**Requesting** the Board of Health to develop and recommend to Council a by-law to prevent the feeding of wild animals.

"THEREFORE BE IT RESOLVED that Legal staff, in cooperation with Animal Control and Health Department staff, report on ways and means in which the City's by-laws might be amended so as to afford more protection to those people who feel threatened by vicious and uncontrolled animals."
