10.1 Community Services Committee - 2001 - 2005 Capital Programs

The Budget Advisory Committee had before it a report (February 26, 2001) from the City Clerk advising that the Community Services Committee at its meetings held on February 22 and 26, 2001, reviewed the 2001-2005 Capital Programs under its purview, and took the following action in regard thereto:

Works and Emergency Services:

- (I) Toronto Emergency Medical Services:
 - (a) recommended to the Budget Advisory Committee the adoption of the recommendations contained in the recommended 2001-2005 Capital Program for Toronto Emergency Medical Services; and
 - (b) requested the Commissioner of Works and Emergency Services and the General Manager, Toronto Emergency Medical Services to report to the Community Services Committee on the status of each individual project in the Capital Program;

(II) Fire Services:

recommended to the Budget Advisory Committee the adoption of the recommendations contained in the recommended 2001-2005 Capital Program for Fire Services;

Community and Neighbourhood Services:

(III) Children's Services:

recommended to the Budget Advisory Committee the adoption of the recommendations contained in the recommended 2001-2005 Capital Program for Children's Services;

(IV) Homes for the Aged:

recommended to the Budget Advisory Committee the adoption of the recommendations contained in the recommended 2001-2005 Capital Program for Homes for the Aged, subject to:

(a) approving the proposed new 178-bed Home for the Aged in Ward 35 - Scarborough Southwest, as recommended in the report dated January 24, 2001, from the Commissioner of Community and Neighbourhood Services; and

(b) deferring the Site Redevelopment Project for True Davidson Acres until the period 2004-2006, providing the new Home for the Aged in Scarborough is approved;

and further that the Budget Advisory Committee be advised of the Community Services Committee's support for the Site Redevelopment Project for Albion Lodge;

- (V) Shelter, Housing and Support:
 - (a) recommended to the Budget Advisory Committee the adoption of the recommendations contained in the recommended 2001-2005 Capital Program for Shelter, Housing and Support;
 - (b) requested the Commissioner of Corporate Services to report to the Budget Advisory Committee on the listing price for 717 Broadview Avenue; and
 - (c) requested the Commissioner of Community and Neighbourhood Services, in consultation with community stakeholders and experts, to prepare a revised forecast on the capital needs for new shelter beds which reflects an increase in the City's homeless population, and report thereon to the Community Services Committee by the Summer of 2001.

On motion by Councillor Sutherland, the Budget Advisory Committee received the aforementioned communication for information.

10.2 Community Services Committee - 2001 Operating Budget

The Budget Advisory Committee had before it a report (February 26, 2001) from the City Clerk advising that the Community Services Committee at its meetings held on February 22 and 26, 2001, reviewed the 2001 Operating Budgets under its purview, and took the following action in regard thereto:

Works and Emergency Services:

- (I) Toronto Emergency Medical Services:
 - (a) recommended to the Budget Advisory Committee the recommended 2001 Operating Budget for Toronto Emergency Medical Services in the amount of \$95,197,200.00 gross and \$39,084,600.00 net;

- (b) requested the Commissioner of Works and Emergency Services, in consultation with the General Manager, Toronto Emergency Medical Services, to:
 - (i) consider the option to lease rather than purchase replacement vehicles, and report thereon to the Community Services Committee by May 2001; and
 - (ii) report to the Community Services Committee on the status of the negotiations with the Province of Ontario with respect to the 2000 and 2001 subsidies for Toronto Emergency Medical Services;

(II) Fire Services:

- (a) recommended to the Budget Advisory Committee:
 - (i) the revised 2001 Operating Budget for Fire Services in the amount of \$242,583,800.00 gross and \$238,869,100.00 net, which includes the impact of:
 - (1) the addition of two out-of-service trucks, totalling \$2,800,000.00; and
 - (2) the addition of 55 firefighters, totalling \$2,612,800.00;
 - (ii) that the fees for false alarms and elevator calls be increased from \$300.00 to \$350.00 per vehicle, and that the Commissioner of Works and Emergency Services be requested to provide the Budget Advisory Committee with an estimate as to the amount of additional revenue this will generate for the City; and
 - (iii) that the fees for highway response be increased to the maximum level of \$350.00 and that the Commissioner of Works and Emergency Services provide the Budget Advisory Committee with an estimate as to the amount of additional revenue this will generate for the City;
- (b) requested the Commissioner of Works and Emergency Services, in consultation with the Fire Chief, to:
 - (i) consider maximizing revenue generating opportunities, such as utilizing the Fire Services name and logo on clothing, accessories, toys, and other appropriate products, and report thereon to the Community Services Committee by June 2001;

- (ii) report to the Budget Advisory Committee on potential savings and efficiencies from allowing maintenance of the Fire Services fleet to be administered by Fire Services directly, and that such report include examples of vehicles being out of service for extended periods of time for minor repairs and of overcharging for vehicle maintenance:
- (iii) consider the option to lease rather than purchase replacement fire services fleet, and report thereon to the Community Services Committee; and
- (c) requested the Commissioner of Works and Emergency Services to review the Toronto Fire Services management structure and consider opportunities for rationalization following implementation of the Records Management System;

Community and Neighbourhood Services:

- (III) Children's Services:
 - (a) recommended to the Budget Advisory Committee:
 - (i) the adoption of the recommendations contained in the recommended 2001 Operating Budget for Children's Services, subject to:
 - (1) reducing such budget by a total of \$14,596,400.00 gross, and \$320,000.00 net, as follows:
 - (i) deferring the implementation of the "early leader" in the Early Childhood Education Development and Care Pilot Project until September 2001 \$600,000.00 gross, \$0.0 net;
 - (ii) deferring for one year the 2000 subsidy space expansion \$13,676,400.00 gross, \$0.0 net;
 - (iii) deferring for one year the contribution to the Child Care Capital Reserve Fund, approved by Council as part of the City of Toronto Daycare Grant being eliminated in 2001 \$320,000.00 gross, \$320,000.00 net;

- (2) increasing such budget by a total of \$4,333,000.00 gross and \$866,700.00 net, as follows:
 - (i) payment of actual cost to licensed child care providers Phase II equity in teaching staff rates and provider rates \$3,333,000.00 gross and \$666,700.00 net;
 - (ii) expansion of special needs resourcing programs addressing children at risk \$500,000.00 gross and \$100,000.00 net; and
 - (iii) expansion of family resource programs better equity of funding across the City \$500,000.00 gross and \$100,000.00 net; and
 - (ii) the approval, in principle, of those recommendations without financial implications contained in the report, entitled "Children and Youth Action Committee Action Plan 2001" and in the joint communication dated February 7, 2001, from Councillor Pam McConnell and Councillor Olivia Chow; and
- (b) deferred consideration of the following motion by Councillor Brad Duguid until the June 2001 meeting of the Community Services Committee:

"That staff review the need to continue to provide City-operated child care services, and report on the potential cost-savings, complications and impacts of turning over City-owned child care centres to non-profit child care agencies."

(IV) Homes for the Aged:

 - (a) recommended to the Budget Advisory Committee the recommended 2001 Operating Budget for Shelter, Housing and Support, subject to:
 - (i) reducing such budget by a total of \$2,543,200.00 gross and \$2,643,200.00 net, as follows:
 - (1) Implement Rent Freeze
 Campaign \$150,000.00 gross/net
 - (2) Eliminate 12 FTEs at Seaton House - \$587,900.00 gross/net
 - (3) Eliminate 1 FTE at Women's Residence \$37,500.00 gross/net
 - (4) Reduce Hostel Redirect
 Program \$288,800.00 gross/net
 - (5) Additional Gapping \$1,212,000.00 gross/net
 - (6) Reduce Hostel Travel and Supplies \$267,000.00 gross/net
 - (7) Realize Social Housing
 Devolution Funding \$100,000.00 net
 - (ii) adding the amount of \$300,000.00 gross and net to the Tenant Defence Fund for the Tenant Support Grants Program and the Outreach and Organizing Program; and
 - (iii) adding 1,000 emergency shelter beds (at \$14.60 net per diem) over a three-year period, at a total cost of \$5,475,000.00 gross and \$1,766,700.00 net each year; and

- (b) requested the Commissioner of Community and Neighbourhood Services to report to the Community Services Committee on opportunities to enhance client training within the shelter system;
- (VI) Social Development and Administration:
 - (a) recommended to the Budget Advisory Committee the recommended 2001 Operating Budget for Social Development and Administration, subject to reducing such budget by a total of \$85,000.00 gross and \$55,000.00 net, as follows:
 - (i) Eliminate contracted desktop services March 1 - \$60,000.00 gross/\$30,000.00 net
 - (ii) Eliminate Social Development Strategy April 1 - \$25,000.00 gross/net
 - (b) referred to the Grants Sub-Committee and the Budget Advisory Committee for consideration the issue of including \$625,000.00 net in the Community Services Grants Program budget, such amount arising from the recommendations contained in the Food and Hunger Action Committee Phase II Report pertaining to the Community and Neighbourhood Services Department;

(VII) Social Services:

- (a) recommended to the Budget Advisory Committee:
 - (i) the recommended 2001 Operating Budget for Social Services, subject to reducing such budget by a total of \$4,450,000.00 gross and \$4,708,800.00 net, as follows:

 associated reduction in GTA Pooling
 Revenues of \$0.4 million
 (as recommend in (ii) below) \$2,700,000.00 net

- (b) requested the Commissioner of Community and Neighbourhood Services to report to the Budget Advisory Committee on the most up-to-date caseload estimate available as of the end of March 2001, prior to the final decision being made on the 2001 Operating Budget Ontario Works Caseload; and
- (c) requested the Commissioner of Community and Neighbourhood Services to report to the Community Services Committee, once issues relating to the transition to the BTP System have been addressed, on the advisability and opportunity to consolidate the 14 local offices into 5 to 10 local offices, such report to include the potential cost-savings.

On motion by Councillor Pitfield, the Budget Advisory Committee received the aforementioned communication for information.

10.3 Homes for the Aged - 2001 Operating and Capital Budgets

The Budget Advisory Committee, during its deliberations, had before it the recommended 2001 Operating and Capital Budgets for Homes for the Aged.

Operating

Councillor Shiner appointed Councillor Sutherland Acting Chair and vacated the Chair.

- A. Councillor Shiner moved that the Budget Advisory Committee recommend to the Policy and Finance Committee, and Council, the adoption of the 2001 Operating Budget for Homes for the Aged, as recommended by the Community Services Committee, subject to:
 - (1) reducing the net budget by \$1,113,800.00 to reflect additional revenue from the Stabilization/Increase in Provincial Funding to result in a zero percent increase; and
 - (2) City Council requesting the Province to pay their fair share of the 80/20 funding that is due to the City, estimated at \$10 million.

(Carried)

Councillor Shiner resumed the Chair.

Capital

- B. Councillor Sutherland moved that the Budget Advisory Committee recommend to the Policy and Finance Committee, and Council, the following:
 - (1) the adoption of the 2001 Capital Budget of \$12,500,000.00 gross and \$11,500,000.00 net;
 - (2) that the proposed Scarborough Southwest Home for the Aged Project be deferred until 2002;
 - the new debt service costs, as outlined in Appendix A, (3) totalling \$2.861 million by 2006, resulting from the approval of the 2001-2005 recommended capital program with incremental operating budget impacts \$0.158 million in 2001, million in \$0.649 2002, \$0.627 million in 2003, \$0.737 million in 2004. \$0.410 million in 2005, and \$0.280 million in 2006, be approved for inclusion in the 2001 future operating budgets, such recommendation to be amended to reflect only the 2001 budget with future year commitments as recommended by the Budget Advisory Committee;

- (4) the new Operating Budget savings, as outlined in Appendix A, totalling \$0.363 million in 2005, resulting from the approval of the 2001-2005 recommended capital program, with incremental operating budget impacts of \$0.171 million in 2001, and \$0.341 million in 2002, and savings of \$0.031 million in 2003, \$0.844 million in 2004, and no impact in 2005, be approved for inclusion in the 2001 and future operating budgets, such recommendation to be amended to reflect only the 2001 budget with future year commitments as recommended by the Budget Advisory Committee;
- (5) for the purpose of establishing a spending control, the recommended 2001-2005 capital program for the Homes for the Aged, with a total cash flow of \$55.073 million with a cash flow of \$12.5 million in 2001, \$21.763 million in 2002, \$14.554 million in 2003, \$3.819 million in 2004, and \$2.437 million in 2005, as outlined in Appendix D, be approved, such recommendation to be amended to reflect only the 2001 budget with future year commitments as recommended by the Budget Advisory Committee; and
- (6) the two previously approved projects from the 1998 and prior capital program, as outlined in Appendix E, be closed.

(Carried)

C. Councillor Soknacki moved that the Budget Advisory Committee recommend to the Policy and Finance Committee, and Council, that City Council be requested to direct the Commissioner of Corporate Services not to declare the property for the proposed Home for the Aged as surplus for municipal purposes until after April 1, 2002, and to consider this parcel of land as the City's contribution for a long term care facility.

(Carried)

Councillor Shiner appointed Councillor Sutherland Acting Chair and vacated the Chair.

D. Councillor Shiner moved that the Budget Advisory Committee recommend to the Policy and Finance Committee, and Council, the following:

- (1) that staff and the architects be advised that the approved Capital Budget for Homes for the Aged is a maximum budget for 2001 and to make sure that the plans proceed within the envelope provided;
- (2) the future year Homes for the Aged Maintenance Program (2002-2005) with a total project cost of \$8.5 million as outlined in Appendix B, be received and the Commissioner of Community and Neighbourhood Services be requested to submit the maintenance plan, prior to September 2001 to the Community Services Committee; and
- (3) the Commissioner of Community and Neighbourhood Services be requested to report to the Community Services Committee on:
 - (a) methods to mitigate the operating impacts of the reconstruction of True Davidson Acres and Albion Lodge;
 - (b) finding a cost-effective alternate site suitable for residents of True Davidson Acres during the reconstruction of the facility; and
 - (c) options with respect to the vacated Albion Lodge and the possibility of turning it into a Supportive Housing Facility once the relocation is completed.

Councillor Shiner resumed the Chair.

10.4 Toronto Atmospheric Fund - 2001 Operating Budget

The Budget Advisory Committee, during its deliberations, had before it the recommended 2001 Operating Budget for the Toronto Atmospheric Fund.

On motion by Councillor Chow, the Budget Advisory Committee recommended to the Policy and Finance Committee, and Council, the adoption of the 2001 Toronto Atmospheric Fund of \$1,830,100.00 gross and \$0 net, subject to:

- (1) the Chief Administrative Officer, in consultation with the President of the Toronto Atmospheric Fund (TAF) and the Chief Financial Officer and Treasurer, be requested to report to the Policy and Finance Committee, prior to October 1, 2001, on a review of the financial and the organizational structure of TAF with a view to determining the most efficient means to achieve the objectives of TAF; such report to include a breakdown of the activities of TAF into major components, and to tabulate the requirements for:
 - (a) level of investment;
 - (b) staffing; and
 - (c) potential for partners or additional investors; and
- (2) if there are savings to TAF as a result of the City Solicitor's report, to examine reducing costs by using the City's legal staff instead of TAF's reliance on outside legal services, TAF and the City Solicitor are requested to:
 - (a) implement changes to minimize costs as expeditiously as possible; and
 - (b) transfer the full costs of such legal services from TAF to the City Solicitor.

10.5 Social Development and Administration - 2001 Operating Budget

The Budget Advisory Committee, during its deliberations, had before it the recommended 2001 Operating Budget for Social Development and Administration.

Councillor Shiner appointed Councillor Sutherland Acting Chair and vacated the Chair.

On motion by Councillor Shiner, the Budget Advisory Committee:

- (1) recommended to the Policy and Finance Committee, and Council, that the recommended 2001 Operating Budget for Social Development and Administration be adopted, in the amount of \$15,049,000.00 gross and \$8,072,600.00 net, subject to:
 - (i) Eliminate contracted desktop services
 March 1 \$60,000.00 gross/\$30,000.00 net
 - (ii) Eliminate Social Development Strategy April 1 - \$25,000.00 gross/net

- (2) received Recommendation (VI) (b), embodied in the report (February 26, 2001) from the City Clerk, under the heading "Social Development and Administration", relating to the Food and Hunger Action Committee Phase II report; and
- (3) deferred consideration of the Squeegee Working Youth Mobilization Program to the Budget Advisory Committee wrap up meeting pending a report from the Commissioner of Community and Neighbourhood Services on potential Federal funding enhancements under the SCPI program.

Councillor Shiner resumed the Chair.

10.6 Children's Services - 2001 Operating and Capital Budgets

The Budget Advisory Committee, during its deliberations, had before it the recommended 2001 Operating and Capital Budgets for Children's Services.

The Budget Advisory Committee also had before it the following communications:

- (a) (October 16, 2000) from the City Clerk advising that City Council on October 3, 4 and 5, 2000, and at its Special Meetings held on October 6, 10, 11 and 12, 2000, forwarded to the Policy and Finance Committee and to the Budget Advisory Committee for consideration during the 2001 Operating Budget process, Clause No. 36 of Report No. 12 of The Policy and Finance Committee, headed "A Strategy for Implementing the Child Care Funding Approved in the 2000 Operating Budget";
- (b) (February 21, 2001) from Mr. Ron Marion, Chair, Le Conseil scolaire de district du Centre-Sud-Ouest, expressing concern regarding reductions that the City of Toronto might be considering in the area of daycare subsidies; and
- (c) (February 22, 2001) from Ms. Cindy McCarthy, Executive Director, Terry Tan Child Centre, expressing concern regarding the proposed cuts to the Children's Services Budget.

Councillor Shiner appointed Councillor Sutherland Acting Chair and vacated the Chair.

Operating

- A. Councillor Shiner moved that the Budget Advisory Committee recommend to the Policy and Finance Committee, and Council, that the recommended 2001 Operating Budget for Children's Services of \$285,698,300.00 gross and \$56,697,600.00 net be adopted, subject to:
 - (1) reducing such budget by a total of \$14,596,400.00 gross, and \$320,000.00 net, as follows:
 - (a) deferring the implementation of the "early leader" in the Early Childhood Education Development and Care Pilot Project until September 2001 \$600,000.00 gross, \$0.0 net;
 - (b) deferring for one year the 2000 subsidy space expansion \$13,676,400.00 gross, \$0.0 net; and
 - (c) deferring for one year the contribution to the Child Care Capital Reserve Fund, approved by Council as part of the City of Toronto Daycare Grant being eliminated in 2001 \$320,000.00 gross, \$320,000.00 net;
 - (2) increasing such budget by a total of \$4,333,000.00 gross and \$866,700.00 net, as follows:
 - (a) payment of actual cost to licensed child care providers Phase II equity in teaching staff rates and provider rates \$3,333,000.00 gross and \$666,700.00 net;
 - (b) funding for paying the actual cost of running Child Care Centres being conditional upon the Province providing 80 percent of the gross cost, with no commitment to City funding in future years;

- (d) expansion of family resource programs better equity of funding across the City \$500,000.00 gross and \$100,000.00 net; and
- (3) the approval, in principle, of those recommendations without financial implications contained in the report, entitled "Children and Youth Action Committee Action Plan 2001" and in the joint communication dated February 7, 2001, from Councillor Pam McConnell and Councillor Olivia Chow;
- (4) reducing the Case Workers Client Services from 10 to 5 FTE's for a savings of \$271,100.00 gross and \$135,550.00 net; and
- (5) the Commissioner of Community and Neighbourhood Services be requested to seek additional funds amounting to \$29.3 million from the Province for the shortfalls in funding of the Child Care Program:
 - (a) user fees revenue;
 - (b) rent to School Boards;
 - (c) additional download program by the Province consisting of wage subsidy, special needs resourcing, resource centres, approved corporations and integration (from cost share of 87:13 to 80:20); and
 - (d) change in cost sharing for the child care administration from 80:20 to 50:50.

 - (2) receive the aforementioned report and communications (a) to (c) for information.

10.7 Social Services - 2001 Operating Budget

The Budget Advisory Committee, during its deliberations, had before it the recommended 2001 Operating Budget for Social Services.

(6) the City's contribution of \$2.735 million for 2,000 additional child care spaces from the Social Services Stabilization Reserve Fund towards the gross cost of \$13,676 million be contingent on 80 percent Provincial funding of \$10.941 million, with no commitment of further City funding from the Social Services Stabilization Reserve Fund for subsequent years.

 - (iv) 85 percent of trips provided by accessible vehicles comprised of 132 buses and 62 accessible taxis;
 - (v) overall vehicle productivity improvement to 5.1 passengers per hour through major initiatives such as:
 - (A) introduction of a trial Express Bus Service from Scarborough Town Centre to the downtown core;
 - (B) expanded areas covered by Zone Service;
 - (C) increased integration with conventional Toronto Transit Commission accessible services; and
 - (D) efforts directed at reducing trip cancellations;

- (vi) overall service quality improvement as measured by 'on-time' delivery of service to 95 percent through major initiatives such as:
 - (A) implementation of a 25 bus tracking trial directed at improving 'same day' service delivery;
 - (B) introduction of an automated 'call-back' feature to update customers on trip status; and
 - (C) updates to the computer scheduling system (WTIS);
- (vii) continue to accommodate original requested trip times within +30 minutes at 96 percent;
- (viii) improved specialized transit service co-ordination with Greater Toronto Area;
- (viv) new Overland economical low-floor (ELF) buses available for service increase to 104 improving vehicle reliability and reducing maintenance costs; and
- (vv) no increase in workforce;
- (3) consider this report in concert with the following:
 - (i) the 2001 Toronto Transit Commission Operating Budget; and
 - (ii) 2001-2005 Toronto Transit Commission Capital Program which includes \$7.2M for Wheel-Trans of which \$6.3M is allocated to the Orion bus replacement program for the purchase of 30 low-floor ELF buses, and \$0.9M for improved scheduling and service continuity; and
- (4) forward this report to City Council for approval and to the Toronto Transit Commission's Advisory Committee on Accessible Transportation for information;".
 - A. Councillor Soknacki moved that the Budget Advisory Committee recommend to the Policy and Finance Committee, and Council, that the 2001 Wheel-Trans budget be adopted at \$44,946.9 million gross and \$42,777.8 million net.

 - (4) the Commission communicate to the Budget Advisory Committee that the Commission's 2001 budget is based on Council's previous direction of an 80/20 operating subsidy for the Toronto Transit Commission;
