14.1 Toronto Housing Company - 2001 Operating Budget

The Budget Advisory Committee, during its deliberations, had before it the recommended 2001 Operating Budget for Toronto Housing Company.

The Budget Advisory Committee also had before it the following communications:

- (a) (March 1, 2001) from Dr. John Metson, President, Toronto Housing Company Inc., advising that the Board of Directors, Toronto Housing Company, at its meeting held on February 26, 2001, adopted, as amended, the report (February 21, 2001) from the Chief Executive Officer, recommending that:
 - (1) the Board of Directors review and comment on the budget reduction proposals contained in the report;
 - (2) the CEO be requested to convey the Board of Directors comments to the Budget Advisory Committee at the meeting of February 28, 2001; and
 - (3) the CEO and President of the Board of Directors advise the Budget Advisory Committee, that the Board recognizes that the City is under financial pressure and feels that the Toronto Housing Company has met those pressures; and while there may be opportunity for further savings in the future, the savings outlined in the report to the Budget Advisory Committee, may not be the best process at this time and that any budget decisions affecting the Toronto Housing Company only be undertaken once decisions are taken by Council related to integration and governance of MTHC/THC;
- (b) (February 27, 2001) from the Chief Executive Officer, Toronto Housing Company, providing, as requested, additional information respecting the Toronto Housing Company; and
- (c) (March 20, 2001) from Mr. Brian Cochrane, President, Mr. Joseph Lyttleton, Executive, Mr. Ken Morland, Vice-Chair, Ms. Pat Milana, Chair, Toronto Civic Employees' Union, Local 416, commenting on the budget reductions for the Metro Toronto Housing Company.

On motion by Councillor Chow, the Budget Advisory Committee:

(1) recommended to the Policy and Finance Committee, and Council, the adoption of the 2001 Operating Budget, as presented;

- (2) requested the Chief Executive Officer of the Metropolitan Toronto Housing Corporation, to report to the Budget Advisory Committee on the financial impact of the recycling initiative on the 2002 Operating Budget, such report to be forwarded to the Works Committee for information; and
- (3) received the aforementioned communications (a) to (c) for information.

14.2 Toronto Public Library - 2001 Operating and Capital Budgets

The Budget Advisory Committee, during its deliberations, had before it the recommended 2001 Operating and Capital Budgets for the Toronto Public Library.

The Budget Advisory Committee also had before it the following reports and communications:

- (a) (February 28, 2001) from the City Librarian reporting, as requested by the Budget Advisory Committee at its meeting held on February 9, 2001, on the breakdown of costs between the Malvern Library component and the theatre component of the project, and the cost per square foot to operate the current library versus the projected cost once renovated; and recommending that this report be received for information;
- (b) (March 23, 2001) from the City Librarian providing, as requested, information regarding the 2001 Operating and Capital Budgets for Toronto Public Library;
- (c) (February 22, 2001) from the Commissioner of Economic Development, Culture and Tourism providing information on the proposed Malvern Community Threatre study; and recommending that this report be received for information; and
- (d) (March 23, 2001) from Mr. Brian Cochrane, President, Toronto Civic Employees' Union Local 416 CUPE, in support of no cuts being made to the Toronto Public Library budget.

 - (b) use in Capital and Operating budgets for maintenance and repair programs.

- C. Councillor Chow moved that the Budget Advisory Committee:
 - (1) request the City Librarian to report to the Budget Advisory Committee wrap up meeting on the four locations relating to the 'Leading to Reading' Program and the 23 locations for 'Children's After School' Program;
 - (2) request the City Auditor to report to the Budget Advisory Committee prior to the 2002 budget deliberations, providing a review of the Library:
 - (a) end of year spending;
 - (b) fleet maintenance and usage; and
 - (c) management structure;

- (3) recommend to the Policy and Finance Committee, and Council, that \$342,000.00 be added back for the Teen Zone Proposal; and
- (4) recommend to the Policy and Finance Committee, and Council, the adoption of Option 1, which allows only for the contract negotiated increases and the annualization of Sunday Services, bringing the reduction to \$2.72 million and 5.2 FTE's.

14.3 Economic Development, Culture and Tourism 2001 Capital Program

The Budget Advisory Committee had before it a report (March 6, 2001) from the City Clerk advising that the Economic Development and Parks Committee at its meetings held on February 16, 26 and March 2, 2001, reviewed the 2001 Capital Program for the Economic Development, Culture and Tourism Department and recommended to the Budget Advisory Committee:

(1) the adoption of the 2001 Capital Program for the following Divisions:

Culture Division:

As presented, subject to the following:

- (a) the Maintenance of Outdoor Public Art Program being reduced by 30 percent to \$124,500.00 in 2001 only;
- (b) the Market Gallery refurbishment and rehabilitation project being deferred to 2002;
- (c) the Restoration of the Morrish Store being reduced to \$175,000.00 in 2001 and the balance of \$75,000.00 being deferred for inclusion in the 2002 submission;
- (d) the Todmorden Mills Papermill Retrofit Project being reduced to \$233,000.00 with the remaining \$233,000.00 being deferred for consideration in 2002;
- (e) the Conservation and Collection Program being reduced by 50 percent to \$52,500.00; and the balance of \$52,500.00 being deferred to 2002; and
- (f) the Fort York Restoration Project being reduced to \$127,500.00 in 2001 and \$127,500.00 in 2002.

Economic Development Division:

As presented, subject to the following:

- (a) the BIA Streetscape Improvement Program being reduced by \$100,000.00;
- (b) the Employment Area Revitalization Program being reduced by \$100,000.00;
- (c) funding for the Commercial Façade Project being reinstated at \$425,000.00 for 2001, and the Commissioner of Economic Development, Culture and Tourism being requested to work within this funding envelope; and
- (d) the Banner and Mural sub-project being reinstated as part of the Employment Area Revitalization Project at \$25,000.00 for 2001.

Parks and Recreation Division:

As presented, subject to the following:

- (a) the following Capital Budget Projects being reduced by 10 percent:
 - (i) Playground Rehabilitation Program (\$150,000.00);
 - (ii) Various Park Rehabilitation Programs (\$130,000.00); and
 - (iii) Corvette Park Waterplay Area (\$25,000.00);
- (b) the following projects being deferred until 2002:
 - (i) Fairbank Community Centre Addition (\$550,000.00);
 - (ii) Fairfield Seniors Centre gym expansion (\$275,000.00);
 - (iii) Masaryk Cowan Community Centre Storage Cabinet and Renovations to Weight Room (\$75,000.00);
 - (iv) Agincourt Tennis Fieldhouse Painting (\$120,000.00); and
 - (v) Ashtonbee Park Fieldhouse construction (675,000.00);
- (c) the St. Jamestown Recreation Centre Project being approved for a total project cost of \$10 million gross and net with a cash flow of \$1 million in 2001, \$6 million in 2002, and \$3 million in 2003, noting that the Economic Development and Parks Committee be informed if any additional third party funding is received for this project;

- (d) the \$1.962 million in the reserve account for community centres being used specifically for start up costs for the south east quadrant of the City in the vicinity of Eglinton Avenue/Black Creek for a community centre facility in 2001, subject to the Commissioner of Economic Development, Culture and Tourism reporting to the Budget Advisory Committee on the availability of such reserve funds for this project;
- (e) the \$150,000.00 for the East Point Park Regrade Soccer Field being reallocated to the Port Union Skateboard Park Repairs in 2001;
- (f) the Dundonald Parkette renovation being added to the 2001 budget at a cost of \$300,000.00 gross and zero net;
- (g) the Murison Park Relocation Project being accelerated to 2001 from 2003 in the amount of \$369,000.00; and
- (h) consideration being given to accelerating the Martin Goodman Trail Maintenance Sub-Project to 2002.

14.4 Economic Development, Culture and Tourism 2001 Operating Budget

- (b) (February 14, 2001) from Councillor Irene Jones, Ward 6 Lakeshore-Queensway, forwarding correspondence from The Honourable Charles Caccia, M.P., regarding the replacement of lead and iron pipes existing in Toronto;
- (c) (February 21, 2001) from the Secretary, Board of Health, advising that the Board of Health on February 19, 2001, recommended that:
 - (1) in order to accommodate the City's financial pressures while minimizing the longer term impacts on programs and services, the 2001 Public Health Operating Budget Submission be reduced as noted below:
 - (a) withdrawal of the budget increase to annualize CYAC initiatives for childhood dental decay prevention (\$21,000.00 gross/net) and mental health promotion (\$124,000.00 gross/\$62,000.00 net);
 - (b) deferral of the budget increase to annualize the Raccoon Rabies control program (\$91,100.00 gross/\$45,500.00 net);
 - (c) withdrawal of budget increase to re-design the courier service (\$22,300.00 gross/\$0 net);

 - (b) eliminating the City's non-mandatory public health dental treatment program (\$5,200,000.00 gross/net);
 - (c) eliminating nursing assessment and referral services for vulnerable adults and seniors (\$931,200.00 gross/\$465,600.00 net);
 - (d) reducing sexual health clinic staffing levels to the provincial minimum (\$205,400.00 gross/\$102,700.00 net);

- (e) eliminating purchase-of-service agreements with community agencies for sexual health promotion and HIV risk reduction (\$675,000.00 gross/\$337,500.00 net);
- (f) eliminating provincially mandated programs for Injury Prevention and Substance Abuse Prevention among seniors (\$273,000.00 gross /\$136,500.00 net); and
- (g) reducing public health inspection services for "demand" calls, such as investigation of potential health hazards, response to information requests and concerns from Councillors and community members, and review of site plan and licensing applications (\$1,051,200.00 gross /\$525,600.00 net);

AND BE IT FURTHER RESOLVED THAT the City support the transition to direct City-wide delivery as a priority by:

- (1) assisting with procurement of suitable facilities and the necessary IT infrastructure and support to meet service delivery needs and IT support; and
- (2) providing the required operational and one-time start-up costs.";
- (e) (February 21, 2001) from the Secretary, Board of Health, advising that the Board of Health on February 19, 2001, recommended that:
 - (1) a four-year phased-in enhancement to the Toronto Public Health TB Control Program be endorsed in principle;
 - an additional \$567,000.00 gross/\$283,500.00 net in 2001 (including a one-time cost of \$30,600.00) along with an additional \$503,300.00 gross/\$251,600.00 net for the annualization in 2002, to implement the first phase of the TB Control Program enhancement as contained in the Toronto Public Health 2001 Operating Budget submission be approved;
 - (3) the City of Toronto strongly urge Citizenship and Immigration Canada (CIC) to strengthen its medical surveillance system to identify TB cases in refugees and new immigrants to Canada, in consultation with Toronto Public Health and other key stakeholders; and
