The Economic Development and Parks Committee reconvened its meeting on Friday, March 2, 2001, at 1:15 p.m.

Parks and Recreation Operating Budget:

  - (3) \$400,000.00 be reinstated for the annualization of the 2000 recommendations for the Children's Report Card Program; and

- (5) the operating impact of Capital projects be deferred to 2002 \$700,000.00 gross and net;

- (7) collective agreement reductions through alternative mechanisms \$430,000.00 gross and net;
