Confirmation of Minutes

On motion by Councillor Augimeri, the Minutes of the Economic Development and Parks Committee meetings held on February 12, 16, 26 and March 2, 2001, were confirmed.

5.1 Toronto Financial Services Cluster Review (City Wide)

The Economic Development and Parks Committee had before it a report (March 7, 2001) from the Commissioner of Economic Development, Culture and Tourism presenting the findings of the Economic Development Division's review of the Financial Services Cluster (FS), which recognizes Toronto's role as the Financial Services Centre of Canada, identifies the challenges facing the industry, recommends strategic directions for encouraging the further growth of the cluster and a process for implementation; and recommending that:

- (1) the Federal and Provincial Ministers of Finance and Economic Development be requested to formally recognize Toronto as Canada's Financial Services Centre given the concentration of the nation's financial services businesses that are located in the City;
- (2) Council endorse the Economic Development strategies related to the marketing and promotion, business development, advocacy, competitive intelligence and human resource development of the Financial Services sector as outlined in detail in the Financial Services Cluster Review (Attachment No. 1);
- (3) the Commissioner of Economic Development, Culture and Tourism be requested to establish a Financial Services Cluster Alliance comprising industry, government, and educational leaders to review and advise on the implementation of the strategic directions in the report;
- (4) the Commissioner of Economic Development, Culture and Tourism be requested to report on the mandate and composition of the Alliance and that the Alliance be requested to report back to the Economic Development and Parks Committee on an action plan outlining priority activities and partnership opportunities;
- (5) Council endorse the requirement of financial institutions to undertake a Community Impact Assessment to determine the impacts of local bank branch closures when they are considering a merger; and
- (6) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

The Economic Development and Parks Committee also had before it a communication (March 26, 2001) from Mr. Raymond J. Protti, President and Chief Executive Officer, Canadian Bankers Association, acknowledging the important work of the Economic Development and Parks Committee and the Economic Development Division of the City of Toronto, which led to the release in July 2000 of the City of Toronto's Economic Development Strategy.

The following persons appeared before the Economic Development and Parks Committee in connection with this matter:

On motion by Councillor Moeser, the Economic Development and Parks Committee recommended to Council the adoption of the aforementioned report.

5.2 Maurice Cody Millennium Playscape Proposal (Ward 22 St. Paul's)

The Economic Development and Parks Committee again had before it a report (January 16, 2001) from the Commissioner of Economic Development, Culture and Tourism providing information on the process for determing the eligibility of funding under the City's Joint School Playground Program for the Maurice Cody Public School Family and School Association's playscape proposal; and identifying other possible sources of funding; and recommending that:

- (1) the Family and School Association of the Maurice Cody Public School be advised to contact the Manager of Standards, Compliance and Environment for the Toronto District School Board to determine their eligibility as a priority proposal under the Joint School Playground Program; and
- (2) the Family and School Association contact the Toronto Atmospheric Fund who provide support and funding for Toronto-based community projects through Cool Schools 2001; a program which provides funding for school improvements which promote solutions to climate change and air pollution.

The Economic Development and Parks Committee also had before it during consideration of the foregoing matter the following communications:

(a) (December 11, 2000) from Councillor Michael Walker, Ward 22 St. Paul's, requesting that the Commissioner of Economic Development, Culture and

Tourism report on the feasibility of providing a matching grant to the Maurice Cody Millennium Playscape Proposal, such report to include the source of funding; and

(b) (February 5, 2001) from Ms. Ellen Valleau, President, Maurice Cody Family and School Association, advising that the Maurice Cody Playscape has received further funding of \$22,775.00 from the Health and Safety Fund, City of Toronto Children's Services Division, bringing the total funds committed to \$76,775.00.

 - A. Councillor Mammoliti moved that the Economic Development and Parks Committee recommend to Council that the remaining \$25,000.00 in the Joint School Playground Program be applied to the Maurice Cody Playground project, subject to the Toronto School Board and/or the community matching said funds; and further that if such matching funds are not available, the monies be reinstated in the Joint School Playground Account.

B. Councillor Filion moved that the Commissioner of Economic Development, Culture and Tourism be requested to report to the Economic Development and Parks Committee meeting to be held on May 14, 2001, on the feasibility of a Joint Playground Program with the Toronto District School Board and the Toronto District Catholic School Board based on the concept of resources being pooled to better meet the needs of some neighbourhoods.

5.3 Harmonized Municipal Alcohol Policy (All Wards)

The Economic Development and Parks Committee had before it a joint report (March 7, 2001) from the Commissioner of Economic Development, Culture and Tourism and the Medical Officer of Health forwarding, for Council's consideration, a draft harmonized Municipal Alcohol Policy (MAP); which will apply to all Special Occasion Permit events held on City-owned locations, and to any event for which the City is the Special Occasion Permit holder; and recommending that:

- (1) Council adopt the harmonized Municipal Alcohol Policy as outlined in Attachment No. 1;
- (2) the harmonized Municipal Alcohol Policy not come into effect until six months after the date of Council's approval in order that implementation measures identified in Attachment No. 3 may be carried out;
- (3) the existing Municipal Alcohol Policies of the former municipalities remain in effect during the six-month period noted in Recommendation No. (2) above;
- (4) the harmonized Municipal Alcohol Policy be forwarded to all City agencies, boards and commissions for their information, and that Council recommend to all agencies, boards and commissions that they give consideration to adopting policies respecting alcohol risk management; and
- (5) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

On motion by Councillor Moeser, the Economic Development and Parks Committee recommended to Council the adoption of the aforementioned joint report, subject to amending Item No. D4 of the "Food and Beverage Requirements", embodied in the proposed Harmonized Municipal Alcohol Policy, to read as follows:

"4. There must be no beer, wine-based cooler or spirit-based cooler products available that are greater than 5.6 percent alcohol by volume."

5.4 Tourism Sector Development and Destination Marketing Services (All Wards)

The Economic Development and Parks Committee had before it a report (March 7, 2001) from the Commissioner of Economic Development, Culture and Tourism, providing a profile of the tourism cluster; reviewing City-based tourism development and marketing activities; making recommendations on Tourism Toronto's 2001 Budget; and recommending that:

- (1) the composition of Team Tourism be expanded so that all Departments are represented on the inter-departmental team for the purpose of co-operatively addressing tourism issues, development and marketing opportunities;
- (2) Tourism Toronto be requested to provide tourist information services at City Hall from June 1 to September 4, 2001;
- (3) the funding provided to Tourism Toronto for contracted destination marketing services be reallocated from the Grants Program to the Economic Development program;
- (4) Tourism Toronto continue to receive the same level of funding provided in 2000, \$4.231 million, for the provision of destination marketing services, and that the Committee's recommendation be forwarded to the Budget Advisory Committee for consideration as part of the 2001 Operating Budget process;
- (5) Mayor Lastman be requested to meet with the Minister of Finance to pursue a harmonized sales tax, or visitor levy, to ensure that Toronto and Ontario does not continue to lose its market share of tourism activity; and
- (6) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

On motion by Councillor Moeser, the Economic Development and Parks Committee recommended to Council:

- (1) the adoption of the aforementioned report, subject to amending Recommendation No. (4) to read as follows:
 - "(4) consideration be given to Tourism Toronto continuing to receive the same level of funding provided in 2000, \$4.231 million, for the provision of destination marketing services, and that the Committee's recommendation be forwarded to the Budget Advisory Committee for consideration as part of the 2001 Operating Budget process;".

- (2) requested the Budget Advisory Committee to give consideration to the following recommendation:
 - "(4) consideration be given to Tourism Toronto continuing to receive the same level of funding provided in 2000, \$4.231 million, for the provision of destination marketing services, and that the Committee's recommendation be forwarded to the Budget Advisory Committee for consideration as part of the 2001 Operating Budget process;".

5.5 Toronto Business Outlook Survey 2000 (All Wards)

The Economic Development and Parks Committee had before it a report (March 7, 2001) from the Commissioner of Economic Development, Culture and Tourism, advising that the 2000 Toronto Business Outlook Survey has been completed; providing a copy of the findings; and recommending that:

- (1) the Commissioner of Economic Development, Culture and Tourism be directed to explore means to annualize the Business Outlook Survey and expand on the breadth/depth of information collected to assist in monitoring business trends and identifying issues of concern to employers in the City;
- (2) the Commissioner of Economic Development, Culture and Tourism be directed to circulate the survey findings to other City department to advise them of issues raised by the business community and relating to municipal services; and
- (3) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

On motion by Councillor Augimeri, the Economic Development and Parks Committee recommended to Council the adoption of the aforementioned report.

5.6 Tradelink Toronto and the National Trade Centre Trade Show Investment Marketing Program (Trinity-Spadina Ward 19)

The Economic Development and Parks Committee had before it a report (February 28, 2001) Commissioner of Economic Development, Culture and Tourism providing an overview of recent successes that Tradelink Toronto and The National Trade Centre (NTC) have had in attracting new trade shows to the NTC; advising that Economic Development staff and the management staff of the NTC will be embarking on a trade show investment marketing program with the support of the Federal Government under the Program for Export Development - Investment Program (PEMD-I) in 2001; and recommending that the Commissioner of Economic Development, Culture and Tourism report on the results of the trade show investment marketing program for the National Trade Centre (NTC) in December 2001.

On motion by Councillor Augimeri, the Economic Development and Parks Committee recommended to Council the adoption of the aforementioned report.

5.7 Revitalization of Employment Lands (All Wards)

The Economic Development and Parks Committee had before it a report (March 12, 2001) from the Commissioner of Economic Development, Culture and Tourism providing an update on the activities of City and Provincial staff in addressing the revitalization of employment lands, including brownfield sites in the City of Toronto, as directed by the Economic Development and Parks Committee; and recommending that:

- (1) the Commissioner of Economic Development, Culture and Tourism, in consultation with the Commissioner of Urban Development Services and the Chief Financial Officer and Treasurer, be requested to report to the Economic Development and Parks Committee on the applicability and implications of any new policies and implementation tools proposed by the Province for the revitalization of employment lands, including brownfield sites, within the City;
- (2) the Commissioner of Economic Development, Culture and Tourism and the Commissioner of Urban Development Services be requested to continue to work on identifying strategic reinvestment areas for employment revitalization to be included in the Official Plan;
- (3) the interdepartmental team be requested to participate in the Province's consultation process on Smart Growth; and

(4) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

The Economic Development and Parks Committee also had before it a communication (March 22, 2001) from Mr. David Pearce, President, Toronto Real Estate Board, expressing the Board's support of the recommendations contained in the aforementioned report.

On motion by Councillor Augimeri, the Economic Development and Parks Committee recommended to Council the adoption of the aforementioned report.

5.8 Culture Plan Progress Report – The Creative City Workprint (All Wards)

The Economic Development and Parks Committee had before it a report (March 8, 2001) from the Commissioner of Economic Development, Culture and Tourism, providing a progress report on the development of a Culture Plan for the City of Toronto; and recommending that:

- (1) the Creative City Workprint (Attachment No. 1) be received;
- (2) the Commissioner of Economic Development, Culture and Tourism be requested to conduct community consultations based on the Creative City Workprint to develop draft recommendations for the Culture Plan;
- (3) Council establish a Steering Committee chaired by the Chair of the Economic Development and Parks Committee and including two additional Councillors to guide development of the City of Toronto Culture Plan;
- (4) the Commissioner Economic Development, Culture and Tourism be requested to identify five key individuals in the creative industries to be appointed to the Culture Plan Steering Committee; and
- (5) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

On motion by Councillor Augimeri, the Economic Development and Parks Committee recommended to Council the adoption of the aforementioned report, subject to amending Recommendation No. (3) to read as follows:

"(3) Council establish a Steering Committee chaired by the Chair of Economic Development and Parks Committee; and further

Councillor Michael Prue and one additional Councillor be appointed to said Committee to guide the development of the City of Toronto Culture Plan."

5.9 Report on Proposal for Formula One Powerboat Race in the Inner Harbour (Ward 28 Toronto Centre-Rosedale and Ward 20 Toronto-Danforth)

The Economic Development and Parks Committee had before it a report (March 12, 2002) from the Commissioner of Urban Development Services outlining the terms and conditions for permission to hold a Formula One Powerboat Race in the Inner Harbour; and recommending that should City Council consent to permitting the Formula One Powerboat Race in the Inner Harbour on August 10, 11 and 12, 2001, such consent be conditional on the proponents (Power Events International and the Dock's Restaurant) entering into an Agreement with the City satisfactory to the City Solicitor, to secure the following matters:

- (a) the proponents receive and provide to the City written authorization from the Toronto Port Authority to hold the event; such authorization may be obtained upon written application to the Harbour Master and is to be approved in the form of a Permit which indicates the conditions relating to such authorization;
- (b) the proponents remove all floating docks and markers from the water immediately following the event;
- (c) the proponents submit to the Commissioner of Urban Development Services a satisfactory Master Operating Plan which includes details of the event, an event schedule, location and marking of racecourse(s), a Site Plan for all event related activity, a Transportation Plan and an Emergency Response and Security Plan;
- (d) the proponents submit to and have approved by Ambulance, Fire and Police Services an Emergency Response and Security Plan;
- (e) the proponents agree to pay for required ambulance, fire and police personnel;
- (f) the proponents submit to and have approved by the Commissioner of Works and Emergency Services a detailed Transportation Plan addressing issues including, but not limited to, traffic control, parking, and public transit provision;
- (g) the proponents agree to implement the measures and programs contained in the approved Transportation Plan and Emergency Response and Security Plan;
- (h) the proponents make application to the Commissioner of Works and Emergency Services for the temporary closing of Polson Street;

- (i) the proponents agree to provide maintenance personnel for garbage removal from public areas including Polson Street;
- (j) the proponents submit a General Review Commitment Certificate to the Chief Building Official for the erection of all viewing stands, announcing towers and any other temporary structures required for the event;
- (k) the proponents submit a Letter of Undertaking to the Chief Building Official agreeing to retain an architect or professional engineer for the general review of all work requiring building permits;
- (1) the proponents agree to clean-up any spill associated with the event to the satisfaction of the Ministry of Environment and the appropriate civic officials;
- (m) the proponents agree not to hold races or pre-race boat warmup prior to 8:00 a.m. or after 5:00 p.m.;
- (n) the proponents provide written notice of event scheduling to nearby film production studios; the proponents shall contact the Urban Development Services Department for the appropriate contact list;
- the proponents make application to the Commissioner of Economic Development, Culture and Tourism for a Parks Access Agreement permitting use of the Polson Street Park during the race event and abide by all terms and conditions of the permit application;
- (p) the proponents agree to repair all damages incurred to the Polson Street Park as a result of the race event activities;
- (q) the proponents, at their expense, take out and keep in full force and effect immediately prior to, during and after the race a comprehensive general liability insurance policy in the amount of \$10,000,000.00 per occurrence and property insurance for all property owned, leased or in control of the Docks Restaurant and Power Events International;
- (r) the proponents fully indemnify the City, its agents, employees, elected or appointed officials against any claim arising from or incidental to the race in a form satisfactory to the City Solicitor;

- (s) the proponents agree to ensure that at the start of each day of racing or the commencement of a race after a long period of delay, the race course and surrounding area be gently cleared of all waterbirds and, with the exception of the start/finish area, race boats stay clear of shoreline areas; and
- (t) all required approvals be received by the Commissioner of Urban Development Services no later than August 1, 2001.

On motion by Councillor Mammoliti, the Economic Development and Parks Committee recommended to Council the adoption of the aforementioned report.

5.10 Outer Harbour Sailing Federation -Licence Agreement Extension (Ward 30 Toronto-Danforth)

The Economic Development and Parks Committee had before it a report (March 12, 2001) from the Commissioner of Economic Development, Culture and Tourism respecting the extension of the term of the City's Licence Agreement with the Outer Harbour Sailing Federation, Water Rats Sailing Club, Toronto Boardsailing Club and the Hanlan Boat Club, to make the Agreement conterminous and consistent with the City's other boat club leases; and recommending that:

- (1) subject to the consent of the Toronto Port Authority as the owner of the lands, the term of the existing Licence Agreements between the City of Toronto and the Outer Harbour Sailing Federation, Water Rats Sailing Club, Toronto Boardsailing Club and Hanlan Boat Club be extended by four one year terms, to be renewed at the discretion of the City;
- (2) consent for the extension of the License Agreements be sought from the Toronto Port Authority as required under the City's lease for the lands; and
- (3) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

The Economic Development and Parks Committee also had before it the following communications:

- (a) (October 16, 2000) from Ms. Jane Stackhouse, Member of the Westwood Sailing Club;
- (b) (undated) from Ms. Leslie L. Barker, Member of the Toronto Winsurfing Club;

- (c) (October 16, 2000) from Dr. C. Cha, Member of the Westwood Sailing Club;
- (d) (September 13, 2000) from Mr. Jeff Yuill, P. Eng., Member of the St. Jamestown Sailing Club; and
- (e) (September 13, 2000) from Ms. Judy Baker, Member of the St. Jamestown Sailing Club.

On motion by Councillor Moeser, the Economic Development and Parks Committee recommended to Council the adoption of the aforementioned report.

5.11 Toronto Island Children's Amusement Area Lease Extension (Ward 28 Toronto Centre-Rosedale)

The Economic Development and Parks Committee had before it a report (March 12, 2001) from the Commissioner of Economic Development, Culture and Tourism respecting the extension of the existing leases held by William Beasley Enterprises for the Children's Amusement Area ("Centreville") at Toronto Island Park; and recommending that:

- (1) the Lease Indentures, as amended, dated February 23, 1966, March 30, 1970, and March 30, 1982, between the City of Toronto and William Beasley Enterprises Limited for the development and operation of a Children's Amusement Area at Toronto Island Park, and expiring on May 14, 2002, be amended as required and extended for a further ten one-year terms; and
- (2) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

Councillor Korwin-Kuczynski appointed Councillor Augimeri Acting Chair and vacated the Chair.

On motion by Councillor Korwin-Kuczynski, the Economic Development and Parks Committee recommended to Council the adoption of the aforementioned report, subject to amending Recommendation No. (1) to read as follows:

"(1) the Lease Indentures, as amended, dated February 23, 1966, March 30, 1970 and March 30, 1982, between the City of Toronto and William Beasley Enterprises Limited for the development and operation of a Children's Amusement Area at Toronto Island Park, and expiring on May 14, 2002, be amended as required in a form satisfactory to the City Solicitor and extended for a further ten one-year terms, subject to the resolution of any outstanding issues relating to the boundaries of the leased areas, and any other outstanding issues relating to the Children's Amusement Area, all to the satisfaction of the Commissioner of Economic Development, Culture and Tourism and the City Solicitor; and".

Councillor Korwin-Kuczynski resumed the Chair.

5.12 Civic Garden Centre Revitalization Plan (Ward 25 Don Valley West)

The Economic Development and Parks Committee had before it a report (March 7, 2001) from the Commissioner of Economic Development, Culture and Tourism respecting a revitalization proposal for the Civic Garden Centre; and recommending that:

- (1) Council approve, in principle, the Civic Garden Centre (CGC) Revitalization Plan as described in this report;
- (2) Council endorse the capital fundraising campaign to be undertaken by the Board of Directors of the CGC to revitalize the Centre and associated landscape;
- (3) Council authorize and direct the Commissioner of Economic Development, Culture and Tourism and the City Solicitor to negotiate and execute revisions to the management agreement for the CGC as outlined in this report;
- (4) staff consider the potential of the City's participation in the capital project for state of good repair items at the CGC as part of the 2002-2006 Capital Budget process pending the fundraising campaign by the Board of Directors of the CGC: and
- (5) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

Ms. Lindsay Dale Harris of the Civic Garden Centre Board of Directors appeared before the Economic Development and Parks Committee in connection with the foregoing matter, and filed a copy of her submission.

On motion by Councillor Augimeri, the Economic Development and Parks Committee recommended to Council the adoption of the aforementioned report.

5.13 Soccer Field Allocation Process – North District (Various Wards)

The Economic Development and Parks Committee had before it a report (March 7, 2001) from the Commissioner of Economic Development, Culture and Tourism respecting a process for a review of the issuance of permits for soccer fields in the former City of North York, as requested by the Economic Development and Parks Committee at its meeting of January 15, 2001; and recommending that:

- (1) the Parks and Recreation Division be directed to monitor and review the process of the issuance of soccer permits in the former City of North York and schedule a meeting of stakeholder groups to discuss the allocation of soccer fields in the North District; and
- (2) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

Councillor Nunziata appeared before the Economic Development and Parks Committee in connection with the foregoing matter.

On motion by Councillor Mammoliti, the Economic Development and Parks Committee recommended to City the adoption of the aforementioned report, subject to adding the following:

- (1) that the Members of Council who have an issue with respect to the allocation of soccer permits be invited to attend the stakeholders meeting to assist the Commissioner of Economic Development, Culture and Tourism with the review with regard to implementing a new policy for the issuance of permits for soccer fields; and
- (2) that the Commissioner of Economic Development, Culture and Tourism be requested to include in the forthcoming report with regard to this matter the issue of alcohol at soccer games and the time factor with respect to the conclusion of night games.

5.14 Appointments to Business Improvement Area Boards Of Management (All Wards)

The Economic Development and Parks Committee had before it a report (March 7, 2001) from the Commissioner of Economic Development, Culture and Tourism, appointing members to the Boards of Management of eight Business Improvement Areas; amending the former City of Toronto Municipal Code, Chapter 20, "Business Improvement Areas"

and Business Improvement Area by-laws of the former municipalities of East York, Etobicoke and York as necessary; and recommending that:

- (1) Council appoint the nominees listed in Attachment No. 1 of this report to the Boards of Management for Eglinton Hill, Junction Gardens, Little Italy, Pape Village, Queen Broadview Village, St. Lawrence Neighbourhood, Upper Village and Village of Islington Business Improvement Areas (BIAs) for the 2001-2003 term;

- (3) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.
