 - (ii) confirmation of the Fall 2001 and Winter 2002 aquatic programming schedule in TDSB pools by the City of Toronto; and
 - (iii) the capital and operating impacts of the potential TDSB pool closures;
 - (b) work closely for one year with the TDSB to communicate the impact of pool closures on 1.2 million participants in Toronto, and a public meeting be planned in the summer with Toronto swim clubs and affected users; and
 - (c) continue discussions with the TDSB to obtain information to identify the cost of pod maintenance and operation to serve as background data for discussion with the Province; and
- (2) the TDSB and the City of Toronto jointly approach the Province of Ontario regarding the education funding formula."

The following persons appeared before the Economic Development and Parks Committee in connection with the foregoing matter:

- Mr. Bruce Davis, School Trustee, Toronto District School Board;
- Councillor Sandra Bussin, Ward 32 Beaches-East York; and
- Councillor Frances Nunziata, Ward 11 York South-Weston.

- (3) the Commissioner of Economic Development, Culture and Tourism be requested to report, through the School Advisory Committee and the School Liaison Committee to the Economic Development and Parks Committee on the cost of doing business with the Toronto District School Board and long term savings, if any, the City could achieve by building recreation facilities and community centres in areas where no such facilities exist at the present time.

B. Councillor Moeser moved that Councillor Mammoliti's motion A.(1) be amended by adding thereto the following:

"that the appropriate City staff participate in a program and facilities audit with the Toronto District School Board at no cost to the City.".

Councillor Augimeri moved that the Commissioner of Economic Development, Culture and Tourism be requested to report, through the School Advisory Committee and the School Liaison Committee to the Economic Development and Parks Committee providing a detailed report on funding arrangements between the City and the Toronto District School Board, to include funding arrangements in the former municipalities of East York, Etobicoke, North York, Scarborough and Toronto.

Councillor Korwin-Kuczynski moved that Commissioner of Economic Development, Culture and Tourism be requested to report, through the School Advisory Committee and the School Liaison Committee to the Economic Development and Parks Committee as to whether the City should have any new future shared use agreements with the Toronto District School Board.

E. Councillor Cho moved that the Economic Development and Parks Committee recommend to Policy and Finance Committee, and Council, that the City support 50 percent of funding for the Toronto District School Board audit.
