Confirmation of Minutes.

2.2 The Path Ahead: A Report on the State of the City's Health – Toronto 2001.

The Board of Health had before it a report (January 9, 2001) from the Medical Officer of Health, providing an overview of the health of people in Toronto along with the issues, challenges and opportunities that face the Toronto Board of Health.

The Medical Officer of Health gave an overhead slide presentation with respect to the report on the State of the City's Health, 2001.

2.3 Capital and Operating Budget Requests for Toronto Public Health for 2001.

Mr. Lee Zaslofsky declared an interest with respect to that portion of the Toronto Public Health Operating Budget as it relates to sexual health clinics. The nature of the conflict being that he is a Board Member of the Hassle Free Clinic and is employed by the Aids Committee of Toronto.

The Board of Health had before it a report (January 15, 20001) from the Medical Officer of Health, identifying pressures on the base operating budget for Toronto Public Health in 2001, presenting the Public Health 2001 Capital and Operating Budget requirements, and outlining the need for additional resources required for Toronto Public Health to meet mandatory requirements and local health needs in specified priority program areas and recommending that:

- (1) the Board of Health adopt the 2001-2005 Public Health Capital Works submission and that the financial implications be considered by the Budget Advisory Committee through the 2001 budget process;
- (2) the Board of Health adopt the 2001 Public Health Operating Budget proposed by the Medical Officer of Health and that this submission be forwarded to the Budget Advisory Committee for consideration, including the following:
 - (a) Annualization of the costs of the Children and Youth Action Committee (CYAC) initiatives, Control of Infectious Diseases Program, the Raccoon Rabies Control Program, the Child Nutrition Program and Emergency Response, all at the service levels approved by Council in 2000, totalling \$3.2 million gross/\$1.6 million net;
 - (b) Public Health Information Technology costs for 2001 of prior year commitments totalling \$3.4 million gross/\$1.7 million net;
 - (c) The base changes in the approved 2000 Public Health Operating Budget associated with salary and other payroll increases resulting from new collective agreements and compensation policies for non-union staff and management totalling \$3.4 million gross/\$1.7 million net;
 - (d) Other base changes in existing programs totalling \$0.6 million gross/\$0.3 million net, including:
 - (i) Redesign of Courier Services
 - (ii) Program Support for Vaccine Preventable Diseases
 - (iii) Program Support for Communicable Disease Control, Healthy Environments and Family Health/Healthy Lifestyles
 - (iv) Communicable Disease Surveillance Unit Epidemiologist

- (v) Recruitment and Retention Incentives; and
- (vi) Information Technology Leasing of New Computers/Printers;
- (e) Funding for program expansion involving Council directed initiatives, service harmonization and increased demand, totalling \$4.3 million gross/\$1.4 million net, including:

 - (ii) Preschool Speech & Language
 - (iii) Cold/Hot Weather Alert
 - (iv) Animal Services
 - (v) Retirement Homes
 - (vi) ETS By-law Enforcement

- (f) New Services in response to local health needs and provincially mandated requirements totalling \$6.9 million gross/\$2.3 million net, including:

- (3) the Board of Health endorse the priority ranking of budget proposals as recommended by the Medical Officer of Health;
- (4) the Chief Financial Officer confirm the availability of funds from the Transition budget for the completion of RDIS amalgamation and report back through the 2001 budget process;
- (5) the Commissioners of Community and Neighbourhood Services, Corporate Services and Finance resolve outstanding issues related to interdepartmental

charges, including but not limited to the coverage of information technology mainframe costs, and report back through the 2001 budget process; and

(6) the Medical Officer of Health report back on the impact of additional revenue generation for non-mandatory public health inspection services if provided on a full cost recovery basis.

The Board of Health also had before it the following communications:

- (i) (January 12, 2001) from the Committee Secretary, Board of Health, Budget Subcommittee, recommending that the Toronto Public Health 2001 Capital and Operating Budget submissions be referred to the Board of Health for its endorsement, and that corporate information and technology support for public health services be reaffirmed as a high priority; and
- (ii) (October 6, 2000) from the Committee Secretary, Board of Health Tuberculosis (TB) Subcommittee, forwarding, for the Board's endorsement, a Resolution with respect to TB control and prevention.

The Medical Officer of Health gave an overhead slide presentation.

Councillor Mihevc appointed Councillor Prue Acting Chair, and vacated the Chair.

Councillor Mihevc moved that the Board of Health adopt the foregoing report from the Medical Officer of Health as amended by:

- (1) amending Recommendation No. (1) by:
 - (a) inserting the words "in principle" after the words "the Board of Health adopt";
 - (b) renumbering Recommendation No. (1) to 1(a) and adding the following new Recommendation No. (1)(b):

"the Board of Health adopt, in principle, the 2001 recommended Public Health Transition Capital Program for Toronto Healthy Environments Information system Phase II for \$1.154 million;";

- (2) amending Recommendation No. 2 by inserting the words "in principle" after the words "the Board of Health adopt"; and
- (3) adding the following new Recommendation No. (7):

"that this report be referred to the Board of Health Budget Subcommittee with the request that it review the priority ranking described in this report in concert with any reduction proposals contained in the Chief Administrative Officer's recommended budget and submit a report with respect thereto to the meeting of the Board of Health scheduled to be held on February 19, 2001."

Councillor Mihevc resumed the Chair.

- (5) requested the Commissioner of Community and Neighbourhood Services, the Commissioner of Corporate Services and the Chief Financial Officer and Treasurer to resolve outstanding issues related to interdepartmental charges, including but not limited to the coverage of information technology mainframe costs, and report back through the 2001 budget process;
 - (6) requested the Medical Officer of Health to report back on the impact of additional revenue generation for non-mandatory public health inspection services if provided on a full cost recovery basis; and
- (7) referred this report to the Board of Health Budget Sub-committee with the request that it review the priority ranking described in this report in concert with any reduction proposals contained in the Chief Administrative Officer's recommended budget and submit a report with respect thereto to the meeting of the Board of Health scheduled to be held on February 19, 2001.

2.4 Community Roundtable on Health September 11, 2000.

The Board of Health had before it a joint report (January 8, 2001) from Councillor Irene Jones and Mr. Lee Zaslofsky, reporting on the four Community Roundtables on Health held on September 11, 2000 and to recommend the integration of identified health needs into Divisional planning and the next steps to implementing an integrated model for community participation with the Board of Health; advising that there are no financial implications resulting from the adoption of this report and recommending that:

- (1) the Board of Health endorse this report and recommend the integration of the community identified health needs into Divisional planning;
- (2) the Board of Health approve in principle the establishment of an integrated model for community participation which includes community health boards, community roundtables, task forces and town halls;
- (3) the Board of Health establish a work group to finalize the model, determine mandate for the Community Health Boards and develop an implementation plan, to be presented at the next Board of Health meeting;
- (4) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

Councillor Filion suggested that there be more community participation.

Councillor Pitfield suggested that every effort be made to include tenants participation in instances where there are health concerns in their buildings.

On motion by Councillor Filion, the Board of Health adopted the foregoing report; and, further appointed Councillor Irene Jones, Mr. Brian Mackay, and Mr. Lee Zaslofsky to the work group in accordance with Recommendation No. (3).

The Board of Health also had before it a communication (October 16, 2000) from the City Clerk, Toronto Cycling Committee, recommending that the Board of Health endorse the communication (October 2, 2000) addressed to Premier Mike Harris from the Toronto Cycling Committee requesting air quality improvements in the City of Toronto.

On motion by Councillor Prue, the Board of Health received the foregoing report for information.

2.8 Air Quality and the Low Sulphur Fuel Purchasing Policy.

The Board of Health had before it a report (January 9, 2001) from the Medical Officer of Health, reporting on the success of the City's low sulphur fuel purchasing policy as a means to reduce air emissions that contribute to adverse health effect.

The Board of Health also had before it a communication (December 12, 2000) from the City Clerk, Toronto Cycling Committee, advising that the Toronto Cycling Committee, at its meeting held on December 4, 2000, requested the Board of Health to:

- (1) strongly urge the Government of Canada to:
 - (i) address the reduction of greenhouse gas emissions here rather than by trading for credits with third world countries. Canada is now among the world's biggest polluters. Citizens using cycles in Toronto feel most intensely the effects of the poor air quality, suffering burning throats and chests, and require the clean air in order to continue to efficiently cycle for recreation and transport, which creates a virtuous circle providing still more clean air;
 - (ii) put the health of citizens foremost the Board of Health has estimated that 1,000 citizens of Toronto die prematurely from the effects of smog each year and to take steps to control greenhouse gas emissions within Canada to meet the Kyoto targets; and
- (2) forward the concerns of the Toronto Cycling Committee to the Right Honourable Jean Chretian, P.C., M.P., and Mr. Lloyd Axworthy, Canada's representative to The Hague Conference, and to relevant government agencies and departments, for appropriate action.

On motion by Councillor Pitfield, the Board of Health:

- deferred consideration of the report (January 9, 2001) from the Medical Officer of Health to its meeting scheduled to be held on February 19, 2001; and
- (2) concurred with the request of the Toronto Cycling Committee embodied in the communication (December 12, 2000) from the City Clerk.

- (3) the Board of Health approve in principle the three-year budget plan as described in this report;
- (4) this report be forwarded to the Budget Advisory Committee for their consideration during the operating budget process;
- (5) this report be forwarded to the Sustainability Roundtable for information; and
- (6) the appropriate City Officials be authorized and directed to take the necessary action to give effect thereto.

- (1) the Board of Health recommend that City Council direct Toronto Public Health to enter into an agreement with Toronto Police Service to conduct reference checks on potential volunteers working directly with children; and
- (2) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

On motion by Councillor Pitfield, the Board of Health recommended to Council the adoption of the foregoing report.

2.11 Early Years Community Co-ordinators Initiative.

The Board of Health had before it a communication (September 25, 2000) from the Minister Responsible for Children, advising of the government's initiative to provide funding to Local Boards of Health, to recruit and to hire Early Years Community Co-ordinators; and advising that \$869,604.00 is provided to the Board of Health for the period October 1, 2000 to March 31, 2002.

The Board of Health also had before it a communication (October 26, 2000) from the City Clerk, forwarding, for information, Clause No. 4 contained in Report No. 7 of the Board of Health, headed "Early Years Community Co-ordinators initiative", which was adopted, as amended, by the Council of the City of Toronto at its regular meeting held on October 3, 4 and 5, 2000, and its Special Meetings held on October 6, 2000 and October

10 and 11, 2000 and October 12, 2000; and drawing the Board's attention to the amendment, by Council, at the beginning of the Clause.

2.12 75 Commissioners Street – Lease Provisions.
