## **Declarations of Interest Pursuant to the Municipal Conflict of Interest Act**

No Conflicts of Interest Pursuant to the Municipal Conflict of Interest Act were declared.

## 1.1. Introduction of Urban Development Services Staff

Councillor Pantalone welcomed the new members of the Planning and Transportation Committee and the Commissioner or Urban Development Services and staff from her department introduced themselves to Committee members.

## 1.2. Revised Organizational Structure for the Committee of Adjustment

The Planning and Transportation Committee gave consideration to a report (December 11, 2000) from Commissioner of Urban Development Services to constitute a Committee of Adjustment for the City of Toronto and recommend an organizational structure for the new Committee corresponding with the boundaries for the six Community Councils and recommending that:

- (1) The City Solicitor be directed to prepare for approval by City Council, a by-law:
  - (a) constituting one Committee of Adjustment for the City of Toronto, comprising a total of 30 members; and,
  - (b) delegating to the Committee of Adjustment the authority to hear minor variance applications pursuant to Section 45(1) of the Planning Act; and that authority be granted for the introduction of any necessary Bills in Council to give effect thereto;
- (2) City Council direct the City Clerk to begin the nomination process so Committee members may be appointed by Council on the nomination of Community Councils as soon as possible;
- (3) City Council adopt criteria for selecting citizen members of the Committee of Adjustment, as set out in Attachment No. 1 to this report;
- (4) City Council adopt honoraria for the Committee of Adjustment of:
  - (a) \$300.00 per Member for each Hearing Day attended; and,
  - (b) \$1,000.00 extra annually for the City-wide Chair, such funds to be provided from the operating budget of the City Planning Division;
- (5) City Council recommend the Committee of Adjustment, when appointed and prior to commencing holding Hearings, to meet as a committee of the whole, to establish six panels corresponding with the boundaries of the six Community Councils and to
  - (a) appoint a City-wide Chair; and,
  - (b) appoint the Chief Planner and Executive Director, City Planning Division as Secretary-Treasurer with authority to delegate the role; and,
- (6) City Council recommend the Secretary-Treasurer schedule all Committee of Adjustment Hearings to start at 2:00 p.m. and meetings to be held in the civic centre headquarters of their respective Community Council; and report back in one year on stakeholder satisfaction.

The Committee also had before it the following reports/communications:

(October 26, 2000) from the City Clerk forwarding the following motion which City Council at its regular meeting held on October 3, 4 and 5, 2000, and its Special Meetings held on October 6, 2000, October 10 and 11, 2000, and October 12, 2000, referred to the Policy and Finance Committee and the Planning and Transportation Committee:

"WHEREAS there are currently six Committees of Adjustment serving the areas bounded by the six Community Councils; and

**WHEREAS** there are a total of 34 members serving on the six Committees of Adjustment; and

**WHEREAS** remuneration for the 34 Committee members is drawn from a total honorarium allocation of just over \$185,200.00; and

**WHEREAS** the remuneration for members of each Committee of Adjustment is based on the pay levels set by their respective former municipality; and

**WHEREAS** there is a wide disparity of remuneration levels between each Committee of Adjustment; and

**WHEREAS** the current Committee of Adjustment members, appointed by the former municipalities, were requested to continue to serve after amalgamation pending a review of the Committee structure and remuneration levels; and

**WHEREAS** Committee of Adjustment members have been awaiting the outcome of this review for close to three years; and

WHEREAS comments by the Acting Commissioner of Urban Planning and Development Services, contained in Clause No. 1 of Report No. 6 of The Planning and Transportation Committee, headed 'Organizational Structure for the New Committee of Adjustment', which was considered by City Council on November 23, 24 and 25, 1999, indicate that 'Currently there is a significant difference between the honorarium of the six Committees of Adjustment for the former municipalities. The total of all honoraria allocated by the former six municipalities is over \$185,200.00, which if averaged for 22 members, allows an honorarium of about \$8,500.00 per year per member.';

**NOW THEREFORE BE IT RESOLVED THAT**, effective January 1, 2001, Committee of Adjustment members be equally remunerated, based on a per

meeting attended basis, with funding provided from within the existing total honorarium allocation set aside for this purpose;

**AND BE IT FURTHER RESOLVED THAT** this approval remain in effect until such time as a full review of the structure of the Committee of Adjustment has been completed."

- (January 5, 2001) from William Jupp objecting to holding Committee of Adjustment and Planning and Transportation meetings in the afternoon and querying the membership
- (January 5, 2001) from William H. Roberts, Director and Former President, Swansea Area Ratepayers Association, supporting:

  - the 30 Committee of Adjustment members be divided into six groups with five members responsible for each of the Community Council Committees of Adjustment;
  - all Committee of Adjustment Hearings be held, where possible, in the civic headquarters of their Community Council; and

- all residential related hearings be held in the evening.

#### 1.3. Kingston Road Streetscape (Ward 36)

## 1.5. Amendments to By-law No. 574-2000, Schedule 2, as it Relates to Driving School Restricted Areas Within the City of Toronto (Wards 42, 43 & 44)

The Planning and Transportation Committee gave consideration to a report (December 6, 2000) from the Commissioner of Urban Development Services outlining requirements respecting the new Ministry of Transportation Driver Examination Centre and the need for the creation of a restricted area to coincide with the Ministry testing areas and recommending that, in order to accommodate the new Ministry of Transportation Driver Examination Centre located at 65 Grand Marshall Drive, a new restricted area be established and incorporated into Schedule 2, Section 10 of By-Law 574-2000. Section 10 of Schedule 2 should be amended by adding:

1. "The area bounded on the north by Finch Avenue East, on the west by Neilson Road, on the south by Ellesmere Avenue and on the east by Meadowvale Road."

On motion by Councillor Moscoe, the Committee recommended to City Council that:

(1) in order to accommodate the new Ministry of Transportation Driver Examination Centre located at 65 Grand Marshall Drive, a new restricted area be established and incorporated into Schedule 2, Section 10 of By-Law 574-2000 and, therefore, Schedule 2, Section 10 of By-Law 574-2000 be amended by adding the following:

"The area bounded on the north by Finch Avenue East, on the west by Neilson Road, on the south by Ellesmere Avenue and on the east by Meadowvale Road.";

- (2) authority be granted for the introduction of the necessary bill in Council to give effect thereto; and
- (3) the Commissioner of Urban Development Services delegate staff to meet with officials of the Ministry of Transportation to develop a protocol to identify out-of-town driving school vehicles which would be applied consistently to all driving school vehicles used to road test applicants at the Provincial Driving Examination Centres.

- (3) the Planning and Transportation Committee recommend to Council the appointment of a Member of the Planning and Transportation Committee to the Sustainability Roundtable for a term of office expiring May 31, 2002, and until his or her successor is appointed, subject to this body being continued by Council.
