9.1 Intergovernmental Co-operation on Property Maintenance and Fencing of Railway and Hydro Lands

The Planning and Transportation Committee gave consideration to a report (August 20, 2001) from the Commissioner of Urban Development Services reporting further on Intergovernmental Co-operation on Property Maintenance and Fencing of Railway and Hydro Lands, and recommending that:

(1) the Federal Minister of Transport be requested to amend the draft Railway Rightof-Way Access Control Regulation and the Railway Safety Act as necessary, and to co-ordinate the enactment of related provincial legislation with the provincial Ministers responsible for transportation and municipal affairs, to provide the following:

> that any costs incurred by a municipality in complying with a requirement under the regulation relating to private property automatically become a lien on the land and deemed to be municipal real property taxes that may be added to the rolls and collected in the same manner and with the same priorities as municipal real property taxes;

- (2) a copy of the letter to the Minister be sent to the Ontario Minister of Transportation, the Association of Municipalities of Ontario (AMO) and the Federation of Canadian Municipalities (FCM) seeking their support for Recommendation No. 1., and
- (3) that the balance of this report be received.

- communication (September 26, 2001) from Allan Sparrow, Community AIR, submitting comments respecting the Toronto Port Authority Land Use Plan.

9.6 **Provincial Policy Statement Five Year Review**

The Planning and Transportation Committee gave consideration to a report (September 24, 2001) from the Commissioner of Urban Development Services providing Council with information and comments on the Provincial Policy Statement Five Year Review, making recommendations with respect to the preparation of a new Provincial Policy Statement, and recommending that:

- (1) this report be forwarded to the Minister of Municipal Affairs and Housing as the City of Toronto's initial comments on the Provincial Policy Statement Five Year Review; and
- (2) the Province be requested to provide all municipalities with an opportunity to review and comment on changes to the Provincial Policy Statement, prior to its finalization and legislative approval.

- (2) the Minister of Municipal Affairs and Housing be advised that the Provincial Policy Statement should explore a central theme of making social infrastructure for land use planning and reinforce the need for the provision of financial tools to assist local municipalities.

9.7 Responding to the Province of Ontario's Smart Growth Initiative

The Planning and Transportation Committee gave consideration to a report (September 28, 2001) from the Commissioner of Urban Development Services making recommendations with respect to a City position on how the Province of Ontario can make its Smart Growth Initiative work for Toronto and all municipalities of Ontario, and recommending that Council:

- (1) endorse this report as the City of Toronto's response to Smart Growth in Ontario and that copies of this report be forwarded to the Province of Ontario's Smart Growth Secretariat, the Minister of Municipal Affairs and Housing, the Prime Minister's Task Force on Urban Affairs and to the Association of Municipalities of Ontario, Federation of Canadian Municipalities, Ontario Professional Planners Institute, and the Regional Planning Commissioners of Ontario;
- (2) direct the Commissioner of Urban Development Services in consultation with appropriate staff, to monitor the development of Ontario's Smart Growth Initiative and report when appropriate to Council on:
 - the position City Council could take with respect to the Province of Ontario's continuing development of the Smart Growth Initiative; and

- the potential implications of any actions taken by the Province of Ontario with respect to this initiative on the City's policy, programmes, and operating procedures; and
- (3) direct the Commissioner of Urban Development Services to report on the position Council could take respecting the development of a regional smart growth management strategy for the Golden Horseshoe/Central Ontario region following the completion of the City led study entitled, "*City and Regional Strategies for Growth that Protect Countryside and Air Quality*".

On motion by Councillor Ashton, the Planning and Transportation Committee recommended to City Council, for its meeting on November 6, 2001, that:

- (1) the report (September 28, 2001) from the Commissioner of Urban Development Services be adopted;
- (2) the Minister of Municipal Affairs and Housing be requested to:
 - (a) rename the proposed Smart Growth Management Councils, by not referring to them as "Councils"; and
 - (b) on motion by Councillor Moscoe, ensure that these bodies be comprised entirely of elected representatives and that the City of Toronto has an appropriate level of representation thereon; and
- (3) requested the Commissioner of Urban Development Services to report to the Planning and Transportation Committee on an effective communication mechanism when the Smart Growth Management bodies are established to ensure that the City's interests are protected.

9.8 Review of Parking Requirements for Rental Apartment Buildings

The Planning and Transportation Committee gave consideration to a report (September 21, 2001) from the Commissioner of Urban Development Services following up on the recommendation for a review of parking requirements in rental apartment buildings

contained in the Rental Action Plan entitled: "Unlocking the Opportunity for New Rental Housing: A Call to Action" which was endorsed by City Council in July 2001, identifying a number of steps that can be taken to help the City address on-going concerns over the provision of parking in new rental apartment buildings while awaiting the completion of the wider Zoning By-law review process, and recommending that:

- (1) the Commissioner of Urban Development Services:
 - (a) approach the private rental industry, through the Urban Development Roundtable – Rental Working Group, to provide information related to parking demand in private rental buildings;
 - (b) approach provincial officials to assist in the review of parking demand in rental buildings by providing information on car ownership levels; and
 - (c) approach the Canada Mortgage and Housing Corporation to assist in the review of parking demand in rental buildings by providing technical assistance and making available any relevant data sources;
- (2) the Commissioner of Urban Development Services and the Commissioner of Works and Emergency Services update the Planning and Transportation Committee on the findings of this work by providing a summary, status report in March 2002; and
- (3) the appropriate City Officials be authorized and directed to take the necessary actions to give effect thereto.

On motion by Councillor Moscoe, the Planning and Transportation Committee recommended to City Council, for its meeting on November 6, 2001, that:

- (1) the report (September 21, 2001) from the Commissioner of Urban Development Services be adopted; and
- (2) the Federation of Metro Tenants Associations, and other tenant associations, be kept informed of this matter.

On motion by Councillor Moscoe, the Planning and Transportation Committee requested that the report (September 21, 2001) be forwarded to the Tenant Defence Sub-Committee.

The following motion was placed by Councillor Moscoe and withdrawn:

"That any study undertaken to review parking in rental buildings be an independent study undertaken or commissioned by the City of Toronto."

9.9 New Zoning By-law Project

The Planning and Transportation Committee gave consideration to a report (October 2, 2001) from the Commissioner of Urban Development Services noting the New Zoning By-law Project received initial endorsement during the 2000 Capital Budget process where it was presented as a multi-year-phased project with an estimated budget forecast of \$6.272 million. The Zoning By-law is part of the core business of the organization. The objective of the New Zoning By-law Project is to produce a single, simplified, comprehensive Zoning By-law that applies to the entire City. It will be a blend of the standards and regulations of existing by-laws with new regulations that implement the new Official Plan policies but would not take a "one size fits all" approach. Funding for Phase One, in the amount of \$466,000 for work associated with project scoping, was approved last year with a request that the task involving the development of the Project Work Plan, once completed, be brought forward. Attached to this report is the detailed Work Plan and Work Schedule for the entire Project.

With the other two tasks associated with Phase One scheduled for completion in the first quarter of 2002, it is important to secure Phase Two funding in 2002 in order avoid delaying the project by almost a year, that is, until the 2003 budget process. This report also recommends approval of funding for Phase Two, which will commence in 2002 and be completed in 2003, and recommends that:

- (1) the Work Plan and Work Schedule attached to this report be adopted;
- (2) the proposed funding for Phase 2 be forwarded to the Budget Advisory Committee for its review during consideration of the 2002 Capital Budget allocation for the New Zoning By-law Project;
- (3) the Commissioner of Urban Development Services report on the status of the New Zoning By-law Project to the Planning and Transportation Committee at the conclusion of each subsequent phase indicating any changes in the scope or timelines of the project and the general findings to date; and

(4) the appropriate City Officials be authorized and directed to take the necessary action to give effect thereto.

On motion by Councillor Moscoe, the Planning and Transportation Committee recommended the adoption of the report (October 2, 2001) from the Commissioner of Urban Development Services and forwarded this report, and the Committee's action in this respect, to the Budget Advisory Committee for its review during consideration of the 2002 Capital Budget allocation for the new Zoning By-law Project and the proposed funding for Phase 2.

9.10 Update on City of Toronto Architecture and Urban Design Awards Program

The Planning and Transportation Committee gave consideration to a report (September 25, 2001) from the Commissioner of Urban Development Services responding to Councillor Flint's request for an update on the City of Toronto Architecture and Urban Design Awards Program, and recommending that this report be received for information.

On motion by Councillor McConnell, the Planning and Transportation Committee recommended that the Commissioner of Urban Development Services be requested to establish a working group consisting of interested members of the Planning and Transportation Committee and the design and development community with a mandate to identify additional opportunities to create incentives for excellence in design and architecture, and to review approaches such as convening a symposium on design in Toronto and providing an annual award in the form of a tax benefit.

On motion by Councillor Ashton, the Planning and Transportation Committee received the report (October 2, 2001) from the Commissioner of Urban Development Services.

9.11 Oak Ridges Moraine - Response to Province of Ontario's Draft Strategy

The Planning and Transportation Committee gave consideration to a report (October 2, 2001) from the Commissioner of Urban Development Services responding to and making recommendations with respect to the Province's proposals for the long-term protection of the Oak Ridges Moraine contained in the booklet "Share Your Vision on the Oak Ridges Moraine" issued by the Ministry of Municipal Affairs on August 14, 2001, and recommending that:

- (1) the City of Toronto supports special legislation being passed that provides for:
 - (i) an 'ecologically-based' Plan for the Oak Ridges Moraine
 - (ii) public consultation on the proposed Plan and legislation with surrounding municipalities and the City of Toronto;
 - (iii) the conformity of local and regional Official Plans with such Plan;
 - (iv) implementation of the Plan; and
 - (v) ongoing management of the Oak Ridges Moraine.
- (2) a Regional Growth Management Strategy for the Golden Horseshoe / Central Ontario be jointly developed by the affected municipalities and the City of Toronto. This Strategy should be referenced in an amended PPS to also include strong statements related to the protection of Natural Core, Natural Linkages and Countryside areas of the Moraine in a consistent manner;
- (3) the City of Toronto, along with other affected municipalities, be consulted in the development and drafting of any special legislation and the Plan through a full Committee Hearing with adequate time for public consultation;
- (4) the Provincial government extend the effective time period of the Act to Protect the Oak Ridges Moraine until such time as the proposed Plan is finalized;
- (5) the City of Toronto supports an adequately funded Oak Ridges Moraine Legacy Trust compatible with existing stewardship bodies; and
- (6) the City Clerk forward this report to the Province of Ontario as input to the Provincial proposal on the Oak Ridges Moraine.

The following persons appeared before the Planning and Transportation Committee in connection with the foregoing matter:

- (2) the Provincial Government be advised of Council's concern that the Province chose not to hold a public open house in the City to Toronto to hear Toronto residents' views on the draft proposals for the long-term protection of the Oak Ridges Moraine; and
- (3) the report (October 2, 2001) from the Commissioner of Urban Development Services be forwarded to the appropriate Opposition Party Critics.

9.13 Outdoor Fireplaces

The Planning and Transportation Committee gave consideration to a communication (undated) from Councillor Flint, forwarding the following Motion:

"WHEREAS there are an increasing number of Chimineas Outdoor Fireplaces being installed in residential rear yards, balconies and decks; and

WHEREAS there is no classification for Chimineas Outdoor Fireplaces in the current bylaw; and

WHEREAS concern has been expressed by the Fire Department over the placement, type and amount of material being burnt; and

WHEREAS abutting neighbours can be adversely affected by the air quality as a result of the smell and/or smoke from Chimineas Outdoor Fireplaces;

THEREFORE BE IT RESOLVED that the Fire Chief investigate the possibility of classifying such outdoor fireplaces as open air burning and treated as such under Article 2.6.3.4 of the Fire Code and report thereon to the Planning and Transportation Committee; and

BE IT FURTHER RESOLVED that the Commissioner of Urban Development Services, in consultation with the City Solicitor, report to the Planning and Transportation Committee on whether the Building Code, or any other City of Toronto By-law and/or Provincial Legislation could be amended to address the safety concerns of these outdoor fireplaces."

On motion by Councillor Flint, the Planning and Transportation Committee requested:

- (1) the Fire Chief and the Commissioner of Urban Development Services to investigate the possibility of classifying outdoor fireplaces as open air burning and treated as such under Article 2.6.3.4 of the Fire Code and report jointly thereon to the Planning and Transportation Committee; and
- (2) the Commissioner of Urban Development Services, in consultation with the City Solicitor, to report to the Planning and Transportation Committee on whether the Building Code, or any other City of Toronto By-law and/or Provincial Legislation could be amended to address the safety concerns of these outdoor fireplaces.

- (2) acknowledge the importance of protecting such convenient inter-regional connections, noting the provincial government's recent policy statements supporting these types of transit connections;
- (3) authorize TTC staff to enter into a long-term license agreement with MT for their use of the Islington Station bus bays, in a form satisfactory to the General Counsel, in recognition of the continuing need for a convenient transfer between TTC and MT services at Islington Station; and
- (4) forward this report to the Cities of Toronto and Mississauga, the Greater Toronto Services Board (GTSB), and the Burnhamthorpe Residents for Traffic Safety (BRTS)."
