4-1(a). 2001-2005 Recommended Capital Expenditure Program.

2001-2005 Recommended Capital Expenditure Program:

The Policy and Finance had before it the following reports and communications:

(i) (April 12, 2001) from the Chair, Budget Advisory Committee, entitled "City of Toronto, 2001-2005 Recommended Capital Expenditure Program, presenting the Budget Advisory Committee's 2001 - 2005 Capital Program for the City of Toronto; recommending projects and cash flow for 2001 approval; advising that the

report also provides an overview of the capital budget process and summarizes the various issues and challenges currently faced by the City; and that this report also reflects all of the amendments and recommendations of the Budget Advisory Committee during the capital budget process up to and including the wrap-up meeting of April 6, 2001; and recommending that:

- (1) the 2001 2005 Tax Supported Capital Program for the City, with a cash flow totalling \$4.603 billion as outlined in Appendix A-1 be received;
- the 2001 Tax Supported Capital Program for new projects with a total cost of \$993.779 million as recommended in Appendix D-2 be approved. These projects require a 2001 cash flow of \$369.790 million and future year commitments totalling \$166.250 million in 2002; \$207.510 million in 2003; \$142.424 million in 2004, \$83.705 million in 2005 and \$24.100 million in 2006 and beyond;
- (3) the 2001 Tax Supported Capital Program for previously approved projects with change in scope with a total cost of \$117.091 million as recommended in Appendix D-3 be approved. These projects require a 2001 cash flow of \$100.362 million and future year commitments totalling \$7.714 million in 2002; \$8.475 million in 2003 and \$0.540 million in 2004;
- (4) the Operating Budget impact, identified in Appendix E-1, that results in an incremental net expenditure impact of \$5.332 million in 2001; \$9.196 million by 2002; \$6.994 million in 2003; \$0.959 million in 2004 and \$1.265 million in 2005 for a total impact of \$23.735 million be approved for inclusion in the 2001 and future operating budgets;
- (5) the Chief Financial Officer and Treasurer report back on the status of previously approved capital projects and provide recommendations to the Budget Advisory Committee on completed projects to be closed;
- (6) all capital projects which have been deferred and / or included as part of the future years capital program (2002 2005) be considered placeholders and subject to full review during the 2002 2006 capital budget review process, unless a project and its future year commitments have been recommended for approval in the 2001 Tax Supported Capital Program;
- (7) the Chief Financial Officer and Treasurer report to the Policy and Finance Committee, prior to October 1, 2001, on the Priority Ranking Tool for the Capital Budget specifically with respect to: (i) establishing a tool or tools for use by all City departments as well as Agencies, Boards and Commissions, (ii) determining whether the tool criteria and weighting is appropriate and (iii) the success or otherwise with which the tool is being used;

- (8) the reports, transmittals and communications that were adopted or received during the Budget Advisory Committee's deliberations of the capital budget be held on file with the City Clerk;
- (9) the Toronto Parking Authority 2001 Recommended Capital Program for new projects, as outlined in Appendix A-2, with a 2001 cash flow of \$9.3 million and no future year commitments be approved;
- (10) the balance of the Non-Tax Supported and Other Capital Program, as outlined in Appendix A-1, including TEDCO, Water Supply and Wastewater be deferred for consideration and reviewed prior to Council's final approval of the 2001 Capital Budget; with the Water Supply and Wastewater Capital Program approved by the Works and Emergency Services Committee, and forwarded by the Budget Advisory Committee to the Policy and Finance Committee without recommendation; and
- (11) additional financing in an amount not to exceed \$349 million be debentured for new and change in scope projects for the 2001 Tax Supported Capital Program, if required, for a term up to but not exceeding 20 years (**Item 1s**)
- (ii) (April 11, 2001) from the Chief Financial Officer and Treasurer, entitled, "Recommended 2001-2005 Tax Supported Capital Plan Debt and Debt Service Impact", identifying the debt and debt servicing requirements for the recommended 2001 2005 capital plan as amended by the recommended adjustments in the Policy and Finance report entitled "2001 Operating Budget Amendments to Budget Advisory Committees' Recommendations", but excluding the impact of the \$50 million Provincial grant; advising that in addition, the report identifies issues surrounding sustainable funding for the capital program; and recommending that:
 - (1) the Chief Financial Officer and Treasurer report on any changes necessary to the capital financing plan should major funding changes occur following approval of the 2001- 2005 Capital Works Program, such as new senior government support for the City's capital program;
 - (2) Council again request that the federal and provincial governments provide the City with sustained ongoing funding to support the City's capital program and help maintain the competitiveness and financial sustainability of the Toronto;
 - (3) Council again request the provincial government to forgive the \$200 million in loans provided to the City to put Toronto on the same basis as other amalgamating cities that received provincial support for transition costs;
 - (4) any surplus in the City's Sinking Fund accounts that is released in 2001 and future years be applied to the capital program to reduce borrowing; and

- (5) the appropriate City officials be directed to give effect to the foregoing (Item 1t).

4-1(b). City of Toronto 2001 Operating Budget.

The Policy and Finance Committee had before it the following reports and communications:

(i) (April 11, 2001) from the Chair, Budget Advisory Committee, entitled "2001 Recommended Operating Budget", presenting the 2001 Recommended Operating Budget for the City of Toronto's Departments, Agencies, Boards and Commissions; advising that this report also provides an overview of the operating budget process and highlights the recommended base budget and new service changes for 2001;

- (ii) (April 10, 2001) from the Chief Financial Officer and Treasurer entitled "2001 Amendments Budget Budget to Advisory Recommendations", reporting on various amendments to the Budget Advisory Committee's Recommended 2001 Operating Budget; advising that the adoption of the adjustments in the report will reduce the Budget Advisory Committee 2001 Operating Budget net pressure from \$173.0 million to \$98 million; that the City's property tax increase on only the residential property class imposed by Bill 140 is reduced from 18.0 percent to 10.2 percent; that because the City's share of the residential property tax bill is approximately 2/3, this will mean a 6.8 percent increase on the total tax bill; and recommending that the adjustments contained in this report be adopted;
- (iii) Copy of Mayor's Remarks to the Budget Advisory Committee on April 11, 2001, respecting the City Of Toronto's Operating Budget; advising, amongst other things, that the Province has agreed to a number of regulation changes which will reduce the pressure on the Operating Budget by \$75 million, including the following:
 - (a) \$45 million through a CVA tax shift;
 - (b) \$6 million in PST relief for the purchase of TTC subway cars;
 - (c) another \$6 million by allowing the city to use the old CVA values for G.T.A. pooling;
 - (d) \$1.5 million in Technology Transition funding for Social Services;
 - (e) a \$1 million reduction in the administration costs billed to Social Services;
 - (f) \$3.5 million in savings as a result of reduced debt-carrying costs; and
 - (g) the City transferring \$12 million from Woodbine Race Track in game revenues;

- (2) if the amending regulation is not filed by April 17, 2001, the Policy and Finance Committee request the Minister of Finance to compensate the City for its loss of interest revenue due to the fact that the City is unable to issue its 2001 final tax bills on schedule pending possible amending regulations.
- (ii) drafts of the City of Toronto 2001 Final Property Tax Bill for the various categories.

Councillor Olivia Chow, Trinity-Spadina, appeared before the Policy and Finance Committee in connection with the foregoing matter.

 - (b) Council schedule a special meeting to adopt a levy by-law levying the education rates for 2001 not later than May 10, 2001;
- in the event that the Minister has not filed the required regulations prescribing the education tax rates for 2001 by May 9, 2001, or if the required regulations are filed by May 8, 2001, but Council is not able to accommodate a special meeting to adopt the levy by-law by May 10, 2001, the Province be requested to reimburse the City of Toronto for costs incurred with respect to the loss of interest earnings and a shortfall in the City's cash flow resulting from the delay in the issuance of the City's 2001 final property tax bills; and
- (4) Council be authorized to waive, on a one-time basis, its directive for a clear 30 days from the date of mailing of the tax bill to the first due date.

The Policy and Finance Committee recommended to Council the adoption of Recommendations Nos. (2) to (4) embodied in the foregoing report (April 10, 2001) from the Chief Financial Officer and Treasurer; and concurred with Recommendation No. (1).

4-5. Toronto Port Authority – Surplus Account.

The Policy and Finance Committee had before it the following Notice of Motion and communication:

"WHEREAS on June 16, 2000, in a report to the Audit Committee, the City Auditor identified a surplus account containing \$50 million in the accounts of the Toronto Port Authority; and

WHEREAS the *Toronto Harbour Commissioners' Act* of 1911 requires that 'surplus profits' be returned to the City; and

WHEREAS the Auditor has recommended that City Finance, in consultation with Legal Services, determine the composition of the surplus account at the Toronto Port Authority with a 'view to determining whether or not any of this surplus qualifies as *surplus profits*' which should be returned to the City under this Act; and

WHEREAS the City is still awaiting this report;

THEREFORE BE IT RESOLVED that City Finance, in consultation with Legal Services, be directed to report to the next meeting of Council; and

(ii) (April 17, 2001) from the President and CEO, Toronto Port Authority, commenting on the issue of the Toronto Port Authority "Reserves".

4-6. Loans from the Bank of Canada.

The Policy and Finance Committee had before it a report (February 14, 2001) from the Chief Financial Officer and Treasurer, providing information regarding the availability of loans to municipalities from the Bank of Canada; advising that given that loans from the Bank of Canada are not interest-free and not available directly to municipalities under the Bank Act, the lowest cost of funds and most flexible terms can be achieved in competitive capital markets without resorting to federal loans or programs that could have higher interest rates and restrict the City's future financing program; that the City continues to have a strong credit rating and enjoys excellent access to domestic and global capital markets; that as new opportunities for financing capital projects arise, staff will continue to evaluate their applicability for improving the City's current and future financial position; and recommending that this report be received for information.

On motion by Councillor McConnell, the Policy and Finance Committee:

- (A) recommended to Council that:
 - (1) the Federal Minister of Finance, in conjunction with the Province of Ontario, be requested to provide low cost, below prime, long-term loans to municipalities, such as through the Bank of Canada; and

- (B) received the report (February 14, 2001) from the Chief Financial Officer and Treasurer, entitled "Loans from the Bank of Canada".

4-7. Purchase of Rear Ravine Lands Located in Kimbark/Coldstream Ravine – 33 Kimbark Boulevard (Ward 16 – Eglinton-Lawrence).

The Policy and Finance Committee had before it the following confidential reports and communications respecting the Purchase of Rear Ravine Lands Located in Kimbark/Coldstream Ravine, copies of which were forwarded to Members of Council under confidential cover, having regard that the subject matter relates to the acquisition of property:

- (i) (January 9, 2001) from the City Clerk, forwarding confidential recommendations from the Administration Committee meeting held on January 9, 2001;
- (ii) (January 17, 2001) from the Chief Financial Officer and Treasurer;
- (iii) (January 25, 2001) from the Commissioner of Urban Development Services; and
- (iv) (March 19, 2001) from the Commissioner of Economic Development, Culture and Tourism and the Commissioner of Corporate Services; and
- (v) (April 4, 2001) from the City Clerk.

The Policy and Finance Committee recommended to Council:

- (1) the adoption of the joint confidential report (March 19, 2001) from the Commissioner of Economic Development, Culture and Tourism and the Commissioner of Corporate Services, respecting the Purchase of Rear Ravine Lands Located in Kimbark/Coldstream Ravine 33 Kimbark Boulevard; and
- the adoption of Recommendation No. (1) embodied in the confidential report (March 16, 2001) from the Director, Community Planning, South District, respecting Interim Control By-law No. 319-2000, attached to the communication (April 4, 2001) from the City Clerk;

which were forwarded to Members of Council under confidential cover; and, further that in accordance with the Municipal Act, discussions pertaining thereto be held in-camera having regard that the subject matter relates to the acquisition of property.

4-8. Tax Policy Options for Charities and Similar Organizations in 2001 and Beyond.

The Policy and Finance Committee had before it a report (April 2, 2001) from the Chief Financial Officer and Treasurer, presenting tax policy options for the treatment of Charitable and Similar Organizations in 2001 and beyond; wherein it is recommended that:

- (1) (a) the Minister of Finance be requested to prescribe an alternate rebate percentage for charities occupying rental premises within the commercial and industrial classes in Toronto that reflects the mandatory limits on tax increases that will apply in 2001 and the *actual* tax increases faced by these organizations since the introduction of Current Value Assessment (CVA) in 1998; and
 - (b) that such rebate percentage for 2001 be set such that rebate amounts equal 40 per cent of the combined total of any CVA-related increases and any municipal levy increase over 2000 taxes;

- (2) (a) in the event that the Minister of Finance does not prescribe an alternate rebate percentage for 2001, that the tax deficiency budget for 2001 be increased to include an additional \$1.28 million to fund the costs of providing mandatory rebates to registered charities, otherwise that the tax deficiency budget be increased by \$61,000 for 2001;
 - (b) that rebates for charities within the commercial and industrial classes be financed from within the commercial and industrial classes, and that such rebate amounts be included in the calculation of the tax rates for these classes; and
 - (c) that the Minister of Finance be requested to prescribe a regulation under Section 386(5) of the *Municipal Act*, if necessary, to allow the tax rates for the commercial and industrial tax classes to be greater than would otherwise be allowed for the purpose of allowing additional taxes to be levied within these classes to fund the municipal portion of mandatory rebates for charities;
- (3) the Minister of Finance be requested to extend, for 2001, the period for payment of the first half of the rebate from 60 days to 120 days following receipt of the application, and from 120 days to 180 days for the balance of the rebate amount;
- (4) Council not adopt any optional increase beyond the prescribed rebate percentage for charities within the commercial and industrial classes;
- (5) Council not provide optional rebates of taxes to similar organizations;
- (6) Council continue tax rebates of 100 percent for properties specifically identified by existing City by-laws (Ethno-cultural Centres and Veteran's Clubs and Legion Halls) for the 2001 taxation year, but that these rebate programs be re-examined for taxation in 2002;
- (7) the Chief Financial Officer and Treasurer, in conjunction with the Commissioner of Community and Neighbourhood Services, conduct a review and provide a report for 2002 on the City's overall treatment of the charitable sector, including current grant levels and property tax measures, with a view towards co-ordinating the City's support efforts and tax policies within this sector; and
- (8) that authority be granted for the introduction of the necessary bill in Council.

The Policy and Finance Committee submitted to Council, without recommendation, the report (April 2, 2001) from the Chief Financial Officer and Treasurer, for consideration with Clause No. 2 of Report No. 4 of The Policy and Finance Committee, respecting the 2001 Provincial Re-Assessment Impacts and Tax Options.

4-9. Vacancy Rebate Program for Commercial and Industrial Properties.

The Policy and Finance Committee had before it a report (April 12, 2001) from the Chief Financial Officer and Treasurer, providing an update on the new vacancy rebate program for commercial and industrial buildings as legislated by Bill 140 and reporting on program features that the Province is proposing to regulate with respect to the program; wherein it is recommended that the Minister of Finance be requested to:

General:

(1) file regulations pertaining to the vacancy rebate program by April 27, 2001;

Eligibility Criteria:

(2) ensure that eligibility criteria and the terms used in setting the criteria are clearly defined in the regulation;

Amount of Rebates:

- (3) regulate that the portion of the "total taxes" attributable to vacant space not include BIA levies; and, should the Minister of Finance regulate that the portion of the "total taxes" attributable to vacant space include BIA levies, the Minister ensure that the filed regulations provide municipalities with the ability to charge BIAs for their share of the cost of any vacancy rebate attributable to their BIA levy;
- (4) regulate provisions to allow municipalities to recalculate the vacancy rebate following the processing of a successful appeal which results in a change to "total taxes";

Applications:

- (5) regulate the following with respect to the vacancy application and verification process:
 - (a) that only one application, designed to meet the needs of the both the municipality and OPAC, be submitted to the municipality. The municipality will submit a copy of the application to OPAC within 5 days of the date the application is received and will forward an acknowledgement of receipt to the applicant;
 - (b) assuming that all information required by OPAC is provided by the applicant at the time of the application is filed with the municipality, OPAC has 75 days from the date the application is received from the municipality to provide the assessment apportionment attributable to the vacant space. If all the information required by OPAC is not provided at the time of filing the application, the 75 days commences after OPAC receives the information required from the applicant;
 - (c) that OPAC be mandated to verify that the information provided on, or with, the application is accurate and that it verify that the eligibility criteria are met;
 - (d) if OPAC is not mandated to verify the accuracy of information provided on, or with the application, the Minister regulate that the municipality have 120 days from the date the complete information is received from OPAC to verify the information provided on, or with, the application and process the rebate accordingly;
 - (e) that OPAC be permitted to request additional information/documentation directly from the applicant/property owner;

Payment Obligations:

- (6) waive the 120 day deadline for payment of rebates in the first year of the program; and, that the for the first year (2001) the deadline for payment be 240 days, 180 days for 2002 and 120 in 2003 and subsequent years;
- (7) regulate that interest becomes payable within 120 days after all required and requested information and documentation is received from the applicant;

- (8) regulate that OPAC be mandated to reimburse the municipality for the cost of any interest payable, if OPAC fails to provide the assessment apportionment to the municipality within the required 75 days, and as a result the municipality is unable to process the required rebate within the legislated 120 days;
- (9) regulate that the interest rate payable on vacancy rebates processed after the 120 days, be set at a rate which is not above the rate the City earns on investments;

Appeals:

- (10) regulate that property owners only be allowed to file an appeal with the ARB, if they disagree with the amount of the rebate that is calculated by the municipality, and that the right to appeal not be extended to situations where the municipality has failed to process the rebate within the 120 days;
- (11) regulate that OPAC be mandated to be party to the vacancy appeal process and to defend the assessment value it determines is attributable to the eligible vacant portion; and

Vacant and Excess Land:

(12) regulate a process, similar to the process followed between 1998 and 2000, making the property owner responsible for filing an application with OPAC each year in order for the property to be returned on the assessment roll as "vacant and excess land".

The Policy and Finance Committee recommended to Council the adoption of the report (April 12, 2001) from the Chief Financial Officer and Treasurer, entitled "Vacancy Rebate Program for Commercial and Industrial Properties",

4-10. Tax Impacts of Provincially Imposed Transition Ratios and Education Tax Rates for the 2001 Reassessment Year.

The Policy and Finance Committee had before it a report (April 12, 2001) from the Chief Financial Officer and Treasurer, presenting the tax impacts arising from the Provincially imposed transition ratios and education tax rates for the 2001 taxation year; wherein it is recommended that:

- (1) the Minister of Finance be requested to file a regulation prescribing the 2001 transition ratio for the City of Toronto as announced on April 2, 2001;
- (2) if the regulation establishing the 2001 transition ratios for the City of Toronto is filed prescribing the same transition ratios as were announced on April 2, 2001, the following tax ratios, arising from Option 3 embodied in this report, be adopted:

- (3) the Minister of Finance be again requested to prescribe a residential and multiresidential education tax rate for 2001 of 0.33934 percent in order to maintain total education tax burden on these classes at the 2000 level, and failing that, to adopt a residential and multi-residential education tax rate for 2001 of 0.37092 percent, a level estimated to be revenue neutral to the Province;
- (4) the Minister of Finance be again requested to file a regulation prescribing the final education tax rates for all property classes for the City of Toronto by April 20, 2001, so that the City can issue its final tax bill in a timely manner;
- (5) the Minister of Finance be requested to file by April 20, 2001, the regulation required by clause 368(4.3(b)) of the *Municipal Act* prescribing the manner in which the tax rates on property in the commercial, industrial and multi-residential property classes are to be determined;
- (6) the clawback rates for the multi-residential, commercial and industrial property classes be set at the appropriate level sufficient to fund the foregone revenues arising from a 5 percent limit on total tax increases for these classes; and

(7) the appropriate City officials be directed to take the necessary action to give effect thereto.

The Policy and Finance Committee recommended to Council the adoption of the report (April 12, 2001) from the Chief Financial Officer and Treasurer, entitled "Tax Impacts of Provincially Imposed Transition Ratios and Education Tax Rates for the 2001 Reassessment Year",

4-11. Comparison of Residential Property Taxes on Similar Single Family Homes in Selected Ontario Municipalities.

The Policy and Finance Committee had before it a report (April 17, 2001) from the Chief Financial Officer and Treasurer, providing a comparison of property tax burdens on similar single family homes in various municipalities across the Province as requested by the Policy and Finance Committee on April 5, 2001; advising that although Toronto has the lowest residential tax rate amongst the selected municipalities presented in this report, this differential does not necessarily translate into a lower tax burden for Toronto taxpayers; that Residential property taxes paid in Toronto for similar properties are on average greater than elsewhere in Ontario; and recommending that this report be received for information.

The Policy and Finance Committee received the foregoing report (April 17, 2001) from the Chief Financial Officer and Treasurer; entitled "Comparison of Residential Property Taxes on Similar Single Family Homes in Selected Ontario Municipalities" and directed that it be forwarded to Council for information.
