## 12.1 Overview of Departmental Air Quality and Greenhouse Gas (GHG) Responsibilities and Activities in the City of Toronto (All Wards)

### 12.2 Review of City Expenditures on Seniors' Services

The Budget Advisory Committee had before it a communication (May 28, 2002) from the City Clerk advising that the Community Services Committee on May 28, 2002, concurred in the recommendations contained in the communication (May 8, 2002) from the Seniors' Advocate, viz:

- (1) the Community Services Committee support that the requests for maintaining current budget levels and/or enhancing departmental budgets in 2003 for services offered to Toronto Senior Citizens, as indicated in this report, be forwarded to the Budget Advisory Committee;
- the Commissioners for Community and Neighbourhood Services, Economic Development, Culture and Tourism, Works and Emergency Services, as well as the Medical Officer of Health and the City Librarian incorporate the recommendations for funding contained in this report into budget submissions for 2003;
- (3) this report be forwarded to the Economic Development and Parks Committee requesting that a strategy to address the recreational needs of seniors be developed, with a proposed budget to implement the strategy; and
- (4) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

On motion by Councillor Pitfield, the Budget Advisory Committee referred the aforementioned report (May 8, 2002) from Councillor Anne Johnston, Seniors' Advocate, to the 2003 Budget deliberations.

On motion by Councillor Tziretas, the Budget Advisory Committee recommended to the Policy and Finance Committee, and Council, the adoption of the aforementioned report.
