#### Minutes of the Midtown Community Council

#### Meeting No. 6

#### Tuesday, June 4, 2002

The Midtown Community Council met on Tuesday, June 4, 2002 in the Council Chambers, North York Civic Centre, Toronto, commencing at 9:39 a.m.

# **Confirmation of Minutes.**

On motion by Councillor Pitfield, the Minutes of the meeting of the Midtown Community Council held on May 7, 2002, were confirmed.

6.1 Public Hearing Pursuant to the Municipal Act Draft By-law - Wallingford Road - Tanburn Place and Treadgold Crescent - Construction of a Raised Driveable Median. (Don Valley East - Ward 34)

At this point in the proceedings, the Midtown Community Council held a Statutory Public Hearing in accordance with the Municipal Act and notice with respect to the proposed enactment of the draft by-law was advertised in a daily newspaper on May 14, 20, 27 and June 3, 2002.

The Midtown Community Council had before it a Draft By-law submitted by the City Solicitor, respecting the alteration of Wallingford Road, Tanburn Place and Treadgold Crescent by the installation of a raised driveable median.

The Midtown Community Council had before it, for information, Clause No. 10 contained in Report No. 3 of the Midtown Community Council, headed "Neighbourhood Traffic Management Plan – Wallingford Road (Don Valley East – Ward 34)", which was adopted, without amendment, by the Council of the City of Toronto at its meeting held on April 16, 17 and 18, 2002.

No one appeared before the Midtown Community Council in connection with the foregoing matter.

On motion by Councillor Flint, the Midtown Community Council recommended to Council that the By-law in the form of the draft by-law be enacted.

# 6.2 Avenue Road - Between St. Clair Avenue West and Dupont Street - Amendments to Parking Regulations. (St. Paul's - Ward 22)

The Midtown Community Council had before it a report (April 15, 2002) from the Director, Transportation Services, District 1, regarding a request from Councillor Michael Walker to allow parking on the east side of Avenue Road, between St. Clair Avenue West and Dupont Street, and to prohibit parking on Sundays on the west side of Avenue Road, between St. Clair Avenue West and Farnham Avenue; advising that funds necessary to undertake the necessary by-law signage adjustments in the estimated amount of \$2,000.00 are contained in the Transportation Services 2002 Operating Budget; and recommending that:

- (1) the stopping prohibition in effect from 7:00 a.m. to 9:00 a.m. and from 4:00 p.m. to 6:00 p.m., except Saturdays, Sundays and Public Holidays, on the east side of Avenue Road, from MacPherson Avenue to St. Clair Avenue West, be amended to operate from 3:00 p.m. to 7:00 p.m., except Saturdays, Sundays and Public Holidays;
- (2) the parking prohibition in effect anytime except Sundays, on both sides of Avenue Road, from a point 38.0 metres south of St. Clair Avenue to Farnham Avenue, be rescinded;

- (3) parking be prohibited anytime on the west side of Avenue Road, from a point 38.0 metres south of St. Clair Avenue West to Farnham Avenue;
- (4) the parking prohibition in effect anytime on the east side of Avenue Road, from a point 15 metres north of Roxborough Street West to Farnham Avenue, be rescinded;
- (5) the parking prohibition in effect at anytime on the east side of Avenue Road, from Lonsdale Road to a point 38.0 metres south of St. Clair Avenue West, be amended to be in effect at anytime from Lonsdale Road to St. Clair Avenue West;
- (6) parking be prohibited anytime on the east side of Avenue Road from:
  - (a) Roxborough Street West to a point 110 metres north of MacPherson Avenue,
  - (b) Cottingham Street to a point 46 metres south thereof,
  - (c) a point 30.5 metres south of Edmund Avenue to Foxbar Road,
  - (d) Foxbar Road to a point 45 metres north thereof,
  - (e) St. Clair Avenue West to a point 50 metres south thereof; and
- (7) the appropriate City officials be requested to take whatever action is necessary to give effect to the foregoing, including the introduction in Council of any Bills that may be required.

Councillor Walker appointed Councillor Flint, Acting Chair and vacated the Chair.

On motion by Councillor Walker, the Midtown Community Council recommended to Council adoption of the foregoing report.

Councillor Walker resumed the Chair.

#### 6.3 Avenue Road at Hillholm Road - South Side - Proposed Pedestrian Crossover. (St. Paul's - Ward 22)

The Midtown Community Council had before it a report (April 23, 2002) from the Director, Transportation Services, District 1, reporting on increasing safety for pedestrian crossing Avenue Road in the vicinity of Oxton Road and Hillholm Road; advising that funds in the estimated amount of \$27,000.00 to install a pedestrian crossover on Avenue Road at the south side of Hillholm Road are available in Transportation Services 2002 Capital Budget; and recommending that:

- (1) a pedestrian crossover be installed across Avenue Road at Hillholm Road on the south side of the intersection; and
- (2) the appropriate City officials be authorized and directed to take whatever action is necessary to implement the foregoing, including the introduction in Council of any Bills that are required.

Councillor Walker appointed Councillor Flint, Acting Chair and vacated the Chair.

On motion by Councillor Walker, the Midtown Community Council deferred consideration of this matter to its next meeting on July 2, 2002.

Councillor Walker resumed the Chair.

# 6.4 Variance for Third Party Wall Sign 1 Concorde Gate. (Don Valley West - Ward 26)

The Midtown Community Council had before it a report (April 5, 2002) from the Director and Deputy Chief Building Official, evaluating and making a recommendation regarding a request for a variance from the Sign By-law by Mr. Michael McRague, of Abcon Media Group, to permit the construction of a temporary (June - October 2002) third party wall sign on the existing high-rise building on the subject property; advising that there are no financial implications associated with this report; and recommending that the request for a minor variance for the Sign By-law be refused.

On motion by Councillor Pitfield, the Midtown Community Council deferred consideration of this matter to its next meeting on July 2, 2002 to permit the Ward Councillor to conduct a community meeting.

6.5 Request for an Exemption from Chapter 248 of the Former City of Toronto Municipal Code to Permit Driveway Widening At 186 Old Orchard Grove. (Eglinton-Lawrence - Ward 16)

The Midtown Community Council had before it a report (May 21, 2002) from the Manager, Right of Way Management, Transportation Services, District 1, reporting on a request for an exemption from the Municipal Code Chapter 248, Parking Licences, of the former City of Toronto Municipal Code, to permit angled driveway widening at 186 Old Orchard Grove, which does not meet the requirements of the Code; advising that there are no financial implications resulting from the adoption of this report; and recommending that:

(1) City Council deny the application for driveway widening for angled parking at 186 Old Orchard Grove;

or

- (2) City Council approve the application for driveway widening for angled parking at 186 Old Orchard Grove, notwithstanding the required landscaped space will not be provided, subject to:
  - (a) the parking area not exceeding 2.6 m by 5.9 m in dimension;
  - (b) the parking area and entrance to same being set back a minimum of 2.0 m from the City sidewalk;
  - (c) the applicant modifying their landscape proposal so that the river rock or other loose stone/chips are setback a minimum of 1.5 m from the sidewalk or are contained so as to eliminate overspill onto the sidewalk;

- (d) the applicant providing the landscape features substantially in accordance with the plan as shown on Appendix 'B', to the satisfaction of the Commissioner of Works and Emergency Services; and
- (e) the applicant paying all applicable fees and complying with all other criteria set out in Municipal Code Chapter 248, Parking Licences, of the former City of Toronto Municipal Code.

The Midtown Community Council also had before it a communication (June 2, 2002) from Debbie Gray and David Kluthe.

On motion by Councillor Johnston, the Midtown Community Council recommended to Council the adoption of Recommendation No. 2, of the foregoing report, ie:

"that City Council approve the application for driveway widening for angled parking at 186 Old Orchard Grove, notwithstanding the required landscaped space will not be provided, subject to:

- (a) the parking area not exceeding 2.6 m by 5.9 m in dimension;
- (b) the parking area and entrance to same being set back a minimum of 2.0 m from the City sidewalk;
- (c) the applicant modifying their landscape proposal so that the river rock or other loose stone/chips are setback a minimum of 1.5 m from the sidewalk or are contained so as to eliminate overspill onto the sidewalk;
- (d) the applicant providing the landscape features substantially in accordance with the plan as shown on Appendix 'B', to the satisfaction of the Commissioner of Works and Emergency Services; and

(e) the applicant paying all applicable fees and complying with all other criteria set out in Municipal Code Chapter 248, Parking Licences, of the former City of Toronto Municipal Code."

#### 6.6 Maintenance of a Carport - Retaining Wall and Steps - 32 Bennington Heights Drive. (Don Valley West - Ward 26)

The Midtown Community Council had before it a report (May 21, 2002) from the Manager, Right of Way Management, Transportation Services, District 1, reporting on the maintenance of a carport, retaining wall and steps which encroach within the public right of way at 32 Bennington Heights Drive; advising that there are no financial implications resulting from the adoption of this report; and recommending that:

City Council approve the maintenance of a carport, retaining wall and steps within the public right of way fronting 32 Bennington Heights Drive, subject to the owner entering into an encroachment agreement with the City of Toronto, agreeing to:

- (a) indemnify the City from and against all actions, suits, claims or demands and from all loss, costs, damages and expenses that my result from such permission granted;
- (b) maintain the carport, retaining wall and steps in good and proper repair and a condition satisfactory to the Commission of Works and Emergency Services;
- (c) remove the carport, retaining wall and steps upon receiving notice to do so with the understanding that the City shall not give notice in the first 75 years; and
- (d) accept such additional conditions as the City Solicitor or the Commissioner of Works and Emergency Services may deem necessary in the interest of the Corporation.

On motion by Councillor Pitfield, the Midtown Community Council recommended to Council adoption of the foregoing report.

# 6.7 Eglinton Avenue West at Old Forest Hill Road -Review of Traffic Volumes on Old Forest Hill Road. (St. Paul's - Ward 21)

The Midtown Community Council had before it a report (May 16, 2002) from the Director, Transportation Services, District 1, reporting on a request from the Midtown Community Council to conduct traffic counts at the intersection of Eglinton Avenue West and Old Forest Hill Road and to review traffic volumes on Old Forest Hill Road; advising that there are no financial implications associated with this report; and recommending that this report be received for information.

On motion by Councillor Mihevc, the Midtown Community Council:

- (1) received the report; and
- (2) requested the Director, Transportation Services, District 1 to provide the Ward Councillor with traffic counts broken down by hour.

6.8 Strathearn Boulevard - North Side - Between Glenayr Road and its West Terminus -Request to Prohibit Parking on One Side of the Street Only. (St. Paul's - Ward 21)

The Midtown Community Council had before it a report (May 10, 2002) from the Director, Transportation Services, District 1, responding to a request to prohibit parking on one side of the subject section of Strathearn Boulevard in order to improve vehicular movement/access; advising that funds to undertake the necessary signage adjustments in the estimated amount of \$200.00 are contained in the Transportation Services Division 2002 Operating Budget; and recommending that:

(1) parking be prohibited at anytime on the north side of Strathearn Boulevard, between Glenayr Road and its west terminus; and

(2) the appropriate City officials be authorized and directed to take whatever action is necessary to implement the foregoing, including the introduction in Council of any bills that are required.

On motion by Councillor Mihevc, the Midtown Community Council recommended to Council adoption of the foregoing report.

6.9 Oaklawn Gardens - West Side - from Heath Street West to the Turning Basin - the Implementation of Three Prohibited Parking Areas. (St. Paul's - Ward 22)

The Midtown Community Council had before it a report (May 17, 2002) from the Director, Transportation Services, District 1, reporting on ensuring that the roadway remains clear of parked vehicles fronting the ends of the residents walkways; advising that funds to undertake the necessary signage adjustments in the estimated amount of \$1,000.00 are contained in the Transportation Services Division 2002 Operating Budget; and recommending that:

- (1) the parking prohibition in effect from 8:00 a.m. to 10:00 a.m., Monday to Friday and the one hour maximum parking limit in effect from 10:00 a.m. to 6:00 p.m., Monday to Friday, on the west side of Oaklawn Gardens, be adjusted to operate from Heath Street West to a point 19.5 metres further north, from a point 21.5 metres north of Heath Street West to a point 19.0 metres further north, and from a point 42.5 metres north of Heath Street West to a point 16.5 metres further north;
- (2) parking be prohibited at anytime on the west side of Oaklawn Gardens from a point 19.5 metres north of Heath Street West to a point 2.0 metres further north, from a point 40.5 metres north of Heath Street West to a point 2.0 metres further north and from a point 59.0 metres north of Heath Street West to a point 2.0 metres to a point 2.0 metres further north and that these zones be designated as loading zones; and
- (3) the appropriate City officials be authorized and directed to take whatever action is necessary to implement the foregoing, including the introduction in Council of any bills that are required.

Councillor Walker appointed Councillor Flint, Acting Chair and vacated the Chair.

On motion by Councillor Walker, the Midtown Community Council recommended to Council adoption of the foregoing report.

Councillor Walker resumed the Chair.

# 6.10 Bayview Avenue and Glenvale Boulevard -Amendments to Turn Prohibitions. (Don Valley West - Ward 26)

The Midtown Community Council had before it a report (May 16, 2002) from the Director, Transportation Services, District 1, seeking approval to exempt TTC vehicles from the weekday morning and afternoon peak period southbound left-turn and westbound right-turn prohibitions at the intersection of Bayview Avenue and Glenvale Boulevard; advising that funds in amount of \$500.00 associated with the installation of appropriate signs are contained in the Transportation Services Division 2002 Operating Budget; and recommending that:

- (1) the existing southbound left-turn prohibition in effect from 7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m., Monday to Friday except Public Holidays at the intersection of Bayview Avenue and Glenvale Boulevard be rescinded;
- (2) the existing westbound right-turn prohibition in effect from 7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m., Monday to Friday except Public Holidays at the intersection of Bayview Avenue and Glenvale Boulevard be rescinded;
- (3) a southbound left-turn prohibition from 7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m., Monday to Friday except Public Holidays, (TTC vehicles excepted) be enacted at the intersection of Bayview Avenue and Glenvale Boulevard;
- (4) a westbound right-turn prohibition from 7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m., Monday to Friday except Public Holidays, (TTC vehicles excepted) be enacted at the intersection of Bayview Avenue and Glenvale Boulevard; and
- (5) the appropriate City officials be authorized to take whatever action is necessary to give effect to the foregoing, including the introduction in Council of any Bills that are required.

On motion by Councillor Pitfield, the Midtown Community Council deferred consideration of this matter to its next meeting on July 2, 2002, to allow the Ward Councillor to meet with the North Leaside Residents Association Incorporated.

# 6.11 Proposed Installation of Speed Bumps in the Public Lane Between Strathearn Road and Peveril Hill North. (St. Paul's - Ward 21)

- (1) the installation of speed bumps in the public lane between Eglinton Avenue West and Dewbourne Avenue, running between Strathearn Road and Peveril Hill North of the type and design noted and at the locations shown on Drawing No.'s 421F-6489 and 421F-6490 dated May, 2002, be approved; and
- (2) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto, including the introduction in Council of any Bills that are required.

p.m. on Fridays to 7:00 p.m. on Sundays, between June 01, 2002 to November 30, 2002; and recommending that the Midtown Community Council grant an exemption to Noise By-law No. 71-89 to the applicant to facilitate the pavement re-surfacing project at Eglinton Avenue East at Bermondsey Road.

  - (a) further study of this concept as a local collector road be carried out under the auspices of the Don Valley Corridor review being undertaken by Urban Development Services in consultation with Works and Emergency Services as previously directed by City Council, for the purpose of providing Council with detailed documentation related to definitive cost estimates, mitigation measures to minimize impacts on the natural environment and measures to avoid traffic impacts on other neighbourhoods;
  - (b) the study also focus on potential alignment opportunities to utilize rail corridor lands to the extent possible, in order to minimize impact on sensitive environmental areas;
  - (c) such detailed study focus on alignment alternatives that provide a local collector road function including opportunities for transit, cycling and pedestrian modes and configured in such a manner that does not encourage more traffic towards, Rosedale, midtown or downtown neighbourhoods;

- (d) to ensure the appropriate levels of public consultation with any interested parties the study be carried out in a manner that satisfies the requirements of Schedule C of the Municipal Class Environmental Assessment Act;
- (2) Staff of Transportation Services develop in greater detail, in consultation with the Ward Councillor and the Leaside Technical Traffic Work Group (TTWG) and report to Midtown Community Council, the implications of a traffic management plan involving temporal turn restrictions for further consideration by the community;
- (3) a copy of this report be forwarded to Works Committee for its information; and
- (4) the appropriate City officials be authorized to take whatever action is necessary to give effect to the foregoing including the introduction in Council of any Bills that may be required.
