Meeting No. 1

Tuesday, January 29, 2002

The Toronto East York Community Council met on Tuesday, January 29, 2002, in Committee Room No. 1, 2nd Floor, City Hall, Toronto, commencing at 9:30 a.m.

No interests were declared pursuant to the Municipal Conflict of Interest Act.

On motion by Councillor Pantalone, the Toronto East York Community Council confirmed the Minutes of its Meeting held on October 23, 2001.

1.1 Victoria Memorial Square (Trinity-Spadina, Ward 20)

The Toronto East York Community Council had before it a communication (January 10, 2002) from Councillor Chow.

The Toronto East York Community Council heard a presentation by the Wellington Place Neighbourhood Association to discuss their plans to improve Victoria Memorial Square.

On motion by Councillor Chow, the Toronto East York Community Council:

- (1) received a presentation from the Wellington Place Neighbourhood Association and endorsed its efforts in the improvement of Victoria Memorial Square;
- requested the Commissioners of Urban Development Services and Economic Development, Culture and Tourism to work with the Wellington Place Neighbourhood Association to develop a plan which will restore Victoria Memorial Square, including the possibility of a Community Improvement Plan; and
- (3) requested the Film Liaison Committee to work with the Wellington Place Neighbourhood Association to examine possible sources of funds.

1.2 Draft By-Law - Stop Up and Close a Portion of the Public Lane North of King Street West Extending Easterly from Widmer Street (Trinity-Spadina, Ward 20)

- (b) the City and the Owner are to act reasonably with respect to all rights and powers granted to them under the Heritage Easement Agreement and in particular, with respect to the application and interpretation of the Heritage Conservation Principles; and
- (c) the City, including its employees, shall, in making or exercising any power, right, approval or decision under the agreement, take into account, among other considerations, the historic and architectural significance of the Property, the operational needs of the Owner, the financial resources available to the Owner and the Heritage Conservation Principles; and
- (3) the appropriate City Officials be authorized and directed to take the necessary actions to give effect thereto.

This would include the area between buildings on the north side, and the east side of the property. The fencing must be of a height subject to by-law limitations;
- (e) a dividing barrier fence in compliance with municipal standards shall be placed that divides the patio area from the sidewalk;
- (f) the operator shall not permit line-ups on the patio;
- (g) the large window in the front shall not be open at any time during hours of operation, or removable. Any other window that opens should not be from service areas so as to prevent noise from filtering on to the street
- (h) the licensee shall install lighting that comes on at or around sundown and stays on until one hour after closing which illuminates the area on the north and east side of the building; and
- (i) the licensee will conduct perimeter checks hourly throughout the evening and upon closing.
