Tuesday, May 7, 2002

The Toronto East York Community Council met on Tuesday, May 7, 2002, in Committee Room No. 1, 2nd Floor, City Hall, Toronto, commencing at 9:30 a.m.

No interests were declared pursuant to the Municipal Conflict of Interest Act.

4.1 Draft By-Laws – Installation of Speed Humps – Macpherson Avenue and Roxborough Street West, between Avenue Road and Yonge Street (Toronto Centre-Rosedale, Ward 27)
