**Confirmation of Minutes.**

On motion by Councillor Li Preti, the Minutes of the meeting of the Works Committee held on January 15, 22 and 25, 2002, and the special meeting held on February 13, 2002, were confirmed.

**3.1 Claim for Damages – 6 Maywood Park.  
(Ward 35 – Scarborough Southwest)**

The Works Committee had before it a report (December 21, 2001) from the Commissioner of Works and Emergency Services providing background information regarding the circumstances surrounding downspout disconnection and a flooding claim at 6 Maywood Park, as requested by Councillor Altobello, Ward 35 – Scarborough Southwest; advising that in a communication to the owner, Mr. Genuis, Toplis Canada, independent insurance adjusters assigned by the City of Toronto to handle the claim on the City's behalf, found no additional information that would lead to reversing their position of denial for the claim, and found that the rain barrel system was designed and installed properly and according to the drawing and agreement signed by Mr. Genuis; furthermore, it appeared that the water entered the basement as a result of seepage through the foundation wall and that the origin of the water entry was not in the vicinity of the rain barrel installation; concluding that in view of the above, no further action is recommended; and recommending that the report be received for information.

On motion by Councillor Li Preti, on behalf of Councillor Altobello, the Committee recommended to Council that the owner of 6 Maywood Park be reimbursed in the amount of \$600.00, without prejudice to the City of Toronto and conditional upon receipt of the appropriate original invoices, to be funded from the Downspout Disconnection Program.

**3.2 Biosolids Beneficial Use Program at  
Ashbridges Bay Treatment Plant -  
Land Application Agreement and  
Pellet Marketing Agreement.**

The Works Committee had before it a report (March 15, 2002) from the Commissioner of Works and Emergency Services recommending that authority be granted to extend the existing agreement with Terratec Environmental Ltd., a subsidiary of American Water Services Canada Corp., to land apply biosolids from the Ashbridges Bay Treatment Plant at

a cost of \$121.36 for each dry tonne of biosolids land applied, and during periods when land application is not possible for Terratec to transport biosolids to landfill, at a cost of \$112.29 per dry tonne, until such time that a new agreement can be negotiated, but no later than June 30, 2002; and the extension of the existing agreement calling for the City to be responsible for the cost of any tipping fees for any biosolids which must be landfilled.

The Committee also had before it a report (March 15, 2002) from the Commissioner of Works and Emergency Services recommending that:

- (1) authority be granted to enter into an agreement with USF Canada Inc. for a five-year term to transport, store and market up to 32,500 dry tonnes per year of biosolid pellets from the Ashbridges Bay Treatment Plant at an initial cost to the City of \$13.35 per tonne, on the terms and conditions set out in the report and as may otherwise be acceptable to the Commissioner of Works and Emergency Services as well as the City Solicitor;
- (2) Council ratify the actions of the Commissioner of Works and Emergency Services in issuing a Purchase Order to USF Canada Inc. for the transportation, storage and marketing of pellets from the Ashbridges Bay Treatment Plant for the initial 30-day facility test period of May 18 – June 17, 2001, for a total cost of \$30,000.00 and until the above-mentioned agreement has been executed, issue a new Purchase Order to USFC for a two-month period at a cost not to exceed \$55,000.00; and
- (3) the appropriate officials be authorized to do whatever is necessary to implement the foregoing referred to above.

The Committee:

- (1) recommended to Council the adoption of the aforementioned reports;
- (2) further recommended that the health study being undertaken by the Medical Officer of Health include consultation with other Medical Officers of Health from regions in the Province where sludges are being applied;
- (3) requested the Commissioner of Works and Emergency Services to report to the next meeting of the Committee, scheduled to be held on May 1, 2002, on the timing for the phasing out and the switching off of the incinerator at the Ashbridges Bay Treatment Plant, and a proposal for a suitable event to commemorate this achievement, to include the citizens and former Councillors who have been actively involved throughout the process; and

- (4) requested the Commissioner of Works and Emergency Services to submit a report to the meeting of the Committee scheduled to be held on September 11, 2002, on the status of the operation and production levels of the pelletization facility, and on the following:
  - (i) options for the possibility of increasing production in the winter months to reduce the problem of storage of the cake material; and
  - (ii) tonnages sent to landfill last year compared to the estimated tonnages to be sent to landfill this coming year, and providing an option to eliminate the landfill process by investigating an expansion of the pelletization facility by the addition of another module or other change to the design.

**3.3 Request for Traffic Control Signals -  
Leslie Street and Overland Drive.  
(Ward 25 - Don Valley West)**

The Works Committee had before it a report (January 11, 2002) from the Commissioner of Works and Emergency Services respecting the feasibility of the installation of traffic control signals on Leslie Street at Overland Drive, as requested by the Midtown Community Council at its meeting of June 12, 2001, by its adoption of a resolution by Councillor Joanne Flint, Ward 25 - Don Valley West; advising that a review of the technical requirements for the installation of traffic control signals at both the intersection of Leslie Street with Overland Drive and Leslie Street at the driveway to St. Bonaventure Church/School was conducted, and that based on the results of staff observations and studies, the installation of traffic control signals on Leslie Street at Overland Drive is not warranted; and recommending that the report be received for information purposes only.

The Committee also had before it a communication (March 26, 2002) from Councillor Joanne Flint, Ward 25 - Don Valley West, requesting that the installation of traffic control signals at Leslie Street and Overland Drive be deferred sine die.

On motion by Councillor Balkissoon, the Committee deferred consideration of the aforementioned report sine die.

**3.4 Environmental Grants Fund.**

The Works Committee had before it a joint report (March 5, 2002) from the Chief Administrative Officer and the Chief Financial Officer and Treasurer responding to the request by the Works Committee at its meeting on November 14, 2001, to establish an environmental grants fund to be administered by the Works Committee, and to recommend ways of increasing public awareness about environmental initiatives; and recommending that:

- (1) the Works Committee's request for the establishment of an environmental grants fund that would be administered by the Works Committee be referred to the Board of Directors of the Toronto Atmospheric Fund (TAF) for response, and that TAF report back to the Works Committee;

- (2) City staff, led by the Technical Services Division of the Works and Emergency Services Department in consultation with other divisions, departments and agencies, develop a list of existing public and private resources for the City's Environmental Plan initiatives, including Environmental Education, Public Awareness and Advocacy, and such list be made available through the City's website, Access Toronto and public libraries; and
- (3) the appropriate City officials be authorized and directed to take the necessary actions to give effect thereto.

The Committee also had before it a communication (March 26, 2002) from Ms. Karen Buck, Toronto, Ontario, providing comments on the establishment of an environmental grants fund.

On motion by Councillor Jones, the Committee recommended to Council the adoption of the aforementioned report, subject to adding to Recommendation No. (1) after the words "administered by the Works Committee" the words "or the Toronto Atmospheric Fund", so that such Recommendation reads as follows:

- "(1) the Works Committee's request for the establishment of an environmental grants fund that would be administered by the Works Committee or the Toronto Atmospheric Fund be referred to the Board of Directors of the Toronto Atmospheric Fund (TAF) for response, and that TAF report back to the Works Committee".

### **3.5 Advertising Agency Competition for Works and Emergency Services.**

The Works Committee had before it a report (March 11, 2002) from the Commissioner of Works and Emergency Services recommending that:

- (1) the optional two years be exercised under the same terms and conditions for the advertising agency Axmith McIntyre Wicht Ltd. to provide advertising services to the Works and Emergency Services Department based on remuneration of 15 percent of the cost of purchased media time and space; and

- (2) approval be granted to issue purchase orders to the recommended agency for up to \$600,000 for advertising in 2002 and up to \$600,000 for 2003 subject to budgetary approval, which includes the costs of production and the agency commission of 15 percent of the cost of the media buy and including all taxes and charges.

On motion by Councillor Li Preti, the Committee recommended to Council the adoption of the aforementioned report.

**3.6 Use of Radiant Heaters Within Licensed Boulevard Café, and Increase in Fees Relating to These Establishments.**

The Works Committee had before it a report (February 27, 2002) from the Commissioner of Urban Development Services recommending that:

- (1) the Committee approve the use of infrared radiant heating units, within licensed boulevard café areas, provided the licence holder ensures:
- (a) that the infrared radiant heating units are certified by a certification and testing organization accredited by the Standards Council of Canada with the installation guidelines as part of the certification;
  - (b) that the infrared radiant heating units are installed and operated in conformity with the manufacturer's instructions and specifications, including clearances from combustible materials;
  - (c) that the infrared radiant heating units are constructed of weatherproof components and certified for outdoor use;
  - (d) that the infrared radiant heating units are inspected by a representative of the energy provider, and a copy of the inspection certificate shall be provided to the City;
  - (e) that the operator obtains a report from the holder of a certificate under Ontario Regulation 348/96 made under the Energy Act:
    - (i) with respect to propane heating units, that the proposed propane heating unit meets the requirements of the Propane Storage, Handling and Utilization Code (Ontario Regulation 250/94); or

- (ii) with respect to natural gas heating units, that the proposed gas heating unit meets the requirements of Ontario Utilization Code B-149;
  - (f) that the infrared radiant heating units are installed with the manufacturer's wire guard so the element cannot be easily touched;
  - (g) that the infrared radiant heating units are secured to the boulevard or the building wall utilizing the manufacturer's listed parts;
  - (h) that the infrared radiant heating units are located so that they do not present a hazard to café patrons or pedestrians;
  - (i) that the operator attaches a locking device to the infrared radiant heating unit of a design satisfactory to the Commissioner, or the energy source connection is equipped with a shut off valve with provision for locking;
  - (j) that the operator obtains evidence satisfactory to the Commissioner respecting completion of a training course offered by the manufacturer in the use of the infrared radiant heating unit by all persons intended to be operating the unit;
  - (k) that the infrared radiant heating units and energy source connections are not attached to any City-owned tree; and
  - (l) that the infrared radiant heating units are located so that the infrared radiant heat waves are directed away from any City-owned tree;
- (2) the Committee approve a new fee for boulevard cafes where heaters are installed, in accordance with the following schedule:
- (a) Area 1 (as defined in section 313-35 D.): \$37.05 per square metre of boulevard café;
  - (b) Area 2 (as defined in section 313-35 D.): \$74.13 per square metre of boulevard café; and
  - (c) Area 3 (as defined in section 313-35 D.): \$18.55 per square metre of boulevard café;
- (3) the appropriate City officials be authorized to prepare any necessary amendments to Chapter 313, Streets and Sidewalks, of the former City of Toronto Municipal Code and introduce the necessary bills in Council to give effect thereto; and
- (4) this report be forwarded to the Planning and Transportation Committee for its information.



The Committee recommended to Council the adoption of the aforementioned report.

**3.7 Progress Report for Western Beaches  
Tunnel Design-Build Contract No. 58507.  
(Ward 14 - Parkdale-High Park;  
Ward 19 - Trinity-Spadina)**

The Works Committee had before it a report (March 8, 2002) from the Commissioner of Works and Emergency Services respecting the progress of the contract for the design and construction of the Western Beaches Tunnel; advising that the City will instruct the contractor to make connections to the existing sewer system to reach Substantial Performance of the design-build contract by May 1, 2002, with default consequences if the contractor fails to proceed with the connecting work; further advising that more “issue resolution meetings” will be attempted to successfully negotiate as many claims as possible, prior to the scheduled mediation on May 10, 2002; and recommending that authority be granted to amend the existing engineering services agreement with the joint consulting firm of CH2M Gore & Storrie Ltd. and MacViro Consultants Inc. for an additional amount of \$374,500.00, including GST, for extended contract administration and site supervision services during construction.

- (1) recommended to Council the adoption of the aforementioned report;

- (2) requested the Commissioner of Works and Emergency Services to submit a report to the Committee on the actual amount that the project will be over budget.

**3.8 Drainage Problems on Private Laneway  
Between Hearne Avenue and Jane Street.  
(Ward 12 - York South-Weston)**

The Works Committee had before it a report (March 8, 2002) from the Commissioner of Works and Emergency Services responding to Councillor Di Giorgio's request that staff report to the Works Committee on options to relieve a private drainage and ponding problem within the properties bounded by Jane Street, Lawrence Avenue and Hearne Avenue; advising that although the City has no obligation to resolve this private property matter, staff have identified two alternative solutions for the property owners to fix their problems; and recommending that Council receive for information the alternative drainage solutions identified by staff for the property owners in the Jane Street, Lawrence Avenue and Hearne Avenue area in order to solve the private drainage and ponding problems among themselves, without involving the City.

On motion by Councillor Di Giorgio, the Committee recommended to Council the adoption of the following Motion:

“WHEREAS the resident at 10 Hearne Avenue has requested that the City cost share in the installation of a catchbasin at the rear of her property; and

WHEREAS the former City of North York policy provided for the City to share up to 50 percent of the cost of such basins;

NOW THEREFORE BE IT RESOLVED THAT notwithstanding staff's intention to harmonize this policy in the future, the City resolve the drainage problem on the private laneway between Hearne Avenue and Jane Street by cost sharing up to 50 percent of the estimated \$25,000 required to install a catchbasin; the City's share of the cost to be funded from the City's 2002 Water and Wastewater budget, Wastewater Account No. CWW416-08.”

**3.9 Consulting Services -  
Water Pollution Control Treatment Plants.**

The Works Committee had before it a report (March 7, 2002) from the Commissioner of Works and Emergency Services providing an update on the annual expenditures pertaining to existing long-term engineering consulting services agreements for the three major Water Pollution Control Treatment Plants; identifying actual annual expenditures for 1992 to 2001, estimated expenditures for 2002-2003, and anticipated termination in 2003 of each

engineering consulting services agreement for the three major treatment plants; and recommending that this report be received for information.

On motion by Councillor Li Preti, the Committee recommended to Council that the consultants' professional liability for the contracts not be compromised as a result of the termination of the agreements referred to in the aforementioned report.

**3.10 Development Review Backlog - District 1.  
(Former East York, Toronto and York)**

The Works Committee had before it a report (March 7, 2002) from the Commissioner of Works and Emergency Services respecting the Department's initiative to reduce the number of outstanding development applications in District 1 waiting to receive Works and Emergency Services Department's comments, as requested by the Committee at its meeting on March 28, 2001; advising that, from a total of 53 developments reported as backlogged in March 2001, the number of backlogged applications has been steadily decreasing and that it is projected that by the end of March 2002, the backlog will have been eliminated; further advising that it is anticipated that this, together with organizational and process changes within WES, will allow staff to improve turnaround times for new applications and improve services to Urban Development Services; noting that with the elimination of the District 1 backlog, staff will no longer be providing monthly status reports; and recommending that this report be received for information.

Councillor Disero appointed Councillor Pitfield Acting Chair, and vacated the Chair.

- (1) congratulated the Works and Emergency Services Department on eliminating the backlog of outstanding development applications; and
- (2) received the aforementioned report.

The Works Committee had before it a report (March 4, 2002) from the Commissioner of Works and Emergency Services advising that forms for Industrial Waste Surcharge Agreements and Sanitary Discharge Agreements have been developed; and recommending that the forms attached thereto for the Industrial Waste Surcharge Agreements and Sanitary Discharge Agreements be designated for use on all new agreements.

On motion by Councillor Jones, the Committee:

- (1) recommended to Council the adoption of the aforementioned report; and
- (2) requested the Commissioner of Works and Emergency Services to submit a report to the Committee providing more information on private water sources.

**3.12 Cleaning and Cement Mortar Lining of Existing  
Water Mains at Various Locations Within

(Wards 37 and 38 – Scarborough Centre)**

The Works Committee had before it a joint report (March 12, 2002) from the Commissioner of Works and Emergency Services and the Chief Financial Officer and Treasurer recommending that Contract No. 02D4-301WS, Tender Call No. 41-2002 for the cleaning and cement mortar lining of existing water mains at various locations within District 4 be awarded to Fer-Pal Construction Ltd., in the total amount of \$2,545,742.93 including all taxes and charges, being the lowest Tender received.

On motion by Councillor Li Preti, the Committee:

- (1) awarded the contract as recommended in the aforementioned joint report in accordance with Chapter 195, Purchasing, of the City of Toronto Municipal Code; and

- (2) requested that the Commissioner of Works and Emergency Services report back to the Committee on the effectiveness of this technology for rehabilitating water mains, with particular reference to the condition of one or two water mains that were cleaned and lined 10 to 15 years ago.

**3.13 Repair of Damaged Sanitary Sewer at

(Ward 34 - Don Valley East)**

The Works Committee had before it a report (February 22, 2002) from the Commissioner of Works and Emergency Services recommending that:

- (1) the Works Committee ratify the awarding of Contract No. 02D3-300-WP, Tender Call No. 292-2001, Cornerbrook Easement – Sewer Repair, to the low bidder, Drainstar Contracting Ltd., in the amount of \$864,560.00; and
- (2) this report be received for information purposes.

The Committee ratified the awarding of the contract as recommended in Recommendation No. (1) of the aforementioned report.

**3.14 Progress Report and Revised Work Plan  
Schedule for Wet Weather Flow  
Management Master Plan.**

The Works Committee had before it a report (March 15, 2002) from the Commissioner of Works and Emergency Services providing a progress report on a number of important components of the Wet Weather Flow Management Master Plan that have been completed, and a revised work plan schedule for the development of the Master Plan which would allow for complete evaluation of alternative strategies, establishing recommended strategies and preparation of the draft reports for the five study areas for public review prior to the summer holiday period; advising that the City will proceed with unilateral binding arbitration with three of the technical consultant teams, the Joint Venture of MacViro Consultants Inc. and CH2M Hill Canada Limited; XCG Consultants Limited; and Marshall Macklin Monaghan Limited, on amounts of their statements of claim for extra work which exceed the amount permitted under the Financial Control By-law; further advising that the City will continue to be available for additional "issue resolution meetings" to allow the negotiations of the claims to proceed to a possible resolution prior to arbitration; and recommending that this report be received for information.

On motion by Councillor Jones, the Committee recommended to Council the approval of the use of binding arbitration in respect of the consultant claims referred to in the aforementioned report, similar to that adopted by Council on a trial basis for claims under Works construction contracts, save and except for monetary limit.

The Works Committee had before it a report (March 15, 2002) from the Commissioner of Works and Emergency Services respecting the additional resources required to implement and enforce the individual facility-specific Pollution Prevention plans requested by the Board of Health, as requested by Council on June 7, 8 and 9, 2000, by its adoption of Clause No. 1 of Report No. 2 of the Joint Works Committee and Economic Development and Parks Committee; advising that the staff complement will provide the resources to complete the implementation of the new Sewer Use By-law and provide the necessary resources for the enforcement activities; and recommending that this report be received for information.

The Committee received the aforementioned report for information.

**3.16 Professional Services for Front Street  
Extension Environmental Assessment and  
Preliminary Design Study -  
Request for Proposals No. 9117-01-7669.**

The Works Committee had before it a joint report (March 12, 2002) from the Commissioner of Works and Emergency Services and the Chief Financial Officer and Treasurer respecting the results of Request for Proposals No. 9117-01-7669 for professional services for the Front Street Extension Environmental Assessment and Preliminary Design Study; and recommending that:

- (1) subject to the execution of a letter of agreement between the Toronto Waterfront Revitalization Corporation and the City of Toronto identifying the City as the lead agency responsible for delivering the Front Street Extension Project, McCormick Rankin Corporation, as the highest overall scoring proponent, be retained to provide professional services as outlined in their technical proposal for the Front Street Extension Environmental Assessment and Preliminary Design Study for an estimated fee of \$598,665.00 including all taxes and charges; and
- (2) authority be granted to appropriate City staff to enter into an agreement with McCormick Rankin Corporation to carry out this study, such agreement to contain clauses satisfactory to the Commissioner of Works and Emergency Services, the Executive Lead for the Waterfront and the City Solicitor.

The Committee recommended to Council the adoption of the aforementioned report.

**3.17 Supply and Delivery of Reflective Sheeting for  
Traffic Signs, Quotation No. 0802-01-0339.**

The Works Committee had before it a joint report (February 28, 2002) from the Commissioner of Works and Emergency Services and the Chief Financial Officer and Treasurer recommending that:

- (1) Quotation No. 0802-01-0339, Categories A to G, for the supply and delivery of reflective sheeting for traffic signs for a 12-month period following award, be awarded to 3M Canada, in the amount of \$404,517.76 including all taxes and charges, which is equal to the amount of approved interim estimates, being the lowest quotes received that met all specifications detailed in the request for quotation;
- (2) the balance of the award to 3M Canada be referred to Council for approval since the portion of the budget related to the balance in the amount of \$599,276.63 must be approved by Council;
- (3) the option to renew for the additional two one-year periods in the amount of \$2,007,588.80 under the same terms and conditions be reviewed by the Commissioner of Works and Emergency Services in co-operation with the Purchasing Agent, provided the supply and delivery were performed at a satisfactory level, to ensure it is feasible to extend the quotation and that funds are available in the Transportation Services Operating and Capital Budgets for the two renewal periods; and

The Works Committee had before it a report (March 6, 2002) from the Commissioner of Works and Emergency Services providing information on the City of Toronto's residential waste resource diversion performance in 2001; advising that in 2001, 27 percent of the City's residential waste resources was diverted from landfill, compared to the diversion rate of 25 percent achieved in 2000, and that this diversion rate will increase in subsequent years as recovery from existing programs is improved and the new Task Force initiated diversion programs to meet the City's new diversion goals are implemented; noting that the next major milestone for the City is the 2003 target of 30 percent diversion; and recommending that this report be received for information.

**3.42 Scadding Court Community Centre  
Composting Pilot Project.**

The Works Committee had before it a report (March 6, 2002) from the Commissioner of Works and Emergency Services providing information on the Scadding Court Community Centre composting pilot project proposal, as requested by the Committee at its meeting of November 14, 2001; advising that the composting pilot project was not included as a funded item in the 2002 operating budget, and that Works and Emergency Services has already undertaken a study in 1997 to test the viability of community composting at multi-residential complexes and non-profit community groups, and has found that multi-bin composters were effective in diverting organics from landfill; further advising, however, that the Department does feel the project has merit and is willing to provide three free multi-bin composters to Scadding Court as a unique demonstration project, which are available from the existing backyard composting distribution program; and recommending that this report be received for information.

Mr. Kevin Lee, Executive Director, Scadding Court Community Centre, appeared before the Committee in connection with the foregoing matter, and submitted material with respect thereto.

On motion by Councillor Layton, the Committee deferred consideration of the aforementioned report until its next meeting, scheduled to be held on May 1, 2002, with a request that:

- (1) the Commissioner of Works and Emergency Services, in consultation

with Scadding Court Community Centre and the Toronto Housing Company, report back to the Committee with a cost/benefit analysis of the Scadding Court Community Centre proposal; and

- (2) the three multi-bin composters be provided free of charge to the Community Centre as indicated in the report.

### **3.43 Results of Increased Tipping Fees for Clean Fill and Rubble During Last Half of 2001.**

The Works Committee had before it a report (March 11, 2002) from the Commissioner of Works and Emergency Services respecting the results of increased tipping fees for clean fill and rubble materials during the last half of 2001, and advising, in response to the request of City Council at its meeting on May 30, 31 and June 1, 2001, that there have been no additional adjustments to the clean fill and rubble tipping fees since they were increased from \$20 to \$30 per load on July 2, 2001; further advising that the increase in tipping fees in 2001 did not reduce the total number of loads of clean fill and rubble received in the City's landfill sites over 2000, and increased revenues by \$213,000 over the previous year; and recommending that this report be received for information.

**3.46 Update on the Ultra Low Flush Toilet Replacement Program.**

The Works Committee had before it a report (March 20, 2002) from the Commissioner of Works and Emergency Services recommending that:

- (1) the Toronto Community Housing Corporation (TCHC) be provided financial incentives to replace existing high water consumption toilets with ultra-low flush toilets in the amount of \$60.00 for 6 litre toilets and \$75.00 for 6/3 litre dual flush toilets;
- (2) the privately owned, multi-unit residential property owners be provided a financial incentive to replace existing high water consumption toilets with ultra-low flush toilets in the amount of \$40.00 for 6 litre and \$55.00 for 6/3 litre dual flush toilets;
- (3) the single family residential property owners be provided a financial incentive to replace existing high water consumption toilets with ultra-low flush toilets in the amount of \$60.00 for 6 litre and \$75.00 for 6/3 litre dual flush toilets in the 2002 pilot project, and that the Commissioner of Works and Emergency Services report back at the end of the pilot or sooner on the success of this project; and
- (4) the appropriate City officials be granted authority necessary to give effect thereto.

On motion by Councillor Layton, the Committee:

- (1) recommended to Council the adoption of the aforementioned report; and
- (2) requested that the Commissioner of Works and Emergency Services:

- (i) report back to the Committee on operating cost savings and the potential for greenhouse gas credits; and
- (ii) explore opportunities to borrow additional funds from, for example, the Toronto Atmospheric Fund or the Green Municipal Investment Fund, in order to further accelerate or create even larger incentives on a cost/benefit basis to expand the program, and report back thereon to the Committee.

**3.47 Lease Amending Agreement with  
Eastern Power Limited -  
Keele Valley Landfill Site.**

The Works Committee had before it a joint report (March 18, 2002) from the Commissioner of Works and Emergency Services and the City Solicitor recommending that the City enter into a lease amending agreement with Eastern Power Limited, granting to Eastern Power Limited an easement and right-of-way in and over the lands at the Keele Valley Landfill Site, set out as Parcel K of the Site Sketch (Schedule "C", Toronto-York Major – Sketch of Lands) attached to this report, for the purpose of constructing, installing and maintaining underground power lines to and from Eastern Power Limited's landfill gas utilization site, and, in addition, extending the current leasehold term of the lease to a date that is 20 years from the date of Council's approval of the lease amending agreement; York Major Holdings Inc. to execute such amending agreement to acknowledge and agree that the leasehold interest to be granted to it by the City over Parcel K will be subject to the easement and right-of-way being granted to Eastern Power Limited in the amending agreement, such amending agreement to be otherwise on terms and conditions satisfactory to the Commissioner of Works and Emergency Services and the City Solicitor.

The Committee recommended to Council the adoption of the aforementioned report.

**3.48 Status of GST Applicability to Michigan Landfill Contracts.**

The Works Committee had before it a report (March 22, 2002) from the Commissioner of Works and Emergency Services advising that the Canada Customs and Revenue Agency has provided the City of Toronto with an internal opinion regarding the applicability of the Goods and Services Tax to the disposal of residual solid waste at Michigan-based landfills under contract to the City of Toronto, and found, based on their interpretation of the Excise Tax Act, that the GST is applicable; further advising that the City is now in a position to submit a counter argument and can pursue additional appeals if unsuccessful at that stage if a formal assessment or determination of the applicability of GST is made; also advising that in order to prepare a counter argument to the CCRA's internal opinion and subsequent appeal process, if required, it is staff's intention to hire a tax consultant and external legal assistance with expertise in the field of taxation, and that a follow-up report will be submitted; noting, however, that if the City is ultimately unsuccessful, Onyx Waste Management Inc. would be assessed with applicable GST costs as per the provisions of the City's contract with that company, and that the City would be obligated to pay the GST charges under the Republic contract for disposal at the Carleton Farms Landfill, as per the negotiated provisions of that contract; and recommending that this report be received for information.

On motion by Councillor Layton, the Committee submitted the aforementioned report to Council without recommendation.

**3.49 Solid Waste Collection By-law  
Limit of Six Bags Per Week.**

The Works Committee had before it a communication (March 21, 2002) from Councillor Howard Moscoe, Ward 15 - Eglinton-Lawrence, respecting the limit of residential garbage collection to six bags per week under the City's Residential Solid Waste Collection By-law, its impact on large families and complaints received from irate constituents because of the limit; and requesting the Committee to consider some form of exception to accommodate the Orthodox Jewish community.

Councillor Howard Moscoe, Ward 15 - Eglinton-Lawrence, appeared before the Committee in connection with the foregoing matter.

On motion by Councillor Li Preti, on behalf of Councillor Moscoe, the Committee referred the aforementioned communication to the Commissioner of Works and Emergency Services for a report to the Committee on some form of exception to the six-bag limit for very large families.

- (4) the appropriate civic officials be authorized and directed to take whatever action is necessary to implement the foregoing.
