8.1 2003 Capital and Operating Budgets

Consolidated Grants

The Budget Advisory Committee had before it the outstanding items respecting the 2003 Operating Budget for Consolidated Grants.

The Budget Advisory Committee also had before it a communication (June 11, 2002) from the Secretary, Board of Health, advising that the Board of Health at its meeting held on June 10, 2002, recommended that whereas the City of Toronto HIV/AIDS partner agencies are unable to provide the service levels required to adequately address continued and emerging HIV/AIDS prevention across the City of Toronto, that City Council allocate an additional \$275,000.00 to the 2003 Consolidated Grants Budget for AIDS Prevention Grants.

Councillor Kyle Rae, Ward 27 Toronto Centre-Rosedale, appeared before the Budget Advisory Committee in connection with the foregoing matter.

- A. Councillor Moeser moved that the 2003 Consolidated Grants Operating Budget, as recommended by the Grants Sub-Committee, be amended by:
 - (1) adding \$22,000.00 for the 18 child nutrition programs that opened in 2002 to bring such funding to the 24 percent level.

(Carried)

- B. Councillor Tziretas moved that Councillor Moeser's motion A. be amended by adding the following amendment:
 - "(2) deleting \$250,000.00 (gross and net) for Grants Service Harmonization, as recommended by the Grants Sub-Committee."

(Carried)

Councillor Shiner appointed Councillor Soknacki Acting Chair and vacated the Chair.

C. Councillor Shiner moved that Councillor Moeser's motion A. be amended by adding the following amendment:

"(3) deleting \$178,800.00 (gross and net) in the New and Enhanced Service Request for two elementary school nutrition programs that were not funded in 2002, as recommended by the Grants Sub-Committee."

- D. Councillor Pantalone moved that Councillor Moeser's motion C. be amended by adding the following amendment:
 - "(4) requesting the Grants Sub-Committee to reallocate funding in the amount of \$55,000.00 within the 2003 Consolidated Grants Budget, such funding to be allocated to the Fort York Guards Program (\$30,000.00) and report thereon to the Economic Development and Parks Committee prior to its consideration of the disbursement of grants funding under its purview."

Public Health

The Budget Advisory Committee had before it the outstanding items respecting the 2003 Capital and Operating Budgets for Public Health.

The Budget Advisory Committee also had before it the following report and communication:

- (a) (January 20, 2003) from the Medical Officer of Health, advising the Budget Advisory Committee and the Board of Health Budget Sub Committee about deficiencies in relation to Public Health's financial management needs based on reports available from SAP and the extent of the Public Health computer systems budget to be assigned towards the identified deficiencies; and recommending that this report be received for information; and
- (b) (January 30, 2003) from the Secretary, Board of Health, advising that the Board of Health, at its meeting held on January 27, 2003, in part, recommended to the Budget Advisory Committee the adoption of the following Recommendation Nos. (5), (6) and (7):
 - (5) the resources provided for the prevention and control of the West Nile Virus public education programs be strengthened;
 - (6) \$1.5 million gross is required to combat West Nile Virus in 2003; and
 - (7) the approval of funds in the amount of \$750,000.00 net to be allocated to the prevention and control of West Nile Virus be deferred until the 2003 Budget wrap-up meeting to ensure provincial funding and that a concerted GTA-wide approach is taken to combat West Nile Virus.

- (2) adding one time funding in the amount of \$688,000.00 net for the West Nile Virus Program, such funds to be from the Water and Wastewater reserve budget for treatment of catchbasins, subject to a favourable report in that regard to City Council for its meeting of February 24, 2003 from the Chief Administrative Officer, in consultation with, but not limited to, the Commissioner of Works and Emergency Services, the Chair of the Board of Health, the Ministry of Fisheries, Toronto Environmental Alliance and the Toronto and Region Conservation Authority."; and
- (b) request the Chair, Board of Health, to report to the Board of Health, and Council, in June 2003 providing a criteria which ensures the Mobile Dental Service Program targets seniors in long term care facilities who are not able to afford such services to allow staff time to assess the program for consideration of funding in 2004.

 - (b) the Budget Advisory Committee recommend to the Policy and Finance Committee, and Council, the following amendment:

"one time funding in the amount of \$680,000.00 net to be taken from the Water and Wastewater reserve budget for treatment of catchbasins."

Councillor Moeser moved that the Budget Advisory Committee request the Chief Administrative Officer, the Mayor and the Medical Officer of Health to approach the Provincial government to reinforce that the West Nile Virus Program should be 100 percent provincially funded as this is a Province-wide issue.

Children's Services

The Budget Advisory Committee had before it the outstanding items respecting the 2003 Capital and Operating Budgets for Children's Services.

The Budget Advisory Committee also had before it a communication (January 30, 2003) from the Secretary, Board of Health advising that the Board of Health, at its meeting on January 27, 2003, supported and endorsed the recommendations contained in the 2003 Action Plan for Children, submitted by Councillor Pam McConnell, Chair, Policy Sub-Committee, Children and Youth Action Committee.

- (a) (August 6, 2002) from the City Clerk, advising that City Council at its meeting held on July 30, 31 and August 1, 2002, directed that Clause No. 17 of Report No. 7 of The Community Services Committee, headed "Multi-year Shelter Strategy for the City of Toronto", be referred to the Budget Advisory Committee for consideration during the 2003 budget review process; and
- (b) (January 12, 2003) from the Commissioner of Community and Neighbourhood Services, addressed to the Community Services Committee, providing information on the expanded Central Intake Model included in the Shelter, Housing and Support 2003 budget submission; and recommending that this report be received.

Capital

- A. Councillor Pitfield moved that the Budget Advisory Committee recommend to the Policy and Finance Committee, and Council, that the 2003 Capital Budget for Shelter, Housing and Support be amended as follows:
 - (1) the funding for the following projects be approved:
 - (a) 28 Bathurst Street;
 - (b) Eva's Shelter; and
 - (c) 717 Broadview Avenue;

with the balance of funding for the remaining projects being contingent upon Council's decision with regard to a report to be submitted to the Community Services Committee, and Council for its May 21, 2003 meeting by the Commissioner of Community and Neighbourhood Services identifying targets for Council's approval related to new shelter beds in 2003 and future by implementing the Multi-Year Strategy for Shelters.

Toronto Transit Commission

The Budget Advisory Committee had before it the 2003 Operating Budget for the Toronto Transit Commission.

The Budget Advisory Committee also had before it the following reports:

- (a) (November 18, 2002) from the General Secretary, Toronto Transit Commission, advising that the Toronto Transit Commission at its meeting held on November 15, 2002, gave consideration to the report (November 15, 2002), entitled "2003 TTC Operating Budget", and approved the following Recommendations Nos. (1), (2), (3) and (6):
 - (1) the 2003 TTC Operating Budget be approved as described in this report and the following accompanying reports:
 - (a) Toronto Transit Commission 2003 Operating Budget Overview;
 - (b) Toronto Transit Commission 2003 Departmental Goals and Objectives;
 - (c) Toronto Transit Commission 2003 Organization Charts; and
 - (d) Toronto Transit Commission 2003 Detailed Operating Budget (Blue Book);
 - (2) this report be considered in concert with:
 - (a) the 2003 Wheel-Trans Operating Budget; and
 - (b) the 2003-2007 Capital Program and 10-year Capital Forecast;

(3) the TTC 2003 Operating Budget includes a budget shortfall of about \$78 million, based on City of Toronto 2002 budgeted operating subsidy levels as summarized below:

Expenditures \$918.5 million; Revenues \$688.1 million;

Subsidy Needed \$230.4 million;

Operating Subsidy \$152.2 million (2002 budgeted level from City);

and

Shortfall \$ 78.2 million; and

(6) this report be forwarded to the Province of Ontario for approval of the "ramp up" subsidy for the Sheppard Subway;

- (b) (November 18, 2002) from the General Secretary, Toronto Transit Commission, advising that the Toronto Transit Commission at its meeting held on November 15, 2002, gave consideration to the report (November 15, 2002), entitled "2003 Wheel-Trans Operating Budget", and approved the following recommendations:
 - (1) 2003 Wheel-Trans Operating Budget of \$45.7M be provided for in this report and companion documents which includes \$48.2M for service partially offset through revenues of \$2.5M, resulting in a subsidy increase of \$1.2M over the approved 2002 budget;
 - (2) Wheel-Trans Service Plan which encompasses the following key factors:
 - (a) Eligibility Criteria and Application Process remain unchanged;
 - (b) registrant base increases by 10.7 percent to 30,100.00;
 - (c) trip demand increasing by 5 percent to 1,658,600.00;
 - (d) unaccommodated rate remains at 2 percent;
 - (e) trips provided by accessible vehicles increase from 85 percent to 88 percent;
 - (f) workforce increases by two; and
 - (g) on-time delivery of service improved from 96 percent to 97 percent;
 - (3) this report be considered in concert with the following:
 - (a) the 2003 TTC Operating Budget; and

- (b) 2003-2007 TTC Capital Program which includes in 2003 \$5.4M for the purchase of 12 ELF buses (\$3.3M) as well as facility improvements and scheduling enhancements (\$2.1M); and
- (4) this report be forwarded to the City of Toronto Council for approval and to the TTC's Advisory Committee on Accessible Transportation (ACAT) for information:
- (c) (February 6, 2003) from the Chief General Manager, Toronto Transit Commission, providing a status update on the Toronto Transit Commission's 2003 Operating Budget and 2003 to 2007 Capital Program; and
- (d) (January 20, 2003) from the Chief Financial Officer and Treasurer, responding to a request concerning the feasibility of exempting the TTC's properties from property taxes; and recommending that this report be received for information.

The Budget Advisory Committee also had before it a communication (January 27, 2003) from Councillor Frank Di Giorgio, Chair, Humber York Community Council, advising that the Humber York Community Council on January 21, 2003:
