Confirmation of Minutes

On motion by Councillor Soknacki, the Minutes of the Budget Advisory Committee meetings held on January 24, 27, 28, 29, 30 and 31, 2003, February 12, 13, 14, 21, 2003 and the Joint Meeting of the Policy and Finance Committee and the Budget Advisory Committee held on February 17, 2003, were confirmed.

11.1 Final Year-end 2002 Capital Variance Report

The Budget Advisory Committee had before it a report (June 3, 2003) from the Chief Financial Officer and Treasurer, providing the City of Toronto Capital Variance report for the year ended December 31, 2002; and recommending that:

- (1) a detailed review of capital projects be performed during 2003 and any adjustments required be reported through the quarterly variance reports and that this review be taken into consideration when planning the 2004 capital budget; and
- (2) this report be forwarded to the Policy and Finance Committee, and Council, for consideration.

On motion by Councillor Soknacki, the Budget Advisory Committee:

- (1) recommended to the Policy and Finance Committee, and Council, the adoption of the aforementioned report; and
- (2) requested the Chief Administrative Officer and the Chief Financial Officer and Treasurer to meet with interested Members of the Budget Advisory Committee to discuss alternative ways to measure project expenditures, including future reports being presented on an "accrual" basis rather than on a "cash flow" basis, and report thereon to the Budget Advisory Committee.

11.2 Final Year-end 2002 Operating Variance Report

The Budget Advisory Committee had before it a report (June 4, 2003) from the Chief Financial Officer and Treasurer, providing the City of Toronto Operating Variance report for the year ended December 31, 2002; and recommending that:

- (1) the unallocated incremental 2002 surplus of \$2.4 million be transferred to the Land Acquisition Reserve Fund to partially offset withdrawals used to finance Council's SARS Economic Recovery initiatives in 2003; and
- (2) the Final Operating Variance report for the year ended December 31, 2002, be forwarded to the Policy and Finance Committee for its consideration.

Councillor Shiner appointed Councillor Soknacki Acting Chair and vacated the Chair.

On motion by Councillor Shiner, the Budget Advisory Committee recommended to the Policy and Finance Committee, and Council, the adoption of the aforementioned report.

Councillor Shiner resumed the Chair.

11.3 2003 First Quarter Capital Variance Report

The Budget Advisory Committee had before it a report (June 3, 2003) from the Chief Financial Officer and Treasurer, providing the City of Toronto Capital Variance report for the first quarter ended March 31, 2003; and recommending that:

- (1) Council adjust the 2003 Approved Capital Budget by \$70.4 million gross expenditures along with associated financing with no incremental financial impact in order to carry forward to 2003 unspent cash-flow for 2002 approved capital projects;
- (2) the Homes for the Aged 2003 capital budget be increased by \$800,000.00 to be fully funded from the Homes for the Aged Capital Reserve Fund, such expenditures to be part of the previously approved HFA General Upgrades project; and
- (3) this report be forwarded to the Policy and Finance Committee for consideration.
 - A. Councillor Pantalone moved that the Budget Advisory Committee recommend to the Policy and Finance Committee, and Council, the adoption of the aforementioned report.

Councillor Shiner appointed Councillor Soknacki Acting Chair and vacated the Chair.

B. Councillor Shiner moved that the Chief Administrative Officer, in conjunction with the Chief Financial Officer and Treasurer, be requested to provide the capital quarterly variance reports based on the estimated cashflow expenditures and report to the Budget Advisory Committee in that regard for its meeting in July 2003 on ways this could be achieved in 2004 and future years.

11.7 Central Waterfront Transit

- (1) recommended to the Policy and Finance Committee, and Council, that the Toronto Waterfront Revitalization Corporation, in consultation with the appropriate City staff and the Toronto Transit Commission, be requested to prioritize within the planned \$800 million funding allocated for public transit and communicate these priorities to the City through the Waterfront Reference Group; and
- (2) received the aforementioned communication for information.

11.8 Procurement Authorization Davisville Carhouse Roofing Rehabilitation Contract S5-27

The Budget Advisory Committee had before it a communication (May 15, 2003) from Mr. Vincent Rodo, General Secretary, Toronto Transit Commission, advising that the Toronto Transit Commission, at its meeting held on May 14, 2003, gave consideration to a report, entitled "Procurement Authorization Davisville Carhouse - Roofing Rehabilitation Contract S5-27", and adopted the following recommendations:

- (1) the Commission authorize acceptance of the tender submitted by Nortex Roofing Ltd. in the amount of \$1,280,000.00, for Contract S5-27 Davisville Carhouse Roofing Rehabilitation; and
- (2) this report be forwarded to the City Budget Advisory Committee for information.
