The Striking Committee met on Monday, April 7, 2003, in Meeting Room C, 2<sup>nd</sup> Floor, City Hall, Toronto, commencing at 10:05 a.m.

Confirmation of Minutes.

On motion by Councillor Mike Feldman, the Striking Committee confirmed the minutes of its meeting held on January 23, 2003.

# 2.1. Appointments of Members of Council to the Special Committee to Structure a Five Year Fiscal Plan

The Striking Committee had before it a communication (March 10, 2003) from the City Clerk, advising that Council, at its meetings held on February 24, 25, 26, 27, and 28, and March 3, 2003, established a seven member Special Committee to structure a Five-Year Fiscal Plan for the City of Toronto, resolved that at least one Member of the Charter City Reference Group be appointed to the Special Committee; and requested the City Clerk to canvass Members of Council for their interest in appointment to the Special Committee, and submit those names to Council for consideration at its meeting to be held on April 14, 2003.
