Minutes of the Toronto East York Community Council

Meeting No. 3

Tuesday, April 1, 2003

The Toronto East York Community Council met on Tuesday, April 1, 2003, in Committee Room No. 1, 2nd Floor, City Hall, Toronto, commencing at 9:30 a.m.

No interests were declared pursuant to the Municipal Conflict of Interest Act.

On motion by Councillor McConnell, the Toronto East York Community Council confirmed the Minutes of its Meeting held on January 21, 2003.

3.1 Draft By-law respecting Surplus Land Declaration and Proposed Closing and Conveyancing of Portions of Adelaide Street East Road Allowance, abutting Premises No. 19 Wilkins Avenue (Toronto Centre-Rosedale, Ward 28)

The Toronto East York Community Council had before it a draft by-law from the City Solicitor respecting Surplus Land Declaration and Proposed Closing and Conveyancing of Portions of Adelaide Street East Road Allowance, abutting Premises No. 19 Wilkins Avenue.

The Toronto East York Community Council also had before it Clause 47 of Toronto East York Community Council Report No. 9, headed "Surplus Land Declaration and Proposed Closing and Conveyancing of Portions of Adelaide Street East Road Allowance, abutting Premises No. 19 Wilkins Avenue", which was adopted by Council at its Special Meeting held on July 30, 31 and August 1, 2002.

The Toronto East York Community Council had before it a final report (March 14, 2003) from the Director, Community Planning, South District, respecting Application to Amend the Official Plan and Zoning By-Law 438-86 – 100 Queen's Park (Royal Ontario Museum), and recommending that approval be given to an application to amend Zoning By-law 438-86, as amended, for a 3716 square metre (40,000 square feet) addition to the existing Royal Ontario Museum to create 6 additional galleries oriented towards the Bloor Street frontage, office space, a restaurant and a café.

The Toronto East York Community Council recommended that:

On motion by Councillor Chow:

- (1) the report (March 14, 2003) from the Director, Community Planning, South District be adopted;
- (2) authority be granted for the introduction of the necessary Bill in Council to designate 100 Queen's Park for architectural and historical reasons under Part IV of the Ontario Heritage Act;
- (3) City Council approve, under Part IV of the Ontario Heritage Act, the alterations to the property at 100 Queen's Park illustrated on drawings HD-01, HD-02, H-01, H-02, H-03 dated January 27, 2003, prepared by E.R.A. Architects Inc. (Attachments No. 3, 4, 5, 6, 7), subject to the following conditions:
 - (i) prior to the issuance of any above-grade permit under the Building Code Act 1992, the owner provide to the satisfaction of the Manager, Heritage Preservation Services:
 - (a) a complete Conservation Plan, to include the Phase One Restoration Plan required prior to demolition of the Terrace Gallery and a detailed description of all additional restoration work relating to the heritage defining features of the property;
 - (b) a letter of credit in a form and in an amount satisfactory to the Manager, Heritage Preservation Services, to secure all restoration work included in the Conservation Plan that is additional to that outlined in the Phase One Restoration Plan;

- (ii) prior to the issuance of the first building permit including excavation and shoring but not including a demolition permit under the Building Code Act 1992, the owner shall enter into and register on title a Heritage Easement Agreement for the property, to the satisfaction of the City Solicitor and the Manager, Heritage Preservation Services;
- (iii) prior to Site Plan Approval, the owner shall submit a detailed landscape plan for the Queen's Park frontage of the property that also illustrates any proposed changes to the existing vegetation adjacent to the heritage facades, to the satisfaction of the Manager, Heritage Preservation Services;
- (4) authority be granted by City Council for the execution of a Heritage Easement Agreement under Section 37 of the Ontario Heritage Act with the owner of 100 Queen's Park, using substantially the form of easement agreement prepared in February 1987 by the City Solicitor and on file with the City Clerk, subject to such amendments as may be deemed necessary by the City Solicitor in consultation with the Manager, Heritage Preservation Services;
- (5) the Architect be urged to ensure that the new structure's transparency be maximised to ensure that the historical building is visible from the street including where the new and old parts of the building are attached;

On motion by Councillor Pantalone:

- (6) the request for a permit for tree removal and injury at 100 Queen's Park be approved, subject to:
 - (a) the trees in question not being removed or injured until permitted construction and/or demolition related activities in accordance with plans approved under Rezoning and Site Plan Approval Application No. 202017 commence which warrant the injury and destruction of the trees; and
 - (b) the applicant agreeing to plant replacement trees acceptable to the Commissioner of Economic Development, Culture and Tourism;

On further motion by Councillor Chow:

(c) the Royal Ontario Museum providing \$50,000.00 for tree planting in the immediate area of the museum, particularly Philosophers' Walk;

On further motion by Councillor Pantalone:

- (d) the Royal Ontario Museum providing \$100,000.00 in funding to the City of Toronto to establish a Trees for Toronto Fund, for a tree planting and identification program in Queen's Park;
- (e) this program be implemented in consultation with the Ward Councillor, the Royal Ontario Museum and the City's Tree Advocate;

On further motion by Councillor Chow:

- (7) the Commissioner of Urban Development Services, in consultation with the University of Toronto, report to the Toronto East York Community Council on the re-establishment of Taddle Creek, in and near the west wall of the Music Terrace at the north entrance of Philosophers' Walk; and
- (8) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

- (3) pursuant to the requirements of Schedule B of the Municipal Class Environmental Assessment Act, Notice of Study Commencement be given to the Ministry of Environment, Fire Services, Emergency Medical Services and Toronto Police Services, and upon final approval of a by-law by Council, Notice of Completion be issued;
- (4) the speed limit be reduced from forty kilometres per hour to thirty kilometres per hour on Fairview Boulevard, from Bowden Street to Broadview Avenue, coincident with the implementation of speed humps; and
- (5) the appropriate City officials be authorized and directed to take whatever action is necessary to implement the foregoing, including the introduction in Council of any Bills that are required.

3.46 Shaftesbury Avenue, north side, east of Yonge Street adjacent to the entrance of the Summerhill Subway Station - Installation of a taxicab stand (Toronto Centre-Rosedale, Ward 27)

- (4) the speed limit be reduced from forty kilometres per hour to thirty kilometres per hour coincident with the implementation of speed humps on:
 - a) Nesbitt Drive:
 - b) Governors Road; and
- (5) the appropriate City Officials be authorized and directed to take the necessary action to give effect thereto, including the introduction in Council of any bills that may be required.

3.48 King Street West and Atlantic Avenue - Installation of Traffic Control Signals (Trinity-Spadina, Ward 19)

WHEREAS the Owner has a purchaser of the vacant, development portion of the property and the purchaser wishes to have the Heritage Easement Agreement deleted from title to the vacant, development portion of the property being purchased; and

WHEREAS the Manager of Heritage Preservation Services is content with deletion of the Heritage Easement Agreement from title to the vacant, development portion of the property; and

WHEREAS time is of the essence in the sale of the development portion of the property;

NOW THEREFORE be it resolved that:

(1) the Owner of the property at 30 Charles Street East be required to post a letter of credit, upon execution of an amending Heritage Easement Agreement, in a form and in an amount satisfactory to the Manager,

Heritage Preservation Services, to secure all work required by the Heritage Easement Agreement;

- authority be granted by City Council for the execution of an amending Heritage Easement Agreement under Section 37 of the Ontario Heritage Act with the owner of 30 Charles Street East, to, among other matters, delete the existing Heritage Easement Agreement from the title of the development portion of the property, receive security and set out the terms of enforcement and reliance on the security, using substantially the form of easement agreement prepared in February 1987 by the City Solicitor and on file with the City Clerk, subject to such amendments as may be deemed necessary by the City Solicitor in consultation with the Manager, Heritage Preservation Services;
- (3) authority be granted by City Council for the execution of a Consent Agreement under Section 53 of the Planning Act with the owner of 30 Charles Street East; and
- (4) the appropriate City Officials be authorized and directed to take the necessary action to give effect thereto."

NOW THEREFORE be it resolved that:

Works and Emergency Services staff be directed to undertake the appropriate studies of traffic operations to determine:

- a) the feasibility of reconfiguring the south-west corner of Yonge Street and Harbour Street to make the corner more pedestrian friendly, including the possible elimination or reconfiguration of the channelized right turn lane, and/or introduction of right-turn restrictions; and
- b) the potential for increasing the number of eastbound turn lanes from Yonge Street onto Queens Quay from one to two, with a concomitant increase of southbound lanes from two to three; and,
- c) the potential for removal of parking on Yonge Street between Harbour Street and Queens Quay Street to facilitate better traffic flow; and,

- d) the feasibility of reconfiguring the north-west corner of Yonge Street and Lakeshore Boulevard to make it more pedestrian friendly; and,
- e) the feasibility of removing all guardrails abutting Yonge Street between the railway underpass and Harbour Street; and,
- f) the cost of adding sidewalk lighting on the east and west sides of the Yonge Street underpass of the railway corridor; and,
- g) the feasibility of closing the parking lot under the Gardiner Expressway south of Lakeshore Boulevard between Yonge Street and Bay Street; and,
- h) the feasibility of adding a TTC shelter at the bus stop on the west side of Bay Street between Harbour Street and Queens Quay; and,
- i) the feasibility of relocating the Bay Street ramp to the eastbound Gardiner Expressway gate and/or pedestrian crossing at this location to make it more pedestrian-friendly; and,
- j) the feasibility and cost of attaching splash guards on the underside of the Gardiner Expressway and ramps to weather protect the sidewalks on the east side of Bay Street and west and east sides of Yonge Street; and,
- k) the feasibility of widening the sidewalk and reducing the length of the taxi lane on the east corner of Queens Quay and Yonge Street to make it more pedestrian friendly; and,
- that Works and Emergency Services staff report back to the Planning and Transportation Committee and/or Toronto East York Community Council no later than September 2003."
