### Minutes of the Toronto East York Community Council

#### Meeting No. 5

**Tuesday, June 10, 2003** 

The Toronto East York Community Council met on Tuesday, June 10, 2003, in Committee Room No. 1, 2<sup>nd</sup> Floor, City Hall, Toronto, commencing at 9:30 a.m.

5.1 City Solicitor submitting Draft By-law to permanently close the public lane north of Adelaide Street East, extending easterly from Ontario Street, at the rear of Premises No. 474 Adelaide Street East (Toronto Centre-Rosedale, Ward 28)

The Toronto East York Community Council had before it a draft by-law from the City Solicitor respecting permanently closing the public lane north of Adelaide Street East, extending easterly from Ontario Street, at the rear of Premises No. 474 Adelaide Street East

- (d) the owner providing financial security in an amount and form satisfactory to the Commissioner of Economic Development, Culture and Tourism to implement the Conservation Plan, prior to the issuance of any building permit, including permits for excavation and shoring.
- authority be granted by City Council for the execution of a Heritage Easement Agreement under Section 37 of the Ontario Heritage Act with the owner of 106 King Street East, using substantially the form of easement agreement prepared in February 1987 by the City Solicitor and on file with the City Clerk, subject to such amendments as may be deemed necessary by the City Solicitor in consultation with the Manager, Heritage Preservation Services; and
- (3) the appropriate City Officials be authorized and directed to take the necessary action to give effect thereto.

(6) require the owner to submit to the Commissioner of Works and Emergency Services approved plans of the development, with sufficient horizontal and vertical dimensions of the exterior walls of the proposed building for the purposes of preparing building envelope plans for site specific exemption by-laws. Such plans should be submitted at least 3 weeks prior to the introduction of a bill in Council;

#### On motion by Councillor Pantalone:

- (7) require the applicant to provide an easement, if so requested by the Commissioner of Works and Emergency Services and/or the Commissioner of Urban Development Services, that would provide for vehicular access to the property at the northeast corner of Hayden Street and Yonge Street;
- (8) require the applicant to protect for future connections below grade to the southwest corner of Bloor and Yonge Streets;
- (9) require the applicant to protect for, and build if required by the Commissioner of Works and Emergency Services and/or the Commissioner of Urban Development Services, an underground connection independent of the subway, between the southeast and northeast corners of Bloor and Yonge Streets;
- (10) require the applicant to plant at least four trees being in the City boulevard, and tol provide an irrigation system, including automatic timer, and be designed to be water efficient by a Certified Landscape Irrigation Auditor (CLIA) and constructed with a back flow preventer to the satisfaction of the Commissioner of Works and Emergency Services, including requirements to maintain good order and operation.

On motion by Councillor Pantalone, the Toronto East York Community Council allowed the introduction of a communication (June 3, 2003) from Councillor Laura Jones respecting Parking on the north side of Gerrard Street East, between Broadview Avenue and Don Jail Roadway.

On motion by Councillor Jones, the Toronto East York Community Council requested the Commissioner of Works and Emergency Services and the President of the Toronto Parking Authority to report to the Community Council, at its meeting to be held on July 8, 2003 on the feasibility of installing Pay and Display Machines on the north side of Gerrard Street East, between Broadview Avenue and Don Jail Roadway as a compensation to the lost revenue in the parking lot on Gerrard Street East, west of Broadview Ave and for ongoing maintenance of the Toronto Zhong Hua Men Archway, on the condition that the Parking Authority approve the construction of the Archway in the parking lot, which may take up to 4 parking spaces in lot, at no cost to the Chinese Chamber of Commerce (East Toronto).
