#### **Confirmation of Minutes**

## 8.1 Cycling on Public Sidewalks – Ward 41 – Scarborough-Rouge River

The Toronto Cycling Committee had before it a memorandum (May 28, 2004) from Councillor Bas Balkissoon (Scarborough Rouge-River, Ward 41), advising that he has been contacted by constituents concerned about the increase in cycling on public sidewalks.

Councillor Bas Balkissoon appeared before the Toronto Cycling Committee.

On motion by Ms. McMartin, the Toronto Cycling Committee recommends that:

- (1) the deputation from Councillor Bas Balkissoon, (Scarborough Rouge-River Ward 41), be received with thanks; and
- (2) the memorandum (May 28, 2004) from Councillor Bas Balkissoon (Scarborough Rouge-River, Ward 41), be referred to the Safety Subcommittee for review and report back to the Toronto Cycling Committee.

#### 8.5 Union Station

The Toronto Cycling Committee had before it a communication (October 4, 2004) from Mr. Tim Laspa, Program Manager, Transportation Planning, Urban Development Services, advising that he will arrange for a presentation before the Toronto Cycling Committee, in early 2005, with representatives from Union Pearson Group (UPG), once the City of Toronto and UPG have entered into a Master Agreement for UPG to operate and maintain Union Station.

Mr. Laspa further advised that planning for the Union Station revitalization would then take place through 2005. During this time, it will be necessary to consider specific details of a variety of Station elements, including bicycle facilities.

# 8.6 St Clair Avenue West Transit Improvement Environmental Assessment – Yonge Street to Gunns Road

The Toronto Cycling Committee had before it a copy of Policy and Finance Committee Report 7, Clause 1, recommendations, which were adopted, as amended, by City Council on September 28, 29, 30 and October 1, 2004.

On Motion by Ms. Nowak, the Toronto Cycling Committee recommends that the Commissioner of Urban Development Services be requested to present to the Toronto Cycling Committee, the design alternatives, for the St. Clair Avenue West Transit Improvement Environmental Assessment – Yonge Street to Gunns Road project, when available.

# 8.7 Bicycle Racks on Toronto Transit Commission Buses

The Toronto Cycling Committee had before it a communication (October 18, 2004) from Councillor Adam Giambrone, Ward 18 – Davenport, and Chair, Toronto Cycling Committee, addressed to Mayor David Miller and the Commissioners, Toronto Transit Commission, advising that on behalf of the Toronto Cycling Committee, the following two recommendations have been presented for their consideration:

"(1) That the TTC initiate a 12-month pilot of bike racks on buses. The pilot should include a minimum of four routes, to be determined in consultation with the Toronto Cycling Committee. Every bus on these routes shall be outfitted with

a bike rack, and a small budget should be allocated to promote the pilot on the website, and at key outdoor locations, such as adjoining subway stations and bus shelters on the routes, and on the bike rack-equipped buses; and

(2) That the TTC should meet with the TCC within one month to identify proposed routes, and develop a proposed budget and timeline for the November commission meeting. This group should meet monthly, and report back to the Commission on its progress at monthly intervals."

On Motion by Ms. Grieveson, the Toronto Cycling Committee recommends that the two recommendations contained in the communication (October 18, 2004) from Councillor Adam Giambrone, Ward 18 - Davenport, be endorsed and that Councillor Adam Giambrone be requested to present the proposal outlined in the noted communication to the Toronto Transit Commission.

On Motion by Mr. Nelson, the Toronto Cycling Committee recommends that the minutes of the Promotions Subcommittee dated September 23, 2004, the minutes of the Safety Subcommittee dated September 27, 2004, the minutes of the Bikeway Network Subcommittee dated September 29, 2004, and the minutes of the Transit and Cycling Working Group dated September 28, 2004, be received.

## 8.9 2005 Toronto Cycling Committee Budget Submission

The Toronto Cycling Committee had before it the Budget Working Group minutes dated October 4, 2004.

Each subcommittee, from their September meetings, forwarded their budget requests to the Budget Working Group for consideration.

Mr. Martin Koob, Chair, Budget Working Group, made a verbal presentation regarding the deliberations and recommendations presented as part of the October 4, 2004 Budget Working Group minutes.

On Motion by Mr. Koob, the Toronto Cycling Committee recommends that:

- (1) the Works Committee be requested to consider the following recommendations from the Toronto Cycling Committee regarding the 2005 Toronto Cycling Committee Budget Submissions:
  - (a) that the base budget for cycling infrastructure in the Works and Emergency Services Capital Budget be increased to \$2 million; and
  - (b) that the Works and Emergency Services Operating Budget be increased by an amount that would allow

for the addition of 2 positions to the staff compliment of the Cycling Pedestrian Infrastructure Unit of Transportation Services, to allow the development of the bikeway network to proceed according to the timelines as set out in the Toronto Bike Plan;

- (2) the Economic Development and Parks Committee be requested to consider the following recommendations from the Toronto Cycling Committee regarding the 2005 Toronto Cycling Committee Budget Submissions:
  - (a) that \$1.5 million be budgeted in the Pathway Upgrades budget item in the Economic Development, Culture and Tourism, Parks and Recreation Capital Budget, in order to enhance the bikeway network;
  - (b) that \$48,500.00 be budgeted in the Economic Development, Culture and Tourism, Parks and Recreation Capital Budget, to allow for Bikeway Network Route Signs to be erected along the Don Trail, Humber Trail, Taylor Creek Trail and the Beltline Trail;
  - (c) that a staff position be created in the Economic Development, Culture and Tourism, Parks and Recreation Operating Budget, to be responsible for planning Bikeway Network Trails in the Parks system and co-ordinating the work of the Parks and Recreation Department in implementing the Bikeway Network;
  - (d) that the Economic Development and Parks Committee request the Commissioner of Economic Development, Culture and Tourism to prepare a report which identifies and consolidates all budget line items, in both the Capital and Current Budgets, that relate to cycling issues, such as pathway maintenance/upgrades, parks

signage, trails, etc.; and that the Commissioner of Economic Development, Culture and Tourism also be requested to report on the feasibility of including all the cycling related issues as a single line item in the Capital and Current Budgets, to allow for easier tracking; and

- (e) that the Economic Development and Parks Committee be requested to consider increasing the resources allocated in the Economic Development, Culture and Tourism, Parks and Recreation Current Budget, for the delivery of the CAN-Bike program through the Parks and Recreation Department; and
- (3) the recommendations from the Budget Working Group regarding the Urban Development Services Toronto Cycling Committee 2005 Budget Submission, be referred back to the Budget Working Group and that the Budget Working Group forward their recommendations directly to Planning and Transportation Committee; and that the Budget Working Group take into account the comments and suggestions made by members of the Toronto Cycling Committee;
- (4) the Chair be requested to present the 2005 Toronto Cycling Committee Budget Submission to the Works Committee, the Planning and Transportation Committee and Economic Development and Parks Committee.
