Confirmation of November 22, 2004 Minutes

On motion by Councillor Ashton, the minutes of the e-City Committee held on November 22, 2004, were confirmed.

Point of Order

Councillor Del Grande arose on a Point of Order and stated that at the November 22, 2004 e-City Committee meeting the e-City Committee requested a report directly to the Committee on the release of information in connection with Request for Proposals 3401-04-3216 (Supply, Delivery and Installation of Desktop and Notebook Computers and Related Products and Services) – Copies of Responses to Sections 5.5, 6, 8, 9, 10 and 12. He stated that the information has not been received.

On motion by Councillor Del Grande, the e-City Committee again requested the Chief Financial Officer and Treasurer and the Commissioner of Corporate Services, in consultation with appropriate City Officials, to provide as soon as possible, to each of the e-City Committee members, copies of the responses from the eight proponents to Request for Proposal 3401-04-3216, Sections 5.5, 6, 8, 9, 10 and 12, and that staff also be requested to submit a report to the e-City Committee. The Committee also requested that if the information is not forthcoming, the City Clerk report to the e-City Committee and to the Mayor as to why the information is not being released.

11.5 Integrating Smart Card Technology with e-City Initiatives

On motion by Councillor Milczyn, with Councillor Soknacki in the Chair, the e-City Committee requested the Commissioner of Corporate Services (Executive Director, Corporate Information and Technology), to ensure that the Parking Authority is involved in the discussions; and also as part of ongoing discussions, request Provincial staff to look seriously at utilizing smart card technology for other non-transit applications in the Municipal sector.

On motion by Councillor Ashton, the e-City Committee requested the Commissioner of Corporate Services (Executive Director, Corporate Information and Technology) to report on the communication from Councillor Milczyn.
