Confirmation of Minutes

On motion by Councillor Rae, the Minutes of the Economic Development and Parks Committee meeting held on December 4, 2003, were confirmed.

2.1 Operation and Maintenance of a Winter Tennis Facility Installation of New Tennis Bubble at Eglinton Flats - RFP (Ward 11 York South-Weston)

- (2) the Commissioner of Economic Development, Culture and Tourism be directed to negotiate and execute a License Agreement with First Service Tennis Management Inc. for the 15-year term commencing October 1, 2004, in a form and content, consistent with the RFP and acceptable to the City Solicitor;
- (3) an obligatory reserve fund called the Eglinton Flats Tennis Facility Maintenance Reserve Fund be established to provide for the ongoing maintenance of the tennis courts at Eglinton Flats;
- (4) Municipal Code Chapter 227, Reserve and Reserve Funds, be amended by adding the "Eglinton Flats Tennis Facility Maintenance Reserve Fund" to Schedule "C"; and
- (5) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto, and that leave be granted for the introduction of any necessary bills in Council to give effect thereto.

2.3 Aerospace Cluster: Directions and Proceedings of the September 18, 2003 Aerospace Stakeholders Conference (All Wards)

- (4) the Mayor request meetings with the Prime Minister of Canada and the Premier of Ontario to garner support for an updated aerospace strategy and particularly aircraft equity guarantees for domestic and export markets, research and technology development support for new product development and increased Canadian content with regards to Air Canada;
- (5) an Aerospace Action Partnership be established to guide the development and implementation of a comprehensive aerospace strategy and that Council endorse the terms of reference for the Partnership as outlined in Attachment No. 3; and
- (6) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

- (7) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

- (3) as part of the 2004 Operating Budget process, the Culture Operating Budget include an increase of \$100,000.00 gross/\$50,000.00 net offset by a decrease in the Toronto Centre for the Arts Operating Budget of \$50,000.00 net and a one-time transfer of \$50,000.00 from the Public Art Reserve Fund (XR 4002) to the Culture Operating Budget for a corporate net \$0 impact;
- (4) as part of the 2005 Operating Budget process, the Culture Operating Budget include an increase of \$70,000.00 net to fund the annualized facility operating costs for MOCCA offset by a decrease in the Toronto Centre for the Arts Operating Budget of \$70,000.00 net for a corporate net \$0 impact; and
- (5) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

- (3) for the duration of the line of credit guarantee, the Commissioner of Economic Development, Culture and Tourism be authorized to issue the City's grant payment to the TSO on monthly installments pro-rated to its annual grant allocation if the line of credit is in good standing and the TSO be requested to submit bimonthly variance reports on their cash flow forecast to the Chief Financial Officer and Treasurer; and

(4) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

2.18 Toronto Cycling Committee 2004 Budget Allocations

The Economic Development and Parks Committee had before it a communication (December 4, 2003) from the City Clerk, advising that the Toronto Cycling Committee on Monday, November 17, 2003, recommended that the following Resolution No. (1) be forwarded to the Economic Development and Parks Committee for consideration:

"WHEREAS City Council at its meeting held on July 24, 25 and 26, 2001, in adopting Clause No. 3 of Planning and Transportation Committee Report No. 8, approved in principle the report headed "Strategic Plan for Cycling in Toronto: The 'Toronto Bike Plan – Shifting Gears'"; and WHEREAS the Toronto Bike Plan projected that \$1.2 million would be required to be budgeted in the 2004 Economic Development, Culture and Tourism Capital Budget, in order to complete the Toronto Bike Plan, within the stated 10 year time frame;

NOW THEREFORE BE IT RESOLVED THAT the Toronto Cycling Committee request the Economic Development and Parks Committee to recommend to the Budget Advisory Committee that \$1.2 million be allocated in the 2004 Economic Development, Culture and Tourism Capital Budget for the infrastructure requirements, as stated in the Toronto Bike Plan."

On motion by Councillor Augimeri, the Economic Development and Parks Committee deferred consideration of the request from the Toronto Cycling Committee until its meeting of February 9, 2004.

2.19 International Alliance Program - City of Toronto Initiative to Explore the Possibility of Entering into a Long-Term Relationship with the City of Paris, France to Stimulate Investment, Trade, Tourism and Civic Exchange

The Economic Development and Parks Committee had before it a communication (October 2, 2003) from the City Clerk, advising that City Council on September 22, 23, 24 and 25 referred the following motion to the Economic Development and Parks Committee:

"WHEREAS the Mayor of the City of Toronto and Councillor Mario Silva have held discussions with the Mayor of Paris, France; and

WHEREAS the City of Paris has expressed an interest in creating a longer-term relationship with the City of Toronto; and

WHEREAS the Mayor of the City of Paris has stated publicly that he believes that Paris can learn much from the City of Toronto; and

WHEREAS the City of Paris has been identified as an Alpha category City, meaning it is a world City and therefore the type of City with which Toronto should align itself; and

WHEREAS the City of Toronto recognizes that forming economic, cultural and community ties with other world cities strengthens Toronto's economy, well-being and international profile; and

WHEREAS the City of Toronto has developed an International Alliance Program to use City-to-City relationships to further Toronto's economic, cultural, tourism, and cross-cultural community development ties internationally; and

WHEREAS the City of Toronto's International Alliance Program Policy outlines the criteria and process by which the selection of all new relationships must abide;

NOW THEREFORE BE IT RESOLVED THAT in accordance with the procedures and criteria established in the International Alliance Program Policy approved by Council in its meeting on December 4, 5 and 6, 2001, Council initiate the exploration of a long-term relationship with the City of Paris."

On motion by Councillor Rae, the Economic Development and Parks Committee referred the motion by Councillor Silva to the Commissioner of Economic Development, Culture and Tourism, for report thereon to the Economic Development and Parks Committee.

2.20 Canadian National Exhibition Association ("CNEA") Appointments to the Board of Governors of Exhibition Place

The Economic Development and Parks Committee had before it a report (October 10, 2003) from Ms. Dianne Young, General Manager and CEO, Exhibition Place; recommending that:

- (1) Ms. Debbie Woodman (Honourary President), Mr. Doug Holyday (First Vice-President) and Mr. Knox Henry (Second Vice-President) be appointed to The Board of Governors of Exhibition Place for a term of office expiring on the date of the CNEA Annual Meeting of the Association on October 14, 2004, or until their successors are duly appointed; and
- (2) the appropriate Exhibition Place officials be authorized and directed to take the necessary action to give effect thereto.

2.21 Dundas Square - Impact of Costs Incurred by the Toronto Police Service

The Economic Development and Parks Committee had before it a communication (October 10, 2003) from Councillor Gloria Lindsay Luby, Acting Chair, Toronto Police Services Board, advising that the Toronto Police Services Board, at its meeting on September 18, 2003, forwarded the following Recommendation to the Economic Development and Parks Committee for consideration:

"The Board send a request to the City of Toronto recommending that upon receipt of an application for a permit to hold an event at Dundas Square which indicates that the total anticipated number of participants attending the event exceeds the capacity of Dundas Square (8,000 persons with no seating), the City not approve the application and, if possible, recommend an alternate location in the City of Toronto which can better accommodate a crowd over 8,000 persons."

A. Councillor Lindsay Luby moved that the Economic Development and Parks Committee refer the aforementioned communication to the Commissioner of Economic Development, Culture and Tourism for report thereon to the Economic Development and Parks Committee.

2.22 Tender No. 200-2003 – Casa Loma Structural Repairs Phase 3 – South Terrace, 1 Austin Terrace (Ward 22 – St. Paul's)
