4.1 Application by the Bloor-Yorkville Business Improvement Area for a "Tourist Area" Exemption from the <u>Retail Business Holidays Act</u> (Ward 27 Toronto Centre-Rosedale)

The Economic Development and Parks Committee had before it a report (April 8, 2004) from the Commissioner of Economic Development, Culture and Tourism, seeking approval of a by-law to permit retail businesses within the Bloor-Yorkville Business Improvement Area to remain open on holidays identified in the <u>Retail Business Holidays</u> <u>Act</u> for the maintenance and development of tourism; and recommending that:

- (1) a by-law be enacted, prepared by the City Solicitor substantially in the form attached, to permit retail businesses within the Bloor–Yorkville Business Improvement Area as detailed in the application submitted December 4, 2003, to open on holidays identified in the <u>Retail Business Holidays Act</u> commencing with the July 1, 2004 Canada Day holiday;
- (2) the Commissioner of Economic Development, Culture and Tourism be authorized to recover advertising and any other associated costs incurred by the City respecting the application from the Bloor–Yorkville Business Improvement Area; and
- (3) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

Ms. Eileen Costello, Aird and Berlis, appeared before the Economic Development and Parks Committee in connection with the foregoing matter.

- (4) subject to the City Clerk reporting favourably on the results of the notice of intention to pass a by-law designating the area (poll) referred to in Recommendation No. (2) above, and upon receipt of the survey prepared by the Commissioner of Works and Emergency Services, the City Solicitor be directed to prepare a by-law designating the area highlighted in Attachment No. 1 as a Business Improvement Area, in accordance with Sections 204 and 209 of the <u>Municipal Act</u>; and
- (5) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

- (viii) Sports Pads (Various Parks) (\$0.450 million new capital project);

 - (c) The Friends of Fort York be awarded a grant of \$15,000.00 to be applied to their 2004 operating budget; and
- (2) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

On motion by Councillor Rae, the Economic Development and Parks Committee recommended to Council the adoption of the aforementioned report.

4.21 Parking Revenue Increase Options

The Economic Development and Parks Committee had before it a joint report (April 29, 2004) from the Commissioner of Economic Development, Culture and Tourism and the Chief Financial Officer and Treasurer, responding to a Council directive requesting staff to explore the feasibility of offsetting the revenues from parking charges in regional and waterfront parks with a commitment of increased revenues in excess of the 2004 approved revenue budget/targets from the Toronto Parking Authority and/or Parking Tag Enforcement revenues; and recommending that this report be received for information.

Councillor Cliff Jenkins, Ward 25 Don Valley West, appeared before the Economic Development and Parks Committee in connection with this matter.

Councillor Lindsay Luby appointed Councillor Hall Acting Chair and vacated the Chair.

On motion by Councillor Lindsay Luby, the Economic Development and Parks Committee directed that the aforementioned joint report be forwarded to Council without recommendation.

Councillor Lindsay Luby resumed the Chair.
