Confirmation of Minutes

10.3 Toronto Pearson International Airport International Air Transport Association (IATA) and Air Transport Association of Canada (ATAC) (All Wards)

The Economic Development and Parks Committee considered the following communication and report:

- (1) (September 30, 2004) from Councillor Brian Ashton, Chair, Economic Development and Parks Committee, forwarding joint letter from International Air Transport Association and Air Transport Association of Canada requesting, the City to participate in the resolution of Pearson International Airport's cost structure, competitiveness and governance.; and
- (2) (December 1, 2004) from the Commissioner of Economic Development, Culture and Tourism providing input into the development of a new *National Airports Act* and the federal government review of Crown rents it charges the Greater Toronto Airport Authority for the use of land and facilities at Toronto Pearson International Airport.

Recommendations:

It is recommended that:

(1) Council request the federal government, through the Minister of Transport and Minister of Finance, to substantially reduce or eliminate the Crown rent for TPIA;

- (2) Council request the Minister of Transport to give consideration to the principles recommended by IATA and ATAC to ensure transparency and accountability of fee setting by airport authorities;
- (3) Council request the Minister of Transport to consult with the City of Toronto and other affected stakeholders, in regard to the development of a new or revised *National Airports Act*; and
- (4) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

10.4 Toronto Trail's Festival Update

The Economic Development and Parks Committee considered a communication (November 24, 2004 from Tom Fiore, Principal, Toronto Trails Festival, providing an update on the Toronto Trails Festival program.

Tom Fiore, Principal, Toronto Trails Festival, appeared before the Economic Development and Parks Committee.

Councillor Ashton appointed Councillor Lindsay Luby Acting Chair and vacated the Chair.

On motion by Councillor Ashton, the Economic Development and Parks Committee:

- (1) received the communication;
- (2) requested the Commissioner of Economic Development, Culture and Tourism, to work with Toronto Trails Festival program representatives to identify opportunities to foster this project as part of the City's fitness strategy and report thereon to the Economic Development and Parks Committee; and

(3) thanked and congratulated Tom Fiore for his very informative presentation and the implementation of the Toronto Trails Festival - "Taking Toronto for a Walk".

10.5 High Park, South Humber Park and Lambton Park Proposed Prescribed Burns, Spring 2005 (Ward 13, Parkdale - High Park; Ward 5, Etobicoke -Lakeshore)

The Economic Development and Parks Committee considered a report (November 26, 2004) from the Commissioner of Economic Development, Culture and Tourism, informing City Council that Urban Forestry Services staff are continuing their efforts to restore and maintain provincially rare black oak savannah/woodland vegetation communities in High Park, South Humber and Lambton Park by implementing prescribed burning as a proven management tool.

Recommendations:

- (1) the City Forester, in conjunction with the Fire Chief/General Manager, be authorized to approve the Operational Prescribed Burn Plan prepared by the Fire Chief and proceed with the implementation of a Prescribed Burn in High Park, Lambton Park and South Humber Park in Spring 2005;
- (2) the City Forester consult with the two local Ward Councillors regarding preparation of appropriate communications for distribution to the local communities;
- (3) the City Forester consult with the Park Supervisors, Fire Services and Toronto Police Services regarding safety issues;
- (4) in future years, the City Forester, in conjunction with the Fire Chief, be authorized to approve the Operational Prescribed Burn Plan prepared by the Fire Chief and proceed with implementation of prescribed burns in appropriate areas following consultation with local Councillors; and
- (5) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

On motion by Councillor Hall, the Economic Development and Parks Committee:

- (1) recommended that City Council adopt the staff recommendations in the Recommendations Section of the report; and
- (2) requested the Commissioner of Economic Development, Culture and Tourism to report to the Economic Development and Parks Committee on the potential expansion of the prescribed burns into other areas of the City to manage the City woodlots.

10.6 Crothers' Woods Natural Area Management Master Plan (Ward 29 Toronto-Danforth)

The Economic Development and Parks Committee considered a report (November 30, 2004) from the Commissioner of Economic Development, Culture and Tourism, reporting, as directed, on the development of a Natural Area Management Master Plan for Crothers' Woods.

Recommendations:

- (1) a Natural Area Management Master Plan for Crothers' Woods be developed by the Parks and Recreation in consultation with all relevant user groups, ratepayers and environmental group representatives, to set out management requirements to mitigate human impacts on the natural environment, preserve its unique character, and improve its environmental health, conditional on the approval of the Capital Budget request under the Environmental Initiatives Section Don Valley Trail Management and Restoration included in the 2005 Parks and Recreation submission;
- (2) the funding request of \$100,000.00 for a Master Plan and subsequent work at Crothers' Woods, included in the \$750,000.00 EMT Recommended Parks and Recreation Capital Budget sub-project entitled "City Wide Environmental Initiatives 2005", be referred to the Budget Advisory Committee for consideration during the 2005 budget process; and
- (3) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

On motion by Councillor Ootes, the Economic Development and Parks Committee:

- (1) recommended that City Council adopt Recommendations (1) and (3) in the Recommendations Section of the report; and
- (2) referred Recommendation (2) to the Budget Advisory Committee for consideration during the 2005 budget process.

10.7 Intention to Designate the College West Business Improvement Area (Ward 18 Davenport and Ward 19 Trinity-Spadina)

The Economic Development and Parks Committee considered a report (November 24, 2004) from the Commissioner of Economic Development, Culture and Tourism, recommending the designation of the College West Business Improvement Area.

Recommendations:

- (1) the area described by Attachment 1 (Maps 1 to 2) be designated as a Business Improvement Area (BIA), under Section 204 of the *Municipal Act*:
- (2) the City Clerk be authorized and directed to send out a notice of Council's intention to pass a by-law designating the area, as defined in Attachment 1 (Maps 1 to 2), as a Business Improvement Area, in accordance with Section 210 of the *Municipal Act*;
- (3) the Commissioner of Works and Emergency Services be requested to prepare a legal description of the area, as described by Attachment 1 (Maps 1 to 2), and to submit this description to the City Solicitor;
- (4) subject to the City Clerk reporting favourably on the poll results referred to in Recommendation (2), and upon receipt of the legal description prepared by the Commissioner of Works and Emergency Services, the City Solicitor be directed to prepare a by-law designating the area as a Business Improvement Area as

- described by Attachment 1 (Maps 1 to 2), in accordance with Section 204 of the *Municipal Act*; and
- (5) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

On motion by Councillor Lindsay Luby, the Economic Development and Parks Committee recommended that City Council adopt the staff recommendations in the Recommendations Section of the report.

10.8 Intention to Designate the West Queen West Business Improvement Area (Ward 18 Davenport and Ward 19 Trinity-Spadina)

The Economic Development and Parks Committee considered a report (November 24, 2004) from the Commissioner of Economic Development, Culture and Tourism, recommending the designation of the West Queen West Business Improvement Area.

Recommendations:

- (1) the area described by Attachment 1 (Maps 1 to 5) be designated as a Business Improvement Area (BIA), under Section 204 of the *Municipal Act*:
- (2) the City Clerk be authorized and directed to send out a notice of Council's intention to pass a by-law designating the area, as defined in Attachment 1 (Maps 1 to 5), as a Business Improvement Area, in accordance with Section 210 of the *Municipal Act*;
- (3) the Commissioner of Works and Emergency Services be requested to prepare a legal description of the area, as described by Attachment 1 (Maps 1 to 5), and to submit this description to the City Solicitor;
- (4) subject to the City Clerk reporting favourably on the poll results referred to in Recommendation (2), and upon receipt of the legal description prepared by the Commissioner of Works and Emergency Services, the City Solicitor be directed to prepare a by-law designating the area as a Business Improvement Area as described by Attachment 1 (Maps 1 to 5), in accordance with Section 204 of the *Municipal Act*; and

(5) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

On motion by Councillor Lindsay Luby, the Economic Development and Parks Committee recommended that City Council adopt the staff recommendations in the Recommendations Section of the report.

10.9 Transition of Audit Costs from the City to Business Improvement Areas (BIAs) (All Wards)

The Economic Development and Parks Committee considered a report (November 30, 2004) from the Commissioner of Economic Development, Culture and Tourism recommending that the City of Toronto continue to provide rebates to help offset the audit costs now incurred directly by BIAs for 2005 and 2006 and that such rebates end in 2007.

Recommendations:

It is recommended that:

- (1) City Council continue to issue rebates to the BIA's to help offset audit costs for the fiscal years 2004 through 2006, to a maximum amount of \$50,000.00 per year, and that such funding continue to be included in the Economic Development, Culture, and Tourism operating budget;
- (2) City Council require BIAs to assume the full cost of auditing financial statements beginning in 2007, at the end of a three-year transition period; and
- (3) this report be forwarded to the Policy and Finance Committee for consideration.

10.10 Review of Toronto Arts Council Operations Funding (All Wards)

Recommendations:

- (3) any further budget enhancement over the 2005 EMT Recommended Budget should be submitted as a business case to the Commissioner of Economic Development, Culture and Tourism and the Chief Financial Officer and Treasurer for inclusion in the operating budget process;
- (4) the TAC consult with the Corporate Grants Team on the feasibility of TAC using the new corporate grants information system; and
- (5) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto, including the introduction in Council of any Bills that may be required.

On motion by Councillor Hall, the Economic Development and Parks Committee:

- (1) recommended that City Council adopt the staff recommendations in the Recommendations Section of the report; and
- (2) requested the Commissioner of Economic Development, Culture and Tourism, in consultation with the Toronto Arts Council, to report to the January 10, 2005 meeting of the Economic Development and Parks Committee, on the notification and appeal process for the allocation of grants throughout the City.

10.11 Major Cultural Organizations Culture Plan Budget Target (All Wards)

10.12 Hospitality Workers Resource Centre Task Force (All Wards)

The Economic Development and Parks Committee considered a report (November 29, 2004) from the Commissioner of Economic Development, Culture and Tourism, reporting on the conclusions and recommendations reached by the Task Force which was established by City Council at its meeting on July 20, 21 and 22, 2004 to devise a long-term plan for the Hospitality Workers Resource Centre as part of a broader labour force development strategy in this key sector of the Toronto economy.

Recommendations:

It is recommended that:

(1) the Commissioner of Economic Development, Culture and Tourism be requested to consult further with key stakeholders in the tourism sector, organizations representing labour and labour development interests, and service providers at all three levels of government and the educational system, and report back to the Economic Development and Parks Committee on the actions needed to advance

the recommendations of "The Tourism and Hospitality Sector in Toronto: Toronto Labour Force Development Readiness Plan 4", paying particular attention to the following:

- (a) the needs of the recent immigrant and less well-educated segments of the workforce;
- (b) the need for additional services for the Hospitality Sector workforce such as were set out in the Hospitality Workers and Resource Centre's October 2004 proposal; and
- (c) the service delivery model that was provided by the Hospitality Workers Resource Centre:
- (2) City Council continue to guide and participate in the consultation process and the determination of actions needed to advance labour force development within the hospitality sector as the "Task Force on Hospitality Sector Labour Force Development"; and
- (3) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

Councillor Shelley Carroll, Ward 33 Don Valley East, appeared before the Economic Development and Parks Committee.

Councillor Ashton appointed Councillor Lindsay Luby Acting Chair and vacated the Chair.

Recommendations:

It is recommended that:

- (1) Council support the City's participation in the Premier-Ranked Tourist Destination Framework (PRTD) process subject to consideration of the financial implications to be determined as part of the 2005 Operating Budget process; and
- (2) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

The Economic Development and Parks Committee considered a communication (November 1, 2004) from the City Clerk advising that the City Council at its meeting on October 26, 27 and 28, 2004, considered Clause 2, Report 8 of the Policy and Finance Committee and directed that commencing with the 2005 report year, Commissioners provide a year-end report of non-financial information to their appropriate Standing Committee, in order to provide information on how programs progressed during the year in terms of performance and achievements; and requested that during the upcoming

budget cycle the Standing Committees establish, by program area, bench marks which could be measured for service delivery.

On motion by Councillor Rae, the Economic Development and Parks Committee received the communication.

10.16 2005 Toronto Cycling Committee Budget Submission

The Economic Development and Parks Committee considered a report (November 25, 2004) from the Toronto Cycling Committee, advising that the Toronto Cycling Committee on October 18, 2004 and November 15, 2004 recommended to the Economic Development and Parks Committee that:

- (1) \$1.5 million be budgeted in the Pathway Upgrades budget item in the Economic Development, Culture and Tourism, Parks and Recreation Capital Budget, to enhance the Bikeway Network;
- (2) \$48,500.00 be budgeted in the Economic Development, Culture and Tourism, Parks and Recreation Capital Budget, to allow for Bikeway Network Route Signs to be erected along the Don Trail, Humber Trail, Taylor Creek Trail and the Beltline Trail:
- a staff position be created in the Economic Development, Culture and Tourism, Parks and Recreation Operating Budget, to be responsible for planning the Bikeway Network Trails in the Parks system and co-ordinating the work of the Parks and Recreation Department in implementing the Bikeway Network;
- (4) the Commissioner of Economic Development, Culture and Tourism prepare a report to the Economic Development and Parks Committee which:
 - (a) identifies and consolidates all budget line items, in both the Capital and Current Budgets, that relate to cycling issues, such as pathway maintenance/upgrades, parks signage, trails, etc.; and
 - (b) reports on the feasibility of including all the cycling related issues as a single line item in the Capital and Current Budgets, to allow for easier tracking; and

(5) it consider increasing the resources allocated in the Economic Development, Culture and Tourism, Parks and Recreation Current Budget, for the delivery of the CAN-Bike Program through the Parks and Recreation Department.

- (1) City Council formally express its support for establishing the C-Series Jet final assembly program at Bombardier's de Havilland site in Downsview and urge senior levels of government to support the growth of the aerospace industry in Toronto and Ontario;
- (2) City Council approve, in principle, the establishment of a Community Improvement Plan (CIP) for the Downsview employment area to encourage its economic development;

- (3) City Council approve, in principle, the provision of financial support for the revitalization and development of new industrial/commercial facilities in the Downsview Employment Area, consistent with the City's new Official Plan, and that includes the use of tax incremental equivalent grants (TIEG) and waiving development related fees as a component of the CIP;
- (4) City Council request the Commissioner of Economic Development, Culture and Tourism, in consultation with the Chief Financial Officer and Treasurer, to report to Council at its next meting with respect to the proposed financial support program; and
- (5) City Council request the Commissioner of Urban Development Services, in consultation with the Commissioner of Economic Development, Culture and Tourism, to report to Council at its next meeting on the process for developing the Community Improvement Plan for the area and any other related issues.
