Confirmation of Minutes

On motion by Fiona Nelson, the Minutes of the meeting of the Board of Health on September 20, 2004, were confirmed.

7.1 Recognition of New Members and Outgoing Citizen Members

On behalf of the Board of Health, the Chair acknowledged the presence of the new citizen members and welcomed them to the Board. He also recognized the work and contribution of the outgoing citizen members and presented a plaque to Nancy Peters and Lee Zaslofsky.

On motion by Councillor Fletcher, the Board of Health requested the Secretary to forward a plaque to Helen Chan and Brian MacKay, the outgoing citizen members who were unable to attend the meeting.

7.2 Strategies to Address the Increase in Sexually Transmitted Infections in Toronto

The Board of Health considered a report (October 4, 2004) from the Medical Officer of Health responding to a request from the Board of Health on June 14, 2004, for a report on current, planned and proposed strategies to address the rising rates of sexually transmitted infections in Toronto and the associated impact of these strategies; advising that additional resource implications of the proposed strategies will be included in the 2005 Toronto Public Health Operating Budget request and Community Partnership and Investment Program submissions and reports, which will be presented to the Board of Health at the November 22, 2004 meeting.

Recommendations:

It is recommended that:

- (1) the Medical Officer of Health include funds for enhancements to all components of sexual health programming to decrease Sexually Transmitted Infections, as outlined in the report, in the 2005 Toronto Public Health Operating Budget submission;
- (2) the Medical Officer of Health include funds for enhancements required for AIDS Prevention Grants in the 2005 Community Partnership & Investment Program Operating Budget submission;
- (3) the Board of Health request the Ministry of Education to require that school boards fully implement the comprehensive sexual health curriculum;
- (4) the Board of Health request Toronto's four local school boards to fully implement the comprehensive sexual health curriculum; and
- (5) the appropriate City Officials be authorized and directed to take the necessary action to give effect thereto.

The Medical Officer of Health made an overhead presentation.

- A. Fiona Nelson moved that the Board of Health:
 - (1) adopt the staff recommendations in the Recommendations Section of the report (October 4, 2004) from the Medical Officer of Health; and

- (2) refer the report to the Mayor's Roundtable on Children and Youth, for its meeting on October 21, 2004. (Carried as amended by motion B. by Trustee Cary-Meagher)
- B. Trustee Cary-Meagher moved that Motion A. by Fiona Nelson be amended by deferring consideration of Recommendations (3) and (4) until the Chair and the Vice-Chair of the Board of Health and the Medical Officer of Health meet with staff of the School Boards to discuss the delivery of the sexual health curriculum and the Medical Officer of Health has prepared a report to the Board of Health on how it can best collaborate with the School Boards to ensure best practices in the delivery of these programs. - C. Councillor Davis moved that a copy of the requests in Recommendations (3) and (4) be forwarded to all student and school councils along with a copy of the report from the Medical Officer of Health. (Not put)

7.3 Learning from SARS: Recommendations for Toronto Public Health Emergency Preparedness, Response and Recovery

The Board of Health considered a report (October 4, 2004) from the Medical Officer of Health submitting the Toronto Public Health report, "Learning from SARS: Recommendations for Toronto Public Health Emergency Preparedness, Response and Recovery;" and advising that any additional resources required to implement the Toronto Public Health Recommendations will be considered in the 2005/6 Toronto Public Health Operating Budget process.

Recommendations:

It is recommended that:

- (1) the Board of Health forward the report to the Ontario Public Health Association, the Association of Local Public Health Agencies, Ontario Boards of Health, The Commission to Investigate the Introduction & Spread of SARS in Ontario and the Provincial and Federal Governments for information and appropriate action;
- (2) the Board of Health urge the Ontario Ministry of Health & Long-Term Care to move forward with the implementation of Operation Health Protection announced in June 2004;

- (3) the Medical Officer of Health report in 2005 on progress in Toronto Public Health emergency preparedness; and
- (4) the appropriate City Officials be authorized and directed to take the necessary action to give effect thereto.

On motion by Councillor Mihevc, the Board of Health referred the report (October 4, 2004) from the Medical Officer of Health back to the Medical Officer of Health and requested that he conduct additional consultations with City departments and report back to the Board of Health as soon as possible.

7.4 Impact of the Toronto Pearson International Airport on Air Quality in Toronto

The Board of Health considered a report (October 4, 2004) from the Medical Officer of Health responding to a request from the Board of Health on April 8, 2002, for a report on the impact of the Greater Toronto Airports Authority operations on air quality in Toronto.

Recommendations:

It is recommended that:

- (1) the Board of Health request the Ontario Ministry of the Environment to:
 - (a) conduct community-based air quality monitoring of nitrogen oxides, carbon monoxide, particulate matter and other pollutants of concern identified in this report in those residential areas around the Toronto Pearson International Airport with the greatest predicted impact; and
 - (b) develop an emissions inventory for the community surrounding the airport for pollutants of concern identified in this report, including carbonyl compounds, especially acrolein;
- (2) the Board of Health request Environment Canada to expand the National Air Pollutant Surveillance program by establishing a monitoring station to monitor for carbonyl compounds, particularly acrolein, in those residential areas with the greatest predicted impact;
- (3) the Board of Health request the Greater Toronto Airports Authority (GTAA), in consultation with the Medical Officers of Health for the City of Toronto and the Region of Peel, Transport Canada, the Ontario Ministry of Environment and Environment Canada, to:

- (a) ensure that, at a minimum, the future air monitoring program at the Toronto Pearson International Airport includes assessment of nitrogen oxides, carbon monoxide, particulate matter and carbonyl compounds, particularly acrolein;
- (b) maintain the Airport ambient air monitoring program for at least 15 years over the period of the airport expansion to assess the potential air quality impacts associated with changes in Toronto Pearson International Airport operations;
- (c) report annually on the results of the monitoring program to the GTAA Noise Management Committee, Air Quality Subcommittee, and the Medical Officers of Health for the City of Toronto and Peel Region;
- (d) commission a human health risk assessment for particulate matter when the aviation related emissions models are revised; and
- (e) implement ongoing measures to reduce on-site nitrogen oxide emissions such as working with the airline companies to make emissions reduction a priority, particularly in considering the purchase of new aircraft;
- (4) the Board of Health forward this report to Peel Regional Council for information;
- (5) the Board of Health forward this report to the Region of Peel and City of Toronto Councillors representing wards adjacent to Pearson Airport; and
- (6) the appropriate City Officials be authorized and directed to take the necessary action to give effect thereto.

On motion by Councillor Fletcher, the Board of Health adopted the staff recommendations in the Recommendations Section of the report (October 4, 2004) from the Medical Officer of Health.

7.5 Legislative and Educational Strategies to Reduce Hot Tap Water Temperature in Homes

The Board of Health considered a report (October 4, 2004) from the Medical Officer of Health providing an update on a recent change to the Ontario Building Code as follow-up to a report dated April 29, 2003, from the Medical Officer of Health, entitled "Amendment of Building Codes to Reduce Hot Tap Water Temperature in Homes" [May 12, 2003 Board of Health Meeting, Minute 4.10]; and describing the implementation of a health communication campaign by Toronto Public Health to reduce hot tap water temperature in homes.

Recommendations:

It is recommended that:

- (1) the Board of Health and Toronto City Council write to the Minister of Municipal Affairs and Housing commending the Minister for amending the Ontario Building Code to reduce hot tap water temperatures;
- (2) the Board of Health forward this report for information and appropriate action to the Planning and Transportation Committee; and
- (3) the appropriate City Officials be authorized and directed to take the necessary action to give effect thereto.

On motion by Councillor Mihevc, the Board of Health:

- (1) requested that:
 - (a) a letter be forwarded to the Minister of Municipal Affairs and Housing commending him for amending the Ontario Building Code to reduce hot tap water temperatures; and
 - (b) the report be forwarded for information and any appropriate action to the Planning and Transportation Committee; and
- (2) recommended that City Council write to the Minister of Municipal Affairs and Housing commending him for amending the Ontario Building Code to reduce hot tap water temperatures; and
- (3) authorized and directed the appropriate City Officials to take the necessary action to give effect thereto.

7.8 City Council Action - Proposed Exemption from the Smoking By-law for Retail Tobacco Stores

The Board of Health considered a communication (October 5, 2004) from the City Clerk advising that City Council on September 28, 29, 30 and October 1, 2004, referred to the Board of Health a Motion, entitled "Proposed Exemption from the Smoking By-law for Retail Tobacco Stores," by Councillor Karen Stintz, with a Fiscal Impact Statement; and containing the following Operative Paragraph:

"... NOW THEREFORE BE IT RESOLVED THAT an exemption to the City of Toronto Smoking By-law be granted for Retail Tobacco Stores and that they be defined as a retail establishment whose sales are comprised primarily of tobacco and related products."

Mirsad Jakubovic, Chief Financial Officer, Havana House, appeared before the Board of Health.

Councillor Stintz moved that the Motion by Councillor Stintz be adopted and the appropriate City Officials be authorized to introduce the necessary Bills in Council to give effect thereto. (Lost)

7.15 Establishment of a Dental Clinic at the North York Civic Centre

WHEREAS the school based model presents several limitations in terms of being able to offer programming to seniors, adults and family units; and

WHEREAS the model adopted in all other communities offers a public space model more adapted to the needs of the community; and

WHEREAS elsewhere civic dental facilities are located in public buildings; and

WHEREAS there is a need to review the model for delivery of service in the North District.

THEREFORE BE IT RESOLVED THAT this matter be referred to the Board of Health; and

THEREFORE BE IT FURTHER RESOLVED THAT the Board of Health consider the feasibility of establishing a dental clinic in the North York Civic Centre.

On motion by Councillor Fletcher, the Board of Health referred the Motion to the Medical Officer of Health for a feasibility report to the Board of Health.
