(i		potential procedures to ensure that Council adheres to the Fiscal Sustainability Principles once they are adopted;
(1		review of the 14 Fiscal Sustainability Principles as included in Toronto City Council's Strategic Plan dated January 2002; and
()		review of other municipalities' practices regarding debt loads, credit ratings, etc.
