# 2.1 2004 Budget Process and Schedule of Meetings

The Striking Committee had before it a joint report (November 25, 2003) from the City Clerk and the Chief Financial Officer and Treasurer recommending that:

- (1) the 2004 Schedule of Meetings attached as Schedule 1 to this report be adopted, on the understanding that City Council may need to make subsequent revisions to the Schedule as noted in this report;
- (2) the 2004 Schedule of Meetings, as approved by City Council, be circulated to the City's Agencies, Boards, Commissions and special committees established by City Council, with a request that wherever possible they avoid scheduling meetings that conflict with City Council meetings and the Standing Committees to which they report; and
- (3) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

The Striking Committee also had before it a communication (October 2, 2003) from the City Clerk forwarding a copy of Clause 58 contained in Report No. 9 of the Policy and Finance Committee, headed "2004 Budget Process, Directions and Schedules", which City Council at its meeting held on September 22, 23, 24 and 25, 2003, adopted and amended this Clause:

- (1) to provide that Council recommend to the incoming Council that the revised 2004 budget process calendar submitted by the Chief Financial Officer and Treasurer be implemented; and
- (2) by adding thereto the following:

"It is further recommended that the Chief Administrative Officer and the Chief Financial Officer and Treasurer be requested to prepare:

- (a) an orientation for Members of Council regarding the 2004 Capital and Operating Budgets; and
- (b) tools to educate the public regarding the City of Toronto's budget challenges."

On motion by Councillor Soknacki, the Striking Committee recommended to Council adoption of the foregoing communication.

AND BE IT FURTHER RESOLVED THAT the appropriate City officials be authorized and directed to take whatever action is necessary to implement these recommendations."
