On motion by Councillor Shiner, Ward 24 – Willowdale, the minutes of the meeting of the Toronto North Community Council held on May 4, 2004 were confirmed.

6.1 Request to Remove One Privately Owned Tree – 281 Fairlawn Avenue (Ward 16 – Eglinton-Lawrence)

The Toronto North Community Council had before it a report (May 3, 2004) from the Commissioner of Economic Development, Culture and Tourism, reporting on an application for a permit to remove one 51 cm diameter white spruce tree on private property.

Recommendations:

It is recommended that:

- (1) Toronto North Community Council deny the request for the removal of one privately owned tree at 281 Fairlawn Avenue; or
- (2) Toronto North Community Council approve the request for the removal of one privately owned tree at 281 Fairlawn Avenue, conditional on the owner agreeing to implement the planting plan on file with Urban Forestry Services.

Recommendations:

It is recommended that:

On motion by Councillor Jenkins, Ward 25 – Don Valley West, the Toronto North Community Council deferred consideration of Clause No. 4a of Toronto North Community Council Report No. 3, titled "Request for Fence Exemption – 14 Breen Crescent (Ward 25 – Don Valley West)" to its meeting on September 14, 2004 to allow the applicant and neighbours involved to pursue the process agreed upon to settle the dispute.

6.4 Request for Approval of Variances from the former City of York Sign By-law No. 3369-79, as amended, for the erection of a back to back third party advertising Roof Sign at 1627 Eglinton Avenue West (Ward 15 – Eglinton-Lawrence)

The Toronto North Community Council had before it a report (March 16, 2004) from the Director of Building and Deputy Chief Building Official, North District, Urban Development Services, reporting on a request by the property owner of 1627-1629 Eglinton Avenue West, for a variance from the former City of York Sign By-law No. 3369-79, as amended, to permit the erection of a back to back off premise roof sign.

Recommendation:

It is recommended that the request for a variance be refused for the reasons outlined in the report.

Recommendations:

 - (c) that the construction fence be erected in accordance with the provisions of the Municipal Code, Chapter 363, Article III, if deemed appropriate by the Chief Building Official;
 - (d) that all debris and rubble be removed immediately after demolition;
 - (e) that the site be maintained free of garbage and weeds, in accordance with the Municipal Code, Chapter 623-5 and 629-10, Paragraph B;
 - (f) that any holes on the property are backfilled with clean fill.

 - (f) the owner providing Heritage Preservation Services with two (2) copies of the required photographs for inclusion in the Heritage Easement Agreement;
- (5) authority be granted by City Council for the execution of a Heritage Easement Agreement under Section 37 of the *Ontario Heritage Act* with the owner of 235 McRae Drive, using substantially the form of easement agreement prepared in February 1987 by the City Solicitor and on file with the City

WHEREAS in its review of the effect of traffic, City of Toronto staff has required that a part of the development access from Keele Street, be restricted to right in and right out; and

WHEREAS Keele Street is being resurfaced this summer (2004);

THEREFORE BE IT RESOLVED THAT City of Toronto Works and Emergency Services staff explore the feasibility of extending the median located at the north of the northerly Highway 401 ramp terminal intersection as part of this year's Keele Street resurfacing work; and

BE IT FURTHER RESOLVED THAT City Council inform the Developer (Independence Way Inc.) to immediately let all of its current and future condo purchasers know that the City of Toronto intends to limit access to the new development from Keele Street to right in and right out only."
