- (b) Draft Terms of Reference for discussion.
- (c) Strike a Nominating Sub-Committee consisting of 3 members and 2 alternates members who will recommend new citizen appointments to the Committee.

- (a) (November 28, 2003) "Six Points Interchange Reconfiguration" (Dundas /Bloor and Kipling); (Form provided if Committee has any concerns or comments regarding this project).
- (b) (October 16, 2003) Scarlett Road/ CP Galt Subdivision Rail Grade Separation; (Form provided if Committee has any concerns or comments regarding this project).

The Toronto Pedestrian Committee had before it a communication (October 20, 2003) from UMA Engineering Ltd. regarding:

(c) Queen's Drive Bridge Detail Design and Construction
Administration Rehabilitation Project (Black Creek Drive and Queen's Drive)

On motion by Mr. J. Richard Nelson the Toronto Pedestrian Committee replied to these matters:

- (a) strongly supports the reconfiguration of the Six Points interchange. The current configuration is hostile to pedestrians and cyclists and the Committee looks forward to a design more appropriate for an urban environment and more supportive of the Pedestrian Charter and Bike Plan;
- (b) supports a review of the Scarlett Road / CP Gait Subdivision Grade Separation and will participate in consultations on problems and solutions of the site.
- (c) thanks UMA Engineering for informing the Committee of the upcoming work on the Queen's Drive Bridge over Black Creek Drive. The Committee particularly commends UMA for their commitment to maintain pedestrian access during the project.

#### 1.8 City Budget issues – Proposed reduction of sidewalk snow clearing

The Toronto Pedestrian Committee had before it a communication (February 11, 2004) from Ms. Helen Riley (Feet on the Street) regarding City budget issues – Proposed

reduction of sidewalk snow clearing and sidewalk repairs while continuing with the Front Street Extension (oral report).
