Confirmation of Minutes

On motion by Councillor Giambrone, the Minutes of the meeting of the Works Committee held on December 4, 2003, were confirmed.

2.1 Modifications to Fees to City of Toronto Waste Transfer Stations

The Works Committee held a statutory Public Meeting on January 12, 2004, and appropriate notice of this meeting was given in accordance with the Municipal Act, 2001.

The Works Committee had before it a report (December 12, 2003) from the Commissioner of Works and Emergency Services recommending that:

- (1) the Solid Waste Management fee for residual waste be increased from \$70.00 per tonne to \$75.00 per tonne at the City's Solid Waste Management facilities, effective March 1, 2004:
- (2) the Solid Waste Management fee for tires be increased from \$110.00 per tonne to \$150.00 per tonne at designated City Solid Waste Management facilities, effective March 1, 2004;
- (3) the revenue of \$20,000.00 related to the increased fee for tires be added to the 2004 Operating Budget for Solid Waste Management recommended by the Executive Management Team; and
- (4) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

No one addressed the Committee.

On motion by Councillor Balkissoon, the Committee:

- (1) recommended to the Policy and Finance Committee the adoption of the aforementioned report; and
- (2) requested the Commissioner of Works and Emergency Services to arrange for a presentation to the next meeting of the Committee on the role of:
 - (i) the Waste Diversion Organization; and
 - (ii) the New and Emerging Technologies, Policies and Practices

Advisory Group and Working Group.

2.2 Decrease in Fee for Clean Fill including Topsoil at Closed Landfills

The Works Committee held a statutory Public Meeting on January 12, 2004, and appropriate notice of this meeting was given in accordance with the Municipal Act, 2001.

The Works Committee had before it a report (December 12, 2003) from the Commissioner of Works and Emergency Services recommending that:

- (1) the fee be decreased for every load of clean fill including topsoil received at City of Toronto closed landfills from \$30.00 to \$20.00 per load;
- (2) the quantities accepted continue to be limited to the City's requirements and must be suitable for the intended use;
- (3) the revenue of \$200,000.00 related to the decreased fee be added to the 2004 Operating Budget for Solid Waste Management as recommended by the Executive Management Team; and
- (4) appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

No one addressed the Committee.

On motion by Councillor Giambrone, the Committee recommended to the Policy and Finance Committee the adoption of the aforementioned report.

2.3 3243-3261 Dufferin Street at Sparrow Avenue – Drainage Problem on Private Laneway (Ward 15 – Eglinton-Lawrence)

The Works Committee again had before it a communication (June 6, 2003) from Councillor Howard Moscoe, Ward 15 - Eglinton-Lawrence, respecting a private laneway running south from Sparrow Avenue (3243 –3261 Dufferin Street) which the storeowners would like to be able to pave but are unable to do so because a catch basin is required; and requesting that 50 percent of the cost of the backlot drainage system be provided by the City of Toronto and the balance including the cost of paving be borne by the shop owners.

The Committee also again had before it a report (June 19, 2003) from the Commissioner of Works and Emergency Services responding to Councillor Moscoe's request that staff report on the City sharing in the cost of the installation of a proposed catch basin in a private laneway at the rear of 3243-3261 Dufferin Street in accordance with the former City of North York Policy – Drainage Works on Private Property (N12); advising that staff will be bringing forward a separate report outlining a harmonized policy on private drainage issues as outlined in Clause No. 17 of Report No. 5 of the Works Committee, adopted by City Council on April 16, 17 and 18, 2002; and recommending that this report be received for information.

The Committee deferred consideration of the aforementioned communication and report until its next meeting on February 3, 2004.

2.4 Rehabilitation of Leaside Bridge over the Don Valley Request for Proposal No. 9117-03-7353 (Ward 26 – Don Valley West; Ward 29 – Toronto-Danforth)

The Works Committee had before it a communication (November 26, 2003) from the City Clerk advising that the Bid Committee at its meeting on November 26, 2003, adopted a joint report (November 10, 2003) from the Commissioner of Works and Emergency Services and Director of Purchasing and Materials Management which recommended that:

- the firm UMA Engineering Ltd., the proponent with the highest overall score and the lowest cost meeting the requirements, be retained for the rehabilitation of the Leaside Bridge over the Don Valley, as described in the Request for Proposals, at a total cost not to exceed \$143,037.09 including contingencies and applicable taxes for the period November 1, 2003 to May 31, 2004;
- (2) the balance of the award, in a total estimated amount of \$716,718.31 including contingencies and applicable taxes for the construction period commencing in June 2004 to December 31, 2005, be referred to the Works Committee and Council for approval; and
- (3) authority be granted to the appropriate City staff to enter into an agreement with UMA Engineering Ltd. to carry out this assignment, such agreement to contain clauses satisfactory to the Commissioner of Works and Emergency Services and the City Solicitor.

Councillor Pitfield appointed Councillor Balkissoon Acting Chair, and vacated the Chair.

On motion by Councillor Pitfield, the Committee:

- (a) recommended to Council that:
 - (1) the firm UMA Engineering Ltd. be retained for the rehabilitation of the Leaside Bridge over the Don Valley in a total estimated amount of \$716,718.31 including contingencies and applicable taxes for the construction period commencing in June 2004 to December 31, 2005, subject to funds being available in subsequent years budgets; and
 - (2) authority be granted to the appropriate City staff to enter into an agreement with UMA Engineering Ltd. to carry out this assignment, such agreement to contain clauses satisfactory to the Commissioner of Works and Emergency Services and the City Solicitor; and
- (b) requested the Commissioner of Economic Development, Culture and Tourism to submit a report as soon as possible to the Toronto Preservation Board on whether the Leaside Bridge should be dedicated as a heritage structure.

2.5 Amendment to Contract No. 47007066 to Butler Inspection Group Inc. - Inspection Services on Welds and Structural Steel

The Works Committee had before it a report (December 11, 2003) from the Commissioner of Works and Emergency Services respecting an amendment to the existing contract agreement with the firm of Butler Inspection Group Inc. to increase the fees for inspection services on welds and structural steel as and when required during the 2003 calendar year; and recommending that:

- (1) Contract No. 47007066 issued to Butler Inspection Group Inc. for the inspection services on welds and structural steel be increased by an additional amount of \$20,000.00 inclusive of GST; and
- (2) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

2.6 Amendment to Purchase Order – Road Reconstruction and Resurfacing on Birchwood Avenue and Forest Heights Boulevard – Contract No. 02D3-11RD, Tender Call No. 245-2002 (Ward 25 – Don Valley West)

The Works Committee had before it a report (December 12, 2003) from the Commissioner of Works and Emergency Services respecting an amendment to the existing purchase order limit for Contract No. 02D3-11RD, Tender Call No. 245-2002, for road reconstruction and resurfacing

of Birchwood Avenue from Gordon Road to Highland Crescent and road reconstruction of Forest Heights Boulevard from Wimpole Drive to 95m west to Vyner Road; and recommending that:

- (1) Purchase Order No. 6008151 be amended by \$86,000.00 from \$767,190.00 to \$853,190.00 including all taxes and charges; and
- (2) the appropriate City officials be authorized to take the necessary action to give effect thereto.

The Committee recommended to Council the adoption of the aforementioned report.

2.7 Amendment to Construction Contract for Markham Road Bridge over Highland Creek – Contract No. 03FS-10S, Tender Call No. 77-2003, (Ward 38 – Scarborough Centre)

The Works Committee had before it a report (December 15, 2003) from the Commissioner of Works and Emergency Services respecting an amendment to the construction contract with Anscon Contracting Inc. and Janscon Holding Inc. (Anscon) to increase the cost for providing material, labour and equipment for the construction of Markham Road Bridge over Highland Creek as specified in the contract documents (Contract No. 03FS-10S, Tender Call No. 77-2003, P.O. No. 6010352); and recommending that authority be granted to amend the contracted construction cost with Anscon Contracting Inc. and Janscon Holding Inc. by \$280,995.45 inclusive of GST from \$534,780.65 to \$815,776.10 inclusive of GST, to provide materials, labour and equipment for the above mentioned structure rehabilitation, Contract No. 03FS-10S.

Councillor De Baeremaeker moved that the Committee defer consideration of the aforementioned report until its next meeting on February 3, 2004. (Carried)

Councillor Balkissoon moved that the Commissioner of Works and Emergency Services be requested to forward to the Committee at its next meeting copies of the agreements with the Utilities. (Carried)

2.8 Amendment to Purchase Order for Request for Proposal No. 9117-03-7102 Reconstruction of King Street West TTC Track between Sudbury Street and Atlantic Avenue (Ward 19 – Trinity-Spadina)

The Works Committee had before it a report (December 15, 2003) from the Commissioner of Works and Emergency Services respecting an amendment to the existing purchase order limit for Request for Proposal No. 9117-03-7102 for the preliminary investigation, feasibility study, detailed design and preparation of tender documents for the reconstruction of King Street West TTC track between Sudbury Street and Atlantic Avenue; and recommending that:

- (1) Purchase Order No. 6010147 be amended by \$79,990.24 from \$83,389.49 to \$163,379.73 excluding all taxes and charges; and
- (2) the appropriate City officials be authorized to take the necessary action to give effect thereto.

On motion by Councillor Del Grande, the Committee recommended to Council the adoption of the aforementioned report.

recommending that this report be received for information.

2.10 Canadian Radio-Television and Telecommunication Commission

The Works Committee had before it a confidential report (December 16, 2003) from the City Solicitor respecting Canadian Radio-Television Decision 2003-82 with regard to the terms and conditions of the existing agreement for access to municipal property, such report to remain confidential having regard that the subject matter relates to litigation or potential litigation affecting the municipality.

The Chair informed the Committee that the Solicitor had advised that the time for filing was extended by the Court to January 30, 2004, as requested.

2.11 Change in Ownership of Company Contracting for Provision of Litter Bins with Advertising

The Works Committee had before it a report (December 12, 2003) from the Commissioner of Works and Emergency Services recommending that Solid Waste Management Services be authorized to negotiate new terms and conditions of the agreements with the re-named Olifas Marketing Group Inc., Urban Equipment of Canada Inc. (EUCAN), with the objective of improving the litter bins with advertising program, and report further to Works Committee with any recommended changes to the agreements.

The following persons appeared before the Committee in connection with the foregoing matter:

The Committee:

"It is recommended that Solid Waste Management Services be authorized to negotiate new terms and conditions of the agreements for the provision of recycling/litter bins with the re-named Olifas Marketing Group Inc., Urban Equipment of Canada Inc. (EUCAN), with the objective of improving the recycling/litter bins with advertising program, and report further to Works Committee with any recommended changes to the agreements.";

 - (iii) the method of collection from bins, and whether all three streams are collected in one truck:
 - (iv) the method and cost of sorting the different waste streams, and the tonnage of each stream;(Motions (ii), (iii) and (iv) by Councillor Fletcher)
 - (v) adding organics to the bins;(Motion by Councillor Giambrone)
 - (vi) the provision of additional bins in the Entertainment District, i.e., King Street, Adelaide Street, Richmond Street and Queen Street, between Spadina Avenue and University Avenue, and/or other methods of keeping the area clean; and (Motion by Councillor Balkissoon, on behalf of Councillor Shiner)
 - (vii) locating bins closer to transit shelters; and (Motion by Councillor Pitfield)
- (4) further requested the Commissioner of Works and Emergency Services, when looking at a new design of the bins, to:
 - (i) include consultation with ergonomics specialists of the Toronto Civic Employees' Union CUPE Local 416;
 (Motion by Councillor Fletcher)

- (ii) consider the feasibility of the bins being constructed in Canada; (Motion by Councillor Giambrone)
- (iii) consider including provision for cigarette butts and batteries; and
- (iv) make every effort to use the existing bins in parks, gas stations etc., where bins are not currently available.(Motions (iii) and (iv) by Councillor Pitfield)

2.12 Assignment of Agreement with Metro Waste Paper Recovery for Processing of Single Stream Recyclable Materials

The Works Committee had before it a report (December 11, 2003) from the Commissioner of Works and Emergency Services recommending that authority be granted to assign the rights and obligations of the contract with Metro Waste Paper Recovery Inc. for the processing of single stream recyclables to Metro Municipal Recycling Services Inc., based on the same prices and terms and conditions, such assignment agreement to be in a form satisfactory to the City Solicitor.

The Committee recommended to Council the adoption of the aforementioned report.

2.13 Design and Production of Solid Waste Collection Calendars – Request for Proposal No. 3001-03-7442

The Works Committee had before it a communication (December 3, 2003) from the City Clerk advising that the Bid Committee at its meeting on December 3, 2003, had before it a joint report (November 17, 2003) from the Commissioner of Works and Emergency Services and Director of Purchasing and Materials Management and adopted the following recommendation:

(1)(a) the firm of Municipal Media Inc. the only proponent responding to the RFP, be engaged to design and produce the City's annual garbage and recycling collection calendars as outlined in the Request for Proposal for an estimated cost not to exceed \$15,000.00

including all taxes and charges for the period commencing November 1, 2003 to December 31, 2003, including all taxes;"

and referred the following recommendations to the Works Committee for consideration:

- (1)(b) the balance of the award, not to exceed an estimated cost of \$242,240.00, including all taxes and charges for the period commencing January 1, 2004 to October 31, 2004, be referred to the Works Committee for consideration;
- the option to renew for two additional one-year terms in the estimated amount of \$204,153.75 for the period from November 1, 2004 to October 31, 2005, and \$161,000.00 for the period from November 1, 2005 to October 31, 2006, under the same terms and conditions, for a total amount of \$607,293.75 (January 1, 2004 to October 31, 2006), be reviewed by the Commissioner of Works and Emergency Services, in cooperation with the Purchasing Agent, provided the design and production of garbage and recycling calendars were performed at a satisfactory level, to ensure it is feasible to extend the contract and that funds are available in the Works and Emergency Services Operating Budget for the option years; and
- (3) provided that there is a favourable review, in accordance with Recommendation No. (2), the Commissioner of Works and Emergency Services be delegated the authority to exercise the option to renew on the terms and conditions set out above and be authorized to instruct the Purchasing Agent to process the necessary contract.

Mr. Rod Muir, Waste Diversion Toronto, appeared before the Committee in connection with the foregoing matter.

The Committee:

- (1) recommended to Council that the firm of Municipal Media Inc. be engaged to design and produce the City's annual garbage and recycling collection calendar for an estimated cost not to exceed \$242,140.00, including all taxes and charges, for the period commencing January 1, 2004 to October 31, 2004;
- (2) further recommended that the option to renew for two additional one-year terms in the estimated amount of \$204,153.75 for the period from November 1, 2004 to October 31, 2005, and \$161,000.00 for the period from November 1, 2005 to October 31, 2006, under the same terms and

conditions, for a total amount of \$607,293.75 (January 1, 2004 to October 31, 2006), be reviewed by the Commissioner of Works and Emergency Services, in co-operation with the Purchasing Agent, provided the design and production of garbage and recycling calendars were performed at a satisfactory level, to ensure it is feasible to extend the contract and that funds are available in the Works and Emergency Service Operating Budget for the option years, subject to the Commissioner of Works and Emergency Services reporting back to the Committee prior to exercising the option to renew for the additional terms;

- (3) requested the Commissioner of Works and Emergency Services to provide to Members of the Committee a Briefing Note with the following information:
 - (i) the cost for the production in-house of a 12-page calendar, without advertising;

 - (iii) a listing of the 54 firms on the Bidders List; and

(4) further requested the Commissioner of Works and Emergency Services to include in the future design of the calendar provision for a one-page tear-off section that can be retained. (Motion by Councillor Giambrone)

2.14 Retail Distribution of City Waste Diversion Containers – Request for Quotation No. 9155-03-7465

The Works Committee had before it a joint report (December 11, 2003) from the Commissioner of Works and Emergency Services and the Chief Financial Officer and Treasurer recommending that:

- (1) the quotation submitted by Home Hardware Stores Limited, being the only quotation received, be accepted for the retail distribution of the City's waste diversion containers for a period of three years with an option to renew for two additional one-year terms under the same terms and conditions (to be reviewed by the Commissioner of Works and Emergency Services, in co-operation with the Purchasing Agent), provided the distribution of waste containers was performed at a satisfactory level during the initial three years;
- (2) provided that there is a favourable review, in accordance with Recommendation No. (1), the Commissioner of Works and Emergency Services be delegated the authority to exercise the option to renew on the terms and conditions set out above and be authorized to instruct the Purchasing Agent to process the necessary contract; and
- (3) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

On motion by Councillor Fletcher, the Committee recommended to Council the adoption of the aforementioned joint report.

2.15 Receipt and Processing of Mixed Broken Glass – Request for Proposal No. 9155-03-7437

The Works Committee had before it a communication (December 17, 2003) from the City Clerk advising that the Bid Committee at its meeting on December 17, 2003, adopted a joint report (December 3, 2003) from the Commissioner of Works and Emergency Services and the Director of Purchasing and Materials Management which recommended that:

(1) Rancor Recycling Inc., being the lowest bidder meeting all of the City's requirements, be retained to receive 7,708 tonnes of mixed broken glass from the City's 35 Vanley Crescent MRF and Thormount Single Stream Facility at a cost to the City of \$32.00 per tonne (total cost of \$254,055.68) including all applicable taxes for the period January 1, 2004 to May 31, 2004;

- the balance of the award to Rancor Recycling Inc., in the estimated amount of \$355,704.32 including all charges and applicable taxes for the period June 1, 2004 to December 31, 2004, be referred to Works Committee and Council;
- Unical Inc., being the lowest bidder meeting all of the City's requirements, be retained to receive 4,792 tonnes of mixed broken glass from the 400 Commissioners Street Processing Facility, at a cost to the City of \$29.50 per tonne (total cost of \$145,604.92) including all applicable taxes for the period January 1, 2004 to May 31, 2004;
- (4) the balance of the award to Unical Inc. in the estimated amount of \$203,822.58 including all charges and applicable taxes for the period June 1, 2004 to December 31, 2004, be referred to Works Committee and Council; and
- (5) authority be granted to appropriate City staff to enter into agreements with Rancor Recycling Inc. and Unical Inc. to carry out this project, such agreement to contain clauses satisfactory to the Commissioner of Corporate Services and the City Solicitor.

The Committee:

 - "(a) Rancor Recycling Inc., being the lowest bidder meeting all of the City's requirements, be retained to receive 7,708 tonnes of mixed broken glass from the City's 35 Vanley Crescent MRF and Thormount Single Stream Facility at a cost to the City of \$32.00 per tonne (total cost of \$254,055.68) including all applicable taxes for the period January 1, 2004 to May 31, 2004;
 - (b) Rancor Recycling Inc. be retained for the balance of the award, in the estimated amount of \$355,704.32 including all charges and

- applicable taxes for the period June 1, 2004 to December 31, 2004;
- (c) Unical Inc., being the lowest bidder meeting all of the City's requirements, be retained to receive 4,792 tonnes of mixed broken glass from the 400 Commissioners Street Processing Facility, at a cost to the City of \$29.50 per tonne (total cost of \$145,604.92) including all applicable taxes for the period January 1, 2004 to May 31, 2004;
- (d) Unical Inc. be retained for the balance of the award in the estimated amount of \$203,822.58 including all charges and applicable taxes for the period June 1, 2004 to December 31, 2004; and

- (2) the balance of the award in the estimated amount of \$1,520,614.58 including all charges and applicable taxes and a contingency allowance of \$100,000.00 for potential additional supplies for the period March 1, 2004 to December 31, 2004, be referred to Works Committee and Council for approval, as part of the 2004 operating budget not included in the 2004 interim budget approvals granted by Council; and
- (3) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

The Committee:

(1) recommended that the balance of the proposal submitted by Badger Meter Inc., Utility Division, be accepted in the estimated amount of \$1,520,614.58 including all charges and applicable taxes and a contingency allowance of \$100,000.00 for potential additional supplies for the period March 1, 2004 to December 21, 2004, be accepted, subject to funds being available in the 2004 Operating Budget; and

(2) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.
