## **Confirmation of Minutes**

On motion by Deputy Mayor Bussin, the Minutes of the meeting of the Works Committee held on February 3, 4 and 10, 2004, were confirmed.

## 4.1 Basement Sewage Discharge during August 2003 Blackout

The Works Committee had before it a communication (March 8, 2004) from Deputy Mayor Sandra Bussin, Ward 32 – Beaches East York, and Councillor Paula Fletcher, Ward 30 – Toronto-Danforth, respecting the backflow and discharge of sewage and wastewater into the basements of residential properties situated along the waterfront near the Ashbridges Bay Treatment Plant as a result of the electrical power failure on August 14, 2003; and requesting the opportunity for residents impacted by this event to appear before the Works Committee.

The Committee also had before it a communication (April 27, 2004) from Ms. Lisa Lindsay Rose.

On motion by Deputy Mayor Bussin, the Committee:

- (1) referred the aforementioned communication to the Commissioner of Works and Emergency Services for consideration, in consultation with Legal Services, of a grant to recognize the unique circumstances as a result of the electrical power failure in August 2003 for those residents who have been identified by staff, and requested staff to report back to the Works Committee on the properties involved;
- (2) requested that the Commissioner of Works and Emergency Services provide an aggressive outreach program to inform residents in that area of the program to install backflow sump pumps, including door-to-door visitation in the appropriate language; and
- (3) also requested the Commissioner of Works and Emergency Services to review options to mitigate against future similar episodes, and report back to the Works Committee prior to the 2005 budget process.

# 4.2 Drain Grant Appeal – 69 Craydon Avenue (Ward 11 – York South-Weston)

The Works Committee had before it a communication (February 9, 2004) from Councillor Frances Nunziata, Ward 11 – York South-Weston, with respect to a request by Mr. Frank Ciancio, owner of 69 Craydon Avenue, for reimbursement for drain repairs which was denied under the Drain Grant Program as the work was not performed by a licensed drain contractor in accordance with the program.

The Committee also had before it a report (April 27, 2004) from the Commissioner of Works and Emergency Services recommending that the appeal submitted by Mr. Frank Ciancio of 69 Craydon Avenue be denied as it is ineligible under the current City of Toronto Drain Grant Program, since

it does not comply with the terms and conditions of the program as adopted by City Council at its meeting of May 11 and 12, 1999.

Councillor Fletcher moved that the aforementioned communication be referred to the Commissioner of Works and Emergency Services to investigate and report back to the next meeting of the Committee on June 2, 2004, on options to solve the issue of the sewer blockage for the 31 affected homes on Logan, Colgate and Booth Avenues, including the pooling of City grant funds. # 4.5 Elimination of Duplicate/Triplicate Street Names – Completion of Phase 1 – Results of Public Consultation

The Works Committee again had before it a report (January 23, 2004) from the Commissioner of Works and Emergency Services recommending that:

- (1) the criteria and form set out in Attachments "D" and "E" to be used to compile the duplicate/triplicate street name change/no change list be approved;
- (2) the Commissioner of Works and Emergency Services be directed to compile the duplicate/triplicate street name change/no change list and to report the proposed changes to the Works Committee;
- (3) the report referred to in Recommendation No. (2) include consideration of potential financial subsidies and other mitigating measures to the parties who will be affected by the street renaming proposals;
- (4) the process to compile and approve the change/no change list (Phase 3), as set out in the body of this report, be approved;
- (5) the revised Policy for Naming Public and Private Streets and Lanes together with the proposed changes to such policy, as set out in Attachment "G", be approved;
- (6) the Criteria for Name Selection, set out in the revised Policy for Naming Public and Private Streets and Lanes and referred to in Recommendation No. (5) therein, also be used for the naming of bridges as well as streets;
- (7) the Commissioner of Works and Emergency Services be directed to compile a name bank to be based on input from groups representing the arts and the fields of medicine, science, engineering and social science;

- (8) the steps for selecting replacement street names (Phase 4), as set out in this report, be approved;
- (9) the businesses, agencies and institutions located on the streets proposed to be renamed be advised to keep stock material with their address at minimum levels until City Council has made a decision as to which of the duplicate and triplicate street names will be renamed; and
- (10) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

# 4.6 Water Meter Replacement and Meter Reading Technology Project – Status Report

The Works Committee had before it a report (April 14, 2004) from the Commissioner of Works and Emergency Services and the Chief Financial Officer and Treasurer providing information on the Water Meter Replacement and Meter Reading Technology Project approved by Council in October 2002, and the next phase of this project as requested by Council at its meeting of September 2003; and recommending that:

- (1) staff be authorized to proceed with the Water Meter Replacement and Meter Reading Technology project to replace/retrofit the City's meters and implement a Fixed Area Network (FAN) meter reading system over an eight-year period, as previously approved by Council in October 2002;
- (2) the Commissioner of Works and Emergency Services and the Chief Financial Officer and Treasurer report to Works Committee each year on the progress of the project implementation, including the costs incurred, the additional revenues realized and operating efficiencies achieved; and
- (3) the appropriate City officials be authorized and directed to take the necessary actions to give effect thereto.

Ms. Giuliana Carbone, Director, Revenue Service, Finance Department, gave a presentation to the Committee in connection with this matter, and submitted a copy of her presentation.

The Committee:

- (A) recommended to the Policy and Finance Committee, and Council, that:
  - (1) staff be authorized to proceed with a Water Meter Replacement and Meter Reading Technology project to replace/retrofit flat rate customers and high volume commercial users only, with high volume users with meters 15 years old or older being given priority;

# (Motion by Councillor Pitfield, as amended by Councillor Balkissoon)

(2) all flat rate customers be placed on meters;

#### (Motion by Councilor Giambrone)

(3) City Council consider the installation of a standard meter for high volume commercial users, and the installation for flat rate customers of a meter in the basement linked by wire to an outside touchpad for reading; and

## (Motion by Councillor Pitfield)

(4) City Council adopt a policy of mandatory replacement of 15-yearold and older water meters and reading devices placed outside homes; and

## (Motion by Councillor Balkissoon)

- (B) requested that the Commissioner of Works and Emergency Services report back to the Works Committee on:
  - (1) a schedule of implementation for replacement of 15-year-old meters for high volume customers;

#### (Motion by Councillor Balkissoon)

(2) a meter maintenance program and how it is being used now; and

#### (Motion by Councillor Pitfield)

(3) the feasibility of the water rate being amended to reflect a charge for non-detected water usage.

#### (Motion by Councillor De Baeremaeker)

Deputy Mayor Bussin, Councillor Del Grande and Councillor Thompson requested that they be recorded in opposition to the motion by Councillor De Baeremaeker.

The following motion by Deputy Mayor Bussin was lost on a tie vote:

- (1) That the matter be deferred until the meeting of the Works Committee on June 29, 2004, and that all motions be referred to staff for a further report to that meeting;
- (2) that staff also report on:
  - (i) the cost of the implementation of standard meters with touch pads and the cost of manual reading; and
  - (ii) the system in use by the Toronto Parking Authority; and
- (3) that a presentation be given to the Committee on Smart Meters at the meeting on June 29, 2004.

# 4.7 Proposed Alteration to the Southerly Branch of Brentcliffe Road and Eglinton Avenue East – Elimination of Northbound Right-Turn Channelization (Ward 26 – Don Valley West)

The Works Committee had before it a report (March 23, 2004) from the Commissioner of Works and Emergency Services recommending that:

- (1) the southerly branch of Brentcliffe Road, between Vanderhoof Avenue and Eglinton Avenue East, shown as proposed curb and pavement modifications on the attached print of Drawing No. 421F-6834, dated March 2003, be modified to remove the northbound channelized right-turn facility;
- (2) the easterly northbound lane on Brentcliffe Road, between Vanderhoof Avenue and Eglinton Avenue East, be designated for right turns only;
- (3) the regulation which designates the southerly eastbound lane on Eglinton Avenue East and Brentcliffe Road for right turns only be rescinded;
- (4) the regulation which prohibits pedestrian crossings on the east side of Brentclffe Road and

Eglinton Avenue East be rescinded; and

(5) the appropriate City officials be authorized and directed to take the necessary action to implement the foregoing, including the introduction in Council of any Bills that may be required.

The Committee recommended to Council the adoption of the aforementioned report.

# 4.8 Steeles Avenue East/Railway Grade Separation Class Environmental Assessment Addendum Study (Ward 39 – Scarborough-Agincourt; Ward 41 – Scarborough-Rouge River)

The Works Committee had before it a report (April 7, 2004) from the Commissioner of Works and Emergency Services recommending that:

- (1) Council approve, in principle, an underpass concept for the Steeles Avenue East/GO Stouffville rail line grade separation; and
- (2) the Commissioner of Works and Emergency Services be directed to complete an Addendum to the Steeles Avenue East/(former) CN Uxbridge Rail Grade Separation Class Environmental Study Report (ESR) with the focus on the underpass option.

On motion by Councillor Balkissoon, the Committee recommended to Council the adoption of the aforementioned report, subject to the Commissioner of Works and Emergency Services communicating with the affected property owners requesting that they indicate, in writing, their preference for an underpass or overpass, and in particular, communicating with Mr. Philip H. Meretsky of Meretsky and Associates.

4.9 Port Union Road Class Environmental Assessment, Lawrence Avenue East to Kingston Road Environmental Assessment Study

## (Scarborough East)

The Works Committee had before it a report (April 7, 2004) from the Commissioner of Works and Emergency Services recommending that:

- (1) the recommended plan for widening Port Union Road between Lawrence Avenue East and Kingston Road and the modifications to the intersection of Kingston Road and Port Union Road, as documented in the Port Union Road Environmental Study Report, be endorsed;
- (2) authority be granted to the Commissioner of Works and Emergency Services to file the Environmental Study Report for the Port Union Road Class Environmental Assessment Study with the City Clerk, and to give public notification of such filing in accordance with the requirements of the Municipal Class Environmental Assessment process;
- (3) the intersection modifications for Kingston Road and Port Union Road, as identified in the Environmental Study Report, be implemented in 2005 upon approval of the Environmental Study Report;
- (4) prior to proceeding with the second phase of the project, the widening of Port Union Road, staff carry out further public consultation and report back to Council; and
- (5) authority be granted to the Commissioner of Urban Development Services to initiate an Official Plan Amendment to reduce the right-or-way requirements for Port Union Road to satisfy the right-of-way width as identified in the Environmental Study Report.

The Committee recommended to Council the adoption of the aforementioned report.

4.10 Legion Road Extension, Park Lawn Road to Lake Shore Boulevard West Environmental Assessment Report Addendum – Park Lawn Road Off-Ramp Modifications (Ward 6 – Etobicoke-Lakeshore)

The Works Committee had before it a report (April 7, 2004) from the Commissioner of Works and Emergency Services recommending that:

- (1) the Addendum Report, which proposes the extension of Legion Road from Park Lawn Road to Lake Shore Boulevard West, including modifications to the F.G. Gardiner Expressway off-ramp at Park Lawn Road, be approved; and
- (2) authority be granted to the Commissioner of Works and Emergency Services to file the Notice of Filing of Addendum for the Legion Road Extension – Park Lawn Road Off-Ramp Modifications Environmental Assessment Study with the City Clerk and to give public notification of such filing in accordance with the requirements of the Class EA process.

On motion by Councillor Del Grande, the Committee recommended to Council the adoption of the aforementioned report.

# 4.11 Alternate Side Parking – Changeover Times and Grace Periods – Follow-up Report

The Works Committee had before it a report (March 25, 2004) from the Commissioner of Works and Emergency Services in response to a request from City Council at its meeting of July 22, 23 and 24, 2003, for a further report on the feasibility of including the grace period for parking changeover days on those streets subject to alternate side parking in the appropriate by-law, to make it clear to parking enforcement personnel that tags are not to be issued during this period; and recommending that:

- (1) this report be received for information; and
- (2) the recommendations contained in Clause No. 8 of Report No. 6 of the Works Committee be adopted, viz.:
  - (a) for consistency, changeover times for alternate side parking be set at midnight on the designated days for those streets operating under the alternate side parking system;
  - (b) the Toronto Police Service Parking Enforcement Unit continue to apply its current operational procedure respecting grace periods for alternate side parking regulations; and
  - (c) the appropriate City officials be authorized to take whatever action is necessary to give effect to the foregoing, including the introduction in Council of any Bills that are

required.

On motion by Deputy Mayor Bussin, the Committee recommended to Council the adoption of Recommendation No. (2) contained in the aforementioned report.

# 4.12 Request for Amendment to Metropolitan Toronto Uniform Traffic By-law No. 32-92 by Increasing the Fine related to "Pedestrian Fail to Yield to Vehicle when Crossing the Roadway"

The Works Committee had before it a communication (January 2, 2004) from the Chair, Toronto Police Services Board, recommending that the Metropolitan Toronto Uniform Traffic By-law No. 32-92, Section 10, "Pedestrian Fail to Yield to Vehicle When Crossing the Roadway", be amended to increase the current fine to \$50.00, the maximum allowable for pedestrian offences under the *Highway Traffic Act*.

On motion by Councillor Thompson, the Committee referred the aforementioned communication to the Commissioner of Works and Emergency Services for a report to the Committee.

- (1) Contract No. 03D1-162TR, Tender No. 263-2003, with Gazzola Paving Limited for the supply of tri-axle dump trucks for snow removal in South District, Area 1 from December 2003 to March 2004, be amended to permit an increase in payment under the contract from \$236,149.00 to \$1,080,364.00 including all charges and applicable taxes, under the same terms and conditions;
- (2) Contract No. 03D1-183TR, Tender No. 208-2003 with Sanan Construction Limited for the supply of tri-axle dump trucks for snow removal in South District, Area 2 from

December 2003 to March 2004, be amended to permit an increase in payment under the contract from \$235,667.50 to \$1,046,750.00 including all charges and applicable taxes, under the same terms and conditions;

- (3) Contract No. 03D3-126RD, Tender No. 309-2003, with 961488 Ontario Limited O/A Sanan Construction for the supply of tri-axle dump trucks for snow removal in the North District from December 2003 to March 2004, be amended to permit an increase in payment under the contract from \$102,292.00 to \$256,418.65 including all charges and applicable taxes, under the same terms and conditions;
- (4) additional funds of up to \$844,215.00, \$811,082.00 and \$154,126.65 to cover the supply of dump trucks for snow removal in South and North Districts be provided from the Winter Control Stabilization Reserve to Cost Centres TP0108, TP0120 and TP0189, respectively, in the event the increased cost cannot be accommodated within the Transportation Services Division's 2004 operating budget at year end; and
- (5) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto including the introduction in Council of any Bills that may be required.

On motion by Deputy Mayor Bussin, the Committee recommended to Council the adoption of the aforementioned report.

# 4.14 Supply of Proprietary Replacement Parts and Components for Crash Cushion Safety Systems on City Roadways on a Sole Source Basis

The Works Committee had before it a report (April 6, 2004) from the Commissioner of Works and Emergency Services respecting the purchase of replacement parts and components for existing crash cushion safety systems in use at various locations on the City's expressways and arterial road network from the systems' distributor, Lecol Company Ltd., on a sole source basis; and recommending that:

(1) a contract be issued to Lecol Company Ltd. for replacement parts and components for various crash cushion safety systems, in the amount of \$900,000.00, including all charges

and applicable taxes from June 1, 2004 to May 31, 2007; and

(2) the appropriate City officials be authorized and directed to take appropriate action to give effect thereto including the introduction in Council of any Bills that may be required.

On motion by Councillor Del Grande, the Committee recommended to Council the adoption of the aforementioned report.

# 4.15 Request for a Pedestrian Crossover -York Mills Road at Birchwood Avenue (Ward 25 – Don Valley West)

The Works Committee had before it a report (March 2, 2004) from the Commissioner of Works and Emergency Services respecting a request to install a pedestrian crossover on York Mills Road in the vicinity of Birchwood Road, which was considered by the former Midtown Community Council on July 8, 2003, and by the Works Committee on September 4, 2003; and recommending that a pedestrian crossover not be installed on York Mills Road, in the vicinity of Birchwood Avenue.

The following persons appeared before the Committee in connection with this matter:

- Mrs. Sigrid Azzopardi and her children, Keira, Paul John and Lauren;
- Councillor Cliff Jenkins, Ward 25 Don Valley West; and
- Councillor Frances Nunziata, Ward 11 York South-Weston.
  On motion by Councillor Giambrone, on behalf of Councillor Jenkins, the Committee recommended to Council that the recommendation in the aforementioned report be struck out, and that a pedestrian crossover be installed on York Mills Road, in the vicinity of Birchwood Avenue.

# 4.16 Feasibility of Installing a Pedestrian Crossover or Traffic Control Signals at Midland Avenue and Havendale Road

## (Ward 41 – Scarborough-Rouge River)

The Works Committee had before it a communication (April 14, 2004) from the City Clerk advising that the Toronto East Community Council on April 7, 2004, had before it a report (March 18, 2004) from the Director of Transportation Services, East District, with respect to the installation of a pedestrian crossover or traffic control signals at Midland Avenue and Havendale Road; and that the Toronto East Community Council recommended that:

- (1) the staff recommendation in the report be struck out; and
- (2) traffic control signals be installed at the intersection of Midland Avenue and Havendale Road.

On motion by Councillor Balkissoon, the Committee recommended to Council the adoption of the recommendations of the Toronto East Community Council contained in the aforementioned communication.

# 4.17 Ossington Avenue, Between Carus Avenue and Geary Avenue/Acores Avenue – Proposed Installation of Traffic Control Signals (Ward 17 – Davenport; Ward 21 – St. Paul's)

- (b) pursuant to the requirements of the Municipal Class Environmental Assessment Act, Notice of Completion be issued; and
- (c) the speed limit on Broadway Avenue, between Mount Pleasant Road and Bayview Avenue, be reduced from 40 to 30 km/h; and
- (3) the appropriate City officials be authorized and directed to take whatever action is necessary to implement the foregoing, including the introduction in Council of any Bills that might be required.

- (4) that Recommendation No. (16) of the Summary of Recommendations contained in the report (April 21, 2004) from the Commissioner of Works and Emergency Services be amended to read as follows:
  - '(16) Source separated organics (SSO) programs be implemented in 50 multi-residential buildings by mid-2005. Any funding needed in 2004 be found through a reallocation of money from the 2004 NET technology budget.';
- (5) that Recommendation No. (18) of the Summary of Recommendations be amended to read as follows:
  - (18) A work plan for implementing SSO programs in all multiresidential buildings by mid-2007 be brought to the Works Committee prior to the 2005 budget.'; and
- (6) that Recommendations Nos. (20), (22), and (23) of the Summary of Recommendations be amended by adding at the end thereof the following:

'That City staff be requested to bring a business plan for full citywide implementation to the Works Committee on time for the 2005 budget process. Such a plan will include options for public

# sector ownership and operation."" Motion B by Councillor Balkissoon:

"That the Summary of Recommendations contained in the report (April 21, 2004) from the Commissioner of Works and Emergency Services be amended as follows:

- (1) references to apartments in the recommendations be changed to multi-family residences with City pick-up;
- (2) Recommendation No. (6) be amended to provide that 2006 be a targeted date, and that staff report to Committee and Council on the progress of diversion regularly before the target date;

- "(1) That the Commissioner of Works and Emergency Services be requested to report back to the Works Committee on a proposal for 25 project officers for "Getting to 60% and Beyond" who are dedicated to assisting in the implementation of the plan, including apartments and ABCD's and particularly the TCHC; and
- (2) that Appendix A be amended by adding the following to the reference to the Working Group:

'The Waste Diversion Working Group include members of the public, City staff, frontline collection workers, and possibly Works Committee members; and that such working group establish plans with timelines, and clear reporting structures for its work and for implementation and operation of diversion programs, and should coordinate its work with that of the working groups for apartments, ABCD's and schools.'"

## Motion D by Deputy Mayor Bussin:

"That the Commissioner of Works and Emergency Services be requested to report to the Works Committee on the feasibility of a pilot project for the use of biodegradable plastic bags."

# Motion E by Councillor Del Grande:

"Given that the City expects to hire 25 by-law officers and given that the City has by-law officers dealing with simple item issues, that staff report back to the Works Committee on the development of a multi-faceted by-law officer to be used across the corporation, i.e. the establishment of an all disciplined by-law officer."

# Motion F by Councillor De Baeremaeker, on behalf of Councillor Palacio:

- "(1) That the Commissioner of Works and Emergency Services be requested to further report to City Council on Recommendation No. (8) in the Summary of Recommendations on setting up policies regarding retrofitting apartment buildings to accommodate recycling chutes, and recycling container capacity to enable residents to fully participate in the existing recycling programs; for example:
  - (i) that the City mandates to "recycle different things down the chute on different days;"
  - (ii) through new and emerging technologies, if the City could find any other mechanism such as Access Coding Cards

that would keep track of who disposes what; and

- (iii) that a similar system to the one used in Vancouver be reviewed, where tenants who do not participate in the program pay an additional \$12 per month in their rent to cover the costs; and
- (2) that Recommendation No. (22) (Reuse Centres and Diversion of Reusable Goods) in the Summary of Recommendations be further amended by requesting the Commissioner of Works and Emergency Services to report directly to City Council on setting up policies for a rollout of "small scrap metal collection" commencing in 2006 and be phased in by districts: for example; District 1 - 2006; District 2 - 2007; District 3 – 2008; District 4 – 2009."; and

## Motion G by Councillor De Baeremaeker:

- "(1) That the City adopt a waste diversion target of a minimum of 70% using existing technologies by 2010;
- (2) that the Commissioner of Works and Emergency Services be requested to report back to the Works Committee on:
  - how the final 30 percent of waste can be diverted from landfill without using thermal technology, including a cost and environmental health comparison;
  - (ii) "front end" changes required to ensure that the 30% of waste not recoverable does become recoverable; and
  - (iii) the feasibility of the City collecting waste at all commercial locations on a cost-recovered basis and ensuring full recycling programs in that sector;
- (3) that the Commissioner of Works and Emergency Services be requested to report back to the Committee in three months on the implementation of a pilot project for additional sorting of residual waste at one of the City's transfer stations, on the model of the

Halifax process, to evaluate the additional diversion that can be achieved; and

(4) that the expansion of durables collection to include small scrap metal items just proceed, without any additional pilot projects; the program can be expanded city-wide and contracted in."

The following motion by Councillor Giambrone, was voted on and lost:

That the report (April 21, 2004) from the Commissioner of Works and Emergency Services be deferred for consideration until the June 2004 meeting of the Works Committee; and that the staff report come back with a new emphasis that promotes the diversion and recycling initiatives, and delays development and implementation of the enforcement measures until after the diversion and recycling initiatives are underway and there has been an opportunity for an assessment.
