- (2) the Commissioner of Works and Emergency Services be directed to compile the duplicate/triplicate street name change/no change list and to report the proposed changes to the Works Committee;
- (3) the report referred to in Recommendation No. (2) include consideration of potential financial subsidies and other mitigating measures to the parties who will be affected by the street renaming proposals;
- (4) the process to compile and approve the change/no change list (Phase 3), as set out in the body of this report, be approved;
- (5) the revised Policy for Naming Public and Private Streets and Lanes together with the proposed changes to such policy, as set out in Attachment "G", be approved;
- (6) the Criteria for Name Selection, set out in the revised Policy for Naming Public and Private Streets and Lanes and referred to in Recommendation No. (5) therein, also be used for the naming of bridges as well as streets;
- (7) the Commissioner of Works and Emergency Services be directed to compile a name bank to be based on input from groups representing the arts and the fields of medicine, science, engineering and social science;

- (8) the steps for selecting replacement street names (Phase 4), as set out in this report, be approved;

- (10) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

(2) requested the Commissioner of Works and Emergency Services to report back to the Committee on the following motions:

(Motion by Deputy Mayor Bussin, on behalf of Councillor Nunziata) Motion A. by Deputy Mayor Bussin, on behalf of Councillor Jenkins:

- "(I) That Recommendation No. (4) in the report (January 23, 2004) from the Commissioner of Works and Emergency Services be deleted and replaced with the following:
 - (4) the Commissioner of Works and Emergency Services prepare a report to the Works Committee containing the list of duplicate and triplicate streets, as follows:
 - Each pair (or set) of duplicate/triplicate streets will be evaluated to determine whether any properties on the streets are zoned for commercial or industrial use and have current commercial or industrial usage.
 - (ii) Where one or more of the streets have commercial or industrial properties as in
 (i) above, the property assessments reported by the Municipal Property Assessment Corporation in 2003 for taxation in 2004 will be totaled for all properties on each street. The street with the highest total assessment will be selected to retain

its name. The other street(s) will be selected for change of name.

(iii) Where none of the streets have commercial or industrial properties, as in (i) above, the number of distinct addresses, including apartments, on the tax roll will be totaled. The street with the greatest number of properties will be selected to retain its name. The other street(s) will be selected for change of name.

- (iv) The Works Committee will forward the report to Community Councils for formal deputations.
- (v) Community Councils will schedule deputations, and staff will distribute the report to individuals on the project mailing list and to all addresses on the streets recommended to undergo a name change.
- (vi) Community Councils will consider deputations and forward recommendations to the Works Committee.
- (vii) The Works Committee will arrange final deputations, if it so chooses, and forward final recommendations to City Council.
- (viii) City Council will approve the final course of action.'; and
- (II) that Recommendation No. (8) be deleted and replaced with the following:
 - (8) the steps for selecting replacement street names (phase 4) be as follows:
 - (i) Where a street is selected to be renamed, the

standard will be to change the suffix (e.g., "Street" to one of "Road", "Avenue", "Lane", "Boulevard", "Drive", etc.) where it would not create a new duplication.

- (ii) City staff will compile a list of up to five possible new suffixes in consultation with the Ward Councillor.
- (iii) City staff in co-operation with the local Councillor will hold a public meeting to discuss the name change.

- (iv) All residents and businesses on the affected street will be mailed a letter informing them of the list of possible new suffixes and invited to vote on the replacement suffix – one replacement suffix, one vote per address – with a time limit of 30 days from the date of mailing.
- (v) The returned ballots will be made available to the Ward Councillor upon request.
- (vi) In the event of a tie, the Ward Councillor may cast the deciding vote.
- (vii) Staff will report on the results of the vote to the affected Community Council.
- (viii) The Community Council will forward recommendations to City Council.
- (ix) City Council will authorize a by-law to change the name of the street.

(x) Where either the Ward Councillor of an affected street recommends an alternate naming process or a petition bearing the signature of property owners in 25 percent of the properties on the affected street proposes an alternate naming process and it is approved by the Works Committee and City Council at their next meeting following the adoption of this Clause, it will replace (i) to (viii) above.""

Motion B. by Deputy Mayor Bussin:

"That Council request the CRTC to look at the issue of requiring cell phone companies to provide for equivalent service for 911 as is available from Bell Canada."

Motion C. by Deputy Mayor Bussin, on behalf of Councillor Soknacki:

 - "(5) The City Surveyor in consultation with stakeholders develop a priority listing and criteria within the name bank to ensure appropriate matching of the significance of the proposed name and the significance of the street to be named."; and
- (5) adding a new Recommendation No. (11) as follows:
 - "(11) the Commissioner of Works and Emergency Services, in consultation with other staff and stakeholders as required, be requested to report to the Works Committee on a policy to give special recognition to people, places and events by naming public and private spaces and property."" and

Motion D. by Councillor Balkissoon:

"That staff be directed to grant an exception to the policy of avoiding similar sounding names for the duplicate and triplicate streets, whenever possible.";

5.4 Interim Evaluation – Street Lighting Maintenance Pilot Project

The Works Committee considered a report (May 17, 2004) from the Commissioner of Works and Emergency Services.

- Toronto Hydro Street Lighting Inc. be retained to continue to provide contracted services related to street lighting maintenance totalling up to \$4,800,000 for the period January 1, 2005 to January 31, 2006, for the North, South, and West Districts of the City of Toronto;
- (2) staff report to Works Committee in the spring of 2005 on the results of a complete evaluation of the East District Street Lighting Maintenance Pilot Project; and
- (3) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

5.5 1599 Jane Street – Connection to Sanitary Sewer (Ward 12 – York South-Weston)

5.9 Request for a Review of Chapter 248,

Parking Licences of the Former City of Toronto Municipal Code (Parking Pads)

"That in light of the number of requests for exemption from Chapter 248, Parking Licences, of the former City of Toronto Municipal Code that are submitted to Community Councils for consideration, and in light of the number of these requests that are routinely approved, the Commissioner of Works and Emergency Services be requested to review Chapter 248 – Parking Licences of the former City of Toronto Municipal Code, with a view to amending the Code to permit these types of requests without obtaining Community Council and City Council approval."

5.10 Traffic Calming – Criteria for Determining Public Support for the Installation of Speed Humps

NOW THEREFORE BE IT RESOLVED THAT the name "June Callwood" be reserved for future use on a street in downtown Toronto and that, in the interim, a street name sign be presented to her on the occasion of her 80th birthday; AND BE IT FURTHER RESOLVED THAT the appropriate City officials be authorized and directed to take the necessary action to give effect thereto."
