#### **Confirmation of Minutes**

On motion by Councillor Del Grande, the Minutes of the meetings of the Works Committee held on October 6 and 13, 2004, were confirmed.

# 12.1 2005 Water and Wastewater Rate Increase,2006-2007 Rate Strategy and Rate Projections for 2008-2014

The Works Committee held a statutory Public Meeting on November 9, 2004, and appropriate notice of this meeting was given in accordance with the *Municipal Act*, 2001.

The Works Committee considered the following:

(i) report (October 28, 2004) from the Chief Financial Officer and Treasurer and the Acting Commissioner of Works and Emergency Services.

## Recommendations:

It is recommended that:

- (1) the water rate and the wastewater rate be increased by 6 percent, effective January 1, 2005, for metered and flat rate customers;
- (2) water and wastewater rate increases of 7 percent and 7 percent effective January1 of 2006 and 2007 respectively, be approved in principle;
- (3) the Commissioner of Works and Emergency Services and the Chief Financial Officer and Treasurer be requested to report back on Toronto's current water and wastewater rate structure review in 2005;
- (4) this report be referred to the Policy and Finance Committee (through the Budget Advisory Committee); and
- (5) the appropriate City officials be authorized to take the necessary action to give effect thereto;
- (ii) communication (March 5, 2004) from the City Clerk advising that the City of Toronto Council at its meeting on March 1, 2 and 3, 2004, adopted, as amended, Clause 35 contained in Report 2 of the Policy and Finance Committee, headed "2004 Water and Wastewater Rate Increase, 2005-2006 Rate Strategy and Rate Projections for 2007-2013"; and advising that Council referred the issue of water rate increase

projections, beyond 2004, to the Budget Advisory Committee and the Works Committee for further analysis and review; and

(iii) report (November 2, 2004) from the Chief Financial Officer and Treasurer in response to the request by the Works Committee relating to the impact of the proposed 2005 water and wastewater rate increases in the context of all other increases facing Toronto residents and businesses.

## Recommendation:

It is recommended that this report be received for information.

The General Manager, Toronto Water, gave a presentation to the Committee and filed a copy of his presentation.

Tony O'Donohue, President, Environmental Probe Ltd., appeared before the Works Committee.

Councillor De Baeremaeker moved that:

- the staff recommendations in the Recommendations Section of the report (October 28, 2004) from the Chief Financial Officer and Treasurer and the Acting Commissioner of Works and Emergency Services be adopted;
- (2) staff be directed to create a reserve account for acquiring land for the purpose of source water protection;
- (3) the City dedicate 1/2 of one percent from within the 2005 rate increase to the source water reserve account; and
- (4) staff report back within three months with proposed terms of reference for applying this fund.

Councillor Thompson moved that the Acting Commissioner of Works and Emergency Services review the contract between the City of Toronto and York Region for the delivery of water for the provision of a detailed review of the financial records from the Finance Department to verify that York Region does not receive a financial benefit from the supply of water from the City of Toronto to is residents, and report to the Budget Advisory Committee.

Councillor Giambrone moved that the Chief Financial Officer and Treasurer and the Acting Commissioner of Works and Emergency Services report to the special meeting of the Works Committee on November 15, 2004, on the 2005 Water and Wastewater Operating and Capital Budgets on the implication of the following:

- that the amount dedicated to water conservation be increased by \$4.5 million, and that the Acting Commissioner of Works and Emergency Services report to the first meeting of the Works Committee in 2005 on ways of affecting an increase in water diversion, especially but not exclusively among high volume users; and
- (ii) the possibility of allowing the Toronto Atmospheric Fund and/or another City body to administer a revolving capital fund that would allow users to access loans to complete water reduction capital projects, and that staff further report on an appropriate time frame for such a loan.

Councillor Pitfield moved that:

- (1) the Province of Ontario be requested to bring into force Bill 175, the Sustainable Water and Sewage Systems Act, 2002, and the regulations under the Act, and make it a priority;
- (2) the Acting Commissioner of Works and Emergency Services report to the Works Committee outlining an approach to utility pricing for water and wastewater services, and on possible benefits experienced by municipalities where these have been utilized; and
- (3) parts (2), (3) and (4) of the motion by Councillor De Baeremaeker be referred to staff for a report.

Councillor Balkissoon moved that:

(1) Municipal Code 227, Reserves and Reserve Funds – Schedule C be

amended to limit the purpose of the Water Capital Reserve Fund to the provision of water infrastructure, and that no change to this purpose be effected by Council without two-thirds of the Members of Council voting in favour of the change;

- (2) City Council rescind the changes made to Municipal Code 227, Reserves and Reserve Funds – Scheduled C, related to the Water Capital Reserve Fund, on January 23, 2003, on a go-forward basis such that it does not affect any previously approved draw, in view of the current plans to improve deteriorating water infrastructure with long-term water rate increases, and in view of the ambiguous language of this amendment; and
- (3) any proceeds to the City resulting from its investment in Enwave Energy Corporation be first applied to replenish funds used for capital calls, with accumulated interest.

Councillor Del Grande moved that City Council be requested to reverse its position of taking funds for Enwave from the Water Wastewater Reserve Capital Fund.

Councillor Fletcher moved that the motions by Councillor Balkissoon be referred to the Policy and Finance Committee without recommendation.

Upon the question of the adoption of parts (i) and (ii) of the motion by Councillor Giambrone, **they were carried**

# 12.8 Disposal of Biosolids from Ashbridges Bay Treatment Plant at Michigan Landfills

The Works Committee considered the following:

(i) communication (October 6, 2004) from the City Clerk advising that City Council at its meeting on September 28, 29, 30 and October 1, 2004, considered Clause 2 of Report 8 of the Works Committee, headed "Prohibition of Materials from Landfills in Michigan", and referred the communication dated September 27, 2004, from Tony O'Donohue,

President, Environmental Probe Ltd., with respect to the disposal of biosolids from the Ashbridges Bay Treatment Plant at Michigan landfills, to the Works Committee for consideration;

- (ii) communication (November 9, 2004) from Deputy Mayor Sandra Bussin, Ward 32 Beaches-East York; and Councillor Paula Fletcher, Ward 30 – Toronto Danforth, expressing concern with respect to a number of issues related to the Biosolids and Residuals Master Plan; and
- (iii) communication (November 9, 2004) from Citizens for a Safe Environment submitting consolidated questions, comments and recommendations.

  - the legal status of the 1999 Mediator's Report, including the commitment to discontinue the use of incineration in Section 10.0 of the Ashbridges Bay Treatment Plant (ABTP) Environmental Assessment Mediator's Report;
  - (2) the legal status, if any, of the 1995 Master Treatment Plan (MTP) Environmental Assessment (EA); and
  - (3) the relationship between the requirements in the MTP EA and the current Biosolids and Residuals Master Plan EA where it concerns the ABTP; and
- (B) the Acting Commissioner of Works and Emergency Services report on the following:
  - (1) increasing the nutrient level of pellets;
  - (2) alternative disposition and beneficial use options;
  - (3) air quality;

- (4) Board of Health reports;
- (5) downstream health and environmental costs of incineration; and
- (6) the fire at the Ashbridges Bay pelletizer building,

as requested in the communication (November 9, 2004) from Deputy Mayor Sandra Bussin, Ward 32 – Beaches-East York, and Councillor Paula Fletcher, Ward 30 – Toronto-Danforth, on the Biosolids and Residuals Master Plan; and

(C) that the December 14, 2004, deadline be rescinded, and the deadline for the public review and comment period on the Biosolids and Residuals Master Plan be established by the Works Committee once staff have reported on the above questions and the three studies being conducted by the Medical Officer of Health have been released and evaluated as to their relevance to the BRMP.

# 12.9 Development of a Citizen Participation Model for Public Consultation Related to Solid Waste

The Works Committee considered the following communications:

(i) (October 25, 2004) from Deputy Mayor Joe Pantalone, Chair, Roundtable on the Environment, forwarding the document from the Roundtable on the Environment's meeting of October 19, 2004.

Recommendations:

That the Works Committee approve for Council consideration the following recommendations:

- (1) The Environmental Assessment process must be led by the community. We are proposing that a group of citizens be appointed to ensure that broad consultation takes place. To be effective over a long period of time, the Community Environmental Assessment Team should be reasonably large but not unwieldy. 15–25 members should suffice.
- (2) The role of City staff will be to support the work of the Community Environmental Assessment Team. The Community Environmental Assessment Team must not be viewed as advisors to staff. Staff should provide administrative support and technical assistance when asked. Decisions taken by the Community Environmental Assessment Team should be reported directly to the Works Committee of Council. These reports should be presented by the Community Environmental Assessment Team.
- (3) The Community Environmental Assessment Team should recommend directly to the Works Committee when they believe consultants are needed for the process. The Community Environmental Assessment Team should propose terms of reference for any relevant consulting contracts to the Works Committee. The Community Environmental Assessment Team should score RFP respondents, and recommend a preferred consultant to Works.
- (4) To ensure that the City's internal contracting standards are met, staff should manage the contractors in regards to payments, timely completion of work and other similar matters.
- (5) Selecting members of the Community Environmental Assessment Team will be critical. Environmental assessment is a rigorous legal process. The Community Environmental Assessment Team members must have ample expertise in environmental issues (preferably in waste management) and in community engagement and law (preferably in environmental assessment). These strengths need to be considered in selecting all members. The group must function as a whole not as two camps amateurs and experts.
- (6) The call for members must be broad and the selection process must be fair. A call for members should be made through paid advertising, lists of interested parties

held by Councillors, the Works Department, and other appropriate bodies. Applicants will be asked to show knowledge of Environmental Assessment, Waste Management, or other related areas such as community engagement, or environment. Applicant resumes or application letters should be reviewed by members of the Works Committee. Every effort should be made to have the Community Environmental Assessment Team functioning as soon as possible.

- (7) Potential vendors, i.e., representatives of waste firms and their trade associations, must not be included in the Community Environmental Assessment Team. The process must neither be tainted by commercial interest nor seen to be tainted.
- (8) Members of the Community Environmental Assessment Team must also be residents of Toronto.
- (9) The City should set a budget for the work of the Community Environmental Assessment Team for the first phase of the Environmental Assessment – developing a Terms of Reference Statement, which is a requirement of the Act. The Community Environmental Assessment Team may wish to retain consultants to support their consultation work and funds should be allocated for this.
- (10) The committee must conduct its work in public.
- (11) Build in a process to interface with other communities with whom there may be a conflict.
- (12) That an honorarium be considered for citizen members.
- (13) That the appropriate City officials be authorized and directed to take the necessary action to give effect thereto;
- (ii) (October 27, 2004) from the New and Emerging Technologies, Policies and Practices Advisory Group advising that the Advisory Group at its meeting on October 27, 2004, adopted the following resolutions:

# Public Consultation for an Environmental Assessment for Waste Management

The Advisory Group fully supports the 10-point proposal for a Community Consultation Group submitted to the Roundtable on the Environment, with the following clarifications and additions:

- (1) the Group should ensure that there is broad consultation with those potentially interested;
- (2) the Group will direct consultants and the EA process based on the public consultation, and with input from City staff on an ongoing (not on an only-when-asked) basis;
- (3) the Group will include citizens with proven experience (not only expertise) in environmental issues (preferably waste management), community engagement, and/or environmental assessment;
- (4) membership on the Group should be expanded to include citizens from potentially affected areas when those areas are identified; and
- (5) to better reflect its purpose, the Group should be named the "Toronto Solid Waste EA Group."

## Solid Waste Diversion Working Group

Consistent with its previous resolutions, the Advisory Group adopted the following set of resolutions:

- (1) the City should establish a Waste Diversion Working Group to oversee the planning, design, implementation, promotion and monitoring of diversion programs. The Working Group should include members of the public, City staff, frontline collection workers, and possibly Works Committee members. It should also establish plans with timelines, and clear reporting structures for its work and for implementation and operation of diversion programs, and should co-ordinate its work with that of the working groups for apartments, ABCDs and schools;
- (2) the Waste Diversion Working Group should report directly to Works Committee; and
- (3) the Waste Diversion Working Group should be established as soon as possible, and no later than April 1, 2005; and
- (iii) (November 9, 2004) from the Citizens for a Safe Environment submitting consolidated questions, comments and recommendations.

Tony O'Donohue, President, Environmental Probe Ltd. appeared before the Works Committee.

The Works Committee recommended that:

(1) City Council approve in principle the Citizen Participation Model for Public Consultation Related to Solid Waste recommended by the Roundtable on the Environment;

# (Motion by Councillor Fletcher)

(2) the Acting Commissioner of Works and Emergency Services be requested to report to the Works Committee meeting on December 8, 2004, regarding administration, accountability and financial aspects of the model; and

# (Motion by Councillor Fletcher)

(3) the Chair and Vice-Chair of the Works Committee be authorized to select the Community Environmental Assessment Team.

# (Motion by Councillor Pitfield)

Councillor Del Grande noted his opposition to the action taken.

The following motion by Councillor Balkissoon was voted on and did not carry:

"That the recommendations of the Roundtable on the Environment be referred to the Acting Commissioner of Works and Emergency Services for a report to the next regular meeting of the Works Committee on an appropriate process."

# 12.10 Amendment to Blanket Contract Purchase Order for Removal of Household Hazardous Waste Collected at Environment Day Events

The Works Committee considered a report (October 19, 2004) from the Acting Commissioner of Works and Emergency Services.

## Recommendations:

It is recommended that:

- (1) Blanket Contract Purchase Order No. 47008330 with Hotz Environmental Services for the removal of household hazardous wastes collected at Environment Days be amended by increasing the amount from \$191,433.70 (including full GST) to \$311,433.70 (including full GST) to account for the increased volume of HHW collected at Environment Days in 2004 and diverted from landfill, with all other terms and conditions remaining unchanged; and
- (2) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto.

On motion by Councillor Giambrone, the Works Committee recommended that:

- City Council adopt the staff recommendations in the Recommendations Section of the report (October 19, 2004) from the Acting Commissioner of Works and Emergency Services; and
- (2) the City Clerk be requested to write a letter encouraging the Minister of the Environment to expedite the designation of household hazardous waste for a waste diversion plan under the Waste Diversion Act, and that this Clause be forwarded to the Association of Municipalities of Ontario.

# 12.11 Request for Approval of Amendment to Blanket Contract Purchase Orders for Processing Leaf and Yard Waste in the Solid Waste Management Program

as she considers reasonable; and

- (iv) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto; and
- (2) this report be received by the Works Committee for information purposes.
