14.7 1599 Jane Street – Sanitary Sewer Hook-up (Ward 12 – York-South Weston)

The Works Committee considered a communication (October 5, 2004) from Councillor Frank Di Giorgio, Ward 12 – York South Weston, with regard to the City providing a sewer connection for the property at 1599 Jane Street which is currently on a septic system and which was considered by the Works Committee at its meeting on June 2, 2004; advising that further to the Works Committee direction to have the applicant pursue options for a sanitary sewer hook-up at 1599 Jane Street that required an easement over neighbouring properties, no workable solutions were found; and requesting that this matter be brought back to the Works Committee for further deliberation and the design of a feasible and acceptable solution.

Councillor Frank Di Giorgio, Ward 12, York South-Weston, appeared before the Works Committee.

- A. Councillor De Baeremaeker, on behald of Councillor Di Giorgio, moved that the Acting Commissioner of Works and Emergency Services be requested to install the sanitary sewer hook-up at 1599 Jane Street, at an approximate cost of \$80,000-\$100,000; and that the property owner be charged the flat rate for that portion of the sewer corrections on his property, which was lost.
- B. Councillor De Baeremaeker moved that approval be conditional on the City of Toronto and the owner of the property entering into an agreement registered on title that requires repayment of the cost plus interest of the installation prior to any approval of any land use charge on the property, which was declared redundant.
- C. Councillor Balkissoon moved that City Council adopt the staff recommendation in the Recommendation Section of the report (May 18, 2004) from the Commissioner of Works and Emergency Services, as follows:

"It is recommended that the installation of the sanitary sewer connection and any associated sanitary sewer extension be undertaken at the cost of the property owner."

which was carried.

14.8 Car Free Day 2005 (Ward 20 – Trinity-Spadina Wards 27 and 28 – Toronto Centre-Rosedale)

The Works Committee considered the following:

(i) report (November 25, 2004) from the Acting Commissioner of Works and Emergency Services on options and costs for Toronto's Car Free Day 2005.

Recommendations:

It is recommended that:

- (1) City Council endorse the concept of a signature street event, involving the closing of both Queen Street and King Street, between Church Street and Spadina Avenue, from 6:30 a.m. to 6:30 p.m., for Car Free Day on Thursday, September 22, 2005;
- an amount of \$500,000.00 be added as a new item to the Transportation Services 2005 Operating Budget to undertake Car Free Day activities as described in this report, and to be considered as part of the 2005 budget review process;
- (3) the Acting Commissioner of Works and Emergency Services be directed to report further to the Works Committee on the detailed plan, including the results of public consultation, for undertaking the Car Free Day signature street event; and
- (4) the appropriate City officials be authorized and directed to take the necessary action to give effect thereto; and

- (ii) communication (November 23, 2004) from the Secretary, Board of Health advising that the Board of Health at its meeting on November 22, 2004:
 - (1) endorsed the initiatives proposed by the Car Free Day Working Group and the proposed Toronto Public Health budget enhancements to support this work, outlined in the report (November 18, 2004) from the Medical Officer of Health;
 - (2) requested that public transit and emission savings from Green Fleet be part of the City of Toronto's current initiatives in the focus of a Car Free Day; and
 - (3) directed that the report be forwarded to the Works Committee for information.

Councillor Karen Stintz, Ward 16, Eglinton-Lawrence, appeared before the Works Committee.

On motion by Councillor Thompson (on behalf of Councillor Stintz), the Works Committee:

- (1) deferred the report from the Acting Commissioner of Works and Emergency Services until its meeting to be held on January 5, 2005, and directed that it be considered with the 2005 Operating Budgets for Transportation Services; and

work in the City of Toronto to park their cars on Toronto's Car Free Day in 2005 and take public transit to work for the day."

14.9 Steeles Avenue East/GO Transit Railway Grade Separation Class Environmental Assessment Study Addendum (Ward 39 – Scarborough-Agincourt Ward 41 – Scarborough-Rouge River)

The Works Committee considered a report (November 19, 2004) from the Acting Commissioner of Works and Emergency Services respecting the Steeles Avenue East/GO Transit Railway Grade Separation Environmental Assessment Study Addendum.

Recommendations:

It is recommended that:

- (1) approval be granted for an underpass grade separation, and associated design elements, at the Steeles Avenue East/GO Transit railway crossing between Kennedy Road and Midland Avenue, as detailed in the August 2004 Addendum Report and highlighted below:
 - (i) widening of Steeles Avenue East to 6-lanes plus bike lanes between Kennedy Road and Midland Avenue;
 - (ii) construction of a railway bridge over Steeles Avenue East;
 - (iii) installation of a pumping station;
 - (iv) reconstruction of Turff Avenue as a cul-de-sac; and
 - (v) relocation of municipal services and utilities; and
- (2) authority be granted for the Acting Commissioner of Works and Emergency Services to issue the Notice of Filing of Addendum for the Steeles Avenue East/GO Transit Railway Grade Separation Class Environmental Assessment Study with the City Clerk, and to give public notification of such filing in accordance with the requirements of the Municipal Class

EA process.

Isabel Mitchell, McMillan Binch, appeared before the Works Committee.

On motion by Councillor Balkissoon, the Works Committee recommended that City Council adopt the staff recommendations in the Recommendations Section of the report (November 19, 2004) from the Acting Commissioner of Works and Emergency Services; and further that a copy of the report be forwarded to Mr. Jim Karygiannis, M.P. for Scarborough Agincourt.

14.10 2005 Toronto Cycling Committee Budget Submission
