MINUTES OF THE COUNCIL OF THE CITY OF TORONTO

**MONDAY, MARCH 1, 2004,
TUESDAY, MARCH 2, 2004, AND

City Council met in the Council Chamber, City Hall, Toronto.

5.1 CALL TO ORDER - 9:35 A.M.

Mayor Miller took the Chair and called the Members to order.

The meeting opened with O Canada.

WHEREAS at the December 18, 2003 hearing, the landlord's contractor did not indicate that vacant possession was required to do the work and instead gave evidence that vacant possession was preferred as the repair could be completed sooner; and

WHEREAS at the same hearing, a manager of the City of Toronto Municipal Licensing and Standards Division gave evidence that in his experience, the proposed renovation was not extensive enough to warrant a vacant possession of the building; and

WHEREAS the Tribunal has requested submission of arguments from both parties and has not made a decision on the landlord application; and

WHEREAS the Tenants' Association of 220 Eglinton East has incurred substantial costs for legal representation to defend their tenancies and applied for an additional grant of \$9,000.00; and

Report dated February 26, 2004, from the Commissioner of Urban Development Services, entitled "Six Month Extension to Interim Control By-law No. 846-2002 as amended by By-law No. 929-2003 for the lands known as 1 to 29 Musgrave Street, 600 Victoria Park Avenue, 2234 to 2276 Gerrard Street East, 2284 to 2316 Gerrard Street East and 2236 to 2366 Gerrard Street East." (See Minute No. 5.130, Page 137):

Purpose:

The purpose of the report is to further extend Interim Control By-law No. 846-2002, as amended by By-law No. 929-2003 for a further 6 months.

Financial Implications and Impact Statement:

There are no financial implications resulting from the adoption of this report.

Recommendations:

It is recommended that:

- (1) City Council extend Interim Control By-law No. 846-2002, as amended by By-law No. 29-2003, for a further 6 months; and
- (2) the City Solicitor be requested to prepare the Bill and authority be granted to introduce the Bill in Council.

Background:

At its meeting of October 29, 30 and 31, 2002, City Council adopted Interim Control By-law No. 846-2002 for the lands known as 1 to 29 Musgrave Street, 600 Victoria Park Avenue, 2234 to 2276 Gerrard Street East, 2284 to 2316 Gerrard Street East and 2336 to 2366 Gerrard Street East. The by-law prohibits the use of land, buildings or structures within the defined area under review, for any new industrial use, as specified in the by-law. Given the changing character of the area, a by-law was put in place to allow for the determination of the appropriate land uses for these properties.

The Interim Control By-law was extended for an additional 6 months by By-law No. 929-2003, adopted by City Council at its meeting of September 22, 23, 24 and 25, 2003. The Interim Control By-law expires on March 24, 2004. As the March 1 meeting is the last City Council meeting prior to the expiry of the Interim Control By-law, it is important that City Council consider this matter at its March meeting.

Comments:

At its meeting of September 22, 23, 24 and 25, 2003, City Council had before it my report dated August 20, 2003, which in addition to extending the Interim Control By-law for 6months provided some details as to the future planning direction for this area.

Staff will be reporting to Community Council in July 2004. Section 38(2) of the Planning Act allows for the extension of an Interim Control By-law to a maximum of 2 years. This will be the final extension.

Conclusions:

An extension of the Interim Control By-law for a further six months will allow for completion of the study.

ATTACHMENT NO. 2[Notice of Motion J(30)]

Report dated March 1, 2004, from the Commissioner of Urban Development Services, entitled "Proposed Interim Control By-law to Prohibit Entertainment Facilities West of Spadina Avenue in the King-Spadina Part II Plan Area (Ward 20 - Trinity-Spadina) " (See Minute No. 5.135, Page 144):

Purpose:

To propose an interim Control By-law to prohibit entertainment facilities on lands west of Spadina Avenue in the King-Spadina Part II Plan area for a one year period. The by-law will enable the Commissioner of Urban Development Services to review the impact of entertainment uses and recommend appropriate zoning standards.

Financial Implications and Impact Statement:

There are no financial implications resulting from the adoption of this report.

Recommendations:

It is recommended that:

- (1) City Council adopt the following resolution:

Whereas Section 38 of the Planning Act authorizes Council to pass resolutions directing that a review or study be undertaken in respect of land use planning policies within the area of the municipality which is to be the subject of an Interim Control By-law, therefore be it resolved that Council request the Commissioner of Urban Development Services to undertake a review or study in respect of land use policies for those lands west of Spadina Avenue in the King-Spadina Part II Plan area that are identified on Attachment No. 2; and

- (2) City Council, after adopting the resolution in Recommendation No. (1) above, grant authority for the introduction of the necessary Bills in Council to substantially give effect to the following:

No person shall, in the area referred to in Recommendation No. (1) above, use any lot or erect any building or structure for an entertainment facility and/or a patio in conjunction with an entertainment facility for a period of one year, save any use lawfully existing on the lands at the time of the passage of these Bills.

Comments:

King-Spadina Part II Plan

City Council adopted the King-Spadina Part II Plan in April 1996 to encourage revitalization of the King-Spadina area, bounded generally by Queen Street West, Simcoe Street, Front Street West and Bathurst Street (see Attachment 1). The area had seen a decline in its

traditional manufacturing base. This Part II Plan was established to encourage flexible development of a very wide variety of residential, retail, entertainment, office and light industrial uses, and it has been highly successful. Between 1996 and 2001 alone, over 4,400 residential units were developed and employment in the area increased by approximately 3,500 jobs.

Entertainment Uses

The Reinvestment Area (RA) designation of the Part II Plan applies to most of the Plan area (Attachment 1) and is the most permissive designation, allowing almost any modern, legal urban activity. Entertainment uses are permitted throughout the RA designation without a size restriction.

The RA designation essentially expanded the area where entertainment uses are permitted beyond the King-Spadina entertainment district, to include the area west of Spadina Avenue to Bathurst Street. When recommending approval of the Part II Plan, staff acknowledged that certain entertainment uses and emerging residential uses may conflict, and indicated that potential conflicts would be analysed.

New Official Plan

At its meeting of November 26, 2002, City Council adopted the new Official Plan for the City of Toronto. The Minister of Municipal Affairs and Housing approved the new Official Plan, in part, with modifications. The Minister's decision has been appealed in its entirety. The new Official Plan is now before the OMB and no hearing date has been set.

The new Official Plan carries forward the King-Spadina Part II Plan of the in-force Official Plan as the King-Spadina Secondary Plan. The new Official Plan designates Reinvestment Area lands of the in-force Official Plan as Regeneration Area, which permits a broad mix of commercial, residential, light industrial, institutional and live/work uses in an urban form.

Implementing Zoning

The Reinvestment Area zoning is the implementing zoning that permits entertainment facilities of any size within the RA area shown on Attachment 1. There are two minor qualifications.

A patio accessory to an entertainment facility is not permitted within 10 metres of a lot in a Residential District. The gross floor area of an entertainment facility cannot exceed 400 square metres when located adjacent to a Residential District, or separated from a Residential District by a street of 6.1 metres in width or less. These references to Residential District do not apply to a residential use that is located within a Mixed-Use or RA District.

Rationale for an Interim Control By-law

Section 38 of the Planning Act authorizes City Council to pass Interim Control By-laws

enabling Council to temporarily restrict a land use while the City studies/reviews the land use policies for affected properties.

At its meeting of November 26 to 29, 2002 City Council directed staff to review land use policies and regulations with respect to nightclubs and large entertainment facilities” in the Part II Plan area.

The established entertainment district is located east of Spadina Avenue in the Part II Plan area and has since 1996 seen a significant increase in the number of entertainment facilities, including large facilities able to accommodate several thousand patrons.

Since 1996, a small number of entertainment facilities have also been established west of Spadina Avenue in the Part II Plan area. This area has also seen a significant increase in residential development since 1996. City staff have observed the impact of a concentration of entertainment facilities east of Spadina Avenue and the resultant issues of noise, graffiti and litter. Given these impacts and conflict with residential uses, a planning study should be undertaken for the area west of the established entertainment district (see Attachment 2) before significant numbers of entertainment facilities locate here. Whether restrictions on entertainment facilities are appropriate west of Spadina Avenue should be considered. The study will review the concerns and issues associated with entertainment facilities and identify whether specific by-law changes would be appropriate to address such matters. In the interim, the establishment of this use, or expansion of this use through the conversion of existing building space or the construction of additions should be prevented so as not to jeopardize the outcome of the study. The Interim Control By-law would not prevent lawfully existing entertainment facilities from continuing to operate.

Conclusions:

The enactment of an Interim Control By-law for the lands identified in Attachment 2 will allow the City to undertake the necessary review of the land use policies as they apply to entertainment facilities in the area west of Spadina Avenue in the King-Spadina Part II Plan area. Given the impacts associated with entertainment facilities, the enactment of the proposed Interim Control By-law authorized under Section 38 of the Planning Act is appropriate.
