### 1. Appointments to the Toronto Licensing Tribunal

### Report 11, Clause 1

The Planning and Transportation Committee recommends that City Council adopt the Sub-Committee's recommendations in the Recommendations Section of the communication (November 24, 2005) from the Sub-Committee Respecting the Toronto Licensing Tribunal.

Recommendations:

It is recommended that:

- (1) Council appoint citizens to the Toronto Licensing Tribunal, as listed in the confidential communication (November 24, 2005) from the Sub-Committee Respecting the Toronto Licensing Tribunal, to replace members who resigned, for the rest of the term of office ending November 30, 2006, at the pleasure of Council, and until successors are appointed; contingent on the member successfully completing a training program on the adjudicative process within 6 months of appointment; and noting that the *Statutory Powers Procedure Act* requires that members' terms continue beyond their term of office or resignation date, only to complete hearing any matters of which they are seized;
- (2) Council appoint the member listed in the confidential communication as Chair;
- (3) the citizens in the confidential communication be held as alternates to be appointed by Council should vacancies arise during the term, and that their names remain confidential until appointed;
- (4) the appropriate City officials be authorized and directed to do whatever is necessary to implement these recommendations; and
- (5) under the *Municipal Act* and *Municipal Freedom of Information and Protection of Privacy Act*, Planning and Transportation Committee and Council discuss this in camera, since the subject includes personal matters about identifiable individuals.
